1. Opening of the meeting

The meeting was opened by its President, Mr Fritz Zeder, at 9:30 a.m. on Tuesday, 25 November 2025. He invited the Director General of Human Rights and Rule of Law, Mr Gianluca Esposito, to give a presentation and exchange views with the Plenary.

Mr Esposito expressed appreciation for the outgoing President, Mr Fritz Zeder, and thanked him for his exceptional work in steering the CDPC during a period of intensive activity.

He informed the Plenary about the new initiative launched by the Secretary General regarding Foreign Information Manipulation and Interference (FIMI), which originated at the European Political Community Summit in Tirana and has since gained political traction. In this context, he recalled the establishment of a CDPC subcommittee tasked with preparing a study on the feasibility of a Council of Europe instrument addressing FIMI, covering both its preventive and repressive aspects. He also welcomed the fact that FIMI features as a priority under the Moldovan Presidency.

Mr Esposito emphasised the very tight calendar for this exercise. The draft study is expected to be approved by the Committee of Ministers by mid-April 2026, with an online CDPC session to be held in connection with the Bureau meeting of 26-27 March 2026. The work will be carried out by a dedicated team within the Directorate of Security, Integrity and Rule of Law, coordinated by Mr Kristian Bartholin.

With regard to migrant smuggling, he recalled that the CM has mandated the CDPC to prepare a Recommendation on deterring and fighting this phenomenon by the end of 2027, supported by a dedicated subcommittee. This will also help implement the Council of Europe Action Plan on migrant smuggling.

He informed the Plenary that the Council of Europe will participate in the upcoming Global Alliance Conference to counter Migrant Smuggling in Brussels, as well as the planned Ministers of Justice meeting on migration and the European Convention on Human Rights (ECHR) in Strasbourg on 10 December 2025.

Regarding environmental crimes, Mr Esposito expressed the hope that the opening for signature of the Convention on the Protection of the Environment through Criminal Law on 3 December will attract a significant number of signatories, including the EU. He highlighted the unique nature of this global legally binding instrument and its role in strengthening international cooperation.

He further encouraged States that have not yet signed the Third Additional Protocol to the European Convention on Mutual Assistance in Criminal Matters to join the seventeen existing signatories, recalling its role in modernising the Convention and improving the effectiveness of cross-border investigations.

Mr Esposito also expressed hope that the CDPC would be in a position to approve the draft Protocol on Asset Recovery and to instruct the PC-RAC to finalise the related Explanatory Report for submission to the CM in early 2026, thereby strengthening the European framework in the area of tracing, seizing, managing and confiscating criminal assets.

Mr Esposito concluded by noting the importance of the CDPC both as a standard-setting body and as a platform for dialogue and peer exchange. He ended with an exchange with some of the delegates.

2. Adoption of the draft agenda and order of business

The CDPC adopted the draft agenda and the order of business of the meeting.

3. Information by the President, members of the CDPC Bureau and the Secretariat

The President, Mr Fritz Zeder, presented an overview of activities undertaken since the previous CDPC Plenary, as well as the conclusions of the Bureau meeting of 22 to 23 October 2025. He also noted the scheduling conflict with the EU CATS meeting and emphasised the need for better coordination of meeting dates in the future.

The Secretary, Ms Eva Pastrana, encouraged CDPC members to promote awareness of the work of the CDPC and its subcommittees, along with relevant Council of Europe Conventions, including the PC-OC instruments on international cooperation with global applicability. This is intended to foster broader ratification and support effective implementation.

She further drew attention to the two Recommendations listed below pending approval. Ms Pastrana proposed to include an item on the new CDPC deliverable on cryptocurrencies under “AOB”. She also informed members that two sets of elections would take place during the Plenary meeting. These are first for the CDPC – the positions of President, Vice President and three seats in the Bureau. One candidate had been received for each of the vacancies.

Regarding the Council for Penological Cooperation (PC-CP), four members of the working group had to be renewed. Mr Peter Rashkov was appointed as adjudicator. Six candidates were presented and delegates were invited to cast their votes for four of them.

All CDPC members were invited to provide updates on recent criminal law developments within their jurisdictions, to suggest new areas of work for the CDPC, or to raise matters relevant to the Committee’s scope of action.

4. Foreign information manipulation and interference (FIMI)

The CDPC took note of the Secretary General’s initiative on FIMI, as well as associated time constraints, affecting the CDPC’s 2026 calendar. It also heard an address by Mr Kristian Bartholin on the designated sub-committee (PC-FIMI).

The PC-FIMI will hold four meetings of three days each, with the two mid-term meetings online. The first meeting is scheduled for January and the last for mid-March 2026. The work of PC-FIMI will be coordinated by Mr Kristian Bartholin in cooperation with the CDPC Secretariat and other relevant intergovernmental committees. The feasibility study is expected to be finalised in view of the Committee of Ministers meeting in May 2026 in Chisinau, and the CDPC is invited to ensure timely fulfilment of this mandate.

The CDPC also took note that all member States will be invited to nominate and send representatives to the PC-FIMI, although the Council of Europe will finance the participation of only twelve designated members. If more are nominated, prioritisation will be applied using geographical, legal system and gender balance. Invitations for nominations to PC-FIMI will be sent to the CDPC delegates early next week. Mr Bartholin also informed the Plenary that the Secretariat has already started work on preparing an initial feasibility study draft, which will be presented at the first PC-FIMI meeting in January 2026 to accelerate progress.

The CDPC further took note that the final feasibility study must be adopted by the CDPC no later than 15 April 2026. The President underlined that, given the time-limit, adoption should proceed via hybrid sessions and/or a written procedure.

The Republic of Moldova and Norway expressed support for the creation of the subcommittee, the latter indicating its intention to nominate a candidate.

The CDPC finally noted that observer delegations may participate and vote at their own expense.

5. Council for Penological Co-operation (PC-CP)

The CDPC began by welcoming the newly appointed Secretary of the PC-CP, Ms Louise Riondel, who replaced Ms Ilina Taneva following her retirement. It then took note of the summary meeting reports of the 38th and 39th PC-CP Working Group meetings, held respectively on 20 - 22 May 2025 in Madrid, Spain, and on 23 September 2025 in Krakow, Poland, and heard a presentation by the PC-CP President, Ms Laura Negredo Lopez.

The Plenary also took note of the election of Mr Jorge Monteiro (Portugal) as President of the PC-CP and Ms Carla Ciavarella (Italy) as Vice-President of the PC-CP for a one-year term (renewable once) starting 1 January 2026.

a. Education in prison

The CDPC examined and approved the draft revised Recommendation Rec(89)12 on education in prison with its Explanatory Memorandum as proposed by the PC-CP. The CDPC decided to transmit both texts to the Committee of Ministers for adoption and taking note, respectively.

b. Foreign nationals in prison - updating CM/Rec (2012)12 concerning foreign prisoners and its Explanatory Memorandum

The CDPC took note that, in line with its mandate, the PC-CP Working Group is continuing its work on revising and updating Recommendation CM/Rec(2012)12 concerning foreign prisoners, together with its Explanatory Memorandum. This work is expected to also encompass probation and be completed by the end of 2026.

c. Updated Council of Europe Probation Rules

The CDPC took note that, in line with its mandate, the PC-CP will review the Council of Europe Probation Rules and Explanatory Memorandum. In this context, a survey on the use and revision of the Rules was recently prepared jointly with the Confederation of European Probation and sent to the Directors General of prison and probation services, the responses to which will serve as the basis for this work to be completed by the end of 2027.

d. 30th Conference of Directors of Prison and Probation Services (CDPPS) “Can we move away from the overuse of Penal Sanctions?” (Krakow, Poland, 24-25 September 2025)

The CDPC took note that the 30th Council of Europe Annual Conference of Directors of Prisons and Probation Services had been held on 24–25 September 2025 in Krakow, Poland, under the title “Can we move away from the overuse of penal sanctions?”. The keynote speech addressed the issue of the net-widening of penal sanctions, while the four workshops focused on the latest SPACE data, the use of data in penal policy and risk assessment, the promotion of positive mental health among prisoners and probationers and trauma-informed care, children with imprisoned parents, and the strategic approach of prison and probation services to crisis management.

e. 31st Conference of Directors of Prison and Probation Services (CDPPS) (Valletta, Malta, 3-4 June 2026)

The CDPC took note that the 31st Council of Europe Annual Conference of Directors of Prisons and Probation Services will take place on 3-4 June 2026 in Valletta, Malta. The CDPC might send a representative to this Conference.

f. Elections

The CDPC thanked the PC-CP outgoing President, Ms Laura Negredo Lopez, the Vice-President Ms Maria Lindstrom and the other outgoing members of the PC-CP WG, Ms Paulina Tallroth and Mr Dominik Lehner for their excellent work and elected the following new members of the PC-CP WG:

6. Committee of Experts on the operation of European conventions on cooperation in criminal matters (PC-OC)

The CDPC took note of the List of Decisions of the 88th Plenary meeting of the PC-OC of 4-6 November 2025, as well as of the oral information provided by the PC-OC Secretary, Mr Hasan Bermek.

The CDPC took note of the information concerning the Informal Conference of Ministers of Justice on cross-border cooperation and mutual assistance, that took place in Valletta, Malta, on 18-19 September 2025. It welcomed the fact that the declaration adopted by the Ministers of Justice reflected the value of the work of the CDPC and the PC-OC. It also welcomed the fact that the Third Additional Protocol to the European Convention on Mutual Assistance in Criminal Matters ("Valletta Protocol") had already been signed by 17 member States and encouraged all States Parties to the Convention to sign and ratify this Protocol.

The CDPC took note of and endorsed the opinion of the PC-OC on the possible accession of Kyrgyzstan to the European Convention on Mutual Assistance in Criminal Matters. The CDPC also instructed the Secretariat to transmit it to the Committee of Ministers when Kyrgyzstan formally requests to be invited to accede to that Convention.

On a general level, the CDPC underlined the importance of the promotion of the abolition of the death penalty.

The CDPC took note of the progress made by the PC-OC on a draft paper on the role of the Council of Europe conventions in the context of international cooperation relating to core international crimes and the articulation between these conventions and the Ljubljana-The Hague Convention. It also noted the fact that the PC-OC updated its compendium on extradition and its document on the case-law of the European Court of Human Rights concerning international cooperation.

The CDPC finally took note of the ongoing work within the PC-OC, including on the issues of the relationship between asylum and extradition procedures, time limits for surrender, confidentiality in MLA proceedings, a questionnaire on the application of the Convention on

the transfer of sentenced persons, as well as the supervision of conditionally sentenced or conditionally released offenders.

7. Environment and Criminal Law

The CDPC took note of the information provided by the Secretary of the CDPC regarding the Convention on the Protection of the Environment through Criminal Law, which will be opened for signature on 3 December 2025 in Strasbourg, with the participation of the former President of the PC-ENV, Mr Šimon Pepřík, as well as information on measures to promote its signature by CoE MS. The Convention could also be signed on the occasion of the Ministerial Conference in Strasbourg on 10 December 2025.

The CDPC took note of the newly established Committee on Environment and the implementation of the Council of Europe Strategy which includes one section on the promotion of the ratification and implementation of the Convention.

The CDPC made a call for a volunteer from among its members to closely follow this topic and report to the CDPC, with the support of the Secretariat.

Ms Eva Pastrana also briefed the Plenary about her participation in the open-ended intergovernmental expert group on crimes that affect the environment under the UN Convention against Transnational Organized Crime. In this expert group, several states highlighted the relevance of the CoE Convention.

8. Smuggling of Migrants

The CDPC took note of the information provided by the Secretariat on the 3rd International Conference on Migrant Smuggling and on the meeting of the Network of Prosecutors on SoM, organised by the CDPC in collaboration with the Council of Europe Division on Migration and Refugees in Strasbourg on 21–22 October 2025. The discussions will help inform the preparation of the draft comprehensive Recommendation on deterring and fighting the smuggling of migrants, emphasising international cooperation, effective legal frameworks, and protection of victims and those assisting them.

The Plenary took note of the information presented by Ms Pastrana on the approved Committee of Experts on combatting the smuggling of migrants (PC-TM) which will be responsible for drafting the Recommendation and supporting the implementation of the Council of Europe's Action Plan on Fostering International Cooperation and Investigative Strategies in Combating the Smuggling of Migrants. The CDPC decided, first, to send the call for candidates as soon as possible; second, to organise the first meeting by the end of February or early March 2026; third, to extend the engagement of the two experts involved in the drafting of the feasibility report, which will be the basis of the draft Recommendation; and fourth, to ask the PC-OC to include an agenda point in their next Mod meeting to discuss how to support the CDPC work in this field, as well as a tour de table in the next Plenary to share salient cases and challenges regarding MLA and SoM.

The Director of Security, Integrity and Rule of Law, Ms Hanne Juncher, will represent the CoE at the EU-led International Conference on a Global Alliance to Counter Migrant Smuggling on 10 December, the same day of the Informal Ministerial Conference at the Council of Europe to discuss issues related to migration and the ECHR.

9. Combating technology-facilitated violence against women and girls

The CDPC took note of the report of the fourth meeting of the Committee of Experts on combating technology-facilitated violence against women and girls (GEC/PC-eVIO), held in

Strasbourg from 30 September to 2 October 2025, during which the draft Recommendation on Accountability for Technology-facilitated Violence against Women and Girls was finalised.

During a first session, the CDPC took note of a presentation by the President of the GEC/PC-eVIO, Ms Venus Mahmood, and held an exchange with her. Ms Mahmood provided an overview of the new Recommendation and responded to comments and questions from delegations. Following discussions, the CDPC decided to make some amendments to the text of the Recommendation.

The following day, the CDPC and the Gender Equality Commission held a joint session with the in-person participation of the GEC President, Ms Sara Slana, and the other members of the GEC participating online. During this session both Committees examined the latest version of the text, included some amendments, and jointly approved by acclamation the Recommendation on Accountability for Technology-facilitated Violence against Women and Girls, as well as adopted the Explanatory Memorandum. Both Committees decided to jointly submit the final text of the Recommendation and the Explanatory Memorandum to the Committee of Ministers, inviting it to adopt the Recommendation and to take note of the Explanatory Memorandum.

In relation to paragraph 14 of the Explanatory Memorandum to the above draft Recommendation, Bulgaria stated its position regarding the interpretation of the term “gender” and gender-related terminology, in accordance with its internal legal order.

10. Asset recovery

The CDPC took note that the Committee of Experts on Criminal Asset Recovery (PC-RAC) held its sixth meeting from 6 to 10 October 2025, with the primary objective of finalising the draft Additional Protocol to the Council of Europe Convention on Laundering, Search, Seizure and Confiscation of the Proceeds from Crime and on the Financing of Terrorism (CETS No. 198), together with its Explanatory Report.

It was noted that agreement had been reached on the text of the draft Additional Protocol, reflecting the results of extensive discussions held since May 2024 with the participation of experts from Council of Europe member States, Morocco, the European Union and relevant international bodies.

The CDPC further took note that the Explanatory Report could not yet be finalised and that its completion will be addressed at the seventh meeting of the PC-RAC, scheduled for 8 to 10 December 2025.

Following a presentation by the President of PC-RAC, Mr Cornel-Virgiliu Calinescu, on the structure and key elements, the CDPC examined and approved the draft Additional Protocol supplementing the Council of Europe Convention on laundering, search, seizure and confiscation of the proceeds from crime and on the financing of terrorism, and decided to transmit it to the Committee of Ministers for adoption.

Regarding the draft Explanatory Report to the draft Additional Protocol supplementing the Council of Europe Convention on laundering, search, seizure and confiscation of the proceeds from crime and on the financing of terrorism, the CDPC took note of observations and comments raised by two delegations during the exchange.

Otherwise, the CDPC did not raise major concerns regarding the draft Explanatory Report and instructed the PC-RAC to fine-tune the Explanatory Report, including discussing comments by the two delegations, one of which provided specific suggestions that will be also provided separately. The Chair of the PC-RAC confirmed that these will be discussed. Other

delegations might also submit comments ahead of the PC-RAC meeting on 8-10 December 2025.

The CDPC decided that any major substantive changes agreed at the final PC-RAC meeting, to be held from 8 to 10 December 2025, shall be communicated to the CDPC for information and, where confirmation is required, validated through a written procedure prior to the final transmission of the Explanatory Report to the Committee of Ministers.

The CDPC instructed the Secretariat with the task of transmitting the draft Protocol and its draft Explanatory Report to the Committee of Ministers as soon as possible, for submission to the Parliamentary Assembly for opinion, with a view to the adoption of the Protocol by the Committee of Ministers as soon as possible in 2026.

11. Artificial Intelligence and criminal law

The CDPC President noted that the deliverable “Draft legal instrument on criminal liability related to the use of artificial intelligence” deadline has been extended until the end of 2027.

The CDPC recalled that a draft questionnaire prepared by the Secretariat together with the two experts, Ms Sabine Gless and Mr Alfonso Peralta, had been approved by the Plenary in June 2025 and subsequently circulated to member States for completion by September 2025. Twenty-seven States responded, allowing the Secretariat to instruct the two experts to develop a mapping study based on the submissions received.

The Plenary then took note of a presentation by the experts on their preliminary findings. Delegations noted the usefulness of the results. The CDPC decided that the final version of the mapping study will be provided to the CDPC-AICL Working Group ahead of its fourth meeting scheduled for 18 December 2025, and to invite member States that had not yet submitted responses to the questionnaire to do so sooner than later to complete the analysis at European level.

The objective of that meeting will be to review the outcomes of the mapping exercise, validate the findings, identify remaining gaps and discuss core legal issues concerning artificial intelligence and criminal liability. The session will also allow assessment of the need for improved consistency or for the development of a common legal instrument, as well as clarification of subsequent steps, including experts' mandate and the workplan for 2026 to 2027.

The CDPC decided that the AICL Working Group will have to prepare a report focused on substantive issues for examination at the next Plenary in June 2026, with the draft to be ready prior to the CDPC Bureau meeting at the end of March 2026. To this end, the Working Group will liaise with other committees, including T-CY and PC-FIMI. It was further noted that the Recommendation on Accountability for Technology-facilitated Violence against Women and Girls may also be relevant to its work.

12. Restorative justice

The CDPC heard presentations by its Secretary, Ms Eva Pastrana, and by Ms Edit Törzs from the European Forum for Restorative Justice, followed by an exchange with both speakers.

During the discussion, Ms Pastrana recalled that the deadline for the deliverable “Draft guidelines for implementing Recommendation CM/Rec(2018)8 on restorative justice in criminal matters” has been extended until the end of 2027 and highlighted the renewed engagement of the PC-CP in supporting progress in this area. The CDPC made a call for a volunteer from among its members to closely follow this topic and report to the CDPC, with

the support of the Secretariat. Due to links to penological work, the CDPC also invited the PC-CP to designate a focal point to follow this process.

13. Election of the President, Vice-President and Bureau members

The Committee expressed its sincere appreciation to Mr Fritz Zeder (Austria) for his effective leadership and excellent work over the past two years. The CDPC also thanked the outgoing member of the Bureau, Ms Anita Marfurt (Switzerland) for her dedication.

The CDPC elected Mr Lorenzo Salazar (Italy) as President and Ms Garonne Bezjak (Germany) as Vice President.

The following members were also elected to the Bureau: Ms Paulina Tallroth (Finland), Ms Florence Gilbert (France) and Ms Anna Wardell (United Kingdom).

14. Information points

a. Committee on Artificial Intelligence (CAI)

The CDPC was reminded that the Framework Convention on Artificial Intelligence and Human Rights, Democracy and the Rule of Law was opened for signature in Vilnius, Lithuania, on 5 September 2024.

Mr Vadim Pak, from the CAI secretariat briefed the Plenary about the current state of play, including recent signatories to the Convention (Canada, Japan, Liechtenstein, Switzerland, Ukraine and Uruguay). In addition, Cameroon and Ghana have joined the CAI as observers. Cabo Verde, South Korea and Malaysia expressed interest in becoming observers.

Finally, the CDPC took note of the update on the ongoing work within the CAI concerning the risk and impact assessment framework (HUDERIA), on the 14th and last CAI meeting on 4 November 2025, and had an exchange with the CAI Secretariat.

b. Combatting organised crime relating to drug trafficking (Pompidou Group)

The CDPC noted that the Joint Expert Group on combating organised crime related to drug trafficking on the basis of the case-law of the European Court of Human Rights (OC DT) held its sixth meeting on 1 to 2 October 2025 and its seventh (online) meeting on 17 October 2025. The discussions focused on reviewing the draft-zero of the Policy Guidelines prepared by the Secretariat and on producing a document called “Key Priorities”. Both texts were intended for presentation to the Pompidou Group ministerial meeting of 27 to 28 November 2025 for adoption.

An exchange followed with the CDPC Vice President, Mr Lorenzo Salazar, who acts as liaison with the Pompidou Group. He informed the CDPC that the ongoing written adoption procedure had been interrupted by one member State, resulting in the postponement of the adoption of the two documents. Mr Salazar expressed confidence that the two documents may be approved early next year.

c. Terrorism

The CDPC took note of the List of Decisions of the 15th Plenary meeting of the Committee on Counter Terrorism (CDCT) held from 19 to 21 November 2025, and heard a presentation by Ms Jelena Jolic, Co-Secretary of the CDCT, regarding ongoing CDCT activities.

It was recalled that in July 2025 the Committee of Ministers adopted the Amending Protocol to the Convention on the Prevention of Terrorism (CETS No. 196).

The CDPC further acknowledged the finalisation of the Report on factors driving violent extremism leading to terrorism, the draft Recommendation on countering terrorism, violent extremism and the underlying radicalisation online, and the Guidelines on support services for victims of terrorism. Both the draft Recommendation and the Guidelines are expected to be submitted to the Committee of Ministers for adoption early next year.

Finally, the CDPC noted that forthcoming priority areas of work will include issues relating to children and youth involved in terrorism, the use of open source and e-evidence in the context of generative AI, and weapons procurement by violent extremist groups and networks.

d. Medicrime

The CDPC took note of the information provided by the Executive Secretary of the MEDICRIME Convention, Mr Oscar Alarcon, on both the Bureau meeting (21 October) and the forthcoming 10th Plenary meeting of the Committee of the Parties (9-10 December 2025).

The CDPC also noted the progress made on the Working Group on unauthorised removal, including theft, from the supply chain of medical products. Furthermore, the CDPC took note of the MEDICRIME Committee's collaborative work with other bodies and observers, including: a) The Joint Expert Group on Organised Crime and Drug Trafficking (OC-DT): This group, which is developing policy guidelines based on the case law of the European Court of Human Rights, held its 5th meeting in Brussels on 1-2 October 2025 to review them; b) The Monitoring Group of the Anti-Doping Convention; and c) Interpol.

e. Council of Europe Convention against Trafficking in Human Organs

The CDPC took note of the information provided by the Executive Secretary of the Santiago de Compostela Convention regarding both the Bureau meeting held on 24-25 September 2025 and the Plenary meeting on 16-17 October 2025 and of the topics discussed therein.

The CDPC was also informed that the Council of Europe had organised a conference on the Protection of Health on 15 October 2025, during which the Santiago de Compostela Convention and other conventions dealing with health were promoted.

f. Council of Europe Convention on Offences relating to Cultural Property

The CDPC took note of the List of Decisions of the 3rd meeting of the Aragon Group (3 July 2025) and of the oral information provided by Mr Oscar Alarcon. In particular, the CDPC was informed about the discussions held during the meeting, with special attention given to the need to reduce tolerance towards offences against cultural heritage.

The CDPC also took note of the Secretariat's participation in the UNESCO Conference on Addressing Illicit Trafficking of Cultural Property in the Digital Era (Paris, 26 June 2025), as well as of the study visit by representatives of the Egyptian Public Prosecution Office to the Council of Europe (8-9 October 2025). Both events were used as opportunities to promote the Convention.

The CDPC was reminded that responsibility for the Convention has been transferred to the it as of August 2025 and was informed about the steps to be taken to ensure a smooth handover and transition.

Finally, the CDPC took note that Ukraine had ratified the Nicosia Convention.

g. Hate Crime

The CDPC heard a presentation from the Secretary of the Committee on Anti-discrimination, Diversity and Inclusion (CDADI), Mr Wolfram Bechtel, on the report of the 11th CDADI meeting, held from 1 to 3 July 2025, and noted that during that meeting it had been decided to submit to the Committee of Ministers, for consideration with a view to adoption, the draft Recommendation on equal rights for intersex persons, together with its Explanatory Memorandum.

The CDPC further took note of the launch of an online database on hate crime resources, containing publicly available and up-to-date materials that have proven effective in practice and may assist member States in their work.

The CDPC was informed of the Conference on preventing and combating hate crime, held on 19–20 June 2025 in Strasbourg under the Maltese Presidency of the Committee of Ministers and with participation of CDPC delegates.

It also took note of the upcoming Conference on the Recommendation on combating hate crime and hate speech, to be held on 28-29 May 2026 and organised by the University of Limerick in Ireland, in partnership with the CDADI.

Finally, the CDPC noted the plans to organise the 3rd No Hate Speech Week, to be held on 17-19 June 2026 in Strasbourg, as well as the planned launch of a Mission-Driven Initiative entitled “Enhancing multi-stakeholder responses to hate speech and hate crime”, funded through the EEA (European Economic Area) and Norway Grants.

h. Child-Friendly Justice

The CDPC took note of the process regarding the draft thematic review of the Guidelines on Child-Friendly Justice, including the consultation process led by the Committee on the Rights of the Child (CDENF), in which the Committee on Legal Co-operation (CDCJ) and CDPC delegates were invited to participate, and the possible update of the CoE Committee of Ministers Guidelines on Child-friendly Justice.

During the CDENF plenary meeting (19-21 November 2025), a presentation of the thematic review was held. As many salient discussions concern criminal law, the CDPC made a call for a volunteer from among its members to closely follow this topic and report to the CDPC, with the support of the Secretariat. Due to references to children and youth (including those who are sentenced or under probation) and to restorative justice, the CDPC also invited the PC-CP to designate a focal point to follow this process.

15. Any other business

The CDPC has been tasked by the CM to prepare a report on national practices as regards investigations and cryptocurrencies within the 2026-2027 biennium. It took note that the Secretariat had started developing a working note on cryptocurrencies, which will be circulated in 2026.

The Netherlands requested further exploration of the use of explosives and dangerous fireworks, which they had raised already in the CDCT Committee, and will follow up with further information in the next CDPC Plenary meeting.

16. Dates of the next meetings

The CDPC confirmed that the next Plenary meetings will be held from 9 to 11 June 2026 and from 24 to 26 November 2026, in Strasbourg.
