#### **MEETING REPORT**

Following its decisions at the 78th Plenary meeting on 3-4 November 2020, the CDPC set up an ad hoc Working Group on the Environment and Criminal Law (CDPC-EC), consisting of experts appointed by the members of the CDPC. The Working Group was entrusted with the main task of assessing whether the drafting of a new Council of Europe Convention on the Protection of the Environment through Criminal Law to replace the existing 1998 Convention (ETS No.172), is feasible and appropriate or not, through a comprehensive Feasibility Study produced by the Working Group.

The Working Group held its third meeting via the electronic platform KUDO, on 7 October 2021. The meeting was dedicated to the examination of the Preliminary Draft of the Feasibility Study on the Protection of the Environment through Criminal Law prepared by the Scientific Expert Ms Véronique Jaworski, which was sent to all members of the Working Group prior to the meeting, following the decisions taken at the second meeting of the Working Group, held on 15 June 2021.

Mr Thomas Grégoire, elected Chair of the Working Group, opened the meeting and welcomed all participants. Mr Grégoire provided information on the Parliamentary Assembly draft Recommendation and draft Resolution titled 'Addressing issues of criminal and civil liability in the context of climate change', which were both unanimously adopted by the Parliamentary Assembly on 29 September 2021.

The Chair noted that both texts make significant reference to the work of the CDPC-EC, recommending that 'the Committee of Ministers draft, without delay, a new legal instrument to replace the Convention on the Protection of the Environment through Criminal Law (ETS No.172)', in order to have a legal instrument better adapted to the current challenges. Mr Carlo Chiaromonte, Head of the Criminal Law Division welcomed all participants on behalf of the CDPC Secretariat and informed the Working Group that hybrid meetings may be possible soon, should the sanitary situation allow it and made a more detailed presentation of the PACE work on environment.

The Chair expressed his appreciation for the comprehensive work of Ms Jaworski (the Preliminary Draft Feasibility Study) and encouraged all Delegations to express their views on the text, to move the work of the CDPC-EC forward. Ms Jaworski was invited to present the prepared Preliminary Draft Feasibility Study in which she provided a clear overview of the structure of the document, emphasising that the purpose is to list the main elements that could serve as a basis for reflection and discussion on the issue of a possible new legal instrument to be developed. The first part of the text is thus dedicated to the examination of the appropriateness of adopting a new instrument (preferably a convention) and the second part refers to the legal issues to be included in a new instrument and the different options for dealing with these.

Following Ms Jaworski's presentation, the Chair opened the floor to all Delegations to exchange views. The Working Group expressed their appreciation for the work prepared and noted several areas for consideration and further work. Specific references were made to the concept of 'International Cooperation' which is prominent throughout the text. States noted that many international legal instruments already exist in this domain and should be both referred to and utilised in the work of the CDPC-EC.

For example, the 1959 Council of Europe, European Convention on Mutual Assistance in Criminal Matters (No.030) and its additional protocols thereto (No.099 and No.182), and the 2014 CDPC text on 'Model Provisions for Council of Europe Criminal Law Conventions' (CDPC (2014) 17 Fin), which intends to set out a 'model Convention' that may be used, as guidance, by future negotiators of draft Criminal Law Conventions. The need, therefore, to further develop 'common rules for enhanced international cooperation', is not necessarily justified.

Various Delegations noted that the specific concepts, under item 2.1.3.1. 'Definitions', could, at this stage, just be listed as possible elements to be included, rather than defined. The Working Group also expressed the need for a more critical and analytical approach to the text. With specific reference to item 2.2. 'Substantive Criminal Law: Offences, Perpetrators, Penalties', some Delegations noted that specifying the relationship between administrative and criminal law is a step in the right direction, however, some concepts could be examined more closely, such as references to a 'hierarchy of enforcement authorities' or environmental damage as a result of the 'cocktail effect'. Such elements may benefit from further clarification and analysis of the different legal traditions of each State, to respect existing domestic legislation and to reconcile with the principle of legal certainty.

Furthermore, the Working Group raised the issue of the Responsibility of Legal Persons under item 2.2.2. of the Study, with regards to the question of making the criminal liability of legal persons mandatory. This aspect was considered potentially controversial given the variations in its nature across different domestic legislations. The Working Group, therefore, highlighted the need to look into the operational needs of this notion and its utility in a possible Council of Europe instrument. Regarding the scope and characterisation of such offences mentioned under item 2.2. namely on proposals pertaining to sanctions, Delegations noted that this will require specific analysis of the possible advantages and drawbacks of certain measures. The final proposal was to use the "Model provisions" document adopted by the CDPC in this regard.

Similarly, with reference to the concept of due diligence, under item 2.4. 'Prevention Measures', the Working Group expressed the importance of understanding precisely how this is regulated by looking at existing international legislation to see what operational needs would be covered by this notion.

On this basis, the Working Group agreed to adjourn the second day of the meeting (scheduled for 8 October 2021), in order to modify the existing text based on the fruitful discussions of the first day. The Working Group decided to instruct the Secretariat to distribute the updated Preliminary Draft Feasibility Study with substantial changes that will reflect the debates of this meeting to all members of the CDPC-EC Working Group as soon as possible. On receipt of this document, all Delegations will be invited to submit written proposals with regards to this text within a time frame that is sufficient for all delegations to consult their relevant national agencies and to accurately respond.

The Chair noted that all proposals will then be incorporated into the existing text and redistributed to the Working Group to form the basis of the discussions at the fourth meeting, expected to take place early 2022. The exact date, format and place of the next meeting will be communicated to all members of the Working Group in due course.
