1. Introduction

Established in 2006, the Centre of Expertise was created to deliver good local and regional governance promoting European standards and best practice. Its capacity building programmes and legal assistance activities are increasingly aimed not only at the local but also the regional and central level of public administration.

The main goal of the Centre of Expertise is to promote the 12 Principles of Good Democratic Governance through the implementation of benchmarks, evaluation instruments and innovative methodologies ("tools"), inspired by the guidelines and recommendations of the Council of Europe's Steering Committee on Democracy and Governance (CDDG). The practical and impact-oriented country-specific projects, often initiated at the request of member states, are implemented in cooperation with local, national and international stakeholders and aim at improving legislation in the area of decentralisation and public administration and at strengthening the institutional capacity of local, regional and central authorities.

The Secretariat of the Centre is part of the Good Governance Division of the Directorate General of Democracy (DG II). It consists of a small team of staff and relies on a network of qualified national and international experts, institutions as well as senior officials of the European Committee on Democracy and Governance (CDDG) to provide policy and legal advice, capacity-building, training, and expertise which, together, also contribute to the development and implementation of state-of-the art toolkits.

The Centre of Expertise is intricately linked to the Council of Europe's intergovernmental sector and has been working in close cooperation with the CDDG, for example when updating toolkits, providing policy advice or organising international conferences. It also cooperates with the Parliamentary Assembly, the Congress of Local and Regional Authorities, the Venice Commission, the Group of States against Corruption, the Council of Europe Development Bank, and other bodies of the Council of Europe

In the second half of 2016, ten years after it was established, the Centre requested an evaluation to be conducted under the aegis of Directorate of Internal Oversight. The evaluation report noted that the expertise of the Centre is highly regarded because it crystallises the experience of all member states. The evolution of the Centre's mission mirrors developments in member states and it is increasingly called upon to provide technical assistance for multi-level governance at all levels of government. The Report concluded that "the Centre has efficiently developed itself as an emerging institution, securing sufficient recognition". Following the Report's recommendation, the Centre prepared its Strategic Plan 2017-22, including the new vision statement and analysis of its strength, weakness, opportunities and threats (SWOT analysis), and an action plan for the next five years.

To reflect the changes, and on the occasion of the 70th Anniversary of the Council of Europe (CoE), it is envisaged to modify name and logo of the Centre of Expertise as follows: a dodecahedron – symbol of Good Governance and "Centre of Expertise for Good Governance" underneath:







2. Overview of Main Activities and Achievements in 2018

In 2018, the Centre of Expertise continued its efforts to promote Good Governance in Council of Europe member states. The most important projects were funded by the European Union and by a number of member states through voluntary contributions. These were implemented in Albania (funded by Switzerland), Armenia (funded by Sweden and Austria), Greece (funded by the EU), Serbia (funded by the EU), and Ukraine (funded by member states in the framework of the Council of Europe Action Plan 2018-2021). In addition, several small high-impact projects were implemented through the ordinary budget in Bosnia and Herzegovina, Croatia, Cyprus, Hungary, Italy, Lithuania, Moldova, Poland, Romania and Spain as well as in Belarus.

In 2018, the team of the Centre of Expertise was actively engaged in fund-raising to ensure follow-up to projects that ended in 2017 or 2018 (for example the Partnership for Good Governance for Eastern European countries, or the projects in Armenia, Greece and Serbia) and to respond to growing demands for advice and capacity-building projects which are highly valued by beneficiary countries. At the same time, the Centre of Expertise tries to broaden the sources of funding, for example by assisting with the preparation of project proposals for submission to the EC's Structural Reform Support Service (SRSS) for EU member states when asked to do so by the countries concerned.

In order to ensure sustainability of project results, the Centre of Expertise cooperated in project design and implementation with local actors, in the first place the governments and associations of local authorities and institutions such as Schools of Public Administration, so that the knowledge and know-how remains in the country. Furthermore, it paid particular attention to coordination with other donors, in particular the Austrian, German and Swiss development agencies, the EC and UNDP, to ensure complementarity of action.

Some of the projects of the Centre of Expertise are designed to contribute to the UN's Sustainable Development Goals, in particular Goal 11 on sustainable cities and communities and Goal 16 on peace, justice and strong institutions. Other projects in Eastern Europe contribute to the European Commission's 20 Goals for 2020 which include, among others, strengthening institutions and governance and improving the participation of civil society in decision-making.

Albania

The core element of the EUR 720.000 (24 months, August 2017 – July 2019, funded by Switzerland) project on "Strengthening Local Government Structures in Albania – Phase III" is the establishment of a public administration portal to improve communication between central and local authorities and facilitate the dissemination of good governance practices. The portal will regroup the full range of Human Resource Management (HRM) tools and procedures elaborated over the course of all phases of the project (based on the CoE's HRM Toolkit) and should be operational by early 2019.

The Leadership Academy Programme (LAP) has also been adapted to the Albanian context and was delivered in close cooperation with the Albanian School of Public Administration and the Albanian School of Political Studies. In line with the evolving mission of the Centre of Expertise to promote good governance at central and local levels and following a direct request from the Department of Public Administration, the LAP was adapted for the Top Management Corps (TMC) of the central civil service to support "The Administration We Want" policy. Six cycles of this LAP for the Corps were delivered to 120 senior civil servants in November and December. The curricula were validated in both English and Albanian by the Albanian School of Public Administration for future delivery to senior civil servants beyond the project life cycle.

Armenia

The project on "Consolidating Local Democracy in Armenia" (15 months, August 2017 – September 2018, EUR 320.000) provided legislative support and policy advice to further decentralisation and enhance civil participation in decision-making. This project also served to pilot several capacity building activities that informed the preparation of a comprehensive new three year project that is expected to be launched in December 2018 with Austrian funding. These capacity-building activities were based on the Civil Participation and Strategic Municipal Planning toolkits and on the European Charter of Local Self-Government.

The new project (3 years, 1.5 million Euro) will run until November 2021 and continue to provide legal and policy advice to central government while helping local authorities deliver better services to citizens by: developing their capacities and institutional structures; improving civil participation and the empowerment of women; promoting respect for good governance principles including through adaptation of the e-learning course on the 12 Principles of Good Democratic Governance to the Armenian context. CoE toolkits to be used in the new project include Civil Participation, Public Ethics Benchmarking (PEB), Local Finance Benchmarking (LFB), Inter-municipal cooperation (IMC), Best Practice (BPP) and the E-tool on good governance.

Bosnia and Herzegovina

The second and third stages of the Leadership Academy Programme (LAP) were organised in Sarajevo and Bijeljina respectively. Newly elected mayors and their staff from six municipalities in the Federation of Bosnia and Herzegovina and six from the Republika Srpska participated in the LAP which was organised in cooperation with the Associations of Cities and Municipalities of the Federation of Bosnia and Herzegovina and of the Republika Srpska. Participants welcomed the opportunity to strengthen relations with colleagues from the other entities and requested further support of the Centre of Expertise in developing effective civil participation and promoting inter-municipal and cross-border cooperation.

Bulgaria

Bulgaria was the first member state to commit to the Strategy of Good Governance and to award the European Label of Governance Excellence (ELoGE) in 2010. In 2018, the Bulgarian Ministry of Regional Development and partners involved, including the National Association of Municipalities, the Foundation of Democracy and the University of Sofia, renewed their support for its implementation.

In September, a national conference dedicated to ELoGE was organised to promote good practices identified among municipalities. The next, fifth cycle of ELoGE in Bulgaria will take place in 2020. Until then, the Bulgarian stakeholders will review the Benchmark in order to facilitate its reading for Bulgarian municipalities, learn from the experience of other countries implementing ELoGE and promote the 12 Principles.

A new cooperation project proposal for Bulgaria was submitted to the SRSS (Structural Reform Support Service of the European Commission) for possible funding and implementation in 2019-20. It focuses on fiscal decentralisation, public ethics and good governance.

Croatia

At the request of the Croatian Ministry of Public Administration, the Centre of Expertise, also in cooperation with the CDDG, provided policy advice on the draft legislation on civil service (performance-based salaries), and public ethics (conflict of interest and post-public service employment). The Minister attended the CDDG meeting in November where he presented Croatian public administration and decentralisation reforms.

Additional information is presented in the section on cross-border cooperation below.

Cyprus

The final report on the 2017 Training Needs Analysis (TNA) project which was carried out in 2017 in cooperation with Union of Cypriot Municipalities (UCM) and the Ministry of Interior was presented and discussed at a national Conference in March 2018. The TNA was followed by the preparation of the National Training and Capacity-Building Strategy (NTS) which was finalised and presented on 11 December 2018 at a national conference with the participation of the Ministry of Interior, Ministry of Finance, Parliament members, local authorities and their associations.

Both the TNA and NTS reports contributed greatly to the national discussions and preparation of the local government reform in Cyprus, which seeks a more decentralised approach and the creation of bigger, more viable municipalities. In fact, the NTS was revised to support this reform through a comprehensive policy on capacity-building and training.

As a result of these projects, the Centre of Expertise was asked to assist the Ministry of Interior and the Union of Cypriot Municipalities in preparing a project proposal to help implement the local government reforms in Cyprus. This proposal was submitted for funding to the SRSS.

France

The Centre of Expertise has developed close ties with the French National Institute of Local Government Studies (INET), based in Strasbourg. The Institute trains senior officials of French local authorities and is part of the French National Centre of Local Public Service (CNFPT). On average four training sessions are co-organised every year at the Council of Europe introducing INET students to the main reform trends in Europe, the Centre's tools and European approaches to performance management.

In 2018, the CNFPT and INET formally informed the Centre of Expertise that they were preparing an ELoGE accreditation request and asked for assistance in providing training on the 12 Principles of Good Governance. Two workshops were held in Strasbourg: one to train the experts and trainers of INET and ALDA (Association of Local Democracy Agencies) and a second to train and prepare for the implementation of ELoGE with representatives of the French pilot municipalities.

Cooperation on the online barometer of local government reforms (https://barometre-reformes.eu/) developed by INET is being discussed.

The Centre of Expertise also cooperates closely with the French National School of Administration (ENA) to help implement capacity-building activities in several European countries.

Greece

The Council of Europe - EU Joint Project "Technical Assistance on Institutional Enhancement for Local Governance in Greece" (21 months, August 2016 - May 2018, EUR 800.000) provided policy advice on governance of metropolitan areas and the status of the capital city; competences of the island municipalities; management of local budgets and improvement of the fiscal supervision system. Capacity building activities focussed on Local Finance Benchmarking (LFB), Public Ethics Benchmarking (PEB), Strategic Municipal Planning (SMP), Inter-municipal Cooperation (IMC, focusing on islands) and ELoGE. Over 70% of all Greek municipalities from all regions were involved in the project activities which were marked by a high level of citizen involvement and participation in the project, especially in the ELoGE surveys.

The project resulted in a solid base of data and evidence with a view to informing the revision of the Kallikratis Reform. The new law on local government, "Cleisthenes I", of July 2018 contains provisions in line with several Council of Europe recommendations, such as the categorisation of municipalities on the basis of new criteria, the streamlining of the distribution of financial resources to municipalities, the mapping and re-definition of local government competences, the amendment of the supervision system, the enhancement of civil participation and public consultation at local level and the strengthening of strategic planning and inter-municipal cooperation.

The project also demonstrated the need to support the revision of the legal framework with more effective and systematic participatory initiatives and capacity-building actions. It contributed to building trust, improving the performance of local public administrations and ensuring ownership of reforms.

Since May, in cooperation with the Greek authorities and the SRSS, the Centre of Expertise has been developing the next project (18 months, EUR 800.000) on inter-municipal cooperation and civil protection services. It is scheduled to begin in January 2019.

Hungary

The Best Practice Programme (BPP) has been implemented continuously since 2008 by the Hungarian National Association of Local Authorities in cooperation with the Centre of Expertise. The 2018 Steering Committee of the programme consists of representatives from the Ministry of Interior, Ministry of Human Resources, Hungarian Village Association, Hungarian National Association of Municipalities and the Hungarian National Association of Civil Guards.

The 2018 BPP was implemented in two areas: the best practice community programmes and activities of Roma and non-Roma in the municipality; and cooperation of local civil guards and local government. Thirty-three applications were submitted. The award ceremony was held on 14 November at the Ministry of Interior in Budapest. Lithuania

Following successful implementation of a Leadership Academy Programme (LAP) cycle in Lithuania in 2017, the Centre of Expertise provided support to the Ministry of Interior and the Association of Local Authorities in developing a project proposal to promote civil participation, PEB and ELoGE. The proposal was submitted to the SRSS for funding.

Moldova

The Institute for Development and Social Initiatives (IDIS) "Viitorul" implemented another round of the Best Practice Programme (BPP) to identify, promote and disseminate good practices among local public authorities The 2018 BPP areas were citizen participation for good governance, local development through community involvement, cultural-historical heritage and quality public services. The award ceremony was held on 18 December 2018.

Poland

The Centre of Expertise supported the Polish Foundation for Local Democracy in the implementation of the first round of ELoGE in Poland. Seven communities and two counties were awarded the Label at a high-level award ceremony in Warsaw on 8 October, coorganised with the major Polish newspaper, Rzeczpospolita. The feedback from the participating mayors, chief executives and the Association of local authorities was very positive particularly as regards the evaluation process, comparing self-evaluations with public opinion, and as to how the benchmark provides common reference points for the improvement of governance at local level. The Foundation is planning to conduct the next round of ELoGE in 2020.

Romania

The Centre of Expertise cooperated with the Romanian Institute of National Administration and delivered three stages of the Leadership Academy Programme (LAP) for approximately twenty mayors. Local trainers were trained and the LAP materials were adapted to the Romanian context. In the course of this training, new LAP modules were developed on, for example, civil participation. The feedback from the Institute's management, trainers and participants was very positive; further cooperation is being discussed. The main challenges identified in the training were mainly related to human resources issues such as the lack/abundance of personnel (both linked to national legal framework limitations) and lack of 'up to date' competencies among staff. Citizens'/community engagement in the decision-making process was another challenge. The participants were also very interested in implementing the ELoGE. Further cooperation is being discussed.

Serbia

After achieving significant results with the implementation of the Council of Europe – EU Joint Programme "Human Resource Management in Local Self-governments" implemented in 2016-2017, the Centre of Expertise continued to support the establishment of a coordinated, continuous and sustainable system for human resource management and professional development of local government staff, in cooperation with the Standing Conference of Towns and Municipalities of Serbia (SCTM). It provided advice to the Ministry for Public Administration and Local Self-governments and the National Academy for Public Administration in relation to professional development and human resource management in local self-government. This remains on the priority list of the Serbian government in its Action plan 2018-2021.

In 2018, the second phase of the "Human Resource Management in Local Self-governments" Programme was prepared (36 months, December 2018 – November 2021, 4 million Euro) in close consultation with the beneficiaries, partners and relevant stakeholders to meet the needs of the Serbian government, local self-governments and the expectations of the EU. The staff also maintained contacts with the GIZ and other donors to ensure project coordination and prevent overlapping of the activities.

Slovakia

At the request of the Ministry of Interior, the Centre of Expertise assisted with the preparation of a comprehensive project proposal to improve the local government system in the country and to provide policy advice and capacity-building based on European standards and best practice. The proposal was submitted to the SRSS for funding.

Slovenia

Following the 2017 Peer Review on the Strategy on Development of Local Self-Government, the Centre of Expertise worked with the Ministry of Public Administration and three associations of local authorities on the preparation of a project proposal to provide policy advice and capacity-building in implementing the strategy and strengthening local governance. The proposal was submitted by the Slovenian Government to the SRSS for funding.

Spain

The Association of Basque Local Authorities (EUDEL) ran two rounds of ELoGE with support from the Centre of Expertise. Two ceremonies were held and about ten labels (tbc) were awarded in March and December 2018. The ELoGE process was very highly rated by the Basque mayors and it was widely publicised in local and national media, including *El Pais* newspaper. The Centre of Expertise was also approached by the Federation of the Catalan Municipalities and the Association of Local Authorities of Spain (FEMP) with a request to help implement ELoGE in 2019.

Turkey

The Argüden Governance Academy developed a customised and operational local governance model for Turkish municipalities based on the 12 Principles of Good Governance, taking into account the Turkish administrative and legal context. The Academy also completed research for the district municipalities of Istanbul and prepared a publication on the Governance Scorecard of Istanbul District Municipalities. In April, the Centre of Expertise participated in the International Conference on "Good Governance at Local Level" in Istanbul, where the results were shared with the public. Further cooperation activities in Turkey are being discussed.

Ukraine

The new EUR 1.8 million, 28-months project began in March as a follow-up to the previous project on "Decentralisation and Territorial Consolidation in Ukraine". It provides further support to decentralisation, territorial administration reform, amalgamation of small local communities, and the reform of the national training system for local public administration. It also offers specific support to decentralisation and leadership development in the Donetsk and Luhansk regions.

Legal advice and expertise to support the development of policy and legislation in line with European standards and good practice was provided through: overviews and opinions on the organisation and statutes of parliamentary assemblies' administrations; the appointment of deputy city mayors following a competitive procedure; legal expertise of draft laws on principles of the administrative territorial structure of Ukraine, the procedure for the formation and removal, establishment and change of Rayon boundaries, and amendments to the law on local self-government bodies. Roundtables with senior government officials, members of parliament, associations of local and regional authorities, local authorities and Council of Europe experts were organised in Kyiv and Strasbourg to support the preparation of the new law on legal supervision of local authorities.

Close collaboration with Mr Georg Milbradt, Special Envoy of Germany for the Ukrainian reform agenda and the GIZ ensured coordination action, additional political support and funding for the project.

The project also supported the implementation of the Action Plan "On Reforming Professional Training System of Civil Servants, Heads of Local State Administration and their First Deputies and Deputies, Local Self-Government Officials and Local Councillors". With support from the Council of Europe experts, the National Agency of Ukraine on Civil Service is conducting a comprehensive capacity and training needs assessment for local civil servants. Training sessions were delivered in the framework of the LAP, supported jointly by the project and the DOBRE programme (US Government funded) in Ukraine.

A cooperation agreement was signed between the project, the GIZ implemented "U-LEAD with Europe: Ukraine – Local Empowerment, Accountability and Development Programme" and the National Agency for Civil Service in Ukraine to jointly support human resource management in all amalgamated *communities*.

Belarus

Over the past 3 years, the Centre of Expertise worked closely with the Academy of Public Administration, under the aegis of the President. The Academy adapted and piloted selected programmes and tools focusing on public administration, human resources and leadership development on the basis of the CoE toolkits. In June 2018, the Academy, with support from the Centre, delivered an assessment of current legislation with focus on Human Resource Management (HRM). This demonstrated increased support for and awareness of the need for reforms, including in the field of HRM and citizen participation.

Currently, the Centre provides support for some legislative initiatives that have been undertaken by Belarus, e.g. amendments to the Law on Civil Service; and to the adaptation of HRM tools and their piloting with the Minsk Region (Executive Committee). A catalogue of functions (HR profiles) for the HR department of the region is being developed in co-operation with the CoE experts. A survey on HRM was carried out at regional level.

Agreed with the Belarus authorities, and subject to available funding, a new (follow-up) project can be implemented in 2019-21, within the new CoE Action Plan for Belarus. It will include assistance to the government to complement and improve the legal framework on civil servants, Training and Capacity Needs analysis, development of a National Training and Capacity-Building Strategy for local public servants, implementation of the HRM toolkit and Leadership Academy Programme and support to the Academy of Public Administration.

Cross-border Cooperation

Special attention was paid by the Centre of Expertise to promoting Council of Europe standards and the Centre's toolkits on cross-border cooperation.

In cooperation with the CDDG and the City of Dubrovnik, the Centre of Expertise organised an international conference on cross-border cooperation (CBC) under the Croatian Chairmanship of the Committee of Ministers of the Council of Europe in Dubrovnik in May 2018. The aim of the conference was to promote the Council of Europe standards and tools in the field of CBC, such as the Madrid Convention and its three additional protocols, as well as the CBC capacity-building tools of the Centre of Expertise. It was a successful event with approximately 60 participants from over a dozen countries. The event generated a lot of interest and follow up. Two stages of the Leadership Academy Programme (LAP) for CBC for were organised local authorities of bordering municipalities from Croatia, Serbia and Hungary. These were held in Sombor (Serbia) and Valpovo (Croatia). The training was organised in cooperation with Central European Service for Cross-Border Initiatives (CESCI) and received very positive feedback from the participants who started developing concrete CBC proposals as the result of the programme.

At the invitation of the Ministry of Economy and Trade and CESCI, the Centre of Expertise also participated in the conference of a Slovak-Hungarian European Grouping of Territorial

Cooperation (EGTC) in order to present and discuss implementation of the LAP for CBC for local authorities from Hungary and the Slovak Republic .

EDEN – an electronic database and capacity-building tool on cross-border cooperation – was updated to include over 600 examples of CBC by the end of 2018. The EDEN platform is also being linked to the new SECCO2 project platform (youth for cross-border partnership and cohesion of the EU Strategies for the Danube Region and the Adriatic-Ionian Region) established by CESCI and the Institute of International Sociology in Gorizia (ISIG) thus multiplying access to EDEN. It is currently the largest and the most comprehensive CBC tool in Europe. The Centre of Expertise is engaged in discussions with the European Commission (DG REGIO), the Mission Opérationnelle Transfrontalière (MOT), the Association of European Border Regions (AEBR), CESCI, ISIG and other stakeholders in order to prepare a proposal on the integration of the existing databases and tools into one pan-European database that would provide solutions for obstacles and advance CBC in Europe.

3. Capacity-Building Tools

The development and promotion of new innovative capacity-building tools is among the priorities of the Centre of Expertise. The tools are regularly revised and updated. All relevant institutions are encouraged to use those tools provided that the copyright is respected, qualified experts are used and the Centre of Expertise is informed.

The revision and development of the Centre of Expertise's toolkits continued in 2018 with updates of the training modules for the Leadership Academy and the Leadership Academy for Cross Border Cooperation, including specific training curricula for central officials.

The on-line training course on the 12 Principles of Good Governance was finalised and published on the Centre's website. Translation and adaptation of the e-learning course to the local context are key components of the proposed new projects in Armenia and Serbia.

The EDEN database has been developed further and opportunities to connect it to related initiatives (please see above under cross-border cooperation) are being examined.

European Union and its institutions

The European Commission is an important partner of the Council of Europe. The Centre of Expertise liaises with the EU Delegations in the countries where it implements cooperation projects. The European Commission currently co-finances some of the biggest projects implemented by the Centre of Expertise, notably in Greece and Serbia where the second phase of the respective projects will get underway in January 2019. In 2018, at the request of the CoE member states, and in cooperation and coordination with the SRSS (Structural Reform Support Service of the European Commission), the Centre helped prepare large project proposals to implement relevant reforms and build capacity in the public service in a number of countries. Decisions on financing by the SRSS are pending.

Another important EU partner in 2018 was the Directorate General for Regional and Urban Policy (DG REGIO), in particular its Interreg, Cross-border Cooperation, Internal Borders Unit. The Centre of Expertise participated in several events and consultations organised on the subject of the new European Cross-Border Mechanism (ECBM) and was invited to present and promote its capacity-building tools in the area of CBC. Cross-border cooperation is of growing importance to the Commission and its new policy for boosting growth in border regions.

OECD

The Centre has been cooperating with the Organisation for Economic Cooperation and Development for a number of years. It participates in the Steering Committee of the Observatory on Subnational Government Finance and Investment, where it contributes on the basis of the standards, tools and expertise on local finance and capacity-building for public authorities. The 2018 meeting was held in December in Paris.

Other cooperation and coordination is under way with OECD SIGMA, the Public Governance Directorate and the Centre for Entrepreneurship, SMEs and Local Development.

OSCE

The Council of Europe and OSCE have a framework agreement of cooperation on local and regional democracy. Contacts are maintained with the Secretariat in Vienna, the Office for Democratic Institutions and Human Rights in Warsaw, as well as field missions.

UN and UNDP

The Council of Europe and UNDP have a Memorandum of Understanding on cooperation in the field of local democracy. UNDP country missions are regularly involved in the implementation of the cooperation projects of the Centre of Expertise, in particular in Albania, Armenia and Ukraine.

The Centre of Expertise contributes to the global UN discussion and promotion of Good Governance, in particular by presenting the 12 European Principles of Good Governance at the expert and plenary meetings of ECOSOC, UN DESA, and UN Habitat. The Centre of Expertise also helped promote and implement the UN Sustainable Development Goals (SDG) and the 2030 Agenda for Sustainable Development through its cooperation with UCLG – United Cities and Local Governments, UNDP, and UN-Habitat. The 12 European Principles were included in the 2018 Report on the Sustainable Cities Dialogue: Urban Governance at the Core of the

Implementation of SDG 11. In fact, the Council of Europe standards and tools in the area of local democracy and governance are among the most advanced in the world and are often used as a model by non-European countries and organisations.

United Cities and Local Governments (UCLG)

The Centre of Expertise cooperates with the UCLG in the promotion of Sustainable Development Goals and Good Governance (please see UN above).

Council of European Municipalities and Regions (CEMR)

The CEMR (which is part of UCLG) has been a long-standing partner and provides a good platform for sharing experience and expertise as well as for promoting the capacity-building tools of the Centre of Expertise. In June, the Head of the Centre of Expertise was a keynote speaker in the panel on Good Governance at the CEMR Conference in Bilbao - https://www.cemrbilbao2018.eu/index.php/en/.

Association of Local Chief Executives (U.Di.T.E.)

U.Di.T.E. is a federation of professional associations which today represents local government in 14 European countries: Belgium, Cyprus, the Czech Republic, France, Hungary, Ireland, Italy, Latvia, Luxembourg, Malta, the Netherlands, Portugal, Spain and the United Kingdom. The Centre of Expertise provided support for the implementation of a pilot project of ELoGE in 2017. In 2018, U.Di.T.E. continued promoting the 12 Principles and the benchmark among its members in coordination with the Centre of Expertise.

European Association for Local Democracy (ALDA)

ALDA is an international non-governmental organisation dedicated to the promotion of good governance and citizen participation at the local level. ALDA focuses in particular on activities that facilitate cooperation between local authorities and civil society. It is the umbrella organisation of the Local Democracy Agencies which are self-sustainable, locally registered non-governmental organisations that promote good governance and local self-government. The Head of the Centre of Expertise represents the Secretary General of the Council of Europe in the Governing Board of ALDA.

In 2018, ALDA submitted a request for the accreditation of ELoGE. The Centre organised a training workshop on the ELoGE for ALDA staff and memberswith a view to promoting the 12 Principles through the LDAs.

CESCI - Central European Service for Cross-Border Initiatives

CESCI promotes cross-border cooperation through applied research, strategic planning, development activities in border regions and regial networking between the local, national and European levels The Centre of Expertise works with CESCI on capacity-building to strengthen CBC in Central and Eastern Europe and in the Balkans (please see also the section on cross border cooperation above).

Regional School of Public Administration - ReSPA

ReSPA is an international organisation entrusted with the mission of boosting regional cooperation in the field of public administration in the Western Balkans. A representative of the Centre of Expertise is member of the RESPA Advisory Board. RESPA expressed an interest in cooperating with the Centre of Expertise in the piloting of a regional Leadership Academy Programme for public authorities at central level. The project proposal was prepared and funding is being sought.

5. Prospects for 2019

Going forward, the Centre of Expertise will continue to mobilise and involve stakeholders from all levels of governance and its broad network of national and international partners in programme design and implementation. This will help improve the impact of its programmes, reinforce commitment to the 12 Principles of Good Democratic Governance across Europe, and help adapt tools to the domestic contexts and emerging needs.

As outlined above, several new large, externally-funded projects are expected to get under way in December 2018 – January 2019 and several more are expected to begin later in the year in function of the availability of financial resources. Funding secured so far will allow planning for the 2019 externally-funded projects in Albania, Armenia, Greece, Serbia and Ukraine. At the same time, the constraints on the ordinary budget and staff represent a major challenge in terms of meeting the growing demand for assistance and cooperation in 2019.

The ordinary budget of the Centre of Expertise will be dedicated to providing continued support of member states that submit requests for policy advice and capacity-building in the area of good governance. Policy advice and a peer review on territorial amalgamation will be organised at the request of the government of Cyprus. The implementation of various toolkits is foreseen in Georgia, Italy, Poland, Romania and Spain. The new e-learning platform on the 12 Principles of Good Democratic Governance will be implemented under the new projects in Armenia and Serbia. The Centre of Expertise plans to continue supporting BPP implementation in Bulgaria, Hungary, Moldova and Romania.

The importance of CBC seems to be growing in Europe, especially in connection with the new EC Communication and policy of boosting growth and cohesion in EU border regions. In this regard, the Centre of Expertise has seen an increase in requests for assistance with capacity-building and especially for the organisation of the Leadership Academy Programme for CBC for the external EU border regions. LAP for CBC will be incorporated into the IPA (Instrument for Pre-Accession Assistance) CBC project proposals under the trilateral (CRO-BiH-MNE) and bilateral (BiH-MNE) programmes. Also, a new benchmark for CBC could be developed as an improvement tool for local and national authorities and practical CBC capacity-building activities are under consideration with CESCI in Central and Eastern Europe and in the Balkans.

In 2019, the Centre of Expertise will revise the Public Ethics Benchmark (PEB) in line with the new Public Ethics Guide being prepared by the CDDG. Transparency International Estonia has expressed an interest in running the second round of the PEB in Estonia.

The Centre of Expertise will continue cooperation with its international partners, especially in the areas of good governance, cross-border cooperation, public ethics and local finance. It will continue supporting the UN 2030 Agenda and is planning to participate in the 68th session of the UN Economic Commission for Europe in Geneva in April 2019 which will be devoted to "Smart Sustainable Drivers for the 2030 Agenda for Sustainable Development".

Such a broad range of projects and activities across a diverse geographic and political landscape require a clear strategic vision and inclusive planning process. The Strategic Plan 2017-2022 of the Centre of Expertise addresses these needs. Pursuing a more impact-oriented approach to the above-mentioned activities, the Centre of Expertise can work towards successful implementation of its Strategic Plan, the priorities of which include – as indicated – promoting Good Governance, piloting of new tools on participation, cross-border cooperation, and public ethics, as well as developing regional projects among its priorities.

The Centre will also attempt to free up more capacity at senior and middle management level to prioritise and optimise the use of resources, analyse results and impact achieved, retain lessons learned, and secure more continuous donor support. Programme staff will be encouraged to perform more autonomously. Finally, as a result of the multiplication of demands and programmes under strict budgetary constraints, the Centre of Expertise will also need to focus more on fund-raising.
