**Abridged report**

**A) FOREWORD**

The European Commission for the Efficiency of Justice (CEPEJ) of the Council of Europe held its 37th plenary meeting in Strasbourg and online on 8 and 9 December 2021. The meeting was chaired by Mr Ramin GARAGURBANLI (Azerbaijan), President of the CEPEJ.

The Director of Human Rights, Mr Christophe POIREL and the Head of the Department for the Implementation of Human Rights, Justice and Legal Co-operation Standards, Mr Mikhail LOBOV, recalled the challenges and principal work to be examined during this meeting.

Mr Christophe POIREL informed the CEPEJ that Mr Mikhail LOBOV will leave the Department to take up the functions of Judge at the European Court of Human Rights on behalf of the Russian Federation and thanked him for his contribution which had enabled the CEPEJ to better coordinate intergovernmental and co-operation activities.

The agenda and the list of participants appear as appendices.

**B) LIST OF ITEMS DISCUSSED AND DECISIONS TAKEN BY THE CEPEJ**

The CEPEJ:

- **thanked** all its members, Working Groups members, national correspondents, pilot courts, European e-Justice Networks members and experts for their constant involvement in the various activities of the CEPEJ, despite the constraints of online meetings, in particular having thus enabled the CEPEJ to accomplish its tasks almost without delay despite the COVID-19 health crisis;

**1. Quality of justice**

- **adopted** the "Revised roadmap for ensuring an appropriate follow-up of the CEPEJ Ethical Charter on the use of artificial intelligence in judicial systems and their environment"<sup>1</sup>, **decided** to submit it to the Committee of Ministers to take note of it and **thanked** the Working group on quality of justice (CEPEJ-GT-QUAL) for having taken into consideration in this document its concern on the relevance and the technical expertise of the CEPEJ as regards the setting up of a certification mechanism for artificial intelligence tools and services in the justice field;

- **noted** that some delegations question the feasibility of implementing this roadmap without an additional budget;
- **took note** of the ongoing work within the CEPEJ-GT-QUAL, in particular on gender equality in the recruitment and promotion process of judges;

## 2. Evaluation of judicial systems

- **took note** of the work in progress within the Working Group on the evaluation of judicial systems (CEPEJ-GT-EVAL) and of the information concerning the preparation of the next CEPEJ Evaluation Report "European judicial systems" (Edition 2022, Data 2020);
- **took note** of the evolutions proposed, in order to continue to improve the content of the Report and in particular of the introduction in part 2 (country sheets) of analyses of the situation of the countries, as presented in the prototype of country sheet<sup>2</sup>;
- **entrusted** the CEPEJ-GT-EVAL to prepare a draft Report for the 2022 evaluation cycle (2020 data) and to submit it to the 38th plenary meeting, so that it can be officially published in Autumn 2022;
- **thanked** the national correspondents for their involvement in the collection of data and **encouraged** them to respect the deadlines of the ongoing quality control in order to allow the stabilisation of the data in time and the realisation of the analyses (part 1 and 2 of the report) according to the presented calendar<sup>3</sup>;
- **took note** that the contributions of the professional observers to the CEPEJ-GT-EVAL (International Union of Judicial Officers<sup>4</sup>, European Expertise and Expert Institute<sup>5</sup>, Council of the Notariats of the European Union<sup>6</sup>) in the form of specific studies based on the 2018 CEPEJ data will be published on the CEPEJ-STAT webpage;
- **welcomed** the continued cooperation with the European Commission, on the basis of the CEPEJ's own evaluation methodology, concerning: (i) the annual study on the functioning of the judicial systems of the member States of the European Union; (ii) the annual evaluation of the functioning of the judicial systems in the beneficiaries of the Western Balkans (Albania, Bosnia-Herzegovina, Kosovo\*, Northern Macedonia, Montenegro and Serbia); (iii) the annual evaluation of the functioning of the judicial systems in the "Eastern Partnership" countries (Armenia, Azerbaijan, Georgia, Republic of Moldova, Ukraine), and **entrusted** the CEPEJ-GT-EVAL with the task of continuing this cooperation which reinforces the pre-eminent role of the CEPEJ in the field of evaluation of justice, as well as the synergies between the European Union and the Council of Europe in this field;

## 3. Cyberjustice and artificial intelligence

- **adopted** the "Guidelines on electronic court filing (e-filing) and the digitalisation of courts"<sup>7</sup>, as amended in the light of the discussions held during the meeting and **decided** to submit it to the Committee of Ministers to take note of it;
- **took note** of the ongoing work in progress within the Working Group on Cyberjustice and Artificial Intelligence (CEPEJ-GT-CYBERJUST);
- **took note** of the launch of the European E-justice Network on 16 November 2021 and of the ongoing work for the creation of an online Resource Centre on Artificial Intelligence and Cyberjustice;
- **took note** of the finalisation of the "Complement to the CEPEJ Guidelines on Videoconferencing in judicial proceedings: selection of good practices"<sup>8</sup>;

- **thanked** the Italian authorities for their invitation to organise a joint meeting of CEPEJ-GT-CYBERJUST and CEPEJ-GT-QUAL on 24 and 25 January 2022 in Pisa in the framework of the Italian Presidency of the Committee of the Ministers;

#### 4. Judicial time management

- **adopted** the “Revised SATURN Guidelines for judicial time management” and **decided** to submit it to the Committee of Ministers to take note of it;
- **took note** of the ongoing work within SATURN Working Group on judicial time management (CEPEJ-SATURN) concerning in particular a possible tool to preventing or reducing delays in civil proceedings;
- **took note** of the organisation of the meeting of the pilot courts Network during which the “Report on judicial time management in times of health crisis” will be presented;

#### 5. Crystal Scales of Justice Prize

- **thanked** the Supreme Court of Slovenia for inviting the CEPEJ to the Award Ceremony of the Crystal Scales of Justice Prize in Ljubljana on 1st October 2021, and especially Mr Jaša VRABEC, Head of the Office for the Development of Judicial Administration of the Supreme Court of Slovenia and President of the CEPEJ-GT-EVAL;
- **thanked** the President of the jury and its members for their valuable commitment and the added value of their analysis;
- **welcomed** the quality of the initiatives received by the Secretariat and encouraged the member States to promote them;
- **congratulated** the winner of the 2021 edition of the Crystal Scales of Justice Prize: "Simplified filing of complaints in hospital for victims of domestic violence", French Ministry of Justice; as well as the two institutions which received a special mention: “virtual quiz “Coubattle” and specific learning websites for schools”, the Danish Courts Administration, and "Establishment, development and strengthening of the action of the Centre of justice of the Odessa region of Ukraine", Kyiv district court, Odessa, Ukraine;
- **informed** that 8 applications were received for the Junior Edition of the Crystal Scales of Justice Prize;

#### 6. HELP<sup>9</sup> Training Program concerning CEPEJ

- **took note** of the preparation, via the HELP platform, of an online training on the theme "The Quality of justice and the work of the CEPEJ" which will include various modules in the fields of the quality of justice, evaluation of the judicial systems, cyberjustice and artificial intelligence and judicial time management;

#### 7. CEPEJ 2022-2023 Activity Programme

- **adopted** the CEPEJ 2022-2023 Activity Programme<sup>10</sup> as amended in the light of the discussions held during the meeting and **decided** to submit it to the Committee of Ministers to take note of it;
- **entrusted** its Bureau to appoint its working groups members by taking into account the proposals presented by the members of the CEPEJ;

#### 8. CEPEJ 2022-2025 Action Plan on "Digitilisation for a better justice"

- **adopted** the CEPEJ 2022-2025 Action Plan on "Digitisation for a better justice"<sup>11</sup> as amended in the light of the discussions held during the meeting and **decided** to submit it to the Committee of Ministers to take note of it;

- **congratulated** the progress and adaptations that were made during the COVID-19 health crisis;

#### 10. European Day of Justice

- **thanked** the judicial institutions of the 19 member States that have organised 36 specific events, mostly online, on the occasion of the European Day of Justice on 25 October 2021, despite the restrictions on access to the courts due to the health crisis;
- **welcomed** the fruitful cooperation with the European Union in the organisation of this day, including the support for the creation of the posters, customisable in 23 languages that have been made available on the CEPEJ website;
- **informed** its members that the report listing the events organised on this occasion is available on the CEPEJ website<sup>12</sup>;

#### 11. Observers to the CEPEJ

- due to lack of time caused by the format of the meeting, **invited** the observers to send to the Secretariat relevant information on their current activities and recent developments which could be of interest to the CEPEJ so that they appear on the CEPEJ website, **and recalled** the importance of their involvement in the implementation of the CEPEJ programme of activities;

#### 12. Other items

- **recalled** that the CEPEJ will celebrate its 20th anniversary in 2022;
- **invited** the members to think of specific events in which the celebration of this anniversary could be included;
- **took note** that the 38th plenary meeting of the CEPEJ should take place on 27 and 28 June 2022 in Malta, and that the dates of all other CEPEJ meetings will appear on the CEPEJ website;

#### 13. Recent developments in the field of justice in the member and observer States

- **took note** of the information from the delegations concerning the certain significant developments in their countries since June 2021;
- **took note** of the invitation by the member of CEPEJ on behalf of Turkey to hold a meeting in his country, in February 2022, on tools of CEPEJ developed for supporting member states in digitalisation of justice.
