A. FOREWORD

The European Commission for the Efficiency of Justice (CEPEJ) of the Council of Europe held its 39th plenary meeting in Strasbourg (France) on 6 and 7 December 2022. The meeting was chaired by Ramin GARAGURBANLI (Azerbaijan), President of the CEPEJ.

The plenary meeting was opened by Frédéric DOLT, Head of the Department “Implementation of human rights standards, justice and legal co-operation,” who recalled the main work to be examined during this meeting.

The agenda and the list of participants are appended.

B. LIST OF ITEMS DISCUSSED AND DECISIONS TAKEN BY THE CEPEJ

The CEPEJ:

1. Recent developments in the field of justice in the Member and Observer States

- **took note** of the information provided by delegations of Austria, Croatia, Greece, Ireland, Israel, Latvia, Luxembourg, North Macedonia, Malta, Türkiye, and Ukraine on a number of significant developments in their countries since June 2022.

2. Artificial intelligence

- **took note** of the progress in the implementation of the “Revised Roadmap for ensuring an appropriate follow-up of the CEPEJ Ethical Charter on the use of artificial intelligence in judicial systems and their environment”¹ and, in particular, of the first assignments of the Advisory Bureau on Artificial Intelligence (AIAB), of its composition, and of the launch of the Resource Centre on Cyberjustice and Artificial Intelligence.

3. Quality of justice

- **adopted** the "Guidelines on gender diversity in the recruitment and promotion of judges"² and the Guide "Promoting mediation to resolve administrative disputes in Council of Europe member states"³;
- **took note** of the other work in progress within the CEPEJ-GT-QUAL, in particular on access to justice for people with disabilities and the evaluation of judges.

4. Cyberjustice

- **took note** of the ongoing work in the CEPEJ-GT-CYBERJUST on the revision of the ICT index, developed in the framework of the evaluation process of judicial systems and implemented under the authority of the Working Group on Evaluation (CEPEJ-GT-EVAL), judicial electronic auctions, public case law databases, and online alternative dispute resolution;
- **took note** of the activities of the European Cyberjustice Network, **invited** the Member States to make the best use of it, and **encouraged** those who have not yet designated members of the network to do so before the 3rd annual meeting to be held on 23 November 2023.

5. Judicial time management

- **adopted** the "Concept note on the preparation of a backlog reduction tool"⁴, **welcomed** the preparation of this future tool which would enable to respond to the requests of many States, particularly through bilateral cooperation, **and decided** to set up an *ad hoc* working group, made up in particular of members of each CEPEJ working group, to prepare it for the next plenary meeting in June 2023;
- **decided** to postpone the adoption of the "draft Revised Time Management Checklist"⁵ and its Explanatory Note⁶ until the next plenary meeting of the CEPEJ in order to take comments received during the meeting into account;
- **took note** of the other ongoing work in the CEPEJ-SATURN, in particular on the possible update of the Recommendation No.R(86)12 of the Committee of Ministers on measures to prevent and reduce excessive workload in the courts, and **invited** the other CEPEJ working groups to contribute to the draft CEPEJ opinion currently under preparation;
- **took note** of the activities of the CEPEJ Network of the pilot courts and of its forthcoming meeting to be held on 30 March 2023 in Lublin, Poland.

6. Evaluation of judicial systems

- **welcomed** the presentation of the CEPEJ Evaluation report on "European judicial systems", 2022 Evaluation cycle (2020 data) composed of three parts (Tables, graphs and analyses – Country profiles – CEPEJ-STAT Database) and **noted with satisfaction** the excellent reception of the report by the Committee of Ministers as well as during the press conference, and across European media;
- **took note** that specific studies based on the CEPEJ 2020 data will be prepared by the justice professionals enjoying observer status with the CEPEJ (Council of the Notaries of the European Union, International Union of Judicial Officers, European Expertise & Expert Institute) and submitted to the CEPEJ-GT-EVAL before their publication on the CEPEJ-STAT page;

- **decided** to launch the next evaluation process on the basis of data of the year 2022, with a view to publishing the results in 2024, **adopted** the revised Evaluation Scheme⁷ for this purpose, subject to any additional amendments sent by members of the CEPEJ by mid-January and that may be proposed by the CEPEJ-GT-EVAL during its meeting in February 2023, **instructed the CEPEJ-GT-EVAL** to adapt the explanatory note accordingly, and **agreed** that the electronic scheme should be opened for reply by national correspondents from March 2023 until 1 October 2023;
- **encouraged** delegations to contact the Secretariat with a view to organising peer reviews to support the collection and quality control of data for the next cycle;
- **welcomed** the continued cooperation with the European Commission, on the basis of the CEPEJ's own evaluation methodology, on: (i) an annual study on the functioning of the judicial systems in the EU member states; (ii) the annual evaluation of the functioning of the judicial systems in the beneficiaries of the Western Balkans (Albania, Bosnia and Herzegovina, Kosovo*, Northern Macedonia, Montenegro and Serbia); (iii) the annual evaluation of the functioning of judicial systems in the "Eastern Partnership" countries (Armenia, Azerbaijan, Georgia, Republic of Moldova, Ukraine), and **entrusted** the CEPEJ-GT-EVAL with the task of continuing this co-operation, which reinforces the preeminent role of the CEPEJ in the field of evaluation of justice, as well as the synergies between the European Union and the Council of Europe in this field.

7. CEPEJ co-operation programmes

- **took note** of the ongoing activities, achievements, and next steps of the cooperation programs presented in the synthesis document⁸ concerning Albania, Azerbaijan, Bulgaria, Georgia, Kosovo*, Latvia, Morocco, Republic of Moldova, Tunisia and the South Programmes IV and V, as well as of the recent changes in the CEPEJ cooperation team;
- **took note** of the results of the *ad hoc* cooperation organised with the Supreme Court of Ukraine to help the Ukrainian judicial system to implement remote judicial hearings in accordance with European standards, through a legislative expertise of a draft law, and the preparation of a practical Guide for the attention of Ukrainian judicial professionals, for which high quality experts had been identified with the help of CEPEJ members.

8. Crystal Scales of Justice Prize

- **invited its members** to promote applications to the next edition of the "Crystal Scales of Justice" prize which will be organised in 2023 **and thanked** France, winner of the 2021 Edition, for having accepted to host the next award ceremony;
- **congratulated** the winning team of the second edition of the Junior Crystal Scales of Justice Prize, organised in partnership with the Faculty of Law of Strasbourg, led by Mrs. Favaro (Faculty of Law of the University of Pisa) who defended the French winning project of the Crystal Scales of Justice 2021, and **thanked** the team for the presentation of its project;
- **thanked** the President of the Jury and its members for their valuable commitment.

9. European Day of Justice 2022

- **thanked** its members for having organised activities in the framework of the 2022 edition of the “European Day of Justice”, celebrated on 25 October.

10. HELP Training Program concerning CEPEJ

- **took note** of the latest progress in the preparation, via the HELP⁹ platform, of an online training course on the theme of the quality of justice and of the work of the CEPEJ, which will include different modules in the fields of quality of justice, evaluation of judicial systems, cyberjustice and AI, mediation, and judicial time management.

11. Observers

- **took note** of the information from the observers (Council of Bars and Law Societies of Europe (CCBE), Council of the Notariat of the European Union (CNUE), European Union of Rechtspfleger and court Clerks (EUR), European Association of Judges (AEM-EAJ), European Expertise and European Institute (EEEI), International Union of Judicial Officers (UIHJ), Organization for Cooperation and Development in Europe (OECD)) on their activities of interest to the CEPEJ.

12. Election of the Bureau

- **elected** Francesco DEPASQUALE (Malta) as President and Ivan CRNČEC (Croatia) as Vice-President of the CEPEJ for a period of two years; **elected** Sonya DJEMNI-WAGNER (France) and Seçkin KOÇER (Türkiye) as members of the Bureau for a period of two years;
- **expressed** its warmest thanks to Ramin GARAGURBANLI for his work during his four years as President of the CEPEJ.

13. Other items

- **took note** of all the dates of CEPEJ meetings in 2023.




