Strengthening the Quality and Efficiency of Justice in Albania (SEJ IV)

Duration	January 2023 - December 2026
Objective	To support the justice governing institutions and courts in the implementation of the reforms aimed at increasing the efficiency and quality of justice system based on the CEPEJ tools and methodologies as adapted to the Albanian context, building upon achievements of the three first phases of the action.
Beneficiaries and stakeholders	Ministry of Justice, High Judicial Council, High Prosecutorial Council, Courts and court users, High Inspector of Justice, School of Magistrates, Bar Association, Mediation Chamber
Expected results	 Increased transparency and efficiency of judiciary institutions through improved court management and performance, improved quality of services for users in accordance with CEPEJ standards and tools Improved judicial statistics in accordance with CEPEJ standards and tools and in coordination with the Dashboard Western Balkans action, Judiciary institutions become more transparent and efficient through improved infrastructure and IT tools Expanded use of alternative dispute resolution in accordance with CEPEJ standards and tools School of Magistrates is further supported to provide quality training on efficiency and quality of justice to magistrates and court administration High Inspector of Justice is supported to streamline judicial inspection in line with European standards
Key achievements	 16 new appointed press judges were introduced to the CEPEJ Guide for the communication of courts and prosecution offices with media and the public through 2 tailored workshops. Recommendations were provided for the implementation of the new judicial map related to the reallocation of cases in reorganised courts and establishment of court sections in appeal and first instance courts. Two court coaching activities were organised in the Appeal court of general jurisdiction and first instance court of Durres in the frame of reorganisation of the new judicial map. Training on thematic inspection were provided for 38 inspectors from High Inspector of Justice in cooperation with European Network of Justice Inspection Services (RESIJ). Initial mediation fact-finding mission was completed (with participation of the National mediation chamber, Bar association, Ministry of Justice and Tirana administrative court).

	 150 non - judge staff of assistance units in the domestic courts, including legal advisors and judicial assistants, were trained on CEPEJ tools on judicial time management aiming to strengthen the role of court administration in ensuring timely judgement and support backlog reduction. Support was provided to the newly established working group on justice system digitalisation. Initial needs assessment visits were organised to the High Prosecutorial Council, General Prosecution Office, Tirana Prosecution Office and Elbasan Prosecution Office.
What is next?	 Remaining training sessions for court administration and legal assistance units on judicial time management tools. Next training sessions for press judges and prosecutors on judicial communication. Further awareness raising sessions for court staff, presidents and judges on CEPEJ tools on judicial time management and court performance. Awareness raising activities to further expand the use of mediation in line with CEPEJ toolkit. Expansion of the use of web-based court user satisfaction surveys to other courts. Follow-up to initial needs assessment visits of the prosecution services.

Key achievements	 Representatives of the key national partners are informed regularly about the relevant CEPEJ tools on mediation, which are translated into the Azerbaijani language and published for awareness raising purposes. CEPEJ experts report with recommendations on data collection and digitalisation of the mediation system in Azerbaijan was submitted to partners following an experts mission conducted in June 2023. CEPEJ experts conducted consultations on improving the mediation training framework in Azerbaijan and an advanced training of trainers to increase the competence of existing mediation trainers and heads of mediation organisations.
What is next?	 Support to digitalisation of the mediation system – creation of a tool for automated data gathering, monitoring, and evaluation of the results of providers of mediation services. Enhancing the competences of mediation trainers and the training resources of the Academy of Justice on mediation. Support to the development of customised training materials based on local culture and experience. Drawing up a mediator's handbook. Launching a working group to establish and monitor the mediation pilot to facilitate the access to mediation services in regions etc.

Duration	January 2023 - December 2026
Objective	To support the justice system of Bosnia and Herzegovina in improving its efficiency and quality in accordance with the standards and tools developed by the CEPEJ.
Beneficiaries and stakeholders	Ministry of Justice, High Judicial and Prosecutorial Council (HJPC), judicial training institutions (JPTC), chief judges, chief prosecutors, court administrators, judges and prosecutors, courts, and Association of Mediators.
Expected results	 Efficiency and quality of the justice system of Bosnia and Herzegovina will be strengthened (including support in shortening the length of proceedings and in reducing the backlog) The capacities for collecting, processing and analysis of data on the functioning of the judicial system and judicial statistics according to the CEPEJ methodology will be supported, in strong coordination with the CEPEJ Dashboard Western Balkans action Justice professionals' capacities on topics related to efficiency and quality of justice will be strengthened, in line with CEPEJ standards and tools
Key achievements	 In close coordination with the HJPC of BiH, 5 first instance pilot courts were selected to cooperate with the CEPEJ in the areas of efficiency and quality of justice through court coaching activities. 15 participants including court presidents, directors of the JPTCs and the HJPC representatives participated in awareness raising sessions on CEPEJ methodology and tools on efficiency and quality of justice and court coaching methodology. 3 needs assessment visits to the pilot courts (Sokolac, Brčko, Cazin) and 2 initial needs assessment visits to JPTC's in Federation of BiH and Republika Srpska were conducted in order to identify main challenges faced by these institutions in terms of quality and efficiency of justice. Gender analysis exercise was launched to identify specific actions to mainstream gender equality throughout the project and its activities. Cooperation between the CEPEJ GT-CYBERJUST working group and HJPC was established; HJPC participates as observer in the work of the CEPEJ GT-CYBERJUST.
What is next?	 Remaining 2 needs assessment visits to pilot courts (Trebinje and Livno) to design tailored court coaching projects. Finalisation of the recommendations for 5 pilot courts in order to suggest tailored court coaching programmes (early 2024).



BULGARIA

Establishing a balanced workload distribution in the judicial system

Objective	To support Bulgaria in its efforts to improve the efficiency of the management and administration of the courts through improved control and verification of statistical data, and improved workload management of judges.

Key achievements	 Fact-finding mission conducted on 20-21 February and discussions held with representatives from the key Bulgarian partner institutions, such as the Ministry of Justice (MoJ), the Supreme Judicial Council (SJC), as well as representatives of courts located in the capital city A preliminary situation analysis has been established based on bilateral consultations with relevant stakeholders at national and regional level and an analysis of the documents collected in terms of data collection and workload allocation have been produced Experience sharing visits carried out from 28 to 30 June, in courts located in the capital city (Sofia Regional Court, Sofia Appellate Court, and Sofia City Court) and regions (Veliko Turnovo Regional Court, Veliko Turnovo Administrative Court, Varna District Court, Varna Administrative Court) A draft assessment report with recommendations on the methodology for control and verification of the statistical data reflecting the activities of the judicial authorities and judges in Bulgaria has been prepared (September 2023). A draft situation and assessment report on the existing criteria to measure the workload of judges in Bulgaria has been prepared (September 2023).
What is next?	 A workshop to present the assessment reports is implemented (end of2023/beginning of 2024). A study-visit is organised to get acquainted with best EU practices and training sessions are organised (January-May 2024).

The Chairman of the Kosovo Judicial Council is now closely monitoring the Clearance Rate and is setting some targets for the end of the year. Objective	To promote further modernisation of the judicial administration, improving the evaluation, efficiency, and quality of the functioning of courts, in particular by strengthening the court management and preventing backlogs, improving the transparency, communication, and accessibility of courts, as well as the public trust and user satisfaction, in line with European standards.

Key achievements	 Launching of the JUSTAT AIS, new tool for gathering and analyses of statistics on court performance. Launching, in cooperation with national partners, of two working groups, to develop (1) detailed guidance for uniform reporting on court performance and (2) recommendations for optimisation of HR policies of the judiciary, including a balanced workload for judges and court staff, ensuring non-discrimination, gender equality, and social inclusion in the employment. Training provided to 22 court managers and staff on performance evaluation, reporting, and court resource planning.
What is next?	 In the coming months the project will contribute towards: Updating JUSTAT AIS by a 4th dashboard (caseflow and structure of the caseload of courts) and promoting its use for the purpose of evaluation and reporting on court performance; Supporting the evaluation of the performance of courts and uniform yearly reporting with a view to improving their efficiency and the quality of judicial services. Assessment of the backlog and the age of pending cases in overburdened courts and supporting the implementation of remedies; Developing recommendations for the adoption and implementation of the workload of judges. Updating the policy documents on judicial communication and supporting practical steps for their implementation, etc.

State of implementation	 The 2023 Report on 2021 data has been submitted to the European Commission on 30 June 2023, completing the 2nd cycle of data collection A peer review and support to data collection mission to the Republic of Moldova has been carried out, along with continuous support being provided to all countries. The revision of the Questionnaire and Explanatory Note for the 3rd cycle of data collection has been finalised in consultations with EC and beneficiaries; further synergies with the Western Balkans Dashboard were achieved. The 3rd cycle will be on 2023 data; the data collection was launched in November. This is a transition cycle due to the change of the year of reference (from "N-2" to "N-1"), upon the EC request.

The new Dashboard Western Balkans started in January 2023 under Horizontal Facility III. The fourth round of data collection has already started.
 Deliverables are provided every year to the European Commission according to the agreed calendar. In 2023, the first report (comparative tables) is provided on 31 May, while the second one (beneficiary profiles) on 30 June. Capacity-building activities are organised as necessary to support data collection. In 2022, two regional workshops on judicial training and CMS took place. Furthermore, a closing event was organised to share information about the beneficiaries' spreading and use of dashboard data. Specific fact-finding mission to Bosnia and Herzegovina, Serbia and
