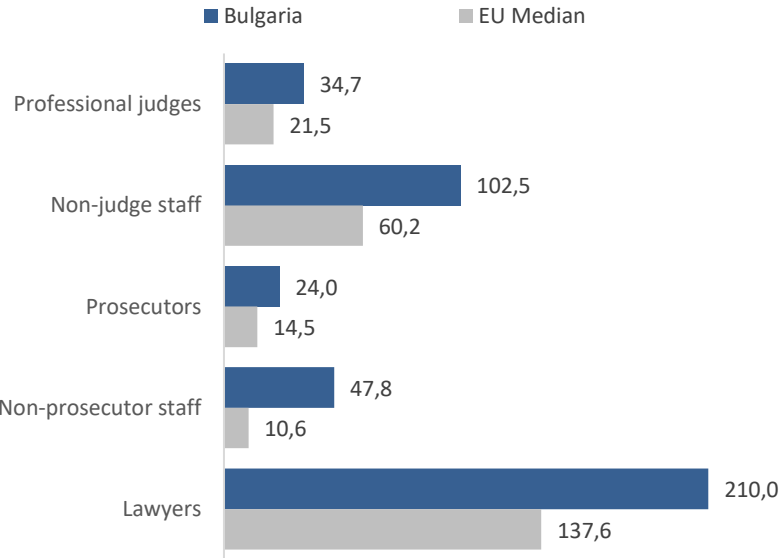

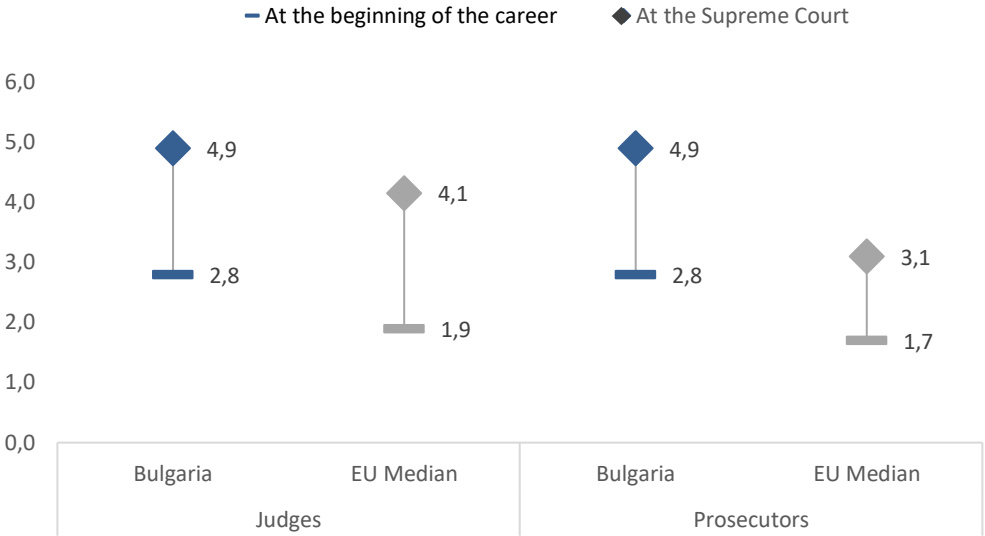

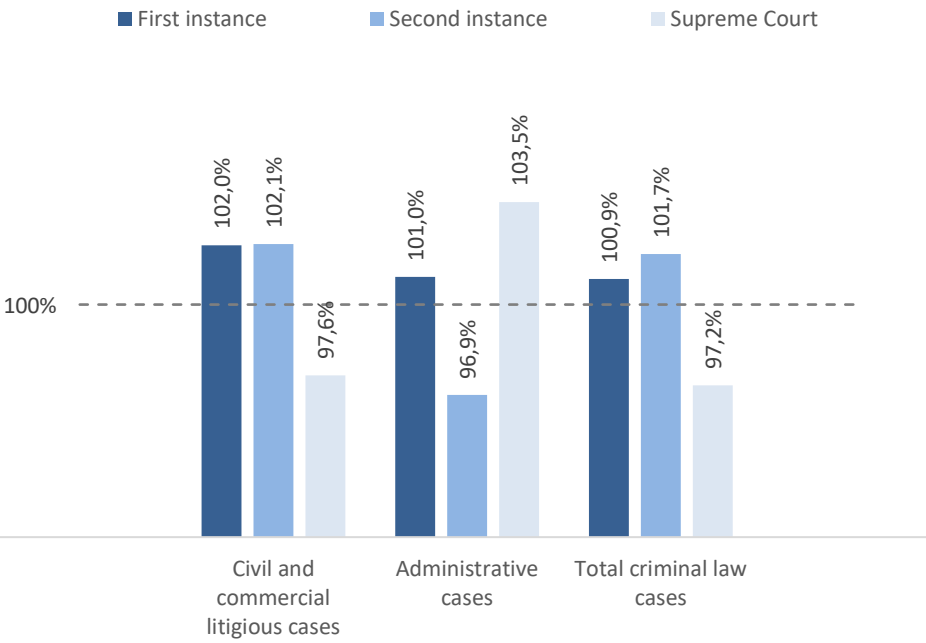


Gross salaries of judges and prosecutors vs average annual salary in 2023

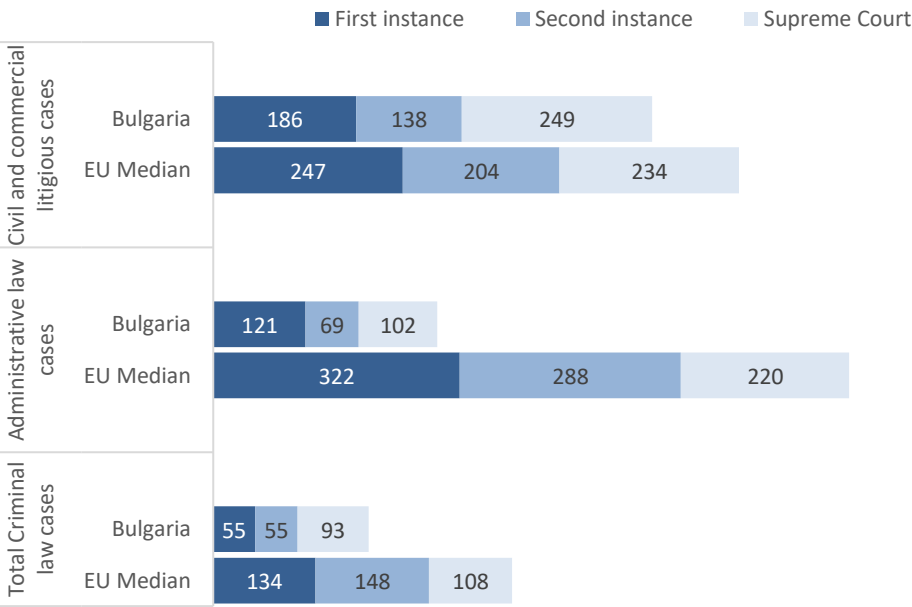

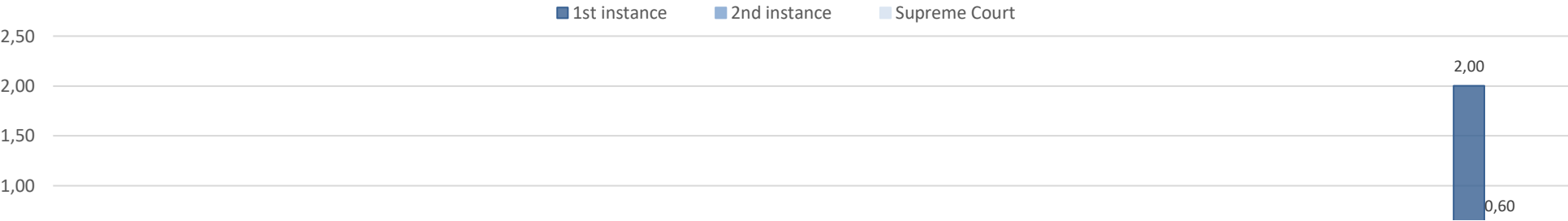


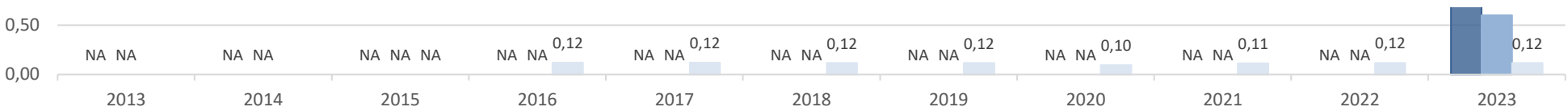
DispositionTime by instance and by matter in 2023 (days)

1. Judicial organisation in Bulgaria (2023 data)

In Bulgaria in 2023, the number of courts considered as legal entities is 180. Namely, there are 147 courts of general jurisdiction and 33 specialised courts.

Among the 147 legal entities of general jurisdiction, 113 District courts act as main first instance courts. They have jurisdiction over all cases except those which are statutorily assigned to another court. They deal with civil, criminal and administrative-criminal cases. The decisions of the district courts are subject to appeal before the respective Regional court.

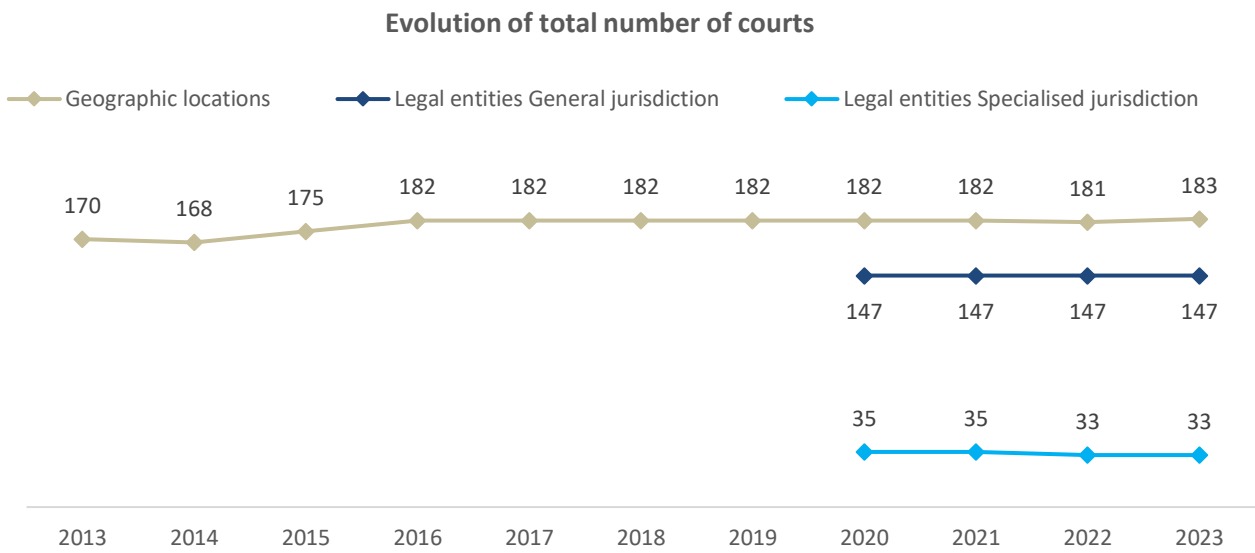
The 28 Provincial/Regional Courts act as courts of first and second instance. As courts of first instance, they examine a precisely defined categories of cases involving significant sums or substantial societal interest. When acting as a second (appellate) instance, they re-examine decisions taken by the District courts. In the frame of question 42, they are included in the number of courts of second instance with general jurisdiction, the decisive indicator used is the number of incoming cases. At second instance, besides the Regional courts, there are in Bulgaria 5 Courts of appeal.

The Supreme Cassation Court is the highest instance court of general jurisdiction. Its equivalent in administrative matters is the Supreme Administrative Court. Among the 33 specialised courts, 31 act at first instance, while 2 are higher instance courts (see below for more details).

In terms of geographic locations, there are 181 courts among which 145 are of first instance. Indeed, the Sofia Appellate Court, Sofia City Court and Sofia District Court are housed in two court buildings each, where sessions are held.

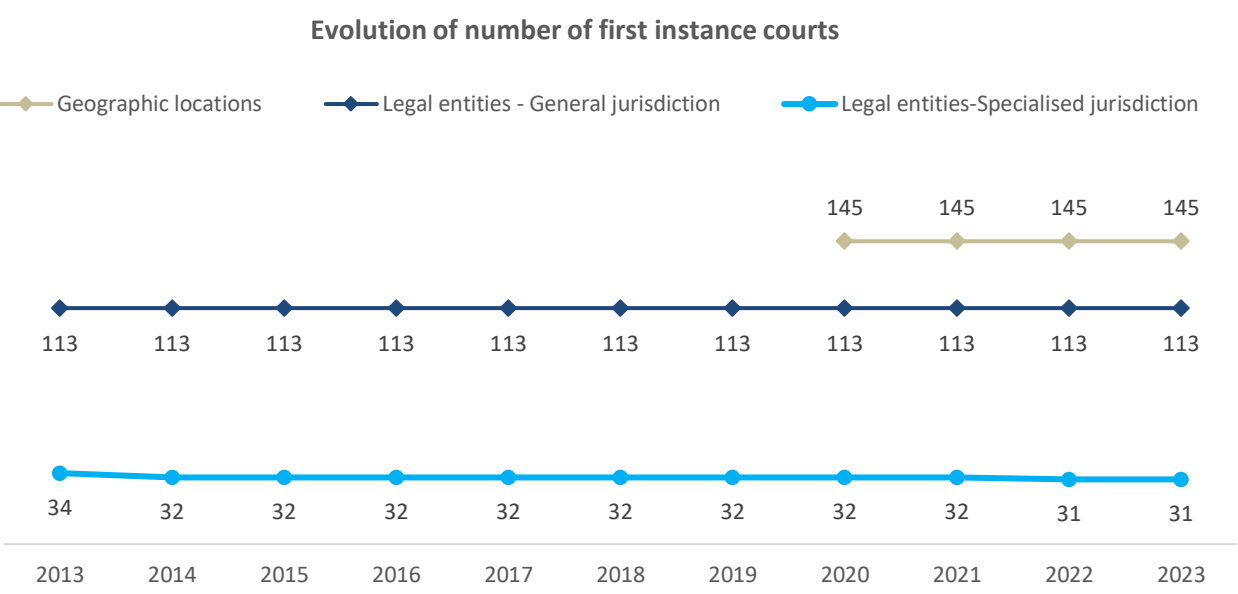

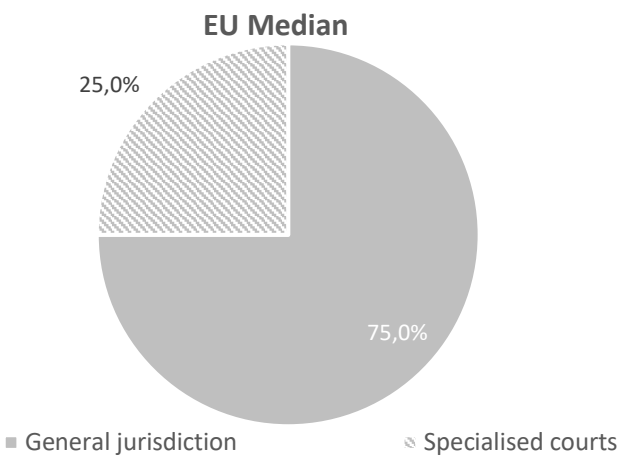
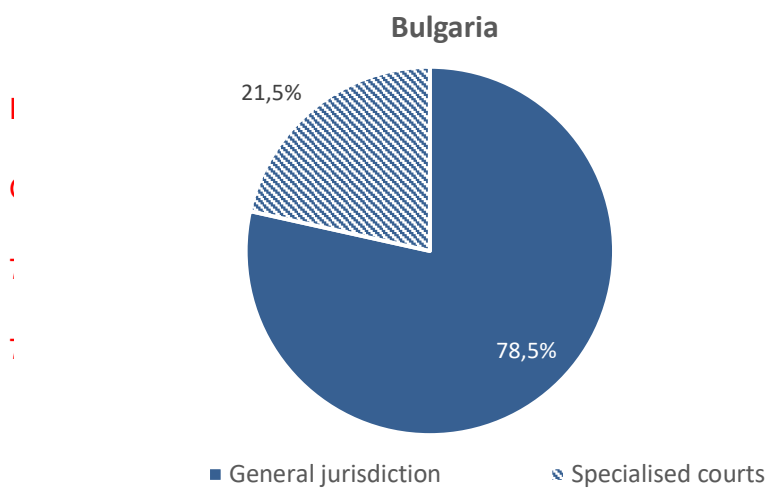


Evolution of number of first instance courts

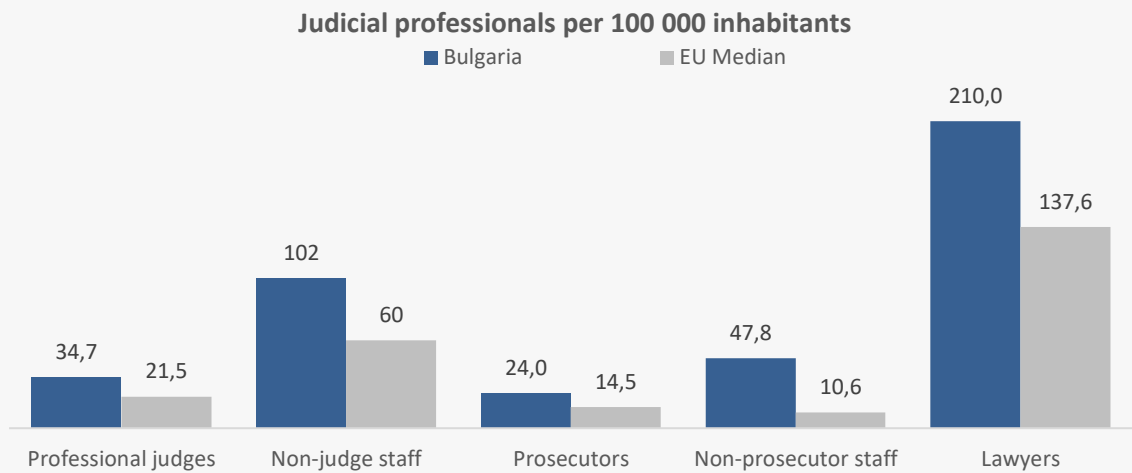

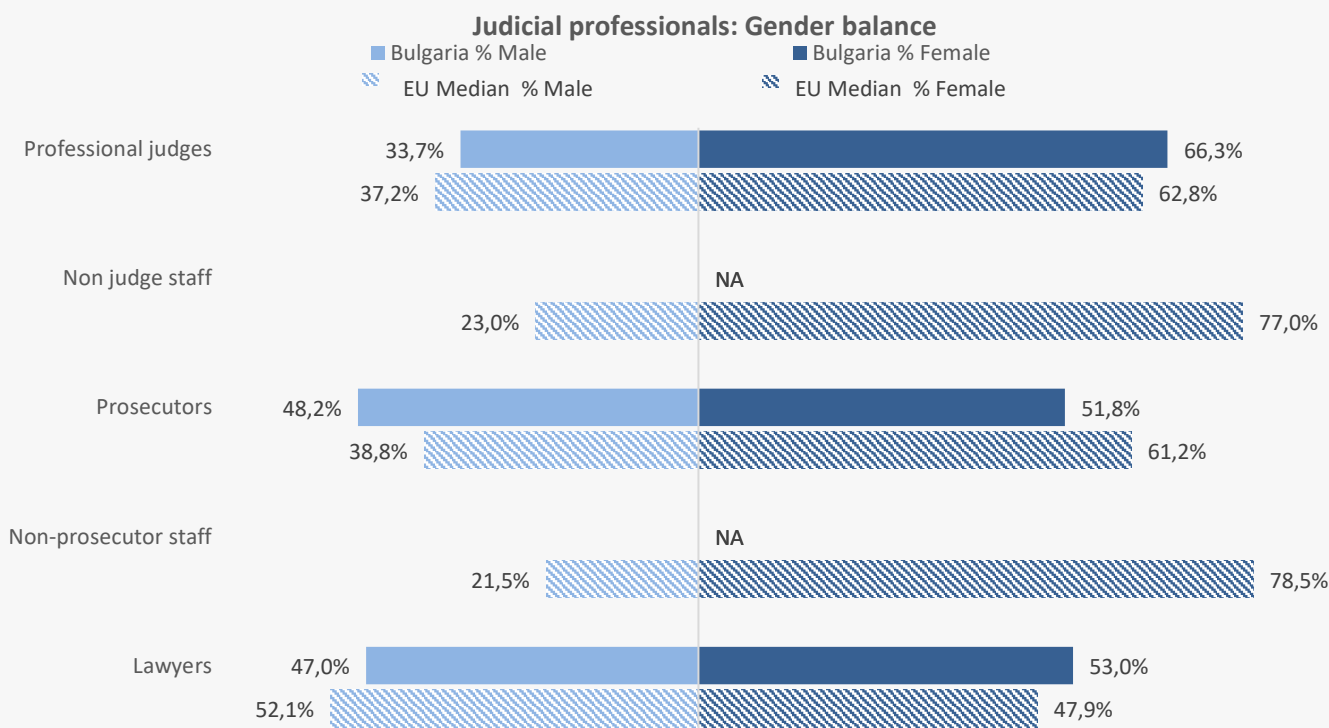

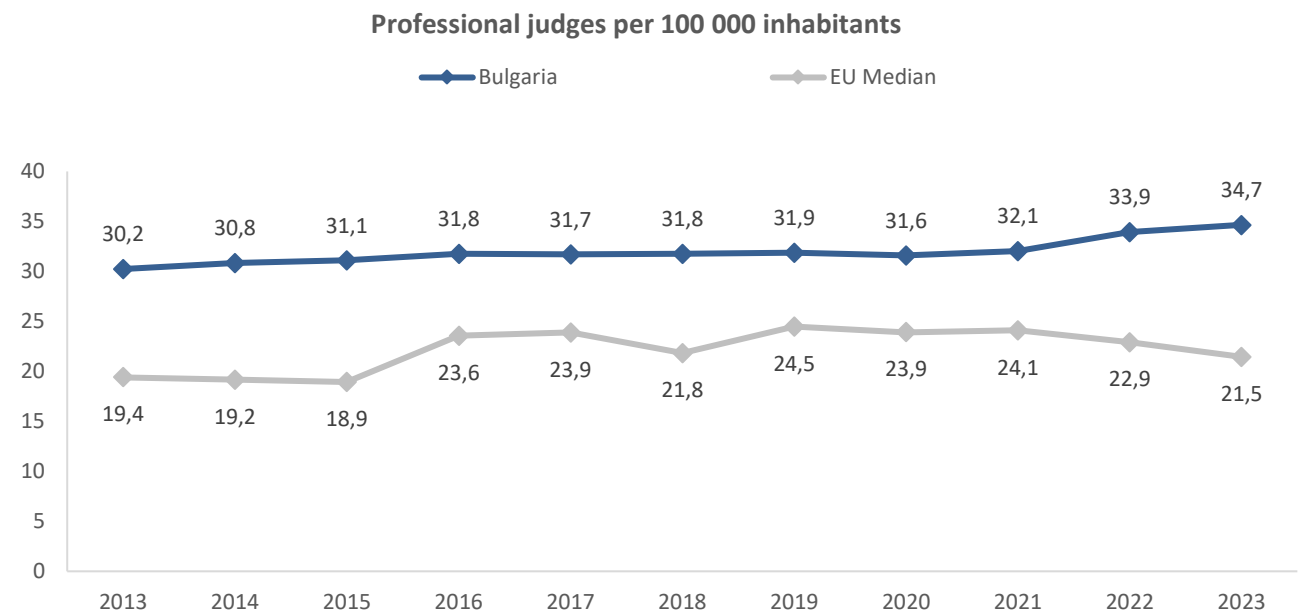

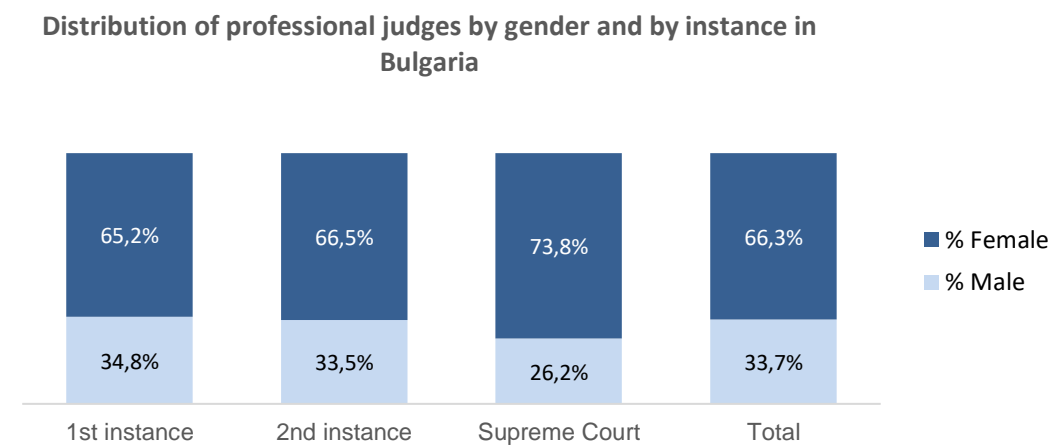
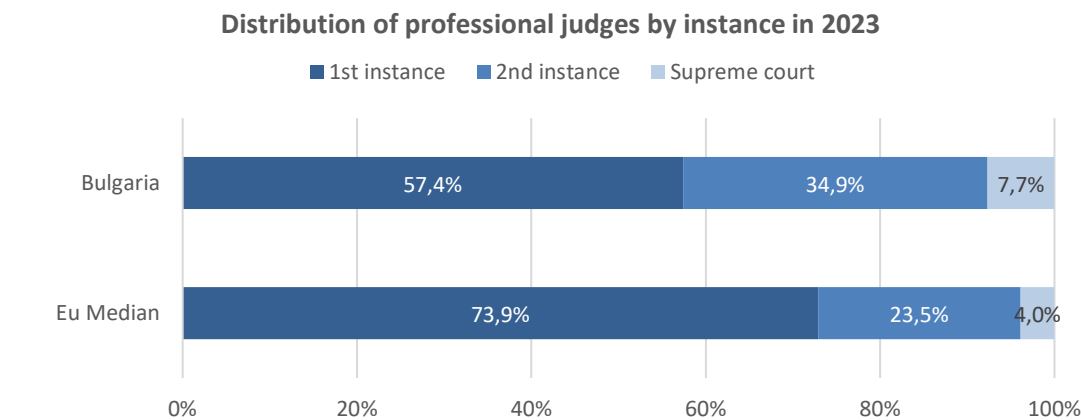


According to 2023 data, the total number of professional judges sitting in courts (all instances) in Bulgaria is 2 234, which is 2,1% more than in previous cycle.

More precisely, in Bulgaria, there are 34,7 professional judges per 100 000 inhabitants (this figure is above the EU median of 21,5 judges per 100 000 inhabitants)

In this cycle, the total number of female professional judges (all instances) is 1 482, which represents 66,3% of the total number of judges.

The total number of judges is distributed among the different judicial instances in the following way: 1 282 are sitting in the first instance courts (of which 836 are female); 780 are sitting in the second instance courts (of which 519 are female) and 172 are sitting at the Supreme Court (of which 127 are female).

Compared with the EU distribution of professional judges per instance, first instance judges are the most numerous, but they are less prevalent than in the EU. Conversely, the percentage of second instance judges is significantly higher than in the EU. At the Supreme Court level, there are more judges in Bulgaria compared with the EU median.

As regards the distribution of the number of judges among the different judicial instances, Bulgaria presents some peculiarities which should be mentioned. The number of first instance professional judges encompasses the judges of the first instance courts as follows - 113 district, 28 administrative, 3 military-district. Are counted as second instance judges, judges of the 28 regional/provincial, 5 appellate and the Military Court of Appeal. It is worth recalling here that the Regional courts have mixed competences as first and second instance for certain categories of cases, but given their predominant competences, they are categorized as courts of second instance. At third instance there are judges of the Supreme Court of Cassation and the Supreme Administrative Court.

As regards the distribution male/female, it has to be specified that female judges represent more than 65% at all three instances.

The total number of 780 second instance judges includes 46 junior judges for whom no information regarding specialization is available.

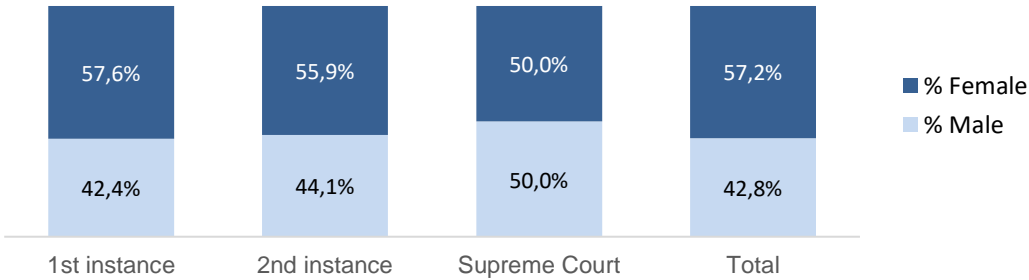

Distribution of court presidents by gender and by instance in Bulgaria

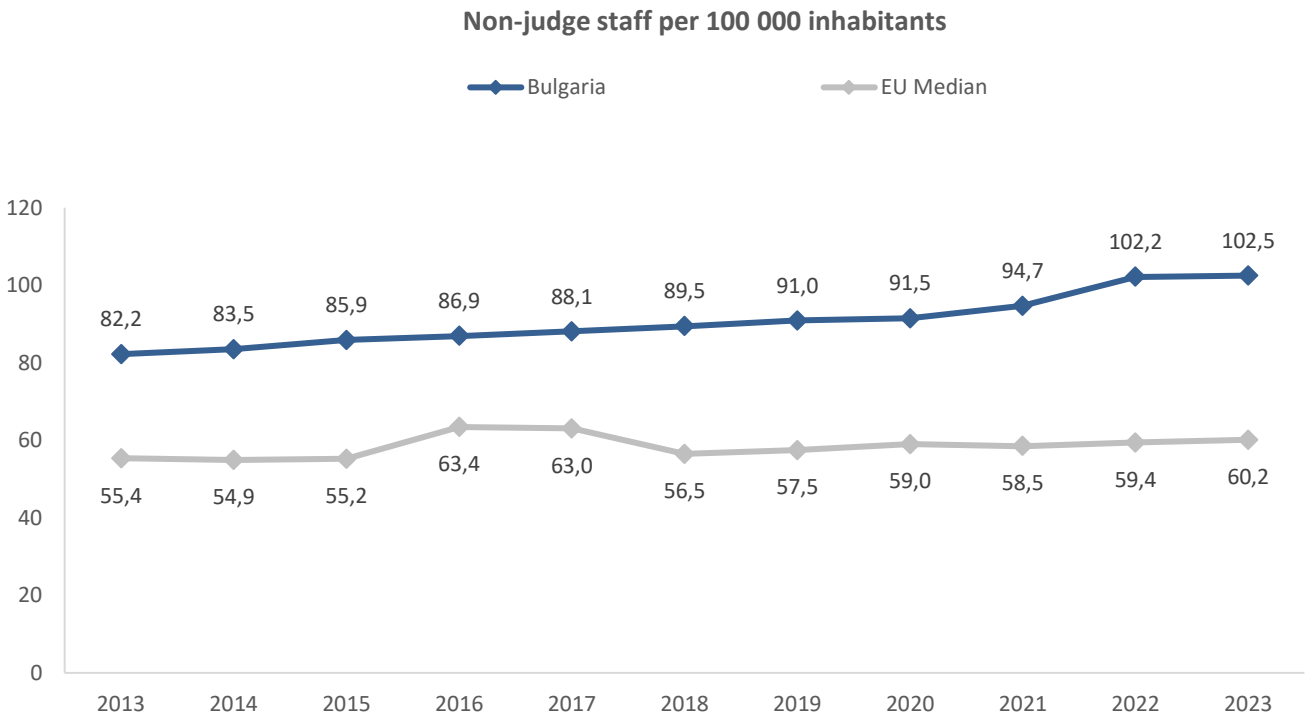


In this cycle, the total number of female court presidents (all instances) is 103, which represents 57,2% of the total number of court presidents.

The total number of court presidents is distributed among the different judicial instances in the following way: 144 are sitting in first instance courts (of which 83 are female); 34 are sitting in second instance courts (of which 19 are female) and 2 are sitting in Supreme Court (of which 1 is female).

In 2023, Bulgaria has 6 606 non-judge staff. The distribution by gender cannot be carried out. The total number of non-judge staff in comparison with the previous cycle reveals an increase of 0,3%.

In 2023, the number of non-judge staff per 100 000 inhabitants has increased (from 102,2 in 2022 to 102,5 in 2023).

During the same period, the number of judges per 100 000 inhabitants evolved from 33,9 judges per 100 000 inhabitants in 2022 to 34,7 in 2023.

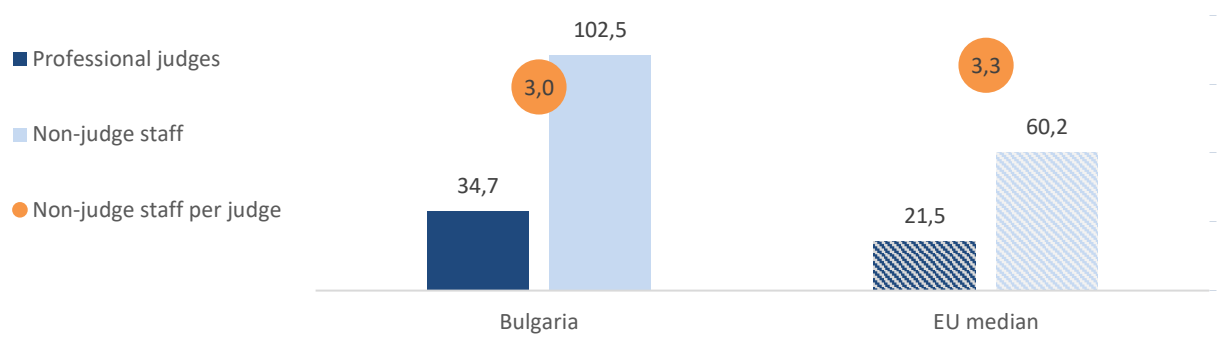
The category “other” encompasses the number of non-judge staff employees working in the recreational field. The total number of judicial employees in the courts does not include trainee judges.

The Judges’ College of the Supreme Judicial Council does not maintain data on the gender distribution of the court clerks (non-judge staff) in the courts, since each court of the respective level (a total of 180 courts) is an independent legal entity and their employer is the president of the respective court.

Professional judges and non-judge staff per 100 000 inhabitants, and their ratio



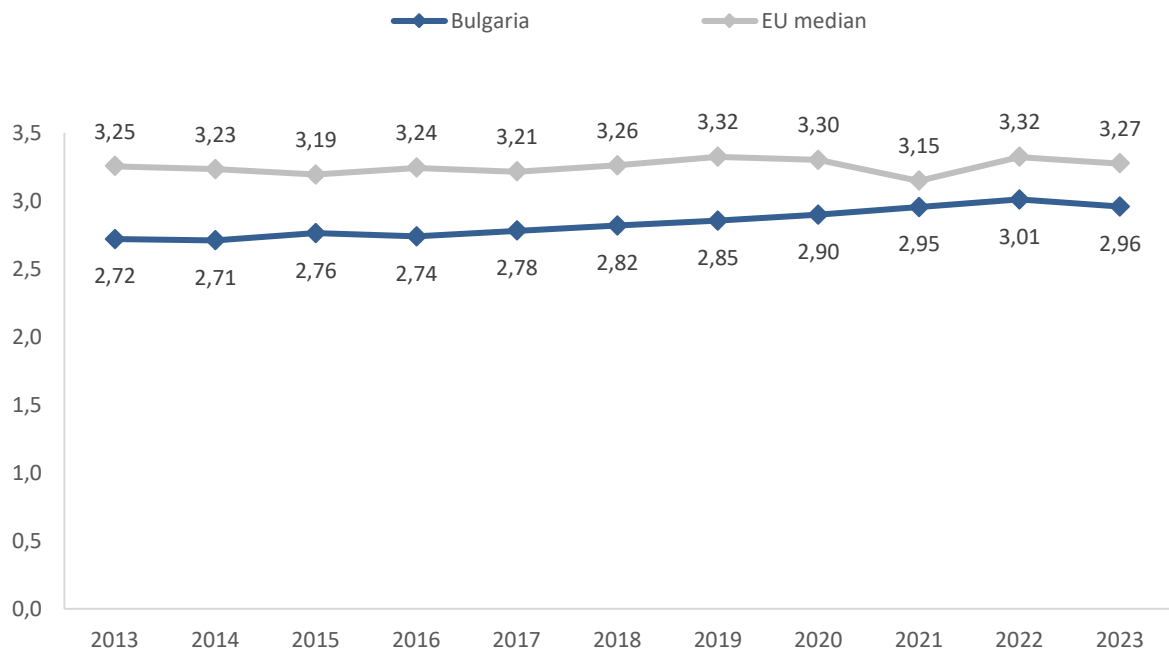
In Bulgaria, there are 34,7 professional judges per 100 000 inhabitants (this figure is above the EU median of 21,5 judges per 100 000 inhabitants) and about 3,0 non-judge staff per judge.

There is no significant difference compared with previous cycle when this ratio was also at 3,0 non-judge staff per judge.

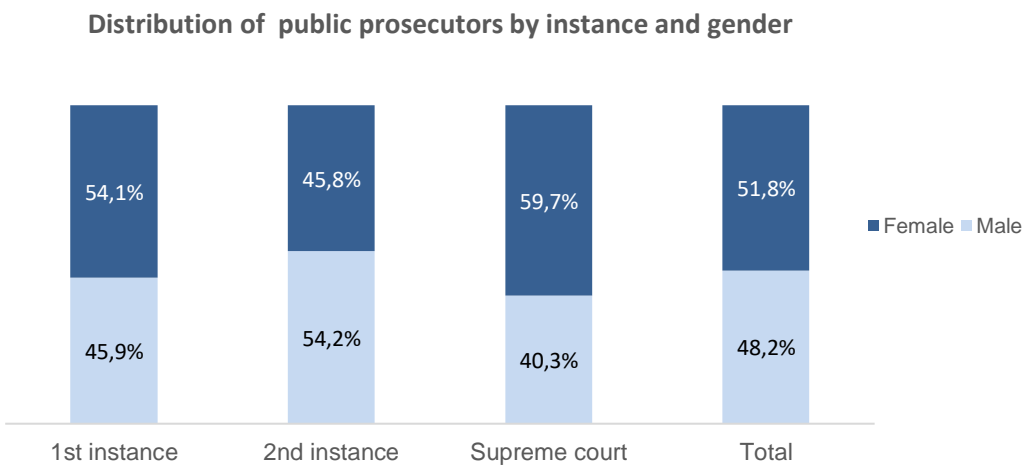
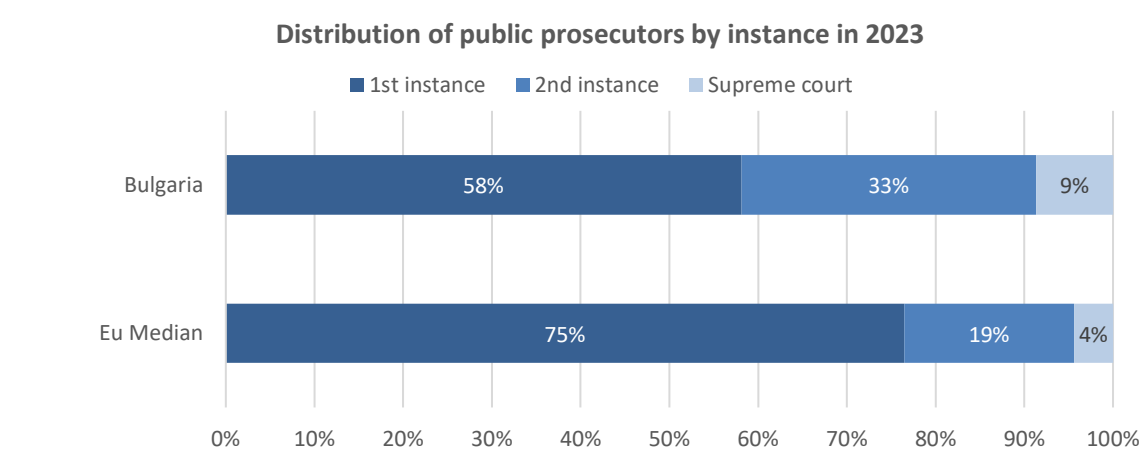
Evolution of the ratio between professional judges and non-judge staff

In this cycle, the total number of Female prosecutors (all instances) is 803, which represents 51,8% of the total number of prosecutors.

The total number of prosecutors is distributed among the different judicial instances in the following way: 900 in first instance (of which 487 are female); 515 are in second instance (of which 236 are female) and 134 in final instance (of which 80 are female).

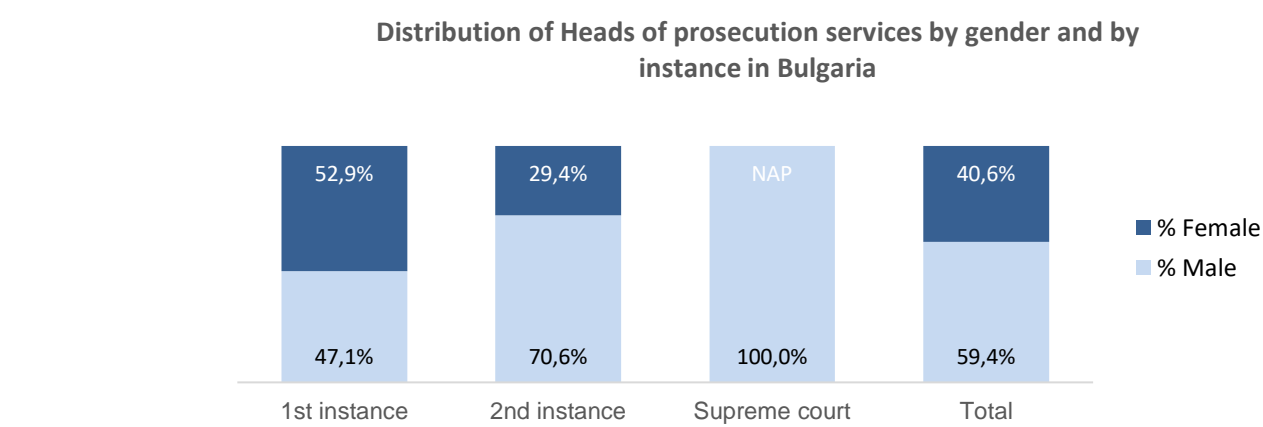
As regards the methodology of presentation of data in respect of the number of public prosecutors, it should be noticed that the provided data refer to the actual number of employed persons for the year of reference.

As regards the distribution male/female, it has to be specified that female prosecutors do not represent the majority only at second instance.

In this cycle, the total number of female heads of prosecution services (all instances) is 28, which represents 40,6% of the total number of heads of prosecution services.

The total number of heads of prosecution services is distributed among the different judicial instances in the following way: 34 at first instance level (of which 18 are female); 34 at second instance level (of which 10 are female) and 1 at the highest instance level who is a man.

It should be mentioned that the process of merging the district prosecutor's offices ended on July 27, 2022. Starting from this date the number of first instance public prosecution offices is 34.

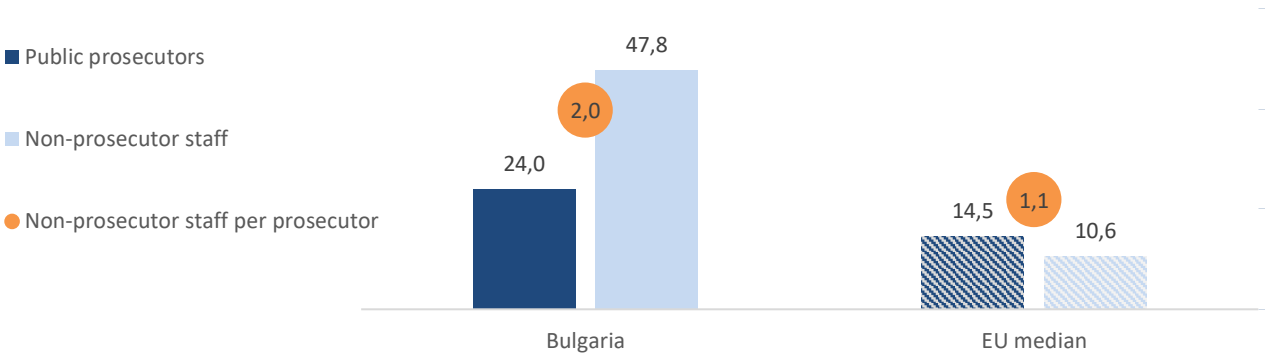

The Prosecutors’ College of the Supreme Judicial Council does not maintain data on the gender distribution of the prosecutor’s office clerks (non-prosecutor staff) in the prosecutor’s offices, since each prosecutor’s office of the respective level (a total of 69 prosecutor’s offices) is an independent legal entity and their employer is the administrative head of the respective prosecutor’s office.

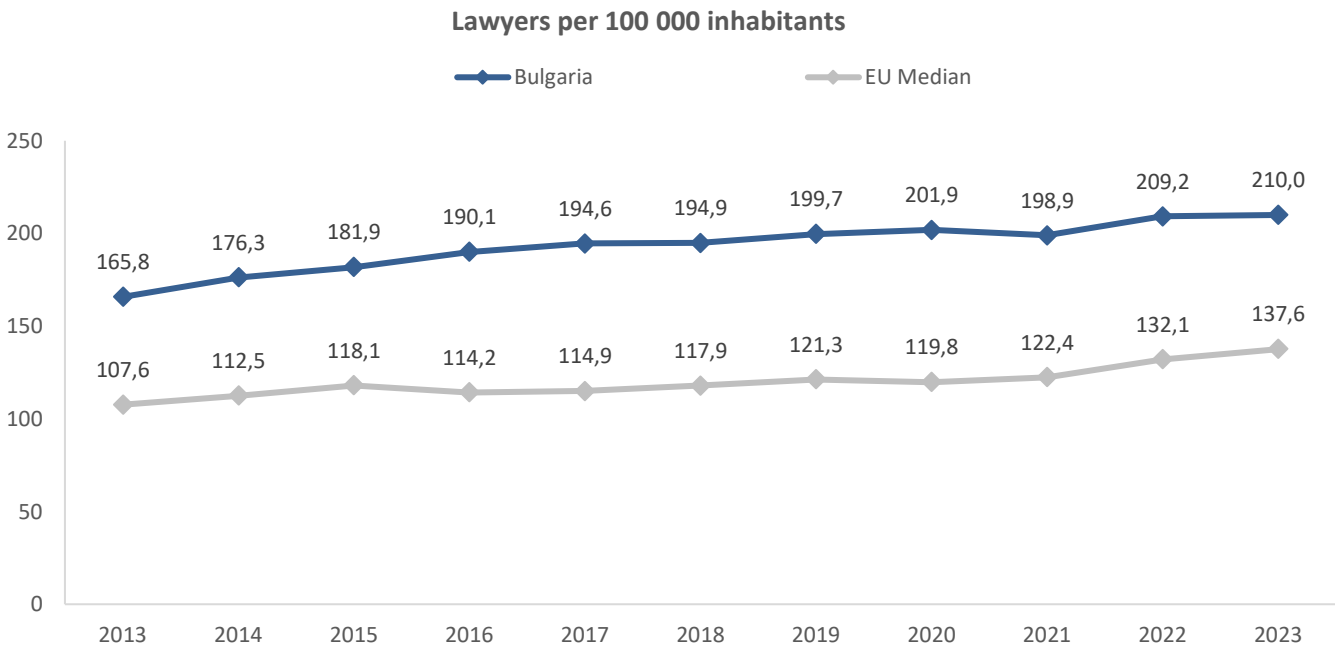

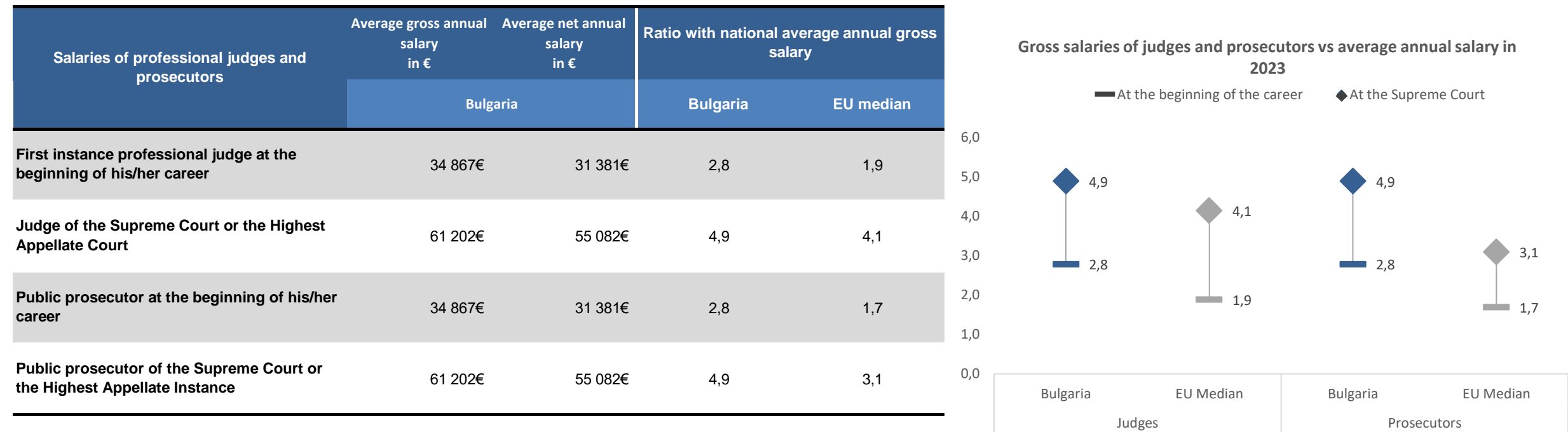

In 2023, there are 13 533 lawyers, which is 0,3% more than in 2022.
There are 7 171 female lawyers which is 53% of the total.

Bulgaria has 210,0 lawyers per 100 000 inhabitants, which is above the EU median of 137,6 lawyers per 100 000 inhabitants.

Salaries of professional judges and prosecutors at beginning of a career and at the highest instance



In the European Union, the absolute gross salary for a judge at the beginning of career ranges from a minimum of 25 759€ to a maximum of 144 856€.

According to 2023 data, the absolute gross salary of a judge at the beginning of his/her career in Bulgaria is 34 867€, which is rather below the EU median of 58 128€. (-40% below)

Compared with the annual average salary in the country, the salary for a judge at the beginning of his/her career is 2,8 times higher. (the EU median is 1,9)

At the highest level, the range of the EU absolute gross salary for a judge is from 58 623€ to 266 974€. Bulgaria's absolute gross salaries for judges at the highest level is -48% below the EU median of 118 595€

For the public prosecutors, the range for the absolute gross salary at the beginning of career is from a minimum of 25 759€ to a maximum of 101 592€.

In 2023, the absolute gross salary of a public prosecutor at the beginning of his/her career in Bulgaria of 34 867€ is rather below the EU median of 49 953€. (-30% below)

Compared with the annual average salary in the country, the salary for a public prosecutors at the beginning of his/her career is 2,8 times higher. (the EU median is 1,7)

At the highest level, the minimum absolute gross salary for prosecutors in the European Union is 51 456€ and the maximum is 199 670€. Bulgaria's absolute gross salaries for prosecutors at the highest level is -35% below the EU median of 93 759€

According to Art. 218, paragraph 3 of the Judiciary System Act (JSA), the remuneration of judges, prosecutors and investigators is determined by a decision of the General Assembly of the Supreme Judicial Council (SJC) and the Supreme Prosecutorial Council (SPC) that adopts "Table No. 1 - for determination of the maximum basic monthly salaries of judges, prosecutors and investigators", which is applicable for all magistrates equally. In this regard, data for judges and prosecutors match completely.

The gross monthly remuneration of judges, prosecutors and investigators is formed by adding to the basic monthly remuneration the remuneration for rank (from Table No. 1) and time served (according to Article 219 of the JSA).

The Act on the Liability for Damage Incurred by the State and the Municipalities sets out the procedure for liability for activity of the Administration, law-enforcement authorities, Commission for Forfeiture of Unlawfully Acquired Assets and Liability for actions of the judiciary bodies, for violation of the right to a hearing and pronouncement of judgment within a reasonable time.

Chapter Three "a" of the Judiciary System Act (JSA) establishes a procedure for the examination of applications submitted by citizens or legal persons against instruments, actions or omissions of the judicial authorities which infringe the right to have the case thereof heard and disposed of within a reasonable time. The verification of the applications is carried out by the Inspectorate to the Supreme Judicial Council, and after its completion the documents in the file are sent to the Minister of Justice. The verification of the circumstances and the ruling on the application shall be carried out within 6 months from its receipt. The maximum amount of compensation may not exceed BGN 10,000. The persons who have received compensation under the Judiciary System Act may not seek compensation on the same grounds in court.

Pursuant to the Act on the Liability for Damage Incurred by the State and the Municipalities (ALDISM), the state and the municipalities shall be liable for any damage inflicted on individuals and legal persons by legally non-conforming acts, actions or omissions of State bodies and municipal authorities and officials upon or in connection with the performance of administrative activity, as well as for the damages caused by the action of repealed as illegal or declared as null and void legal acts (Art. 1, para 1). Art. 2, para. 1 and para. 2 of the ALDISM, lists the cases in which the State shall be liable for any damage inflicted on citizens by criminal investigation authorities, public prosecution authorities or court. The scope of the ALDISM includes the responsibility for illegal acts, actions or omissions of the bodies and officials under the Anti-Corruption and Confiscation of Illegally Acquired Property Act, performed during or on the occasion of exercising their powers or service, as well as the responsibility of the bodies of the judiciary for violation of the right to consider and resolve the case within a reasonable time.

In the Republic of Bulgaria, there are two mechanisms for indemnification for damages, in relation to the criminal proceedings.

The first mechanism is regulated in the Liability of the State and Municipalities for Damages Act described before.

Statistics are not maintained in the Prosecutor's Office in compliance with the CEPEJ categories. Only the total amount of the indemnifications awarded under actions brought against the Prosecutor's Office in accordance with the procedure of the Liability of the State and Municipalities for Damages Act is available for year 2023: BGN 2 824 095.16 (EUR 1 443 937).

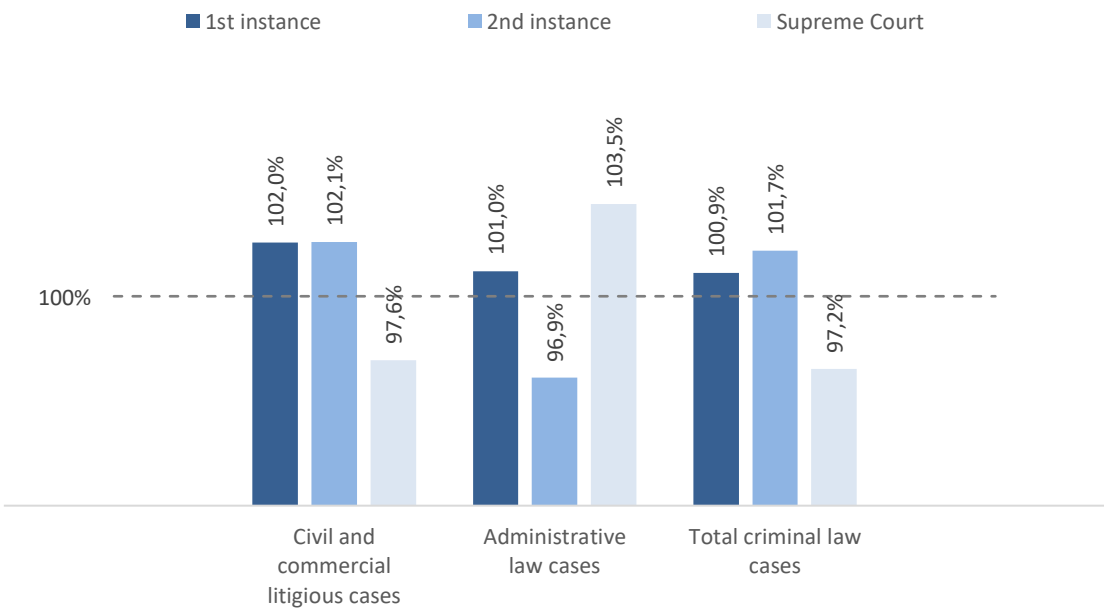

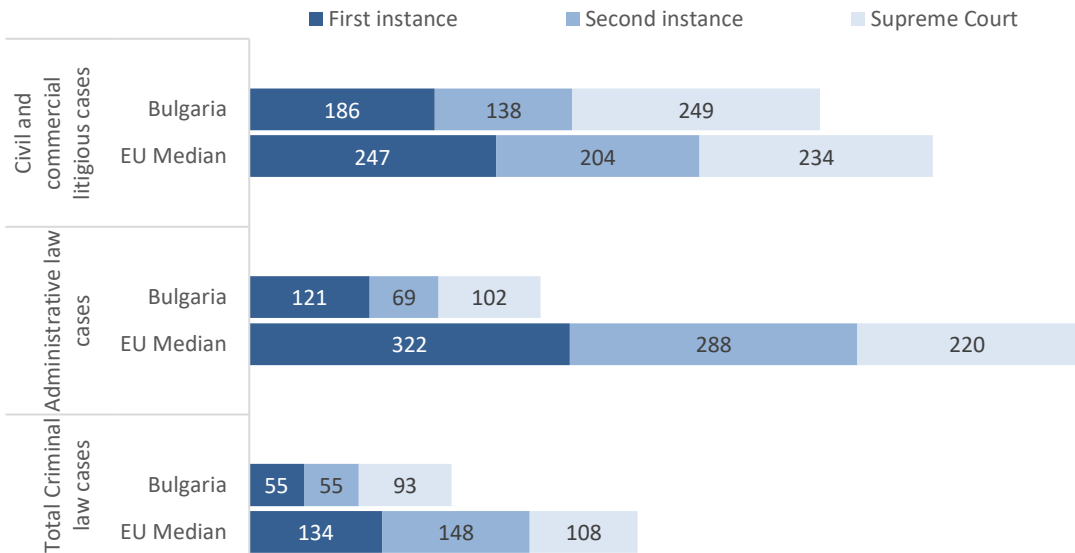

At the outset, it should be highlighted that for the first time, data on civil and commercial litigious cases at first and second instance are available, allowing measuring both efficiency indicators – Clearance Rate and Disposition Time.

In 2023, similarly to the EU trend, the shortest total length of proceedings (all instances combined) in Bulgaria is registered in criminal matters. Indeed, at all three instances, the Disposition Time for criminal cases is considerably below the respective EU medians.

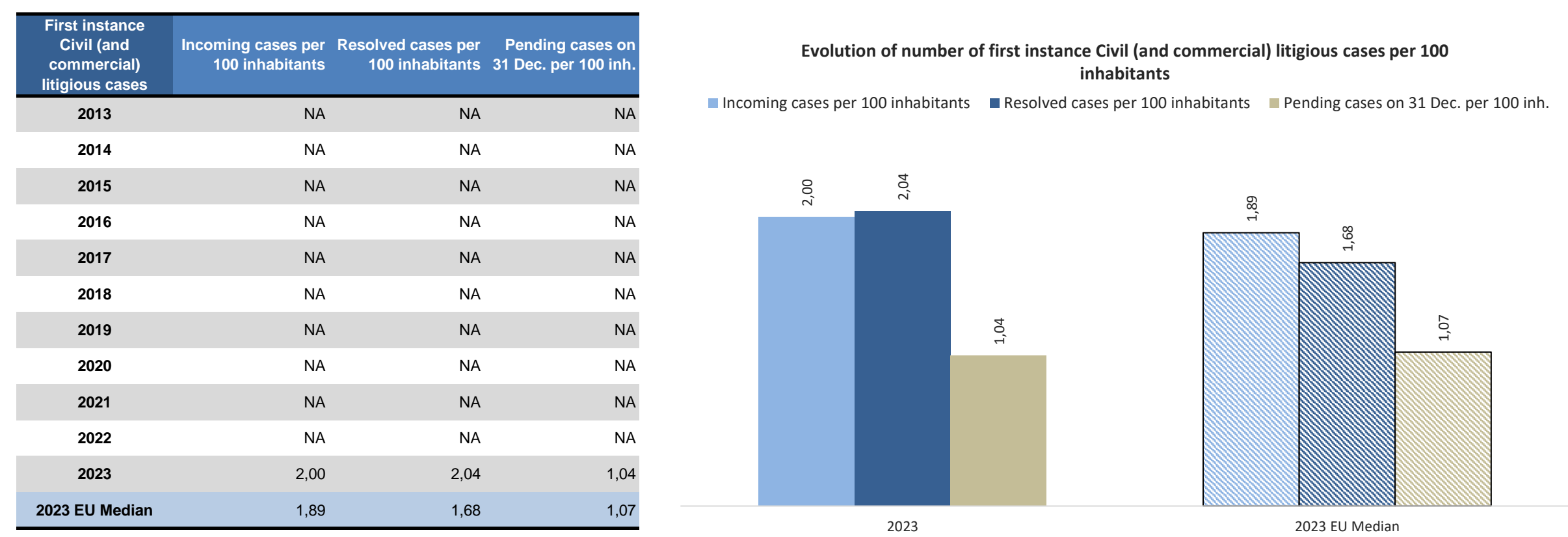
Conversely, while administrative proceedings are the longest in the EU, civil and commercial litigious cases take the longest in Bulgaria. However, the Disposition Time remains below the respective EU medians except at the Supreme Court level, where the DT is slightly above the EU value.

In administrative matters, the Disposition Time is significantly below the respective EU values at all three instances.

In 2023, second instance courts appear as the most efficient, while the lowest Disposition Time is registered for first and second instance criminal cases.

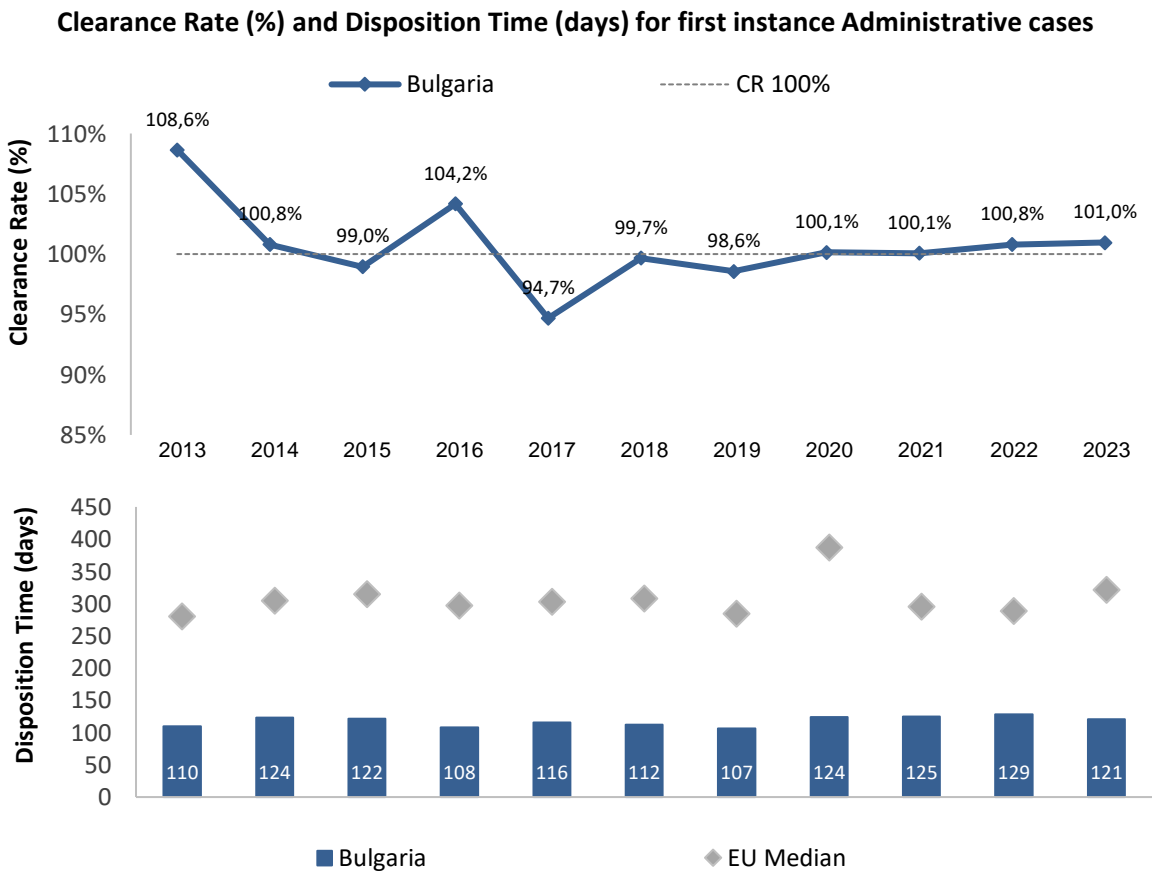

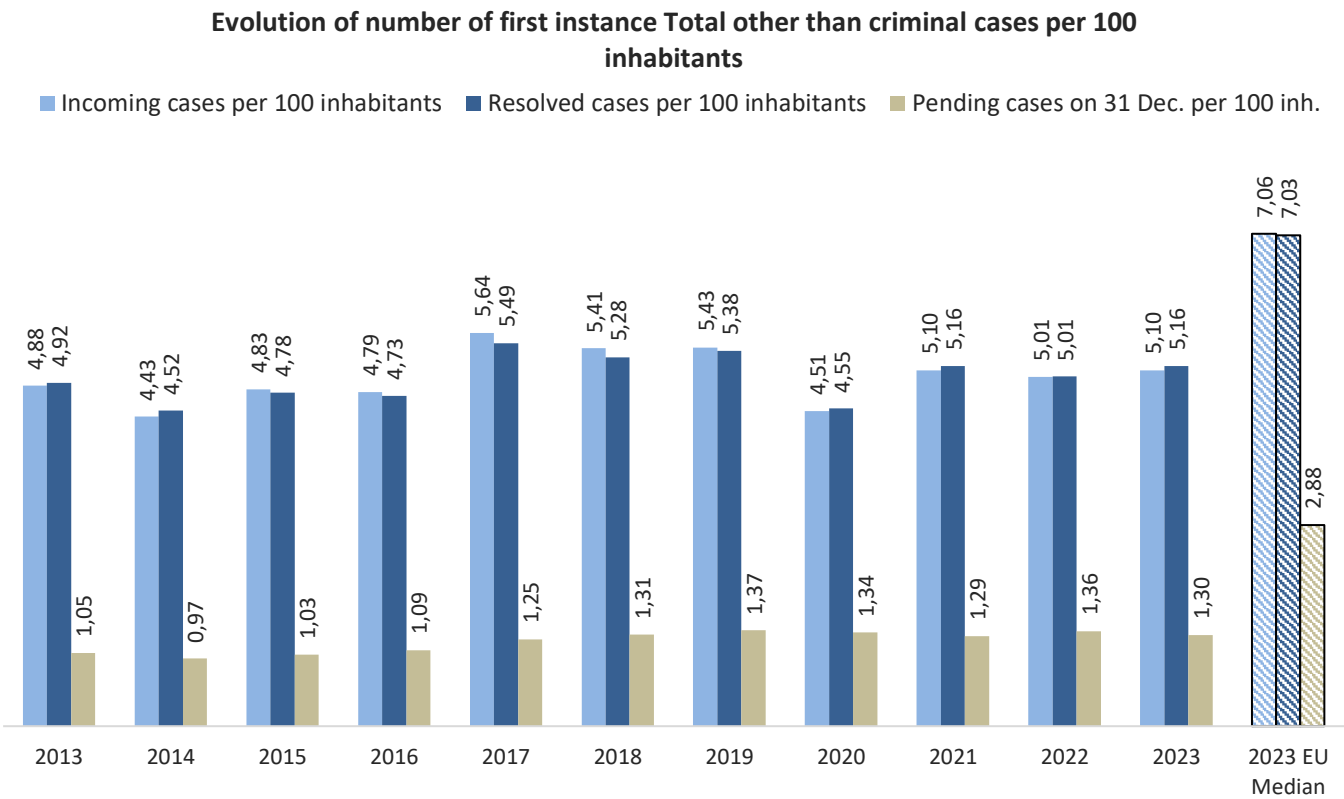

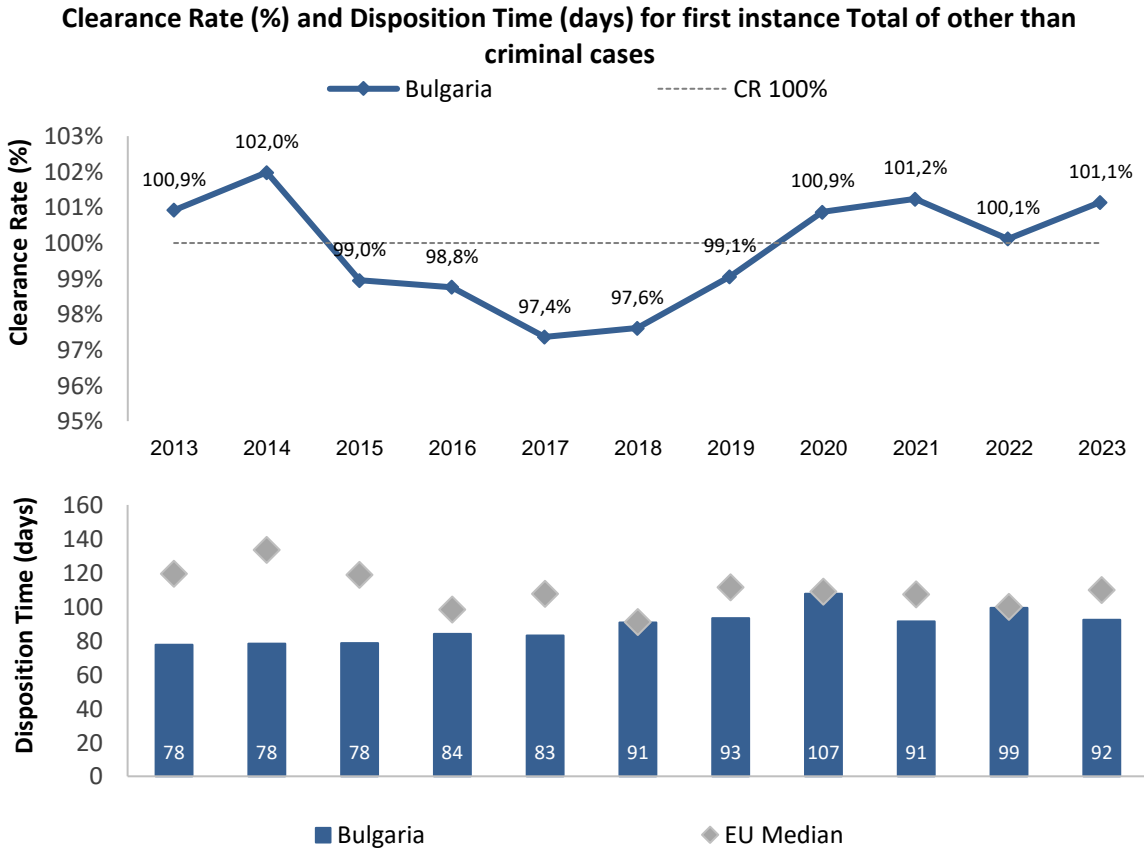

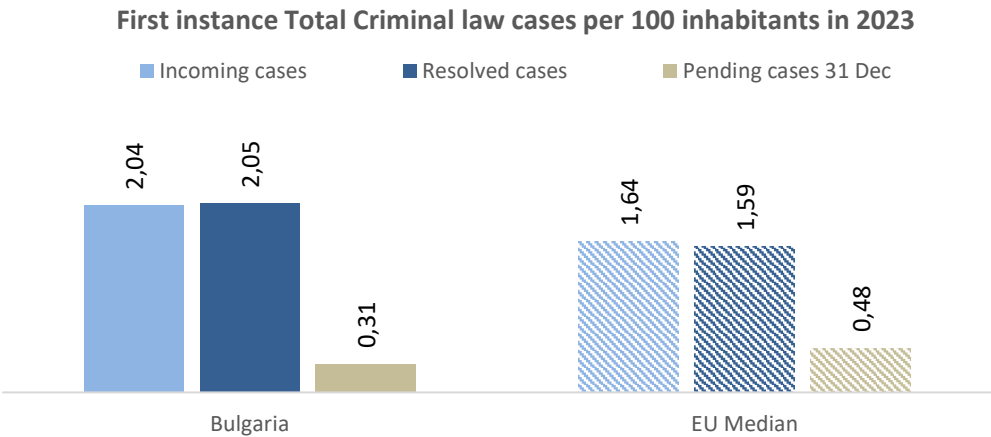

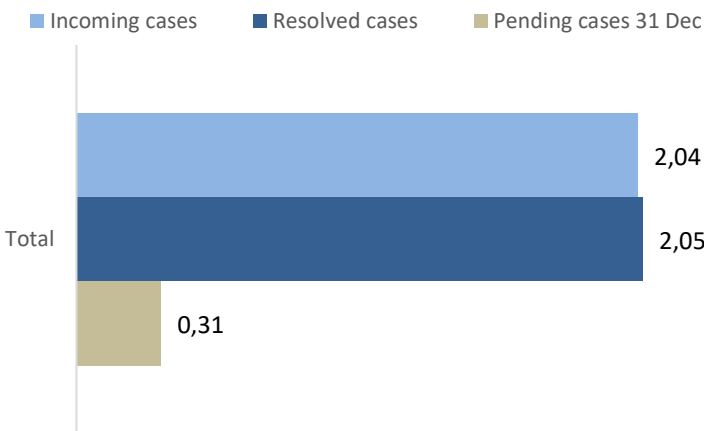

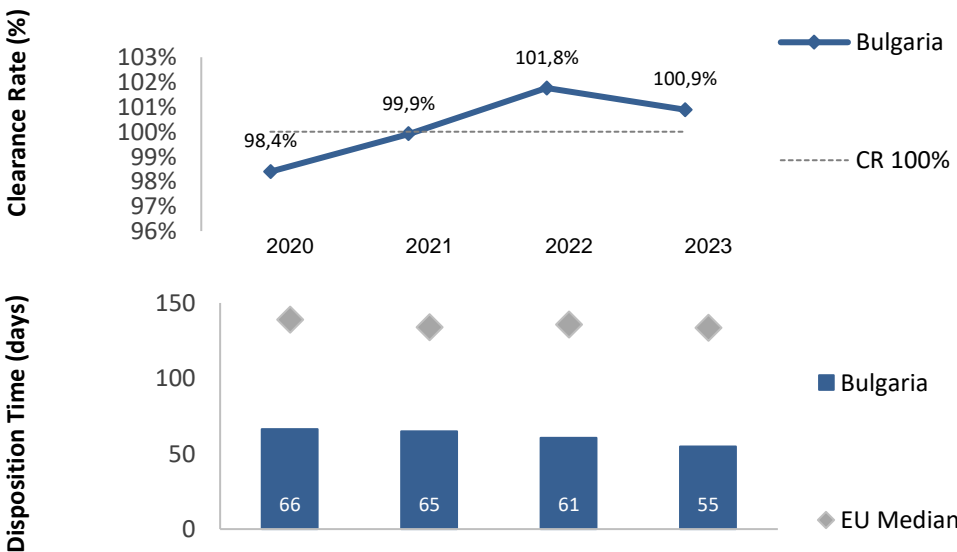

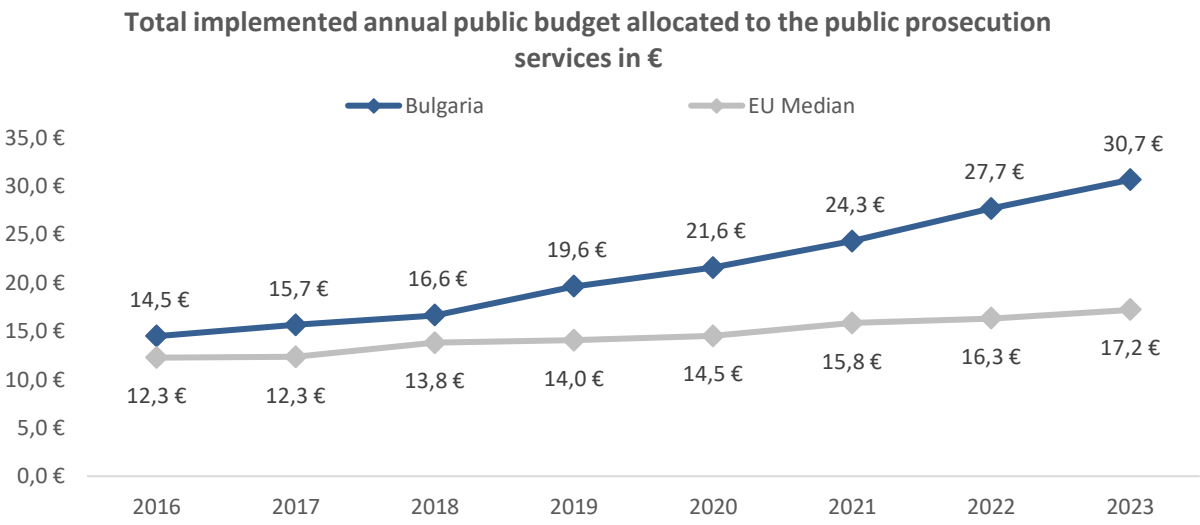

The Prosecutor's Office prepares a consolidated budget for all units, namely district, regional, military-regional, appellate, military-appellate prosecutor's offices, the administration of the European delegated prosecutors, training and rest bases and submits it to the Supreme Judicial Council (SJC). Pursuant to Article 361 of the Judicial System Act, the budget of the PRB includes all revenues from the activity, maintenance costs, relations with the central budget and other budgets.

There are objective reasons for the high growth in the approved (and respectively implemented) training budget in 2023 compared to 2022. On the one hand, there was higher activity of magistrates in organizing and participating in external trainings (organized by other institutions, forums, etc. with participation fees) after the lifting of the COVID 19 quarantine. On the other hand the in-person trainings in the learning facilities and training centers of the Prosecutor's Office of the Republic of Bulgaria were minimized or not conducted during the coronavirus period according to the internal training calendar.

In addition, by Decision under Protocol No. 8/10.03.2022, p. 3 of the Plenum of the Supreme Judicial Council a positive opinion was expressed that the Prosecutors' Training Base - Recreational Facility "Izgrev" in the town of Byala, assigned to be managed by the Prosecutor General of the Republic of Bulgaria, should be provided for temporary use by evacuating representatives of the judiciary in the Republic of Ukraine and their family members and/or Bulgarian citizens and Bulgarians with Ukrainian citizenship living in Ukraine, including in the event of evacuation. In 2022, due to the accommodation of refugees from Ukraine, the base in Byala could not be used for conducting trainings/seminars, which is also the reason for the higher increase in funds for training magistrates planned for 2023 after the base is emptied of refugees.

“1. Pending cases on 1 January” – pre-trial proceedings (PTP) pending with the prosecutor as of 1 January for which the investigation has been completed by an investigative body and sent to the prosecutor.

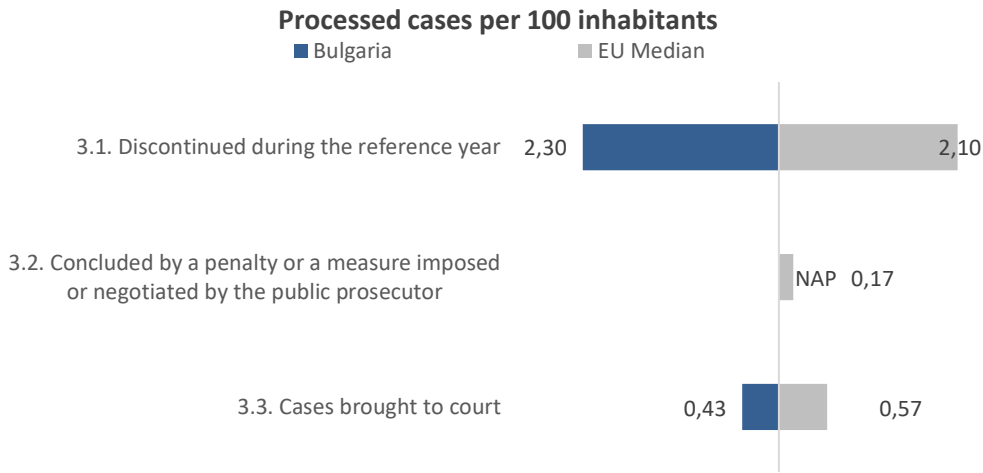
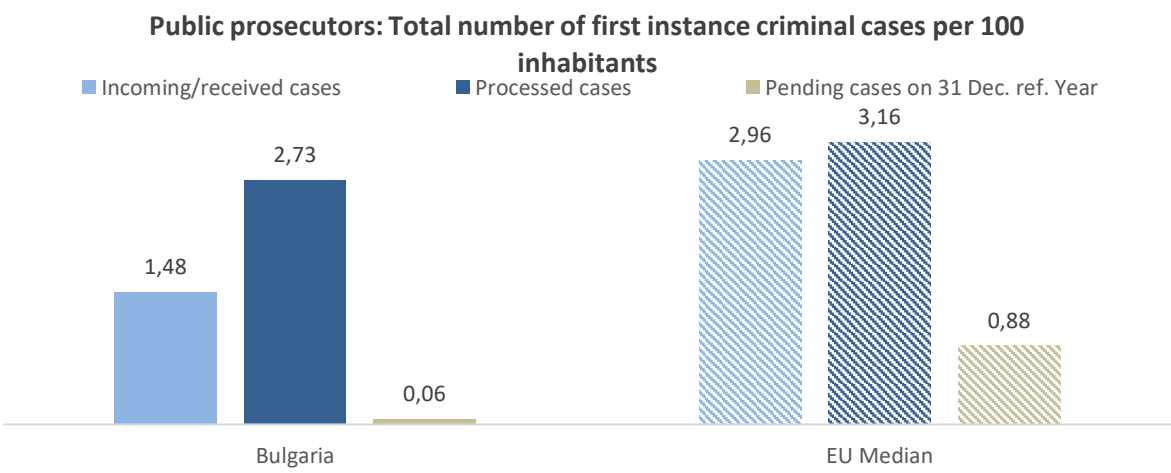

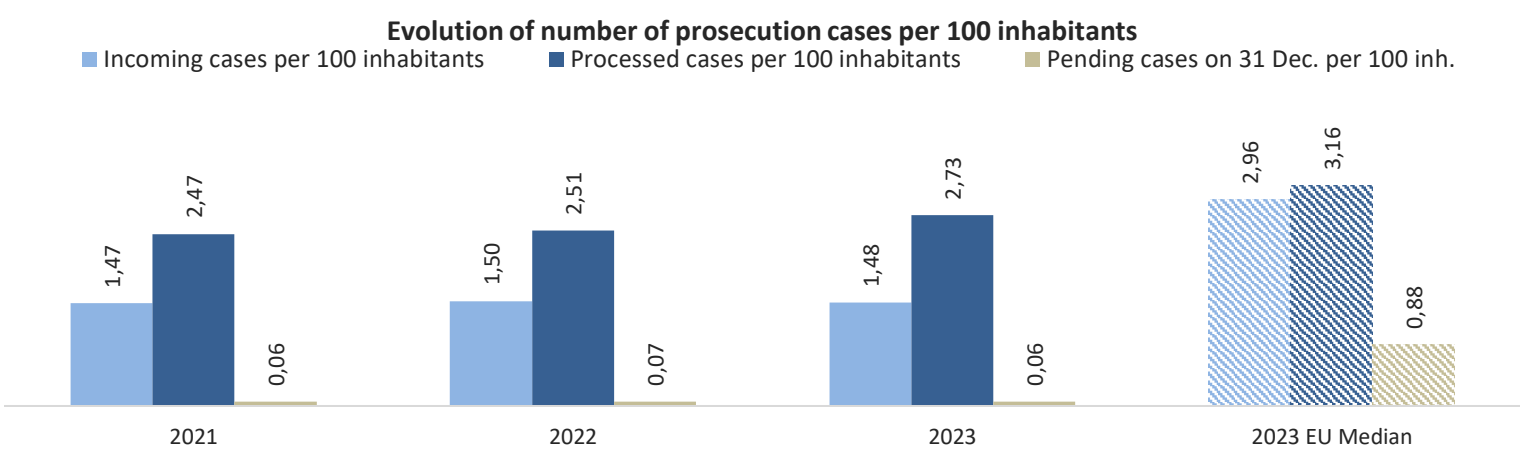
For statistical reporting purposes in the PTP (and not pursuant to the CCP), a pretrial proceeding is reported as resolved when any of the following prosecutor's decisions are made: a decree to send the PTP to the competent jurisdiction, a decree to suspend the PTP, a decree of discontinuance, a prosecutor's act to bring the case to court – indictment, a proposal for a settlement under Article 381 CCP, a proposal under Article 375 CCP, in conjunction with Article 78a CCP, for exemption from criminal responsibility with the imposition of an administrative penalty, and a proposal for a settlement under Article 375a(1) CCP.

The statistical analysis distinguishes between the total number of cases decided in which one of the above-mentioned prosecutor's acts was handed down and the cases decided on the merits. Cases decided on the merits are only those decided by a decision to discontinue the criminal proceedings or by a prosecutor's act to bring the case to court, which concludes the pre-trial phase. PTPs decided by a decision to suspend and refer are not included as they do not end the pre-trial phase/criminal proceedings. PTPs sent to the jurisdiction are reported by the sending prosecutor's office as monitored PTPs and resolved PTPs, but are not reported as PTPs closed by the investigating authority. PTPs discontinued due to the expiry of the statutory limitation period (under Article 24(1)(3) CCP) shall be counted as PTPs observed and decided, but shall not be counted in the number of PTPs discontinued as they were already counted as such when they were discontinued. Suspended PTPs in previous periods are not counted in the total number of PTPs observed during the reference period, except in cases where the suspended PTP is resumed, where it is included in the number of PTPs observed and according to its current status at the end of the period.

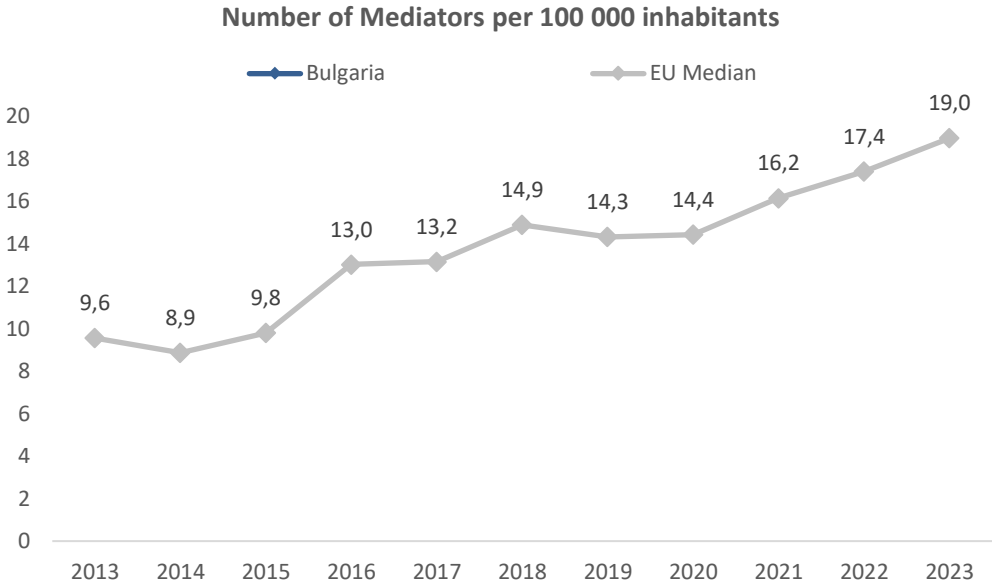

The information about the number of registered court-related mediators is not available. As of December 2023, the total number of mediators registered in the Unified Register of Mediators at the Ministry of Justice is 4692 (for 2023 the number of newly registered is 862).

The requirements that a person must meet in order to be registered as a mediator, according to the Bulgarian legislation, are to be a capable person who has not been convicted of crimes of a general nature; have successfully completed a training course for a mediator; not be deprived of the right to exercise a profession or activity; has a permit for long-term or permanent residence in the Republic of Bulgaria, if the person is a foreign citizen and is entered in the Unified Register of Mediators to the Minister of Justice. A person applying for a mediator must have successfully completed a training course for a mediator in an organisation approved by the Minister of Justice, and those who pass the exam are issued with a certificate of completion of mediation training. Under the current Bulgarian legislation, no work experience is required in connection with the entry of a mediator in the Unified Register of Mediators. As a requirement for registration as a mediator, the person must have legal capacity, not have been convicted of a crime of a general nature and if he is a foreign citizen to have a permit for long-term or permanent residence in the Republic of Bulgaria.

A person applying for a mediator shall submit to the Ministry of Justice an application for registration in the ERN in accordance with a form approved by the Minister of Justice. The application shall be accompanied by: 1. a certificate according to a standard form for successfully completed training course for mediator in an organization approved by the Minister of Justice; 2. a criminal record document, where the person is not a Bulgarian citizen, as the data on the criminal record of the Bulgarian citizens shall be established ex officio; 3. a declaration that the person has not been placed under guardianship, has not been deprived of the right to exercise a profession or activity and does not perform functions of administration of justice in the system of the judiciary; 4. a document for paid state fee, except when it is paid electronically. Where the requirements of the Act are met, the Minister of Justice shall, within 30 days of the submission of the application, issue a certificate to the mediator for his/her entry in the Unified Register of Mediators kept by the Ministry of Justice.

In 2023, there are 702 notaries which represents 10,9 notaries per 100 000 inhabitants.

Notaries and Notarial Practice Act regulates the legal status of notaries and of the Notary Chamber, the organisation of the notarial practice and notarial fees. Notaries are private persons who are entrusted by the State with the performance of notarial acts as provided for in the laws. They are independent in the performance of their duties and comply solely with the law. The Minister of Justice exercises control over the practice of each notary as to the implementation of the law and the Statute of the Notary Chamber of Bulgaria. The Council of Notaries also has the power to monitor compliance with the obligations of the notaries and the assistant notaries, and may take part through its representatives in disciplinary proceedings against such notaries and assistants in the prescribed cases. The notary procedures are stipulated by the Civil Procedure Code (Articles 569-594).

Comments on writing assistance tools

By Decision of the Plenum of the Supreme Judicial Council under protocol No. 25/29.09.2023, the designed software for accelerated creation and reproduction of acts and other documents through dictation and automatic conversion of voice recording into text /voice-to-text/ and accompanying processing systems are approved and implemented in all judicial bodies.

8. Systems for measuring and evaluating the performance of courts and public prosecution services in Bulgaria (2023 data)

In Bulgaria, quality standards are determined for the judicial system at national level (e.g. quality systems for the judiciary and/or judicial quality policies). Specialised personnel within the courts and the public prosecution services is entrusted with implementation of these national level quality standards.

The Inspectorate to the SJC checks the organization of the initiation and movement of judicial, prosecutorial and investigative cases, as well as the closing of cases within the established terms and in case of violations, signals the administrative head of the relevant body of the judiciary and the relevant College of the Supreme Judicial Council; sends signals, proposals and reports to other state bodies, including the competent bodies of the judiciary; examines applications against violation of the right to examine and resolve cases within reasonable time.

The Judges' College of the SJC annually analyses and reports the degree of workload of the bodies of the judiciary; requests and summarizes every 6 months information from courts about their activity; resolves questions about the organization of the activity of the relevant system of judicial authorities; adopts rules for the allocation of cases between the judges who consider cases allocated according to Art. 9, para. 3, in order to equalize their total workload; determines the number of judicial officers according to the degree of workload on the proposal of or after agreement with the administrative heads of the bodies of the judiciary, and may open new and lays off positions.

The Plenary of the SJC on the proposal of one of the Colleges, after coordination with the administrative heads of the bodies of the judiciary, determines the number of judges, prosecutors and investigators in all courts, prosecutor's offices and investigative departments according to the degree of workload; hears and accepts the annual reports of the bodies of the judiciary under Art. 84, item 16 of the Constitution.

Approved by the Prosecutor General/ chief prosecutor is the Directive on the control activity of the Prosecutor's Office, aimed at ensuring the exact and uniform application of the laws in the performance of the functional duties of the prosecutors and investigators. The Directive regulates the conditions, order and procedures for carrying out control activities through audits, checks and analyzes of the work of the prosecutor's offices, the National Investigation Service, as well as individual prosecutors and investigators, outside of the institutional and official verification of the legality of their acts.]

Other: the Inspectorate to the Supreme Judicial Council, pursuant to Art. 54 of the Judiciary System Act, examines the organization of the administrative duties of the courts, prosecutor's offices and investigative bodies; reviews the organization of the initiation and motions of court, prosecutor's and investigative proceedings, as well as the closure of cases within the established deadlines; analyzes and summarizes the cases that have been closed by a final court act, as well as the closed files and cases of prosecutors and investigators, adopting a procedure for regular reporting and publication of the results of the analysis and summary of the closed cases; in the event of contradictory judiciary practices, observed in the execution of work pursuant to Article 54(1)(3) of the Judiciary System Act, notifies the respective authorities to request the adoption of interpretative decisions or interpretative rulings; performs integrity and conflict of interest checks for judges, prosecutors and investigators on their property declarations, as well as on the detection of actions that violate the reputation of the judiciary and those related to the breach of the independence of judges, prosecutors and investigators; reviews applications against the hearing and settlement of cases within a reasonable timeline, prepares an annual programme for planned inspections and an annual report on its activities, submitted to the Plenum of the Supreme Judicial Council; adopts a model for reporting on the settlement of cases within the legal timeline in the performance of duties under Article 54, (1)(2) of the Judiciary System Act, in coordination with the Supreme Judicial Council; prepares annual summaries of good and bad practices in terms of compliance with the ethical rules in accordance with the relevant European and international standards in relation to the abovementioned checks and provides the information to the relevant Colleges of the Supreme Judicial Council.

In Bulgaria, there is a system to regularly evaluate the activity of each public prosecutor both quantitatively and qualitatively.
