






Incoming cases per 100 inhabitants

1. Judicial organisation in Greece (2023 data)

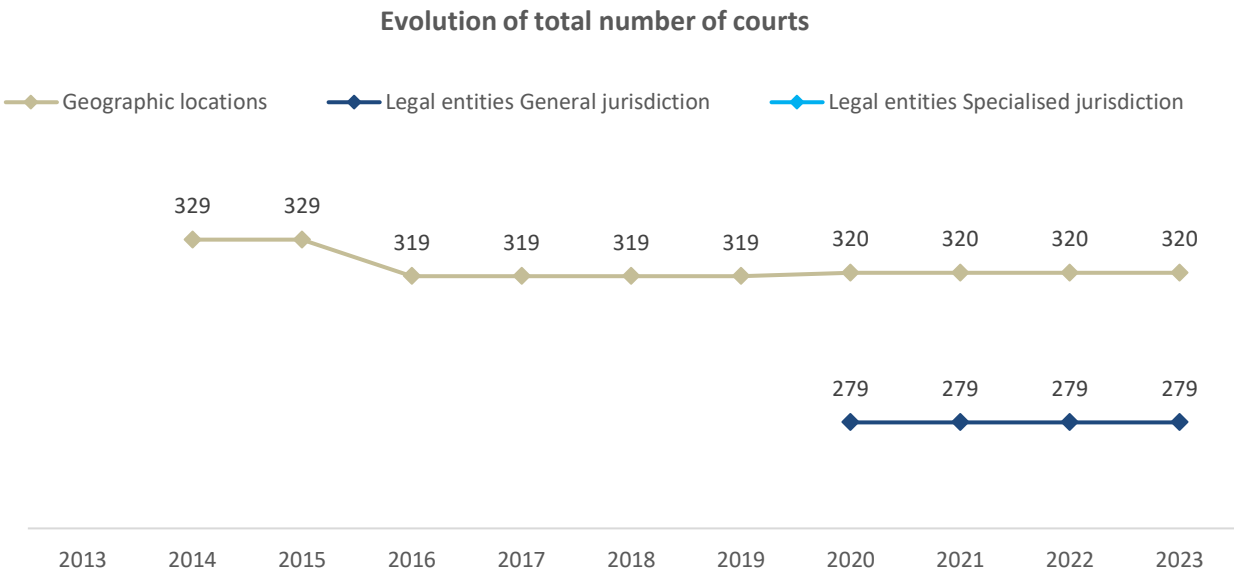
In Greece, in 2023, the total number of courts of general jurisdiction (legal entities) is 279. There are 259 first instance courts of general jurisdiction (196 Local and District Criminal Courts and 63 Courts of First Degree). There are 19 second instance courts of general jurisdiction and the Supreme Court as the highest court of general jurisdiction (Areios Pagos).

The accurate number of first instance specialised courts encompassing administrative courts, military courts and other courts is not available. However, it is reported that administrative courts include 30 first instance courts, 9 second instance courts and 1 Supreme Court (the Council of State) that is considered as one of the three Supreme Courts in Greece. The higher instance other specialized court is the Court of Auditors that is also considered as one of the three Supreme Courts in Greece.

There are in total 320 courts as geographic locations, among which 289 are acting at first instance.

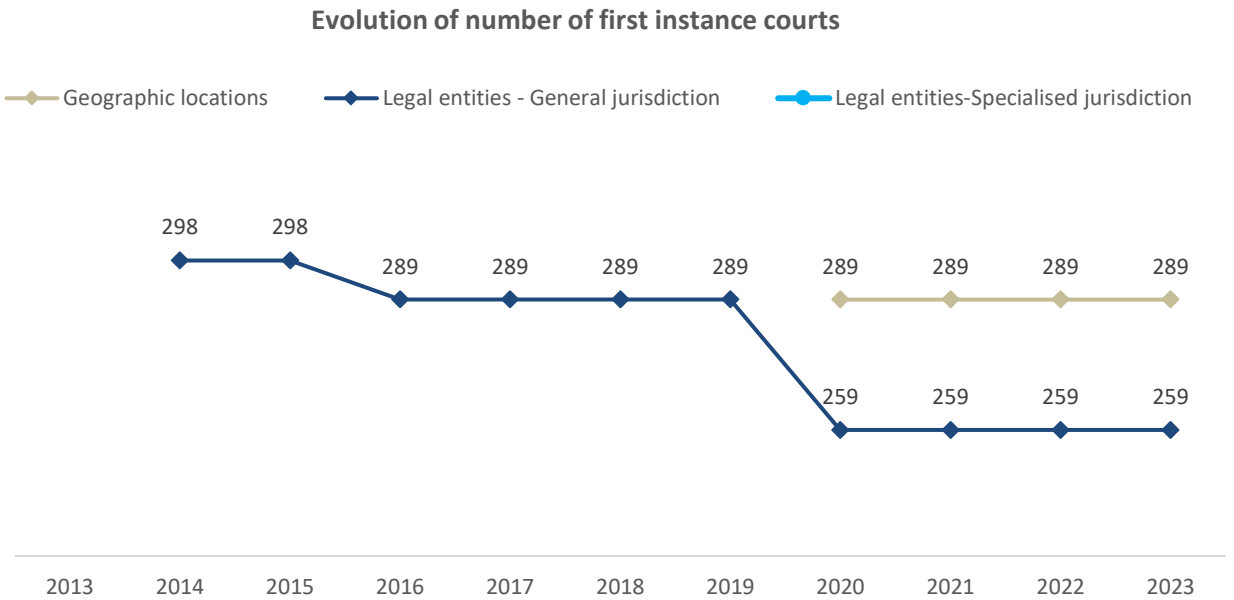

In Greece, there are no special courts for the fields of law described above, besides those already mentioned. The Greek Constitution is reluctant to provide specialised courts in the Greek legal system. Instead, within the Courts of First Instance and Courts of appeal of large cities there are special chambers, where the task of adjudicating in special categories of law (e.g. family law, commercial law, etc.) is assigned. Judges entrusted with such duties have usually the correspondent specific studies.

As far as other special courts are concerned, special provisions regulate the operation of courts for military, navy and air force courts. It should be noted that these courts are under the jurisdiction of the Ministry of National Defence, therefore there is no further information.

Administrative courts include: 30 first instance courts, 9 Appeal courts and 1 Supreme Court (the Council of State).

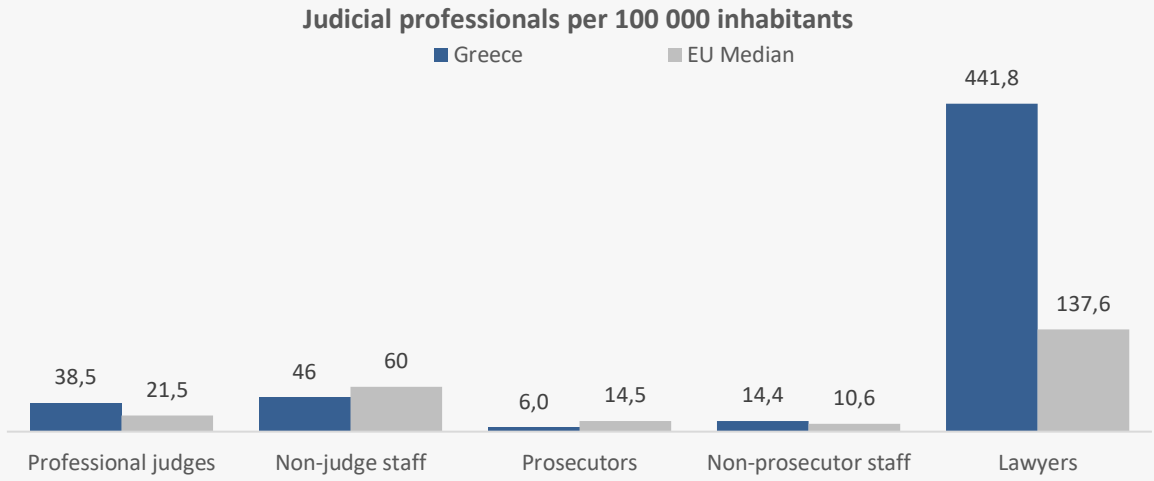
The "Other specialised courts" include the Court of Auditors which is one of the three Supreme Courts in Greece.

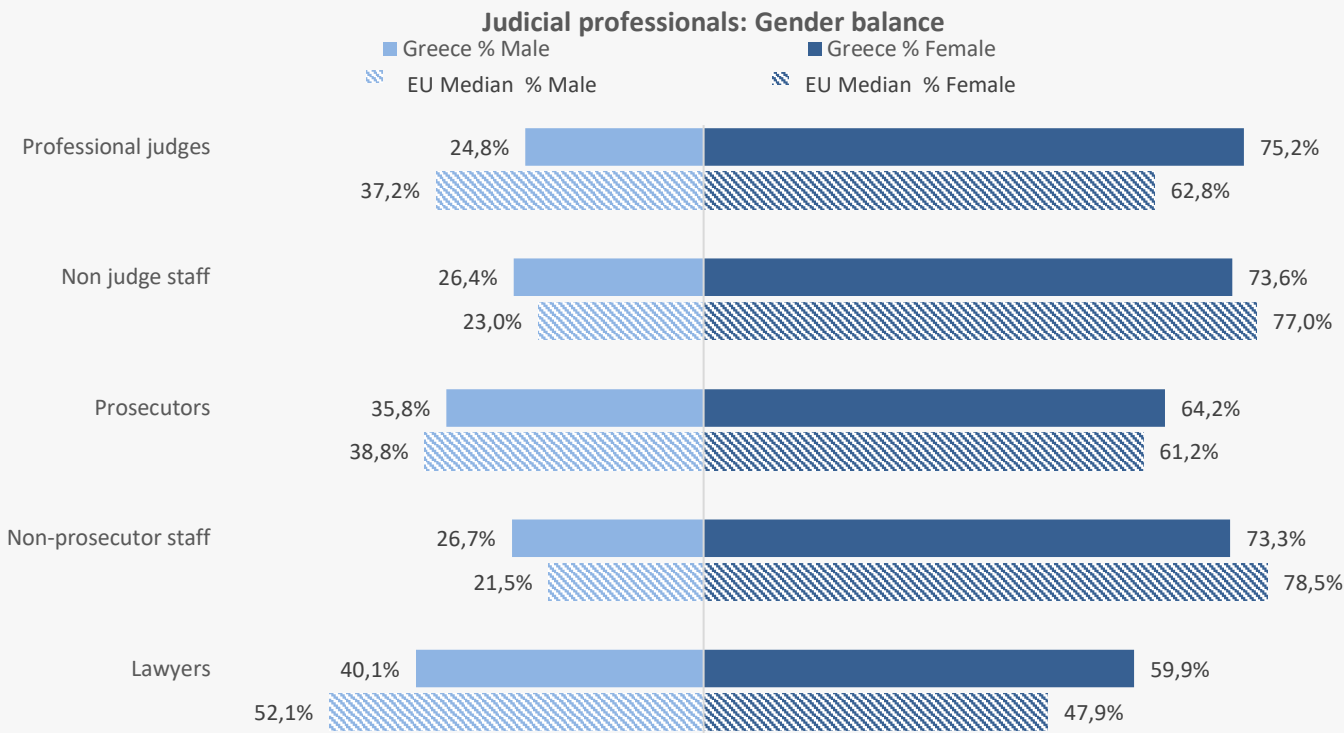

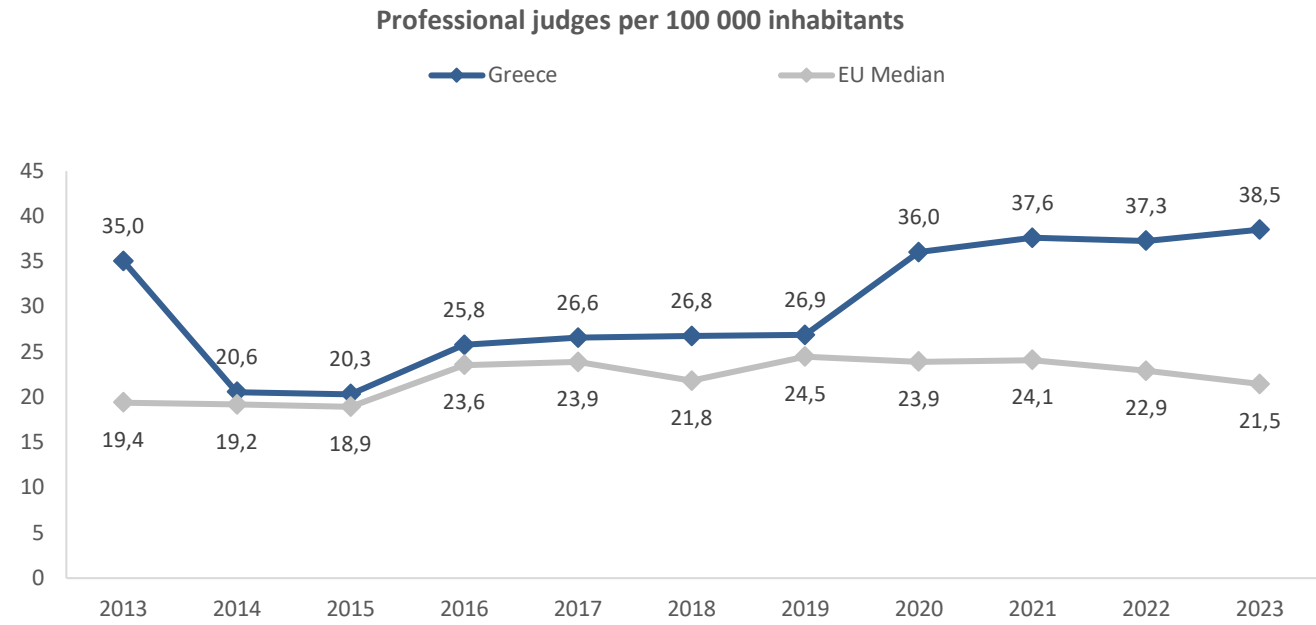

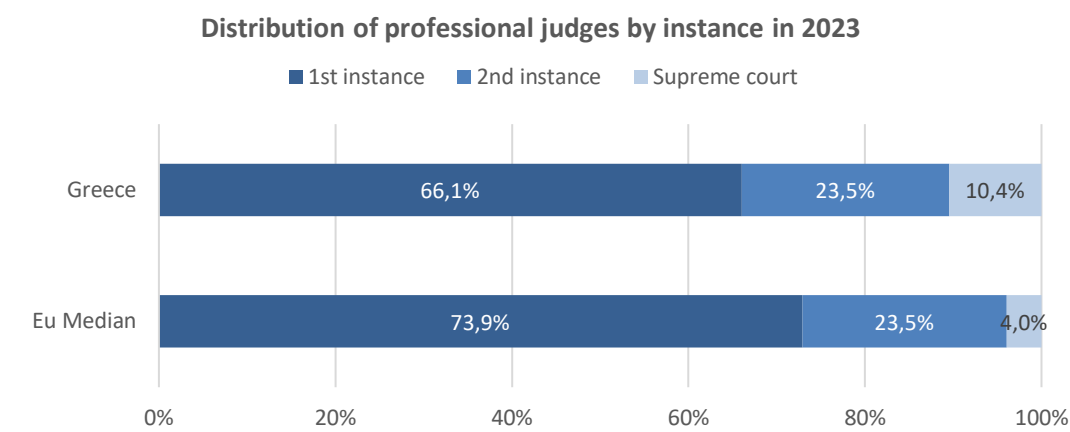


According to 2023 data, the total number of professional judges sitting in courts (all instances) in Greece is 4 012, which is 0,8% more than in previous cycle.

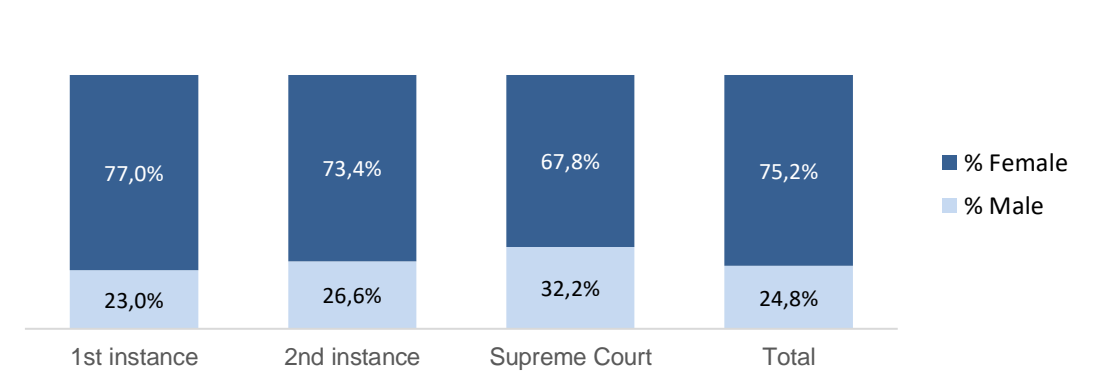

In this cycle, the total number of female professional judges (all instances) is 3 017, which represents 75,2% of the total number of judges.

The total number of judges is distributed among the different judicial instances in the following way: 2 650 are sitting in the first instance courts (of which 2 041 are female); 943 are sitting in the second instance courts (of which 692 are female) and 419 are sitting at the Supreme Court (of which 284 are female).

Compared with the EU distribution of professional judges per instance, there are fewer first instance judges in Greece than in the EU. Second instance judges are at a similar level, while the percentage of third instance judges is more than twice that of the EU.

As regards the distribution of the number of judges among the different judicial instances, it has been pointed out that judges of local courts and district criminal courts are included in the number of first instance judges along with judges of the 63 courts of first degree.

As regards the distribution male/female, it has to be specified that female judges constitute the majority in Greece, exceeding the 65% at all three instances.

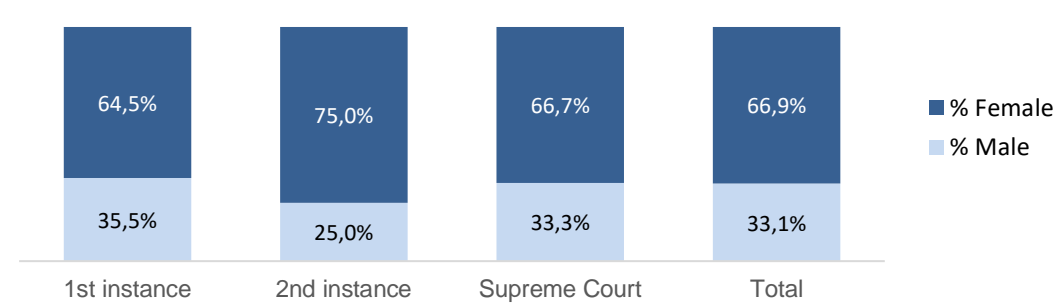

Distribution of court presidents by gender and by instance in Greece



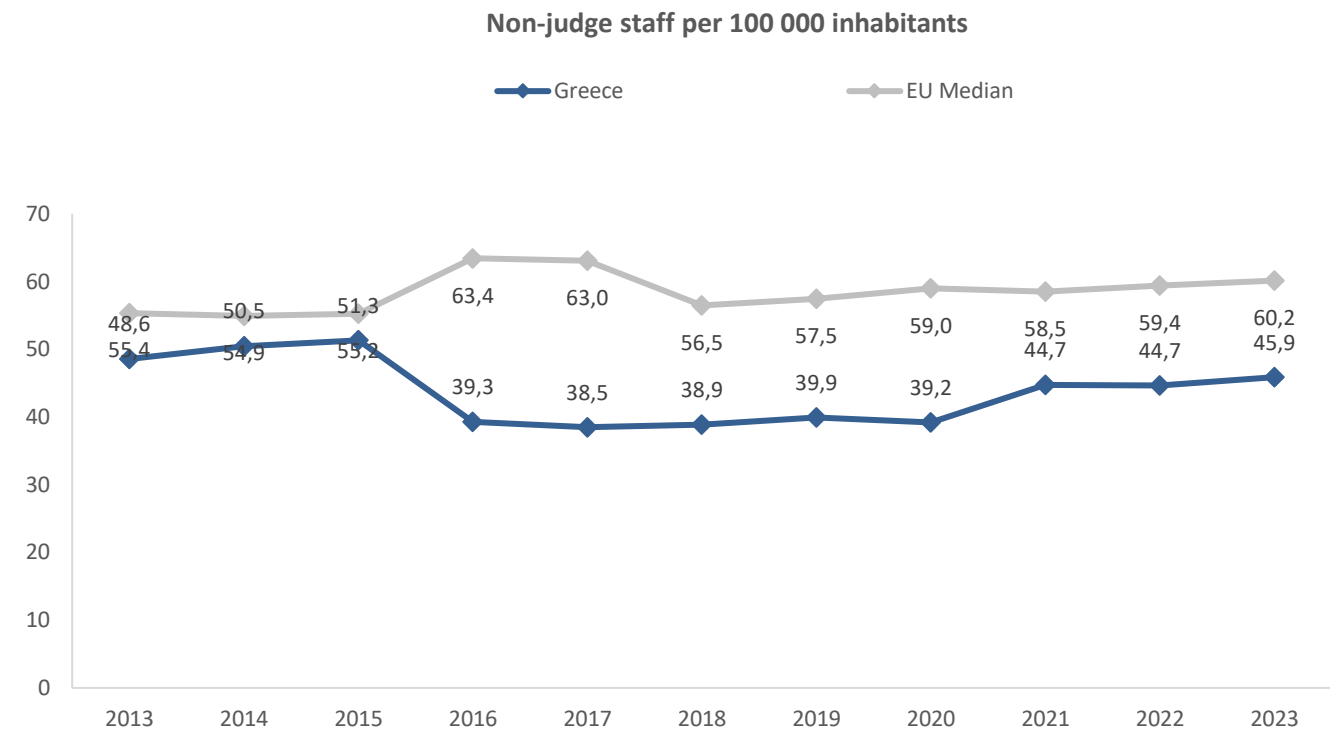
In this cycle, the total number of female court presidents (all instances) is 83, which represents 66,9% of the total number of court presidents.

The total number of court presidents is distributed among the different judicial instances in the following way: 93 are sitting in first instance courts (of which 60 are female); 28 are sitting in second instance courts (of which 21 are female) and 3 are sitting in Supreme Court (of which 2 are female).

The presidents of the courts are responsible for the operation of the courts and the work of the judges. Starting from 2016, information is given on court presidents who have the respective duties. As far as the Presidents of the 63 courts of first degree are concerned, they are also responsible for matters of organization and operation of the local and district criminal courts. Are counted as first instance court presidents the presidents of the 63 courts of first degree and the 30 administrative courts. Are considered as second instance court presidents those of the 19 Courts of appeal and the 9 Administrative courts of appeal. Finally, third instance court presidents are those of the Areios Pagos (Supreme Court), the Council of State, and the Court of Auditors.

In 2023, Greece has 4 776 non-judge staff (of which 3 514 are Female). The total number of non-judge staff in comparison with the previous cycle reveals an increase of 0,1%.

In 2023, the number of non-judge staff per 100 000 inhabitants has increased (from 44,7 in 2022 to 45,9 in 2023).

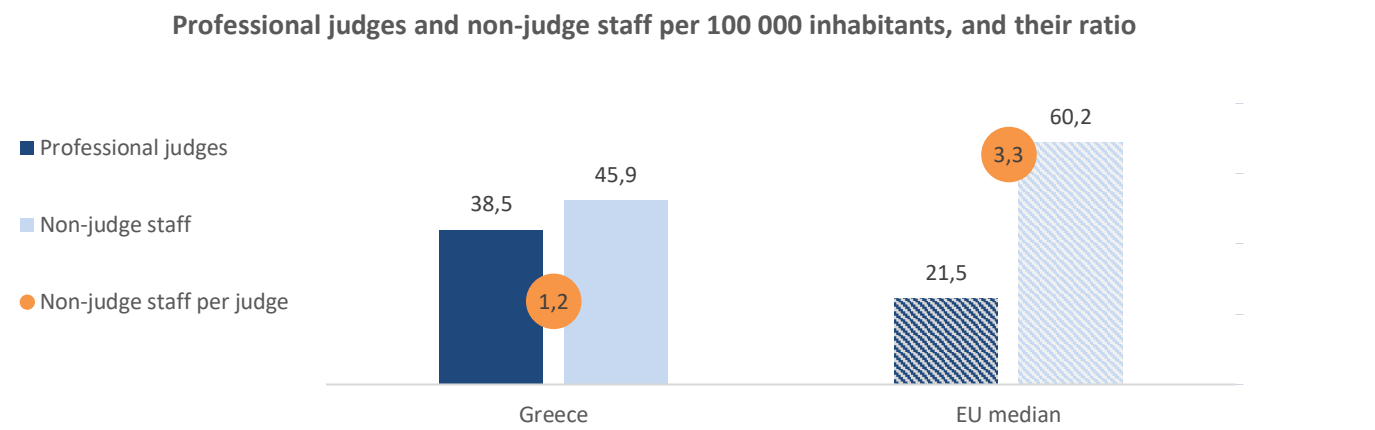

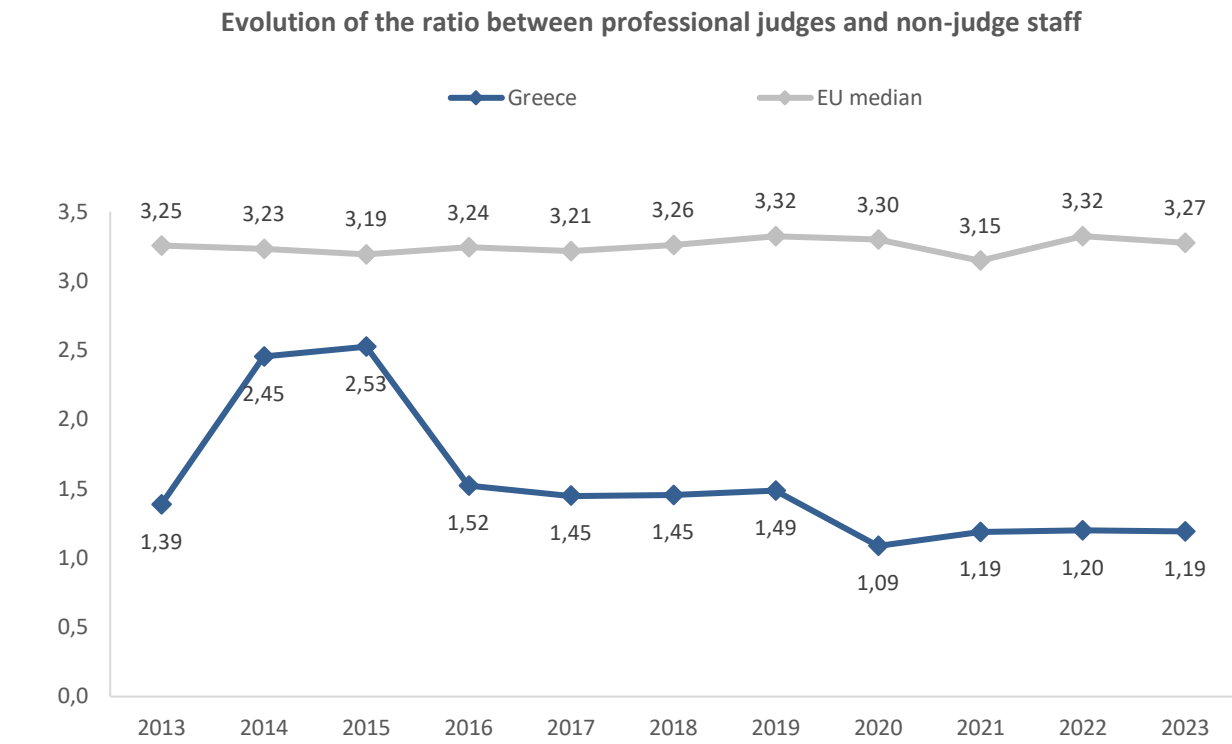

In Greece, there are 38,5 professional judges per 100 000 inhabitants (this figure is above the EU median of 21,5 judges per 100 000 inhabitants) and about 1,2 non-judge staff per judge. There is no significant difference compared with previous cycle when this ratio was also at 1,2 non-judge staff per judge.

Evolution of the ratio between professional judges and non-judge staff

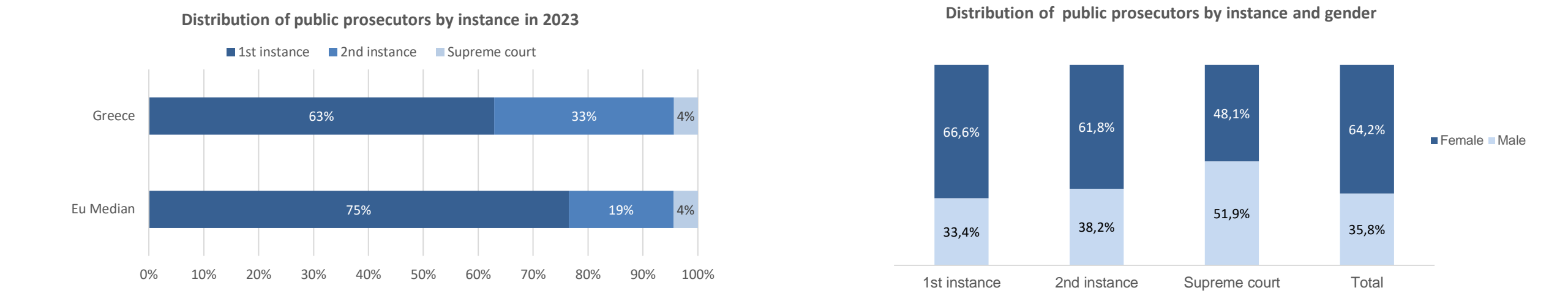

In this cycle, the total number of female prosecutors (all instances) is 400, which represents 64,2% of the total number of prosecutors.

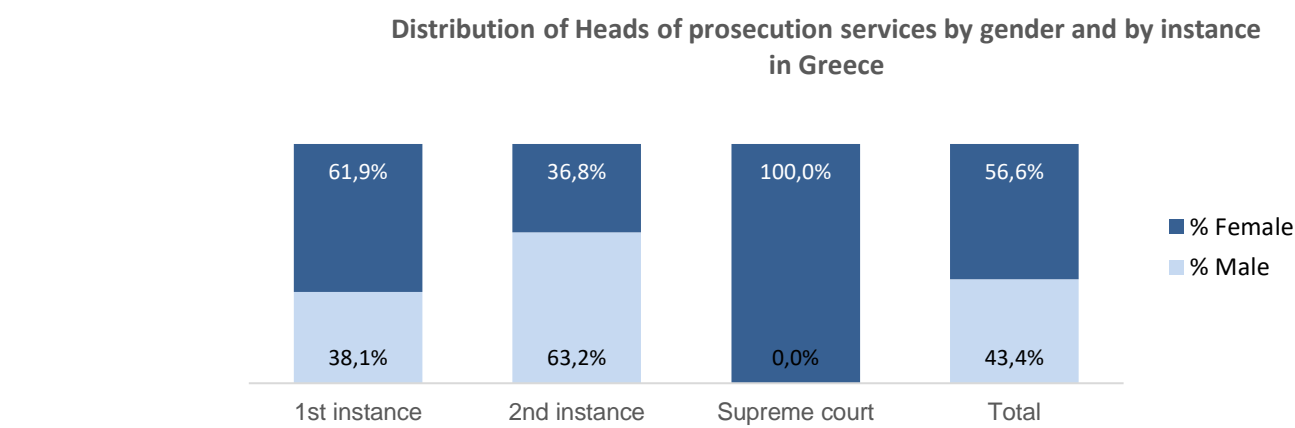
The total number of prosecutors is distributed among the different judicial instances in the following way: 392 in first instance (of which 261 are female); 204 are in second instance (of which 126 are female) and 27 in final instance (of which 13 are female).

As regards the distribution male/female, it has to be specified that female prosecutors constitute the majority except at the final instance where their percentage remains slightly below the 50%.

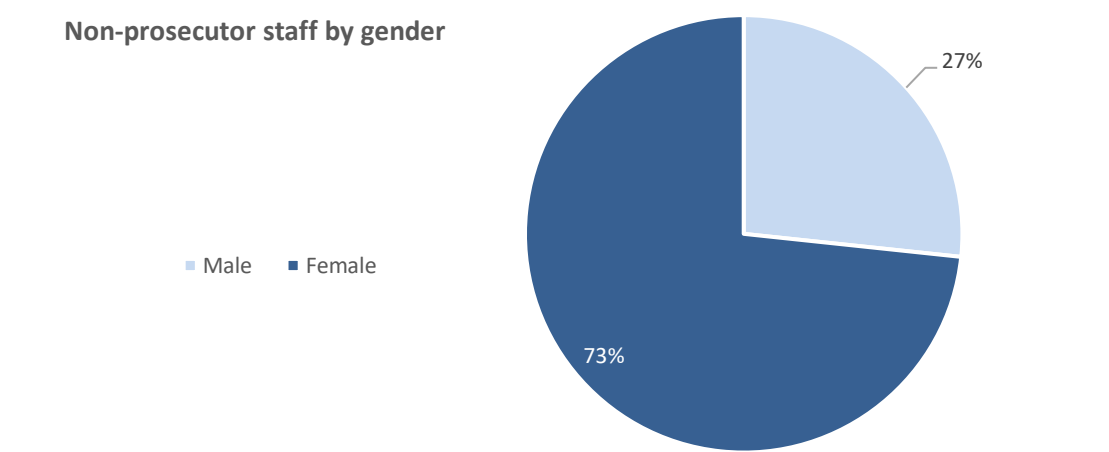


In this cycle, the total number of female Heads of prosecution services (all instances) is 47, which represents 56,6% of the total number of Heads of prosecution services.

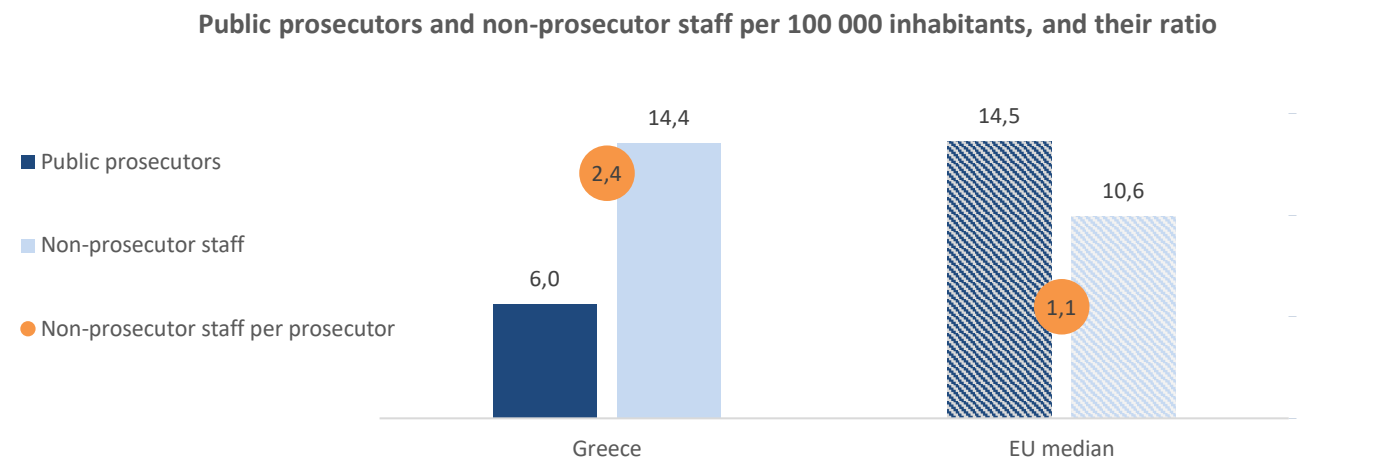

Ratio between non-prosecutor staff and public prosecutors

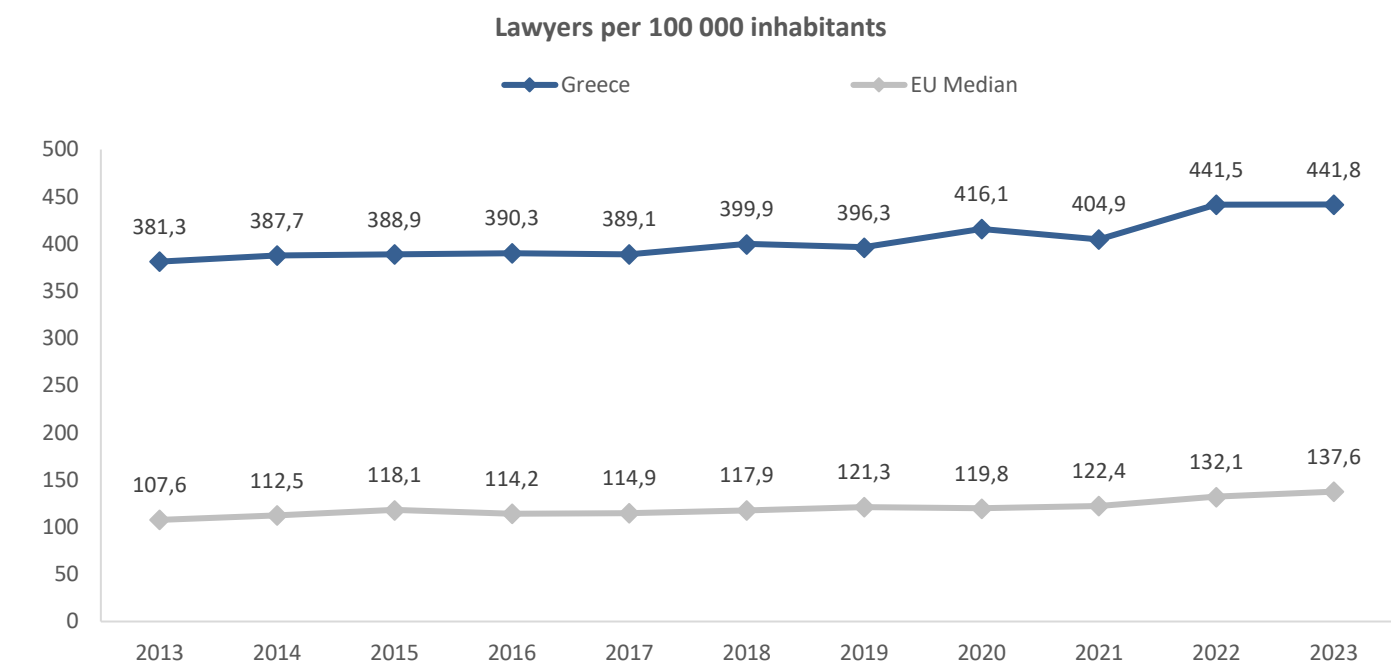

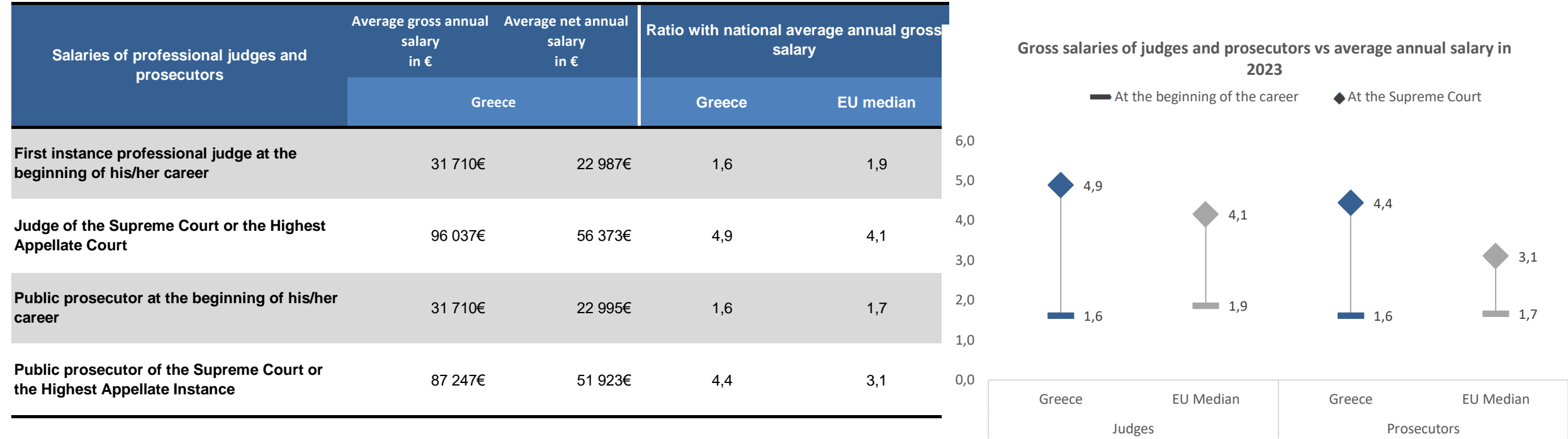

In 2023, there are 46 009 lawyers, which is -2,4% less than in 2022.
There are 27 580 female lawyers which is 60% of the total.

Greece has 441,8 lawyers per 100 000 inhabitants, which is significantly above the EU median of 137,6 lawyers per 100 000 inhabitants.

Salaries of professional judges and prosecutors at beginning of a career and at the highest instance



In the European Union, the absolute gross salary for a judge at the beginning of career ranges from a minimum of 25 759€ to a maximum of 144 856€.

According to 2023 data, the absolute gross salary of a judge at the beginning of his/her career in Greece is 31 710€, which is rather below the EU median of 58 128€. (-45% below)

At the highest level, the range of the EU absolute gross salary for a judge is from 58 623€ to 266 974€. Greece's absolute gross salaries for judges at the highest level is -19% below the EU median of 118 595€

For the public prosecutors, the range for the absolute gross salary at the beginning of career is from a minimum of 25 759€ to a maximum of 101 592€.

In 2023, the absolute gross salary of a public prosecutor at the beginning of his/her career in Greece of 31 710€ is rather below the EU median of 49 953€. (-37% below)

Compared with the annual average salary in the country, the salary for a public prosecutors at the beginning of his/her career is 1,6 times higher. (the EU median is 1,7)

At the highest level, the minimum absolute gross salary for prosecutors in the European Union is 51 456€ and the maximum is 199 670€. Greece's absolute gross salaries for prosecutors at the highest level is -7% below the EU median of 93 759€

It should be noted that the survey based on which data on average national salary are established is conducted on a four-year basis. The most recent data are for 2022 and they became available at the end of 2024. The ratio for salaries of judges and prosecutors in 2023 is calculated using this data.

1. Council of State:

Excessive length of proceedings – just satisfaction: Law 4055/2012 .

Administrative compliance with court decisions: Law 3068/2002. 2. Within 2023, 2 applications for excessive duration of the trial were filed before the Council of State and 4 decisions were issued on applications from previous years, with which the public was imposed a total amount of 15,400 euros as just satisfaction. 3. Within 2023, 42 applications were submitted for non-execution of decisions of the Council of State and 4 decisions were issued on applications from previous years, with which monetary sanctions of 76,000 euros were imposed on the administration.

2. First and second instance Administrative courts:

Excessive length of proceedings: 11 (number of requests for compensation), 6 (number of compensations granted), 10,500 € (total amount of compensation granted)

Non -execution of court decisions: 396 (number of requests for compensation),38 (number of compensations granted), 150,800€ so far, as significant percentage of these cases is still pending.

Before civil and criminal courts, the compensation cases for unjustified delay/excessive length of trial are based on Law 4239/2014 (Government Gazette A 43) "Just satisfaction due to exceeding the reasonable duration of the trial in the civil and criminal courts and in the Court of Auditors and other provisions" under the title "Entitled to bring an application".

The right to compensation is referred to in articles 535 to 544 of the Code of Criminal Procedure. For 2023 compensations paid for wrongful arrest/detention were at least 41,280 € and for wrongful conviction at least 50,140€.

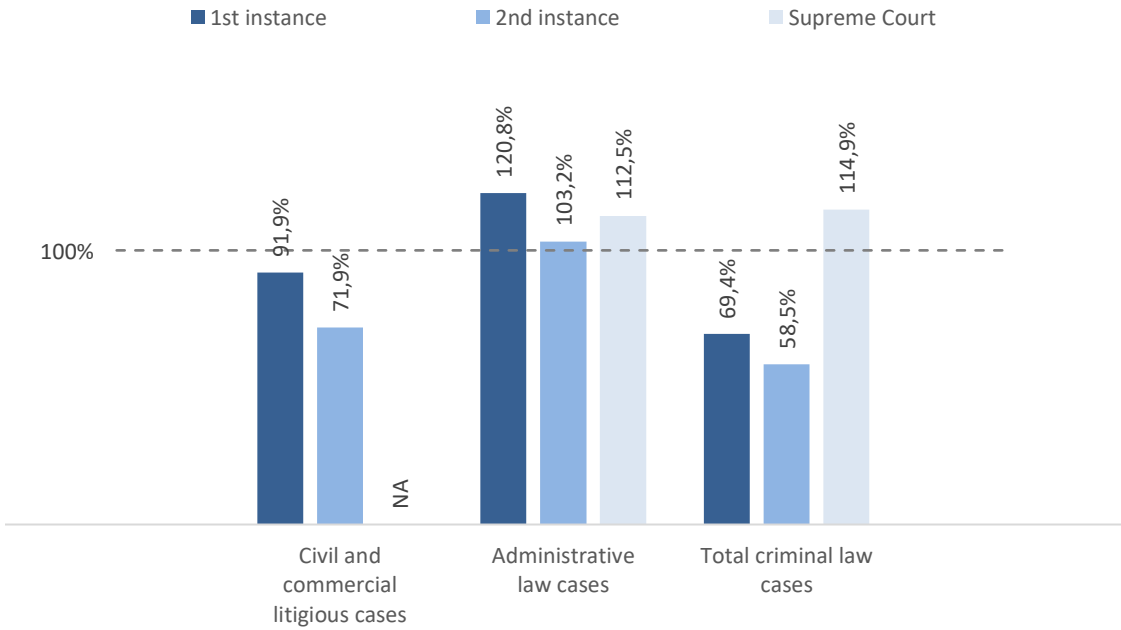
The Clearance Rate shows the capacity of a judicial system to deal with the incoming cases. A Clearance Rate of 100% and higher does not generate backlog.

The Disposition Time determines the estimated number of days necessary for a pending case to be solved in a court.

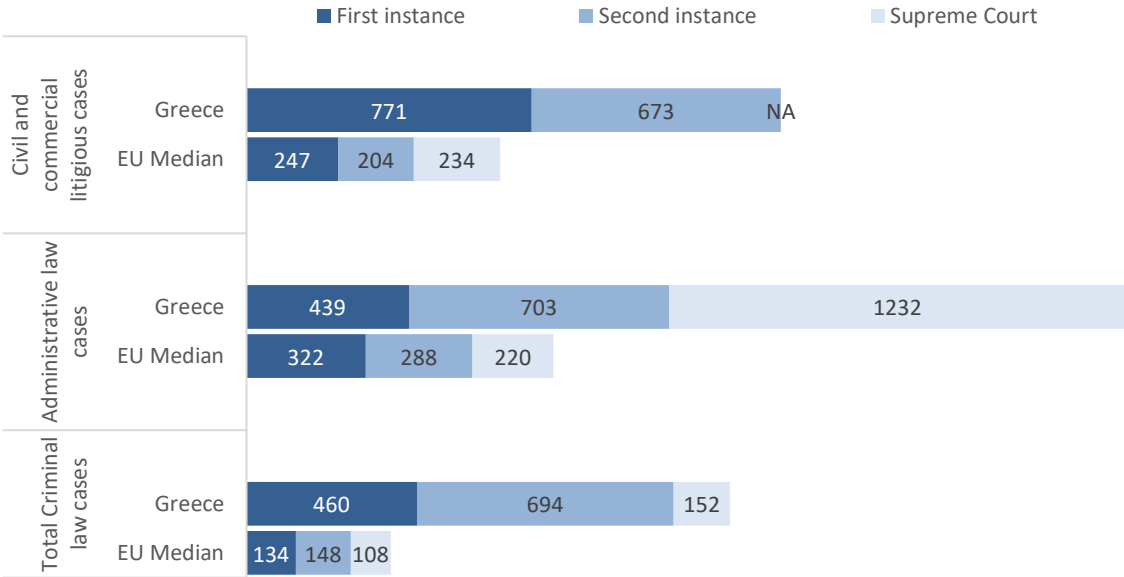

Similar to the EU trend, administrative proceedings (total length of the three instances combined) are longer than criminal proceedings in Greece. However, with regard to civil cases, the analyses are limited by the fact that it is not possible to distinguish between civil litigious and civil non-litigious cases dealt with by the Supreme Court. Accordingly, the efficiency indicators cannot be calculated in respect of third instance civil cases.

The efficiency analyses should be carried out in the light of the particular context of Covid-19 pandemic and the related measures implemented in Greece. The latter were fully implemented on 15 March 2022, when the functioning of the courts gradually started to normalise. This situation resulted in an increased number of pending cases at the beginning of 2023.

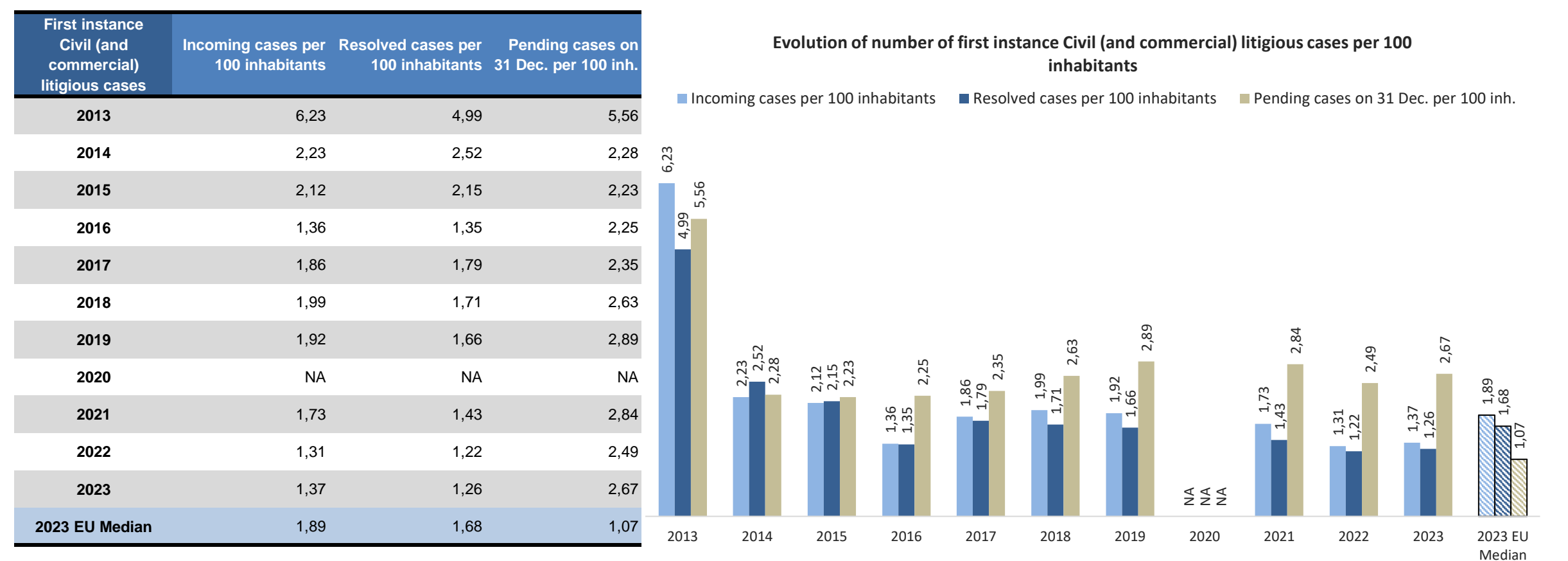
Moreover, it should be mentioned that in 2023 there were 3 consecutive elections in Greece which resulted in the suspension of courts' activity for about 3 months in total.

The situation described above affected above all first and second instance courts dealing with civil and criminal cases. Their Clearance Rate was low for 2023, especially in criminal matters, and the Disposition Time values are high above the respective EU medians.

As to administrative cases, the threshold of 100% Clearance Rate has been exceeded at all three instances. If the Disposition Time indicator improved at first and third instance compared to 2022, it increased at second instance. At all three instances the Disposition Time values remain well above the respective EU medians.

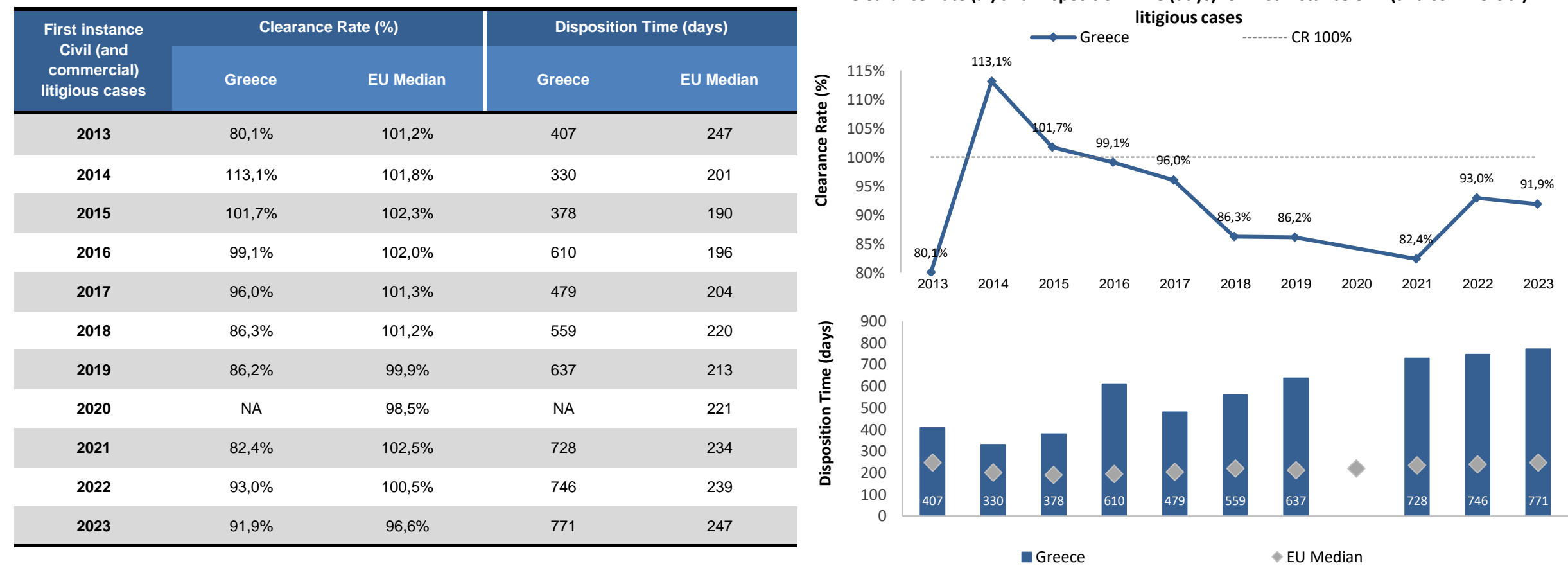

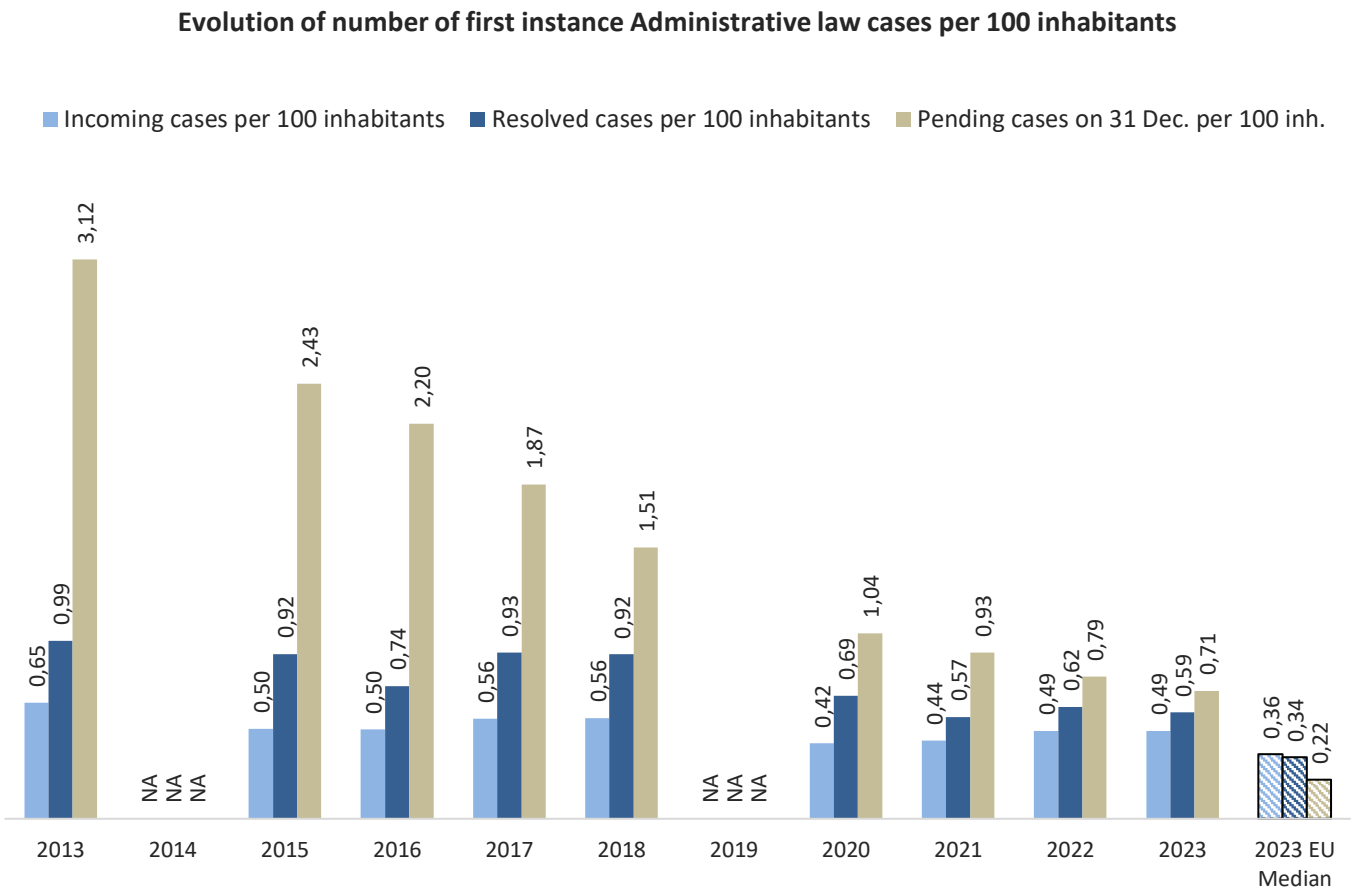

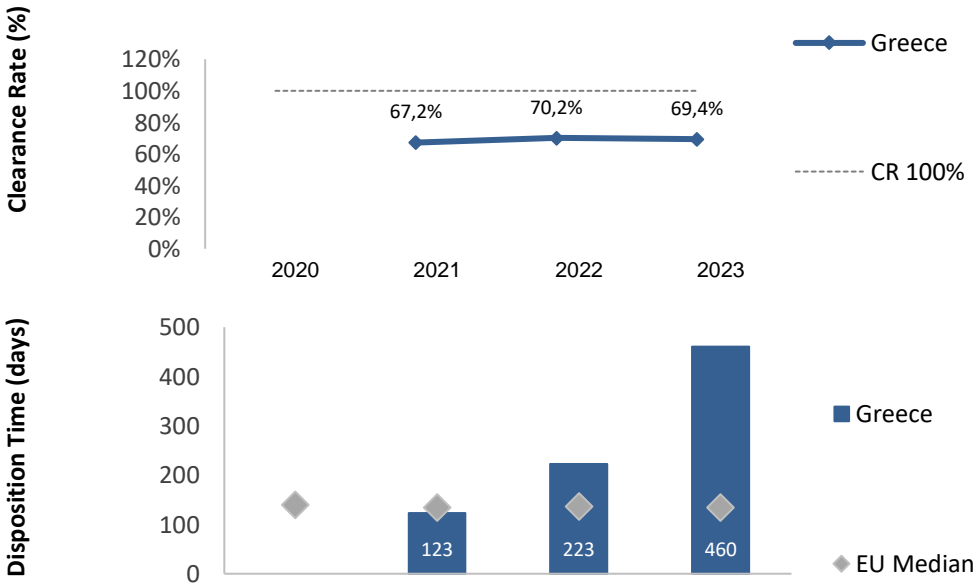

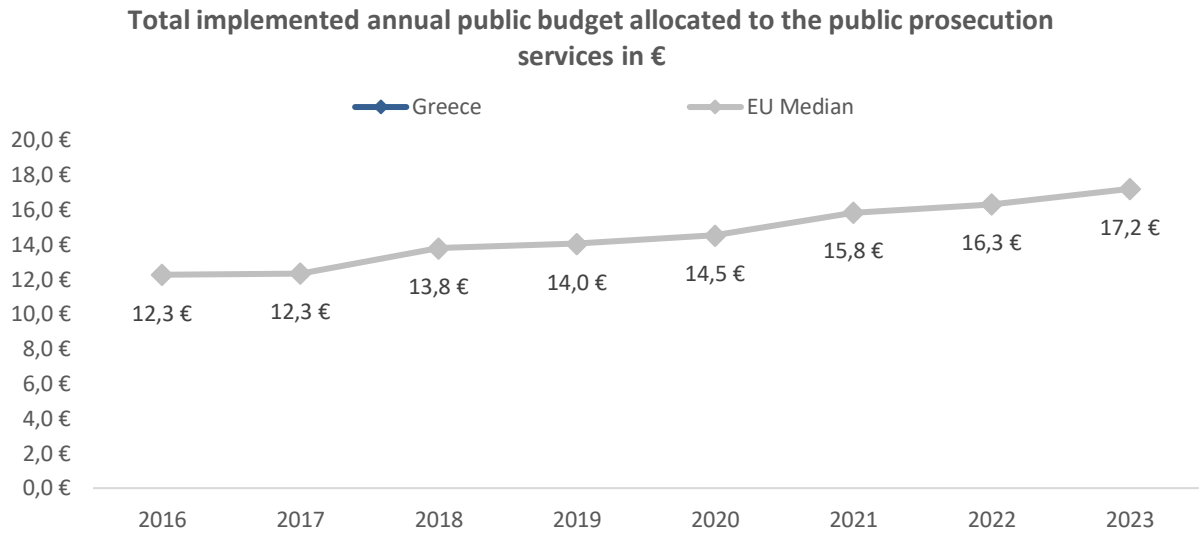
The variations in the numbers should be construed in the light of the pandemic contexte. In the year 2022, courts were, for part of the year, under a restricted regime due to the measures implemented to contain the Covid-19 pandemic. This gave the judges the opportunity, alongside new cases, to deal with cases that had already been heard. At the same time, however, due to the courts not being fully operational, the number of cases to be pending increased at the end of 2022, which were transferred for adjudication in 2023, when the courts were fully operational and consequently the flow of judgments was limited.

Moreover, it should be considered that there were 3 consecutive elections in Greece in 2023, which resulted in the suspension of the courts for about 3 months in total.

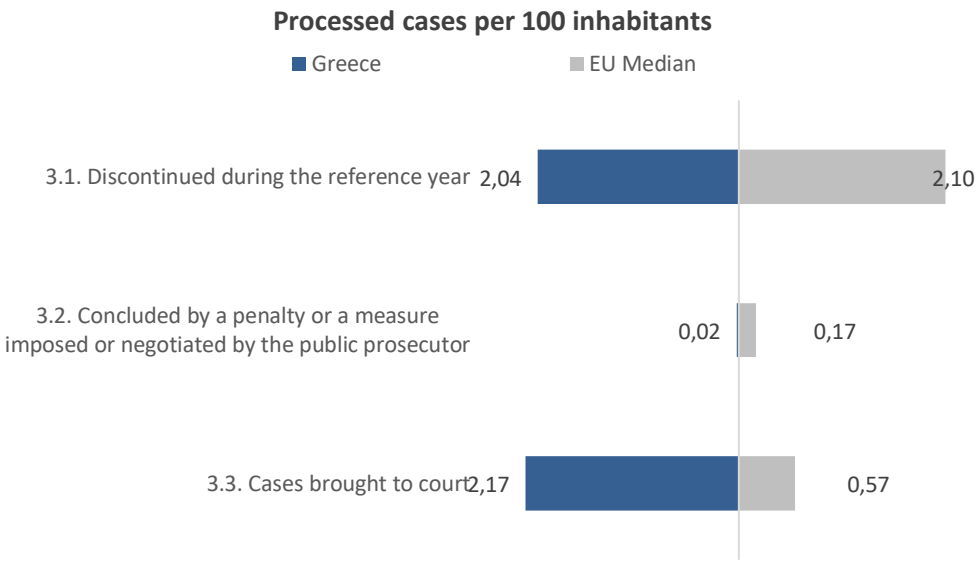
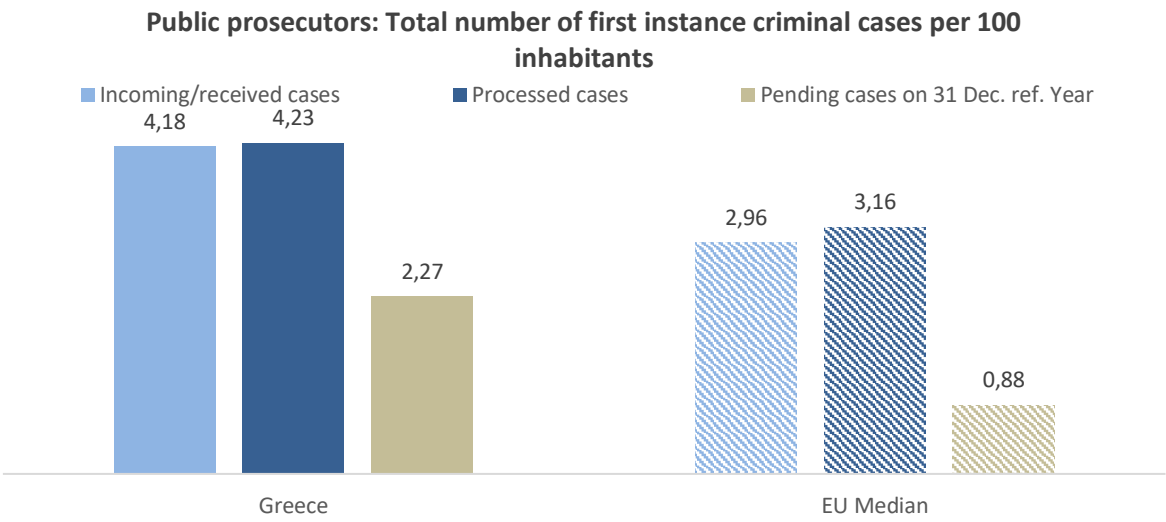

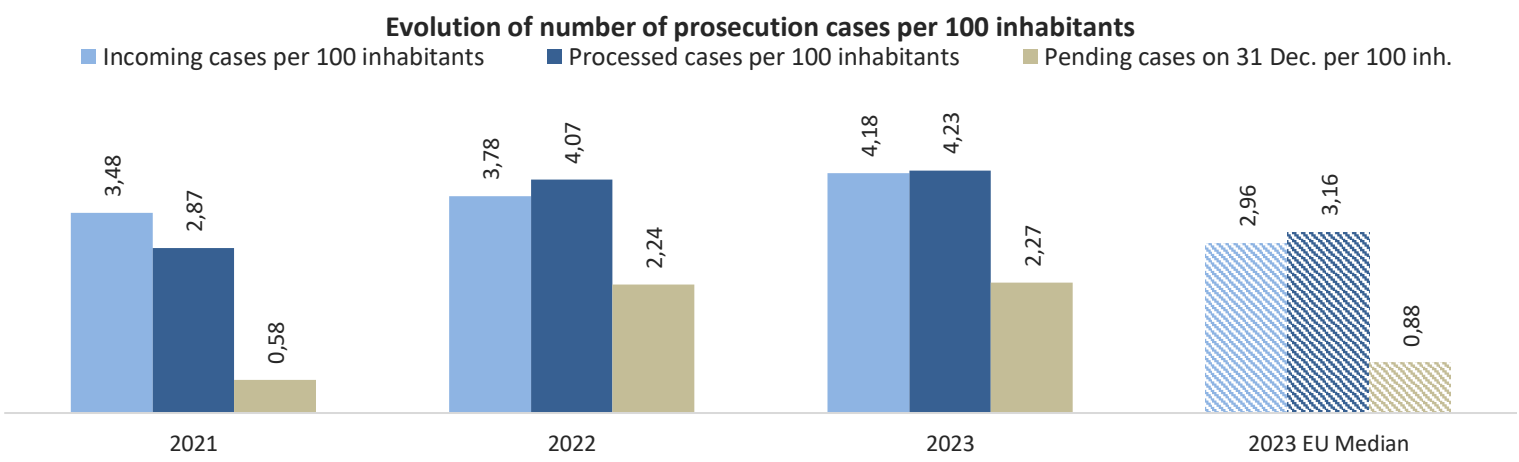
Cases against unknown offenders are referred either to the investigating magistrate (when they are felonies) or to a preliminary procedure (when they are misdemeanors). All cases that are referred to the investigator are returned to the public prosecutor, whether the perpetrator is identified or not. Cases where the perpetrator could not be identified are considered as resolved, while the rest (where the perpetrator is identified) follow further criminal proceedings and are either solved within the reporting period or are considered pending in the next time period. More precisely, cases where the offender could not be identified are placed in the "unknown perpetrator file". Cases placed in the "unknown perpetrator file" are suspended with a decision of the prosecutor and such decisions are counted as " 3.1.1 Discontinued by the public prosecutor because the offender could not be identified".

Concerning the decreases in the number of cases dismissed for reasons of opportunity and cases concluded by a penalty, during the implementation of the restrictive measures related to the Covid 19 pandemic, police activity was greatly increased with constant patrols which resulted in a rapid increase in arrests and consequently in criminal prosecutions for selected offences, such as violation of the drug law. With the expiry of the restraining orders, arrests and criminal convictions decreased.

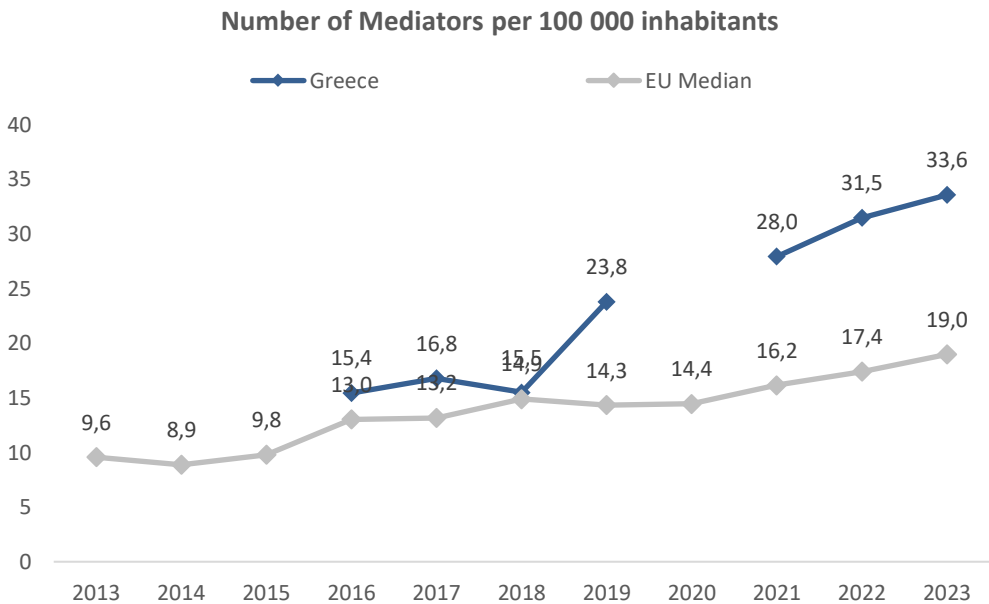

In 2023, there are 3 496 accredited or registered mediators who practise court related mediation which represents 33,6 accredited or registered mediators per 100 000 inhabitants.

The variation of the number of mediators between 2022 and 2023 is about 4,0%.

The training of mediators is ensured by training bodies referred to in Article 22 of law 4640/2019. The aim and responsibility of the training providers is to train the candidate mediators in the principles, the mediation process, the skills of mediators and the other modules provided for by law 4640/2019 for training program. In particular, the trainees acquire the theoretical understanding on which mediation is based and the experiential practical background they need in order to succeed in the exams. The mediation training and education programmes implemented by the training bodies, consist of the following:

- Theory: introduction and general principles of mediation, process evolution, negotiation and communication techniques, conflict analysis, understanding of differences and conflicts, mediation law, legal framework, ethics, confidentiality, personality theory, principles of individual and group psychology, understanding the role of the mediator;
- Practical skills: practice on techniques and skills, role-playing games, simulations, group exercises, case studies.
- Assessment: oral and / or written examinations.

The accreditation of trained mediators takes place after examinations before the Examination Committee of the Ministry of Justice. All the conditions for attending mediator training seminars and participation in mediator accreditation exams are described in N.4640/2019.

Comments on recording of court hearings

In civil and criminal hearings, the recordings are systematic by default. However, the president of the court and/or the presiding judge has discretionary power to decide not to record a hearing.

8. Systems for measuring and evaluating the performance of courts and public prosecution services in Greece (2023 data)

In Greece, quality standards are determined for the judicial system at national level (e.g. quality systems for the judiciary and/or judicial quality policies). Specialised personnel within the courts is entrusted with implementation of these national level quality standards.

Law 4938/2022, article 102 par.4 subsection, includes among other evaluation elements the quality of the judges' work with the additional consideration of any successful appeal or cassation against their decisions. The inspector examines, among other things, the quality of their work, i.e. the processing of the legal and factual part of each case and takes into account the cassation or appeal of the decisions drawn up by the inspectors upon admission of the respective legal remedy during the inspected period as well as the wording of the judicial decisions.

Article 104 refers to plenary of the Supreme Courts issuing directions in conjunction with Article 102 which refers to assessment criteria. From the combination of articles 104 and 102 and 100, 101, 102, 104 of Law 4938/22, the following innovations regarding the inspection system result: a) the drafting of an evaluation report on the operation of each court and prosecutor's office (not foreseen before) b) the drafting of an evaluation report of the directors, the courts and the prosecutor's offices (not foreseen before) c) the drafting of an evaluation report of the presidents and the presiding departments and judicial formations of each court and prosecutor's office d) for the inspection of the judges, they take into account the available statistical data.

The two-year term of the inspectors is expected to significantly upgrade the evaluation system, because it will provide the possibility of controlling the judicial work over a longer period of time, especially for the crowded judicial formations. The Inspectors of the courts receive for the first time instructions from the Plenaries of the courts, specific directions for the operation of the courts and the evaluation of the supervisors, statistical data are used and specially reasoned reports are drawn up. The new way of evaluation has been systematized and good practices are reported.

There is a system for inspecting the quantitative and qualitative performance of judicial officials (law 4938/2022) and decisions of the Administrative Plenary of the Council of State regarding the framework of instructions, practices and guidelines for the evaluation of the Council of State's Associate Councillors and Rapporteurs, as well as judges of the administrative courts. A Charter of Ethics for judges of the Council of State has also been approved.

With the 19/2023 decision of the Council of State in Plenary and the Council, a framework of guidelines, instructions and practices for the inspection of ordinary administrative courts, their directors and other judges was formulated on the basis of article 104 of the Code of the Organization of Courts (Law 4938/22). (General Commission of the State for ordinary administrative courts). Decision 7/23 of Areios Pagos in Plenary and the Council.

According to Law 4938/2022 (art. 99-104), Supreme Court judges appointed as inspectors for two year's term, draft every year general reports on the operation of each court and prosecutor's office in their district and recommend the necessary measures for the proper functioning of the service.

Regarding the administrative courts, the General Commission of the State for ordinary administrative courts monitors and inspects the functioning of the administrative courts and assists their work (Articles 32-33 of Law 4938/2022). In the near future it is expected to use a business intelligence program through the upgraded Integrated Data Management System for the Administrative Justice, in order to extract composite statistical data without contacting any court. The Head of each court is responsible for the assignment of cases between judges of his/her competence. In this sense, he/she is aware of the quantitative performance of judges. The assigned cases have to be dealt with by the judges within the period of 8 (eight) months according to Law 4983/2022 (art. 99-104) and Law 2717/1999 art. 194 par.1.

Besides the heads of courts, there are also the plenary of the Supreme Courts.

Each administrative court sets up an internal service regulation (Article 19 of Law 4938/2022) which specifies, among other things, the number of cases assigned to each judge per month or year, taking into consideration the special circumstances of each court, the number of serving judges and the seriousness of the cases (General Commission of the State for ordinary administrative courts).
