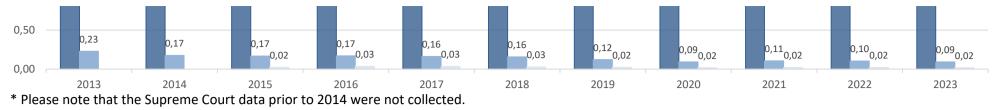




Incoming cases per 100 inhabitants

1. Judicial organisation in Hungary (2023 data)

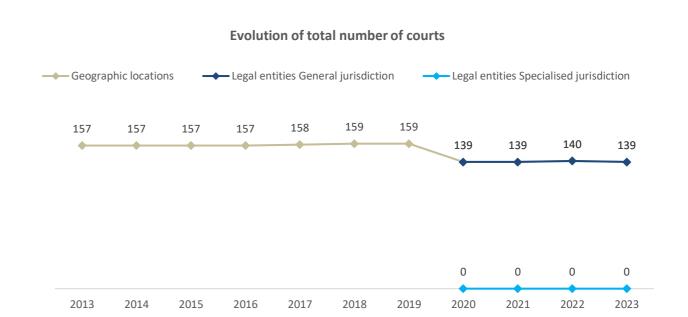
Hungary has 139 courts of general jurisdiction and no specialised courts. The Hungarian court system is organised as follows:

- Kúria (1) the Hungarian Supreme Court its jurisdiction in criminal, civil and administrative cases covers adjudication of extraordinary remedies and appeals, adopting uniformity decisions. It also decides if municipal decrees are in compliance with higher level legislation.
- Regional courts of appeal (5) their jurisdiction in criminal and civil cases covers the adjudication of appeals received from the regional courts (third instance in criminal cases).
- Regional courts (20) their jurisdiction in criminal, civil and administrative cases covers the adjudication of appeals received from district courts, administrative and labour courts, and procedure at first instance in certain criminal and civil cases.
- District courts (113) their jurisdiction in criminal and civil cases covers the procedures at first instance.

The number of judges in the largest district court is 357, whereas the smallest court operates with one judge. Out of the 113 district courts, the district courts in the seat of the

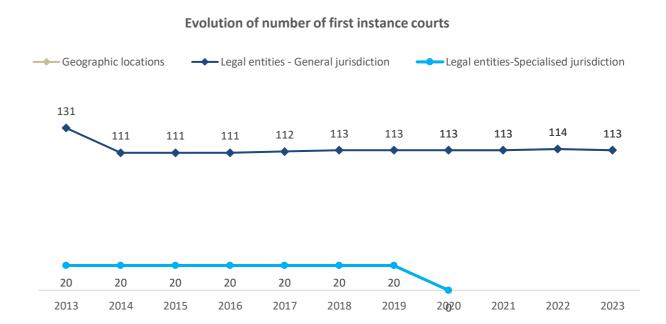

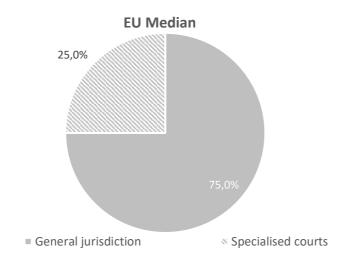


Evolution of number of first instance courts

Regional courts deal with labour cases at first instance. Administrative cases are dealt by eight regional courts on a regional level.

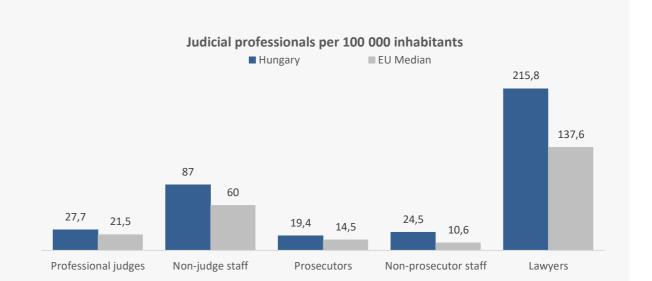

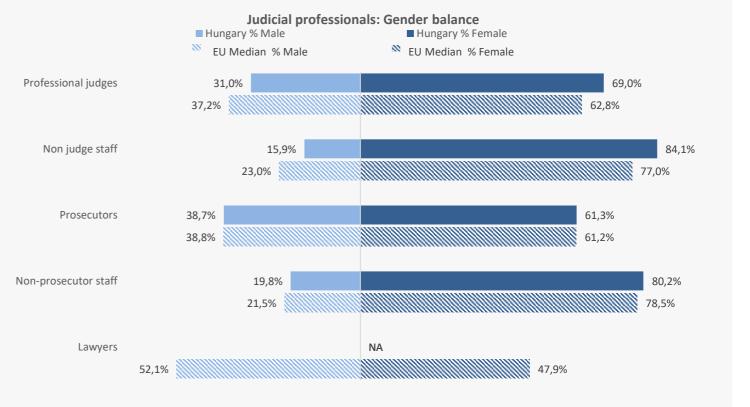

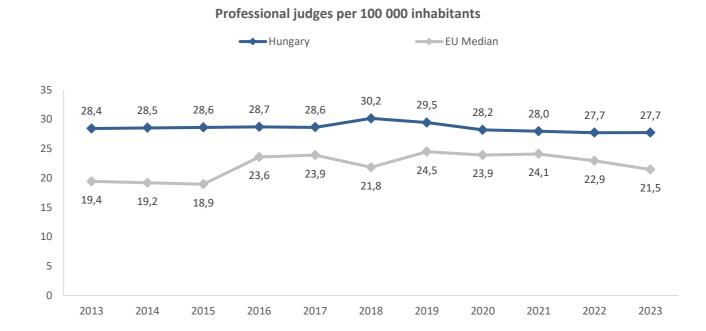

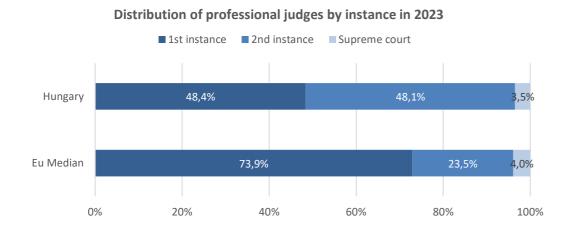


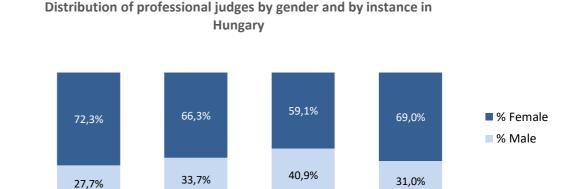
According to 2023 data, the total number of professional judges sitting in courts (all instances) in Hungary is 2 657, which is -0,1% less than in previous cycle.

More precisely, in Hungary, there are 27,7 professional judges per 100 000 inhabitants (this figure is above the EU median of 21,5 judges per 100 000 inhabitants)

In this cycle, the total number of female professional judges (all instances) is 1 833, which represents 69,0% of the total number of judges.

The total number of judges is distributed among the different judicial instances in the following way: 1 287 are sitting in the first instance courts (of which 931 are female); 1 277 are sitting in the second instance courts (of which 847 are female) and 93 are sitting at the Supreme Court (of which 55 are female).

In Hungary, the distribution of professional judges across judicial instances differs significantly from the EU average. At the first instance level, the proportion of judges in Hungary is notably lower, at 48,4%, compared to 73,9% in the EU. Conversely, the representation of judges at the second instance is considerably higher in Hungary than the EU average, while the distribution at the third instance is nearly equal.

Since 2012, following the establishment of the National Office for the Judiciary, the methodology for data collection has remained consistent. First instance professional judges are defined as those serving in District Courts. Judges at the second instance include those from Regional Courts and Regional Courts of Appeal. For Regional Courts, the allocation of first and second instance cases is determined annually through bylaws. These bylaws are issued by the court president after consulting the judicial council and the court's professional department.

As regards the distribution male/Female, it has to be specified that female judges are predominant at every instance level, with the highest percentage at first instance with 72,3%. At second and third instance their representation is slighly lower, but still over 50%.

Distribution of court presidents by gender and by instance in Hungary

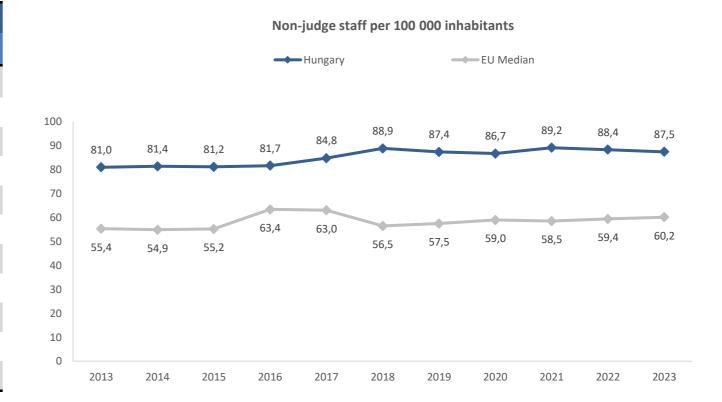


In this cycle, the total number of female court presidents (all instances) is 72, which represents 51,4% of the total number of court presidents.

The total number of court presidents is distributed among the different judicial instances in the following way: 114 are sitting in first instance courts (of which 62 are female); 25 are sitting in second instance courts (of which 10 are female) and 1 is sitting at Supreme Court level.

In 2023, Hungary has 8 383 non-judge staff (of which 7 051 are Female). The total number of non-judge staff in comparison with the previous cycle reveals a decrease of -1,2%.

In 2023, the number of non-judge staff per 100 000 inhabitants has decreased (from 88,4 in 2022 to 87,5 in 2023).

During the same period, the number of judges per 100 000 inhabitants evolved from 27,7 judges per 100 000 inhabitants in 2022 to 27,7 in 2023.

In this cycle, the non-judge staff is broken down as follows:

- 963 Rechtspfleger (or similar bodies) with judicial or quasi-judicial tasks having autonomous competence and whose decisions could be subject to appeal (among which 783 are Female);
- 833 non-judge staff whose task is to assist the judges such as registrars (of which 736 are Female);
- $_{\circ}$ 6 587 other (of which 5 532 are Female);

Court secretaries ("bírósági titkár") are employees of the court similar to Rechtspfleger. They are lawyers, who after acquiring a degree at a law faculty have made the bar exam (which requires at least 3 years professional practice). They are enabled to perform duties of judges in cases specifically defined by law.

According to the Constitution when a court secretary is dealing with a case they have the same independence as a judge. In criminal cases they can make out of trial decisions (e.g. order an expert to be included in the case), or they can hear witnesses on request of another court. This practically means they assist the judges in pre-trial phase of the case. In misdemeanour cases they adjudicate the case - this is an area of law in which mostly court secretaries deal with cases of first instance. In civil and labour cases they can make any decision that can be made without hearing the case. This practically means they assist the judges in pre-trial phase of the case. In administrative non-litigious cases they can make any decision that can be made without hearing the case. In company registry cases they can make every decision, as well in insolvency cases (with some exceptions).

From 2012, the category "non-judge staff assisting judges" includes only staff directly assisting judges.

Other non-judge staff includes staff in charge of different administrative tasks and of the management of the courts (3) and technical staff (4).

Professional judges and non-judge staff per 100 000 inhabitants, and their ratio

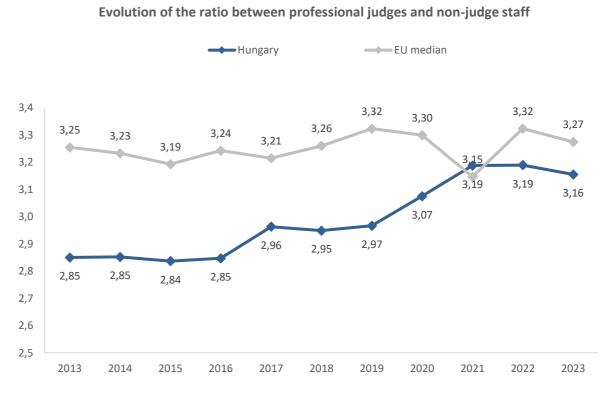


In Hungary, there are 27,7 professional judges per 100 000 inhabitants (this figure is above the EU median of 21,5 judges per 100 000 inhabitants) and about 3,2 non-judge staff per judge.

There is no significant difference compared with the previous cycle when this ratio was at 3,2 non-judge staff per judge.

Evolution of the ratio between professional judges and non-judge staff

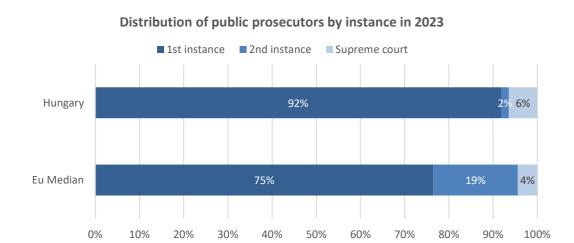

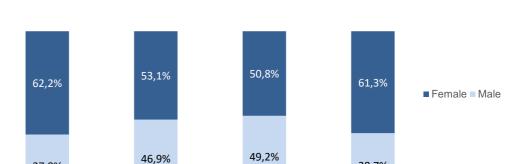

In this cycle, the total number of Female prosecutors (all instances) is 1 142, which represents 61,3% of the total number of prosecutors.

The total number of prosecutors is distributed among the different judicial instances in the following way: 1 710 in first instance (of which 1 063 are female); 32 are in second instance (of which 17 are female) and 120 in final instance (of which 61 are female).

As regards the methodology of presentation of data in respect of the number of public prosecutors, it should be noticed that on 31 December 2023, 2 prosecutors (1 male and 1 female) were working temporarily at the Ministry of Justice. These two prosecutors were included in the total number, but were not taken into consideration when looking at the number of prosecutors working at each/different level. All prosecutors are appointed to work full-time, but it may occur that a prosecutor temporarily works part-time, for child care reasons for example.

As regards the distribution of the number of prosecutors among the different judicial instances, Hungary presents some peculiarities which should be mentioned. At first instance level, the number of prosecutors includes prosecutors working for district and district level prosecution offices, together with the number of prosecutors working for chief prosecution offices. Out of this number, the number of prosecutors working at chief prosecution offices is 544 (239 men and 305 women), the number of prosecutors working for district (district level) prosecution offices is 1,166 (408 men and 758 women).

As to the number of prosecutors at second instance, the table includes only the number of prosecutors working at the appellate chief prosecution offices. The reason for this is that no exact answer can be given to the question. In the Prosecution Service of Hungary, prosecutors working at district and district-level prosecution offices only proceed with first instance cases. Prosecutors of chief prosecution offices working at county (or county-level) prosecution offices handle first instance cases which fall into the jurisdiction of regional/county courts, but part of the prosecutors of chief prosecution offices handle cases at second instance or at second instance, as well in cases initiated at first instance by district or district prosecution offices. Our personnel database, however, does not contain information on the number of such prosecutors of chief prosecution offices.

Prosecutors of the appellate chief prosecution offices handle second instance cases or, in specific circumstances, they proceed at third instance.

As regards the distribution male/Female, it has to be specified that female prosecutors represent the majority of prosecutors across all three instances. The highest representation of female prosecutors is at first instance level with 62,2%. At second and third instance the increase since the last cycle could be explained by the increase in the number of female prosecutors serving in the Chief Prosecution Offices of Appeal. However, this is primarily due to the overall low number of prosecutors in these offices, where even a small numerical increase can result in a substantial percentage change.

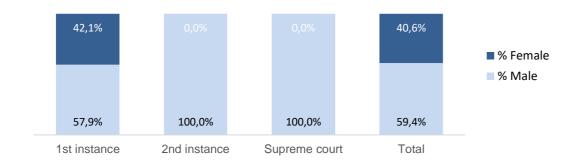
This growth in staff was driven by the evolving workload at the Chief Prosecution Offices of Appeal and the need to recruit new staff to replace those retiring or transferring to other positions. Women already represent a high proportion of prosecutors in the Prosecution Service of Hungary, accounting for 61.3% in 2023. Under these circumstances, there is no specific reason why more women successfully applied for or were seconded to posts as prosecutors in the Chief Prosecution Offices of Appeal in 2023.

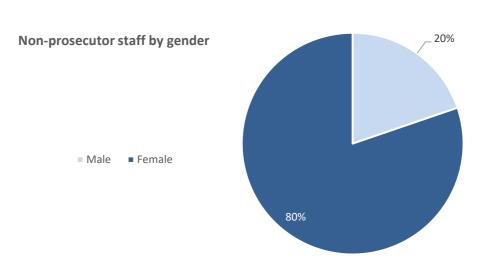
The total number of Heads of prosecution is distributed among the different judicial instances in the following way: 145 at first instance level (of which 61 are female); 5 at second instance level (of which 0 are female) and 1 at the highest instance level.

The table contains the following heads/senior leaders of prosecution offices: the prosecutor general; prosecutors who are heads of departments at the Office of the Prosecutor General and prosecutors who are heads of autonomous divisions at the Office of the Prosecutor General (the latter two groups of employees consist of 14 persons who are exercising employer's powers with respect to subordinate prosecutorial employees at the Office of the Prosecutor General); appellate chief prosecutors (where there was no appointed or acting appellate chief prosecutor, the head of division at the appellate chief prosecution office in charge of the appellate chief prosecution office); chief prosecutors; prosecutors who are heads of district (or district-level) prosecution offices (in a district prosecution office, there was temporarily no appointed or acting head of district prosecution office, therefore this structural unit was headed by the deputy head prosecutor).

Within the data relating to the Office of the Prosecutor General, the heads of structural units with functional responsibilities (e.g. IT Department, Autonomous Administrative Division) are also indicated.

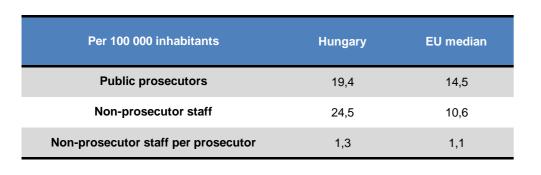

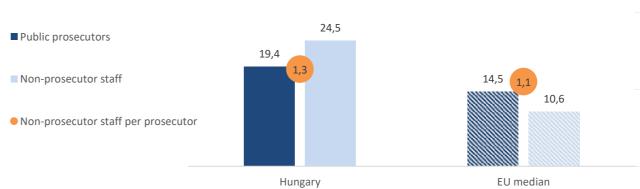

Public prosecutors and non-prosecutor staff per 100 000 inhabitants, and their ratio

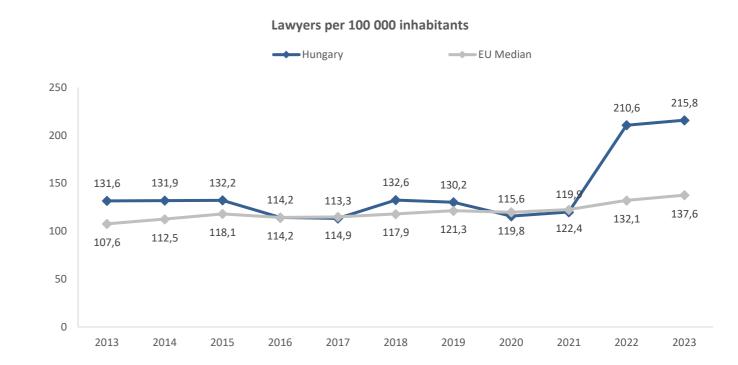

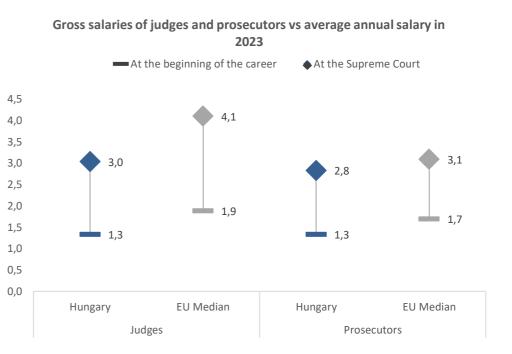
In 2023, there are 20 686 lawyers, which is 2,3% more than in 2022.

Hungary has 215,8 lawyers per 100 000 inhabitants, which is above the EU median of 137,6 lawyers per 100 000 inhabitants.

The statistical register of the Hungarian Bar Association has changed recently, due to which the data on the separate numbers of female and male lawyers is no longer available. Only data on the total number of lawyers practicing in Hungary is available.

In the European Union, the absolute gross salary for a judge at the beginning of career ranges from a minimum of 25 759€ to a maximum of 144 856€.

According to the 2023 data, the absolute gross salary of a judge at the beginning of his/her career in Hungary is 25 759€, which is significantly below the EU median of 58 128€. Hungary is the country with the lowest minimum absolute gross salary in the EU.

Compared with the annual average salary in the country, the salary for a judge at the beginning of his/her career is 1,3 times higher (the EU median is 1,9). Compared to the 2022 data, the decrease in starting (beginning of the career) salary resulted from a change in the calculation method. In previous years, the average salary of the appointed judges was presented, which depends on the length of service, while this year the hypothetical lowest salary available is given.

At the highest level, the range of the EU absolute gross salary for a judge is from 58 623€ to 266 974€. Hungary is the country with minimum absolute gross salary of 58 623€ for judges at the highest level. The highest salary received at the Supreme Court was defined without any leadership allowances, which is why it is less than the average salary was in the 2022 data.

For public prosecutors, the range for the absolute gross salary at the beginning of career is from a minimum of 25 759€ to a maximum of 101 592€.

In 2023, the absolute gross salary of a public prosecutor at the beginning of his/her career in Hungary of 25 759€ is rather below the EU median of 49 953€. Hungary is the country with the lowest minimum absolute gross salary in the EU.

Compared with the annual average salary in the country, the salary for a public prosecutors at the beginning of his/her career is 1,3 times higher (the EU median is 1,7).

At the highest level, the minimum absolute gross salary for prosecutors in the European Union is 51 456€ and the maximum is 199 670€. Hungary's absolute gross salaries for prosecutors at the highest level is -42% below the EU median of 93 759€.

Excessive length: If the court is not able to finish the cases within reasonable time a compensation may be awarded to the parties. The court decides about the compensation in a fast track procedure.

Non-execution of court decisions: Usually the court orders a 15 day deadline for fulfilling its final decision. If the party that is obliged to do so does not fulfil this obligation they also have to pay an interest from that day.

Wrongful arrest: The damages occured for wrongful arrest, house arrest or preliminary detention at a psychiatric institution shall be compensated.

Wrongful condemnation: Any pecuniary punishment or cost of the procedure that was paid by the accused person should be repaid with interest included.

Other: the court awards a compenstaion if the circumstances of the imprisonment of a convicted or arrested person violate his/her fundamental rights.

Act XCIV of 2021, effective in 2022, governs financial compensation for delays in civil litigation. The above data shows the results of the proceedings initiated under the new legislation.

Civil Proceedings - Excessive Length of Proceedings

Under Hungarian civil procedural law, financial compensation is available for breaches of the reasonable time requirement in court proceedings. This compensation applies only to parties involved in the proceedings, regardless of the outcome, and does not require proof of specific disadvantage. Compensation is granted if the proceedings or their stages (first instance, second instance, or review) exceed reasonable time limits set by law.

These limits are:

- Entire proceedings: 60 months (36 months for specific cases like personal status, child maintenance, press vindication, and employment).
- First instance: 30 months (or 36 months if initiated by an order for payment procedure).
- Second instance: 18 months.
- Review proceedings: 12 months.

The duration subject to compensation is calculated by deducting legally disregarded periods from the total duration. Compensation is determined by multiplying the eligible duration (in days) by 400 forints per day.

Civil proceedings - Non-execution of Court Decisions

In Hungarian civil proceedings, fulfilling judgments is primarily voluntary. If the unsuccessful party does not comply within the prescribed time, the successful party may initiate enforcement proceedings, with the costs borne by the unsuccessful party.

In cases of payment delays, the debtor is obligated to pay interest for late payment from the date of the delay. This late-payment interest is not considered compensation, meaning the successful party does not need to prove any damages resulting from the delay.

Criminal Proceedings

Hungarian law, under Act XC of 2017 on Criminal Proceedings (Be.), provides recompense for unjust restrictions on liberty, detailed in Chapter CVIII. Compensation is available for pre-trial detention, compulsory psychiatric treatment, criminal supervision with restricted movement, or custody. It also applies to imprisonment, juvenile correctional education, or enforced psychiatric treatment if a court, through extraordinary legal remedies, later acquits the defendant, imposes a lesser penalty, or terminates the proceedings.

Prolonged criminal proceedings alone do not qualify for recompense. However, delays may be considered a mitigating factor during sentencing, and be included in the short statement of reasons as per Section 562(1) of Be.

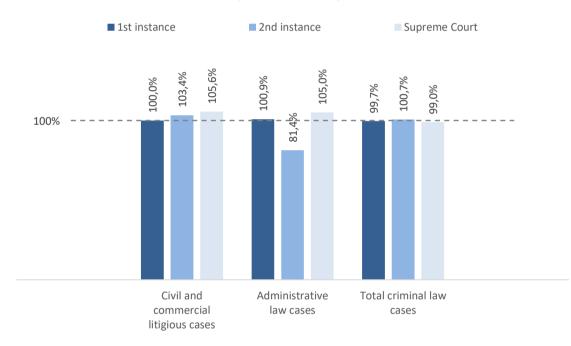

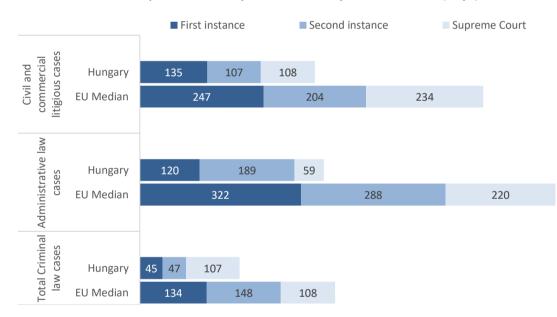

In 2023, Hungary recorded Disposition Times below the EU medians across all case types and judicial instances. The shortest Disposition Times were observed in first- and second-instance criminal cases, with averages of 45 and 47 days, significantly lower than the EU medians of 134 and 148 days, respectively. Administrative cases also demonstrated faster resolution compared to EU medians, with average times of 120 days at first instance, 189 days at second instance, and 59 days at third instance. Similar trends were noted for civil and commercial litigious cases. A decline in incoming civil cases—due to factors like mediation, increased thresholds for payment orders, and the 2018 Civil Procedure Code—has accelerated case completions at all court levels, reducing pending cases. For instance, the Curia's pending civil cases fell from 877 in January 2022 to 553 by the end of 2023, with resolved cases consistently outpacing incoming cases.

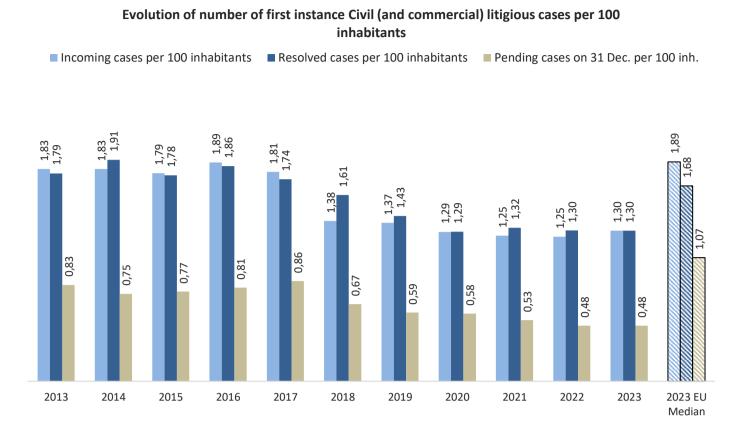
Clearance Rates were above or close to 100% across most case types and judicial levels, with the notable exception of second-instance administrative cases, which reported a Clearance Rate of 81.4%. As regards this category of cases, the number of cases pending, incoming, and resolved as of January 1, 2023, and the number of cases pending as of December 31, 2023, decreased compared to the previous year. The data reflect legislative changes implemented to address the workload of the Curia (Hungary's Supreme Court). A legislative amendment in 2021 expanded the Curia's jurisdiction to include appeals as a second-instance court in administrative disputes, making it the general second-instance court for administrative cases nationwide. This change resulted in a substantial increase in the Curia's caseload, making it the most burdened court in Hungary by autumn 2021.

To alleviate this issue, Parliament passed Act No. CXXXIV of 2021, effective March 1, 2022, which redistributed second-instance administrative cases to the Regional Appellate Court of Budapest. The Administrative Chamber of this court began handling such cases as a general second-instance body. The transition was carried out gradually, following an "ascending order" approach, without transferring pending administrative cases from the Curia. The reduction in the Curia's workload due to this legislative change was first reflected in the 2023 data.

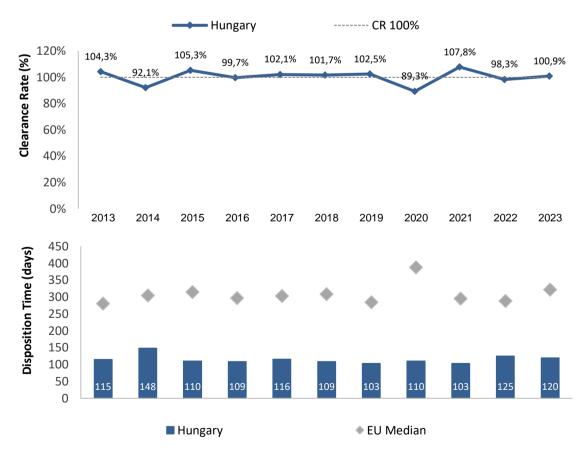

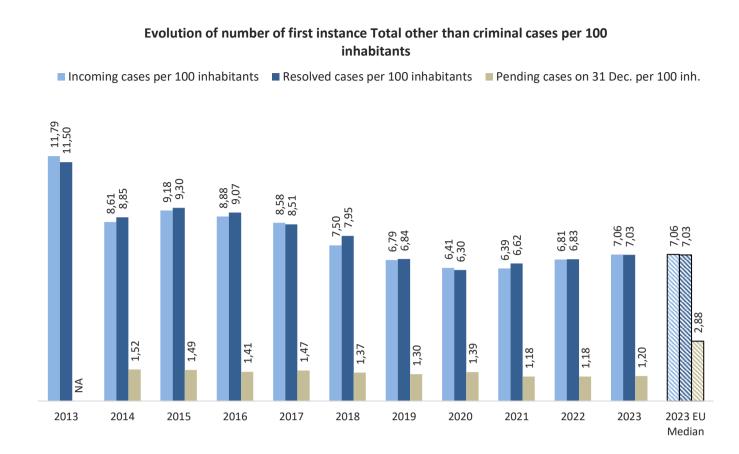

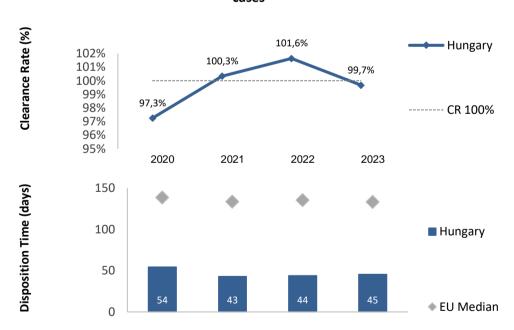

With a Clearance Rate calculated at 99,7% in 2023 Hungary seems to deal effectively with its first instance total criminal law cases.

Between 2022 and 2023, the Clearance Rate has decreased by -2,0 points.

In 2023, first instance total criminal law cases are solved in approximately 45 days, which is significantly below the EU median of 134 days.

The analysis of the 2022 - 2023 period reveals a 3,4% increase of the Disposition Time.

Criminal offences are severe or minor crimes. Severe crimes (bűntett) are committed intentionally and are punishable with at least two years of imprisonment. All other criminal offences are minor crimes (vétség). Crimes that are not committed intentionally are always considered as minor crimes, despite the possible punishment.

Misdemeanours (szabálysértés) are not considered as criminal offences, but are unlawful acts that are endangering the society. The authorities intervening in their respect are the police, the district office, or the National Tax and Customs Office. Their decisions can be reviewed by the relevant section of the respective district court upon request of the accused person. Generally, the court rules without oral hearings, based on the available documents. However, it can set a hearing if it finds it necessary or if the party charged by a misdemeanor requests it. The judgment is a final and enforceable decision.

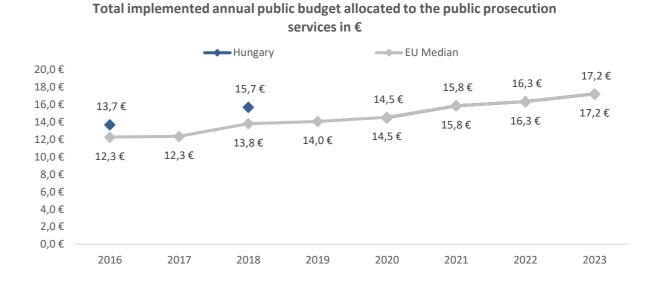
It is noteworthy that the Hungarian law identifies also the category of civil offences encompassing offences mainly against public administration. However some criminal offenses, such as property crimes involving objects of small value (under 50000 HUF), are classified in this category as well. Civil offences fall under the jurisdiction of various administrative agencies, local governments or traffic police, but not the courts.

Concerning the methodology of presentation of data, as according to the Hungarian Criminal Code not only severe crimes (bűntett), but also almost every minor crime (vétség) punishable with imprisonment, is included into the category "severe criminal cases". Thus, misdemeanors (szabálysértés) are included into the category "minor criminal cases".

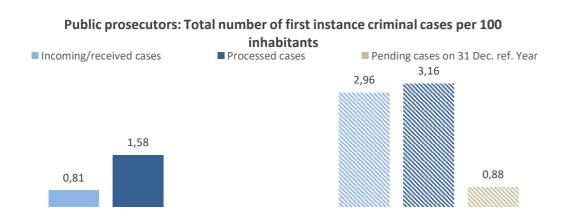

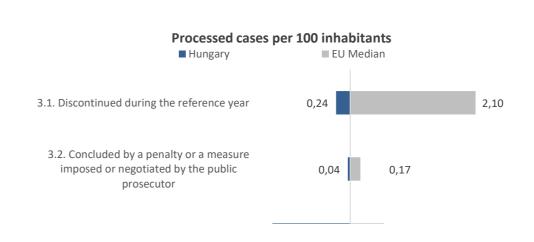

Cases discontinued for other reasons - The reason for the increase is the growth in the number of cases recorded under provision IV of Section 398 (2) c) of the Criminal Procedure Code (Termination of liability to punishment for other reasons specified by law).

The data source - in accordance with the previous data provision - is The Statistical Subsystem of Completed Criminal Proceedings of the Unified Investigation Authority and Prosecution Service Criminal Statistics System (hereinafter ENyÜBS-BBS). In the ENyÜBS-BBS subsystem, the data is recorded when the investigating authorities or the Prosecution Service have made a procedural decision giving reasons for the provision of statistical data in connection with the crime (e.g.: dismissal of the criminal complaint, termination, suspension, accusation/indictment), relating to which statistical data was provided. Considering the time of data recording, the ENyÜBS-BBS subsystem is, therefore, of a so-called follow-up nature, so it does not show how many crimes occurred in the year under review, but it shows how many legal decisions were made in connection with such acts and in how many cases statistical data was provided in this context (in a registrative manner).

As a result, the above also means that an ongoing criminal proceeding may not be included in the ENyÜBS database yet. As regards "Pending cases on 1 Jan. ref. year" and "Pending cases on 31 December ref.year", no data is collected on the number of pending cases – on a given day – into the records of the Prosecution Service.

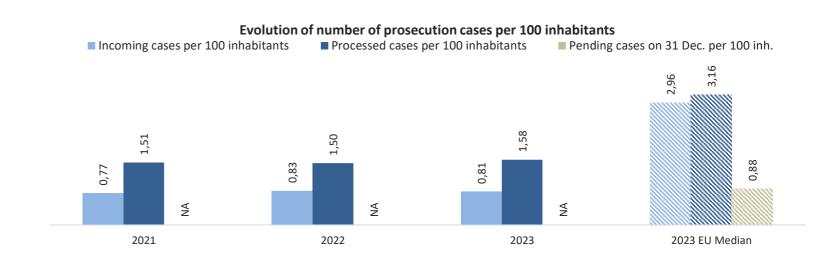

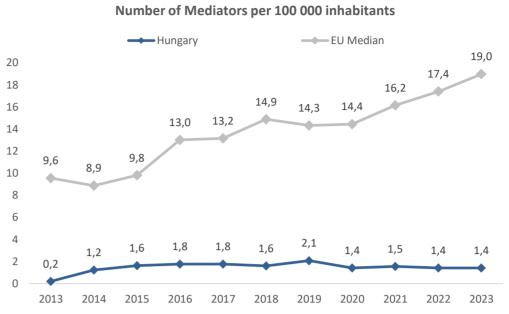

In 2023, there are 135 accredited or registered mediators who practise court related mediation which represents 1,4 accredited or registered mediators per 100 000 inhabitants.

The variation of the number of mediators between 2022 and 2023 is about -0,7%.

A court mediator can be a judge or a court secretary who has completed professional training that includes both theoretical and practical knowledge as required by law and can only be appointed upon request. The judge or court secretary must submit their request for appointment as a court mediator to the president of the court exercising the employer's rights. The president of the court forwards the request, along with their recommendation, to the president of the National Office for the Judiciary (NOJ). The president of the NOJ appoints the judge or court secretary to carry out court mediation activities.

In 2023, there are 313 notaries which represents 3,3 notaries per 100 000 inhabitants.

In Hungary due to the official nature and constitutional status of a civil law notary in exercising public authority a notary may only assume office as a result of a successful application procedure and the appointment of the Minister of Justice. The appointment is the sole event when the notary is commissioned by the State to fulfil tasks forming part of the justice system upon the formal request of clients. The number of notaries and their tariffs is governed by a regulation of the Minister of Justice.

In the near future, the total number is expected to be reduced by 3.

Comments on writing assistance tools

Usage rate decrease: in 2022, writing assistance tools to all employees in the entire court system were provided. These were licensed tools that staff tried out and tested. Based on user feedback, by 2023 it was determined that, considering the specific characteristics of the Hungarian language and legal terminology, these tools did not make court work more efficient. The language recognition functions were not scalable enough, so the tools were phased out. Simultaneously, cloud-based tools were acquired that, although previously restricted by legal regulations, could now be developed and trained. Although, these tools were fewer in number than in the past, they were used by half of the staff.

A new feature has been introduced in the Judgement Support System that, during the anonymisation of specific court rulings, automatically suggests options for standardising roles and legal phrases consistently throughout the document.

Another such feature allows for the automatic insertion of data available in the court system into designated sections of ruling templates during the editing process.

Comments on recording of court hearings

Deployment rate decrease: the procurement of technical equipment for recording of court hearings varies depending on the available budgetary resources. There is an ongoing intent to expand and a continuous search for opportunities. Once the equipment is procured and installed, the courts strive for maximum utilisation across all case types.

In 2022, courts had access to a licensed transcription tool that allowed for creating transcripts from recordings in both civil and criminal cases. These tools have since been phased out. While less commonly used in civil cases, the ViaVideo system is widely utilised in criminal cases and offers numerous functionalities.

Not all court hearings are recorded, even in criminal cases. However, when a hearing is conducted using the ViaVideo system, it is almost always recorded. The installation of the ViaVideo system for courtroom video and audio recording began in 2018. The number of remote hearings has been steadily increasing year by year and month by month. On average, approximately 85% of all remote hearings are held in criminal cases.

8. Systems for measuring and evaluating the performance of courts and public prosecution services in Hungary (2023 data)

In Hungary, quality standards are determined for the judicial system at national level (e.g. quality systems for the judiciary and/or judicial quality policies). However, there is no specialised personnel within the courts or the public prosecution services entrusted with implementation of these national level quality standards.

Second instance courts have to prepare a note on the decision and the trial procedure of the first instance court, based on professional criteria in every case. In this note, the court of appeal has to examine: the application of substantive, procedural and administrative regulations; the preparation of the hearings; the quality of the judges trial leading practice; if the coercive measures were well founded; if the hearings were set timely; if the ruling was transcribed in time; if the decision was edited correctly. The conclusions are summarised and judges of first instance courts are informed about them at least once a year.

Furthermore, the departments of the Supreme Court (Kúria) responsible for examining the judicial practice evaluates the practice of the courts and regularly inform judges about their experience.

There is no specified number of cases to resolve for each judge, but according to the act on the Legal Status and Remuneration of Judges and the regulation governing the administration of courts, the number of hearing days is mandatorily specified.

According to the Act on the Legal Status and Remuneration of Judges -section 124 - disciplinary measures may be imposed against a judge for professional misconduct. Although it is theoretically possible for the above measures to be applied in the event of non-compliance with the quantitative requirement indicated in question 83, this does not occur in practice.
