Tamar TALIASHVILI is a Georgian politician, member of the political party "Georgian Dream". She holds office of the head for the commission on Education and Culture of the Assembly of Tbilisi since 2014 when she was elected to the legislature of the capital city of Georgia first time. Mrs. TALIASHVILI was re-elected to the Tbilisi city assembly in 2017 as a majoritarian representative from single mandate constituency and continues to serve as a chair of the commission for education and Culture of The Tbilisi City Assembly. Mrs. TALIASHVILI served as a Head of Administration of the Ministry of Internal Affairs of Georgia in 2012-2013. For her professional capacities and outstanding achievements in the Georgian public sector, Mrs. TALIASHVILI was nominated for the US State Secretary Award "Women in Public Service" in 2011.
