Child-friendly Justice Project
Exchange Visit in Slovenia**

Context

The Joint European Union-Council of Europe Child-friendly Justice project is an innovative 27-month initiative driven by the combined efforts of the Council of Europe and the European Commission and implemented by the Children’s Rights Division of the Council of Europe. Launched on 1 January 2024, the project aims to improve the protection of children in contact with the law – as offenders, victims, witnesses or parties in non-judicial, judicial (such as civil and criminal cases) and administrative proceedings – across Europe at national and local levels.

Belgium, Poland, and Slovenia have been selected as focus countries to pilot the implementation of activities at national and local level to collect data, identify gaps, improve legislation, policies, and practices. Since July 2024, with the support of experts, the three focus countries have conducted their self-assessment through the roll-out of the Council of Europe Child-friendly Justice Assessment Tool, i.e. collecting and analyzing data related to Child-friendly Justice in each country. Data collected and analysed will help formulating recommendations to adapt Belgium’s, Poland’s, and Slovenia’s legal and policy framework in line with the Council of Europe and European Union standards, strengthen capacities of professionals working for and with children in contact with the law, and raise the awareness of children in contact with the law and their parents.

The objective of the exchange visit in Slovenia is two-fold:

- Exchanging on and improving data collection and data analysis related to focus countries’ Child-friendly Justice self-assessment.
- Visiting and learning from Slovenia’s experience on CFJ, especially the former co-operation projects aiming at [Supporting the implementation of Barnahus in Slovenia - Phase II - Children's Rights \(coe.int\)](#) and [Improving the juvenile justice system in Slovenia - Children's Rights \(coe.int\)](#) as well as the current co-operation project [Ensuring the best interests of the child in civil court proceedings in Slovenia - Children's Rights \(coe.int\)](#)
