Channels of communication for the request of MLA: (through diplomatic channels or other): In case of urgency (Art 15.2) direct transmission (link to contact details of competent authorities) or other	<p>Requests for MLA should to be sent directly to the Chilean Central Authority or to the authorities above-mentioned, in copy to the Chilean Central Authority. Diplomatic channel is not needed.</p> <p>Notwithstanding this, urgent requests may be forwarded, in advance, to the Chilean Central Authority by e-mail or any other safe electronic means of communication that might be available.</p> <p>In general, the Chilean Central Authority encourages the use of electronic means for the formal transmission of MLA requests. In order to implement this, a simple agreement with the Foreign Central Authority suffices for this purpose.</p>

Means of communication (eg. by post, fax, e-mail ²):	<p>E-mail, preferably and post, as well.</p> <p>Encryption or electronic signature is not required in regular communications.</p>

Language requirements:	<p>According to a declaration made under art.16, par.2, of the Convention, MLA requests should always be translated into Spanish, while the translation of annexes may be required only when deemed necessary.</p>

Limitation of use of evidence obtained:	<p>By declaration made under art. 26, par. 5, of the 2nd Protocol to the Convention, the handling of information is submitted to Chilean domestic law.</p>

Other relevant information: (e.g. documentation required for special types of assistance)	<ul style="list-style-type: none"> • Videoconference: Art. 10 of the 2nd Protocol to the Convention, doesn't apply accused or suspect. • Requests for Search and Seizure: Only if consistent with Chilean law. • Temporary transfer of detained persons: Only with consent of the concerned person. • Requests for summons: Must be received, at least, 50 days in advance to the date of appearance before Court.
