The Conference of INGOs

The Conference of INGOs is the body of the Council of Europe which brings together all international NGOs with "participatory status". This status is granted by the Secretary General and is regularly revised.

The Conference of INGOs currently brings together more than 300 international NGOs working together

- to strengthen European citizens' access to human rights
- to protect democratic values and systems based on the Rule of Law.

The purpose of the Conference is therefore to commit itself to the participation of civil society in public life and to the right to freedom of association, freedom of assembly and freedom of expression (which are closely linked) and are the essential elements of a dynamic civic space and sound democratic governance.

The Conference is committed to preserving an enabling environment for NGOs in member States and to facilitate dialogue between civil society, the public authorities and other stakeholders. This is a fundamental axis of its work in the Council of Europe and in all the 47 member States.



Vision

As a representative body, the Conference of INGOs constitutes an institutional connection between the Council of Europe institutions and more than 800 million Europeans.

Through the Conference of INGOs, the Council of Europe recognises a vibrant, pluralistic and dynamic civil society to be an indispensable actor of the democratic system, aiming to safeguard a civic space, acting for open, diverse and inclusive societies and accountable governments. It is essential that the Conference's activities achieve impact within the

It is essential that the Conference's activities achieve impact within the Council of Europe and in its member States.

Therefore, the Conference of INGOs must simultaneously be

- close to the grassroots organizations,
- working for a general interest of civil society,
- involved in the high-level decision-making process in the Council of Europe and other international organisations.

Participatory status with the Council of Europe

In recognition of the increasingly active role played by the INGOS since 1952, the Council of Europe decided to change their consultative status to a participatory status in 2003. In July 2016, the Committee of Ministers adopted a new resolution on participatory status, **Resolution (2016)3**. It sets out the rules for the granting of participatory status to INGOs, gives more information on the background of the status, what it represents, the conditions to be met by INGOs and the possibilities it gives to INGOs to co-operate with the Council of Europe and increase the relevance and quality of INGOs enjoying participatory status.

The Conference of INGOs represents "civil society" at the Council of Europe and works to promote participatory democracy. In addition to holding two annual sessions a year, it organises events linked to the priorities of the Council of Europe.

Resolution CM/Res(2016)3



Rules of Procedure of the Conference of International Non-Governmental Organisations (INGOs) of the Council of Europe

The Rules of Procedure give a framework to the Conference of INGOs.

- They determine
 - the Composition of the Conference of INGOs,
 - its Structure,
 - Its Terms of Reference and its Functioning.
- > They define the role (terms of reference and functioning) of
 - the President, Vice- Presidents
 - the Standing Committee and its members,
 - Its Committees and Expert Council(s)
- > They determine
 - the general principles and procedure of elections,
 - the responsibilities of the Verification and Dispute Committee
 - the Appellate Committee
 - the procedure for amendment to the Rules of Procedure.



New Rules of Procedure – NGOs' collective contribution to the future of the Conference of INGOs

The INGOs adopted new rules for the Conference during the December 2020 session, following a long participatory debate, and this, with the aim of strengthening its impact, its flexibility and with a view to offer a bottom-up approach.

With a large majority, the INGOs voted for Rules of Procedures allowing:

- lighter structures
- greater operational efficiency
- the creation of Committees directly validated by INGOs in line with the priorities of the Council of Europe
- The possibility of creating one or more Expert Council(s) with a mandate to study essential questions not yet covered within the Council of Europe
- a good ethical governance

Action Plan 2018-2021

The Action Plan sets out the main orientation and specific priorities of the Conference's work for 3 years and aims to reinforce the voice of civil society in the Council of Europe.

The Action Plan shows how the Conference of INGOs provides both a conceptual and an operational response to the Council of Europe's, and more specifically the Secretary General's priorities, and contributes to the protection of the organisation's values which are being affected by current political and economic factors.





Priorities

The priorities announced in the Action Plan are organised as follows:

- 1. To protect and reinforce freedom of association and associated rights and to contribute to the democratic security in Council of Europe member states
- 2. To observe and reinforce civil participation in the decision-making within the Council of Europe and in its member states
- 3. To contribute to building an inclusive society and to protect access to education and to social, cultural and economic rights by vulnerable groups
- 4. Contribute to the blossoming of a modern European Cultural Identity
- 5. Continue to develop the institutional strengthening process of the Conference of INGOs to respond in a relevant way to the institutional evolution of the Council of Europe and geopolitical challenges.

Equality is central to fulfilling the Council of Europe's mission, and is therefore also a priority for the Conference of INGOs.

All entities of the Conference of INGOs will conduct actions to contribute to these priorities under the guidance of the Standing Committee whose role is to ensure consistency and coherence of the whole Action Plan.



Working Methods

The management body of the Conference of INGOs is the Standing Committee, composed of directly elected voluntary members of the Conference of INGOs.

The INGOs with participatory status, together with invited NGOs and experts contribute on a voluntary basis to the work through

- Committees (working groups until April 2021)
- debates,
- side events,
- country visits
- other activities led by the Conference of INGOs.

Among its working methods, there are sessions which include debates with Council of Europe personalities and institutions.



Country visits of the Conference of INGOs

The Conference of INGOs of the Council of Europe visits member States to meet local NGOs and public authorities to better understand the cooperation between NGOs and decision-makers and to discuss NGO participation in the public decision-making process.

-The Conference hears the point of view of both NGOs and authorities to find out what use is made of these participatory existing mechanisms.

Each visit is followed by a report which highlights the important issues for the NGOs at that specific moment and socio-political context. Recommendations are formulated to improve the effectiveness of cooperation between NGOs and the public authorities. The findings of the visits also contribute to advancing the Council of Europe's work in this field.

The participation of civil society in decision-making is one of the priorities of the Secretary General of the Council of Europe and this work contributes to civil society's effective and meaningful participation in the political decision-making process.

Gender Equality

The Conference of INGO supports the Council of Europe's strong commitment to a de facto and substantive gender equality at all levels and in all areas and follows all Council of Europe standards.

The Conference of INGOs follows the Council of Europe's Equality Strategy 2018-2023 as well as the numerous recommendations adopted by the Committee of Ministers on equality.

Among the main challenges that gender equality poses in the member states:

- Combatting Gender Stereotypes and Sexism in the media, in education, against sexist hate speech
- Preventing and Combatting Violence against Women (including emerging issues on migration)
- Guaranteeing Equal Access of Women in Justice
- Achieving Balanced Participation of Women and Men in Political and Public Decision-Making

In this context, the Standing Committee of the Conference of INGOs created a "Gender Equality Watch Unit" to remain vigilant about the conditions under which States act in matters of gender equality, to support NGOs in their democratic mission and to monitor respect for human rights. The "Watch Unit" is operational by receiving information from the INGO network acting in the field, by making visible good practices in the field and by proposing an analysis in the light of the work carried out within the Council of the Europe and other international and European organizations and institutions, in particular on the basis of international legal instruments applying to gender equality.



Integrated Youth Approach - Bridging Generations

It is essential to take into account the youth perspective in the work of the Conference of INGOs.

A Task Force on Youth has the role to develop a youth perspective to the work of the INGO Conference:

- facilitating the participation of young people,
- encouraging an intergenerational, more inclusive and representative dialogue
- becoming a platform for debate and support known and recognised by young people in all member States
- > Youth INGO Representatives Programme (thanks to INGO Service)
- Specific actions
- Explicit references are made in the delivered products ("Youth Check") and action led by the Working Groups;
- Collaboration and implementation of actions with CoE and external partners



Migration Task Force

Beyond the humanitarian emergencies, a change of paradigm is needed to build fully cohesive societies, with respect for human rights and laws in the countries. This Taskforce will develop well-argued common positions, including a prospective analysis of post-migration phenomena, and allow the Conference of INGOs to react in an appropriate manner whenever it proves necessary, and to mutualise the knowledge and expertise of its members.

Functions:

- Receive and analyse information (alerts) from the INGO networks acting at the grassroots level on the protection and reception of migrants in the Council of Europe member States.
- Remain vigilant to the conditions in which NGOs operate for their humanitarian mission
 of welcoming and integrating migrants and also remain vigilant with regard to the
 defense of their rights. Collect and publish good practices in this area;
- Propose an analysis of the information received in the light of the work carried out within the Council of Europe and other international organisations, on the basis of international legal instruments applying to migration law;
- Develop and propose reasoned collective statements regarding the identified phenomena to the Conference of INGOs.



Expert Council on NGO Law

The Conference of INGOs already founded in 2008 its Council of Experts on NGO Law: an independent body made up of experts who conduct studies on laws in force or in preparation at national level, ensuring their compatibility with the Council of Europe standards in this area.

The Expert Council drafts and publishes legal opinions on the situations of countries where Democracy is threatened by restrictions imposed on civil society.

For examining the evolution of NGO law, there is a reading grid which consists of a legal framework and numerous reference documents.

Recently, the Expert Council has adopted <u>Guidelines on Protecting NGO Work in Support of Refugees and Other Migrants</u>. These guidelines have been developed to help Council of Europe member States and international organizations to ensure, when taking action against trafficking in human beings and migrant smuggling and responding to the presence of refugees and other migrants, that their laws, policies and practices are consistent with standards relating to the treatment of non-governmental organisations and the protection and promotion of civil society space in Europe.







How can I participate as representative?

- Ask questions if something is not clear!

Your Responsibilities as a Representative

- Forward important info to your NGO (in its diverse member countries!)
 Write reports and articles for your NGO's newsletter
- Share with the Conference of INGOs information about the initiatives undertaken by your national members, about the impact of your project, your concerns and analyses.
- Propose recommandations and topics to be discuss by the Conference of INGOS.
- Help prepare the future of the Conference of INGOs by staying informed about the drafting of the new Rules of procedure
- Know and respect the <u>Code of Conduct</u>
- Know and Respect the <u>Communication Charter</u>
- Remind the treasurer of your NGO to contribute to INGO Service Association!
- Inform your NGO about the Conference and all its tools! (e.g. dialogue toolkit)
- Give a proxy to a colleague if you cannot participate to a vote for any reason!



How can my NGO participate?

- Inform your representative on the situation of your NGO in different countries

- Contribute to INGO Service Association

Code of conduct of the Conference of INGOs

Adopted by the Conference of INGOs on 10 April 2019

The Conference of INGOs adopted a Code of Conduct which supplements the Rules of Procedure of the Conference of INGOs.

<u>The purpose</u> of this Code of Conduct is to govern participation in the activities of the Conference. Its provisions apply to <u>all</u>, whether legal or physical persons, who participate in the activities of the Conference.

It defines general principles of behavior, like e.g. to respect and defend the values and principles of the Council of Europe, to act with integrity and honesty, not engage in sexist or discriminatory behavior, to take decisions solely in the general interest while pursuing their declared objectives, not to act in a way as to bring the Conference into disrepute or tarnish the Conference's image, to undertake to comply with the Rules of conduct. It defines sanctions that may be imposed for a breach of this Code of Conduct.



Communication Charter of the Conference of INGOs

This charter sets out to establish for the Conference of INGOs of the Council of Europe

- the references,
- the aims,
- the conditions of implementation, and
- the directives and principles to be observed
 - by the members of the Standing committee as well as
 - by member organisations of the Conference



Code Of Good Practice For Civil Participation In The Decision-making Process

The principal objective of this Code is to contribute to the creation of an enabling environment for NGOs in member States as well as in Belarus. It aims to define a set of general principles, guidelines, tools and mechanisms for civil participation in the political decision-making process.

The Code is intended to be implemented at the local, regional and national level. It is based on practical experiences from NGOs across Europe, and the sharing of their good practices and valid methods to engage with public authorities.


An additional objective of the Code of Good Practice is to be a relevant and effective tool for NGOs — from the local to international level — in their dialogue with parliaments, governments and public authorities. It aims to be an interactive and action-oriented instrument, so that NGOs and public authorities across Europe can effectively utilize it. It is also targeted at public authorities — which include parliament, government, and public administration at the local, regional and national level.
