Each Leadership Dialogue will be presided over by two Co-Chairs, one from a developing country and one from a developed country, to be appointed by the two Presidents of the international meeting.

National consultations

With financial support from the Government of Sweden and facilitation by UNDP, 58 Stockholm+50 national consultations will be organized between February and May 2022. These consultation outcomes will inform the Stockholm+50 international meeting through national reports and a global synthesis report that captures key findings, recommendations, data, media coverage, and links to national policy frameworks such as NDCs, NAPs, NBSAPS, green recovery, and sector strategies. They are also closely linked to regional and other thematic organizations organized by UNEP and partners.

The 58 consultations will be supported in: Algeria, Angola, Argentina, Barbados, Bhutan, Burkina Faso, Cameroon, Central African Republic, Chile, China, Colombia, Costa Rica, Cote D'Ivoire, Cuba, Ecuador, Ethiopia, Federated States of Micronesia, Fiji, Georgia, Guatemala, Guinea, India, Indonesia, Iraq, Jordan, Kazakhstan, Kenya, Kyrgyzstan Liberia, Maldives, Mali, Mauritius, Mexico, Morocco, Mozambique, Namibia, Nigeria, Programme of Assistance to the Palestinian People, Papua New Guinea, Peru, Philippines, Rwanda, Samoa, Serbia, Sierra Leone, Sri Lanka, Somalia, Sudan, Thailand, Timor-Leste, Trinidad and Tobago, Turkey, Uganda, Uruguay, Uzbekistan, Vanuatu, Viet Nam, and Zimbabwe

In addition to these 58 consultations, other countries are welcome to organize their own dialogues.
