Synopsis

The meeting held in Paris on 12 March 2025

The Committee on Culture, Science, Education and the Media, meeting in Paris on Wednesday 12 March 2025, with Ms Linda Hofstad Helleland (Norway, EPP/CD), Chairperson, in the chair, as regards:
