Synopsis of the meeting held in Strasbourg during the 2nd part-session 2025

The Committee on Social Affairs, Health and Sustainable Development, meeting in Strasbourg with Ms Saskia Kluit (Netherlands, SOC), Chairperson of the Committee, in the Chair, on:
