# I. <u>Main developments between the Assembly's first part-session of 2023 and the</u> second part-session of 2023

# A. Assembly's response to the Russian Federation's aggression against Ukraine

Addressing the multifaced consequences of the Russian Federation's aggression against Ukraine and supporting our member State Ukraine has continued to be the Assembly's number one priority during this period. On 24 February 2023, the President of the Assembly, together with Council of Europe's Secretary General, the Minister of Foreign Affairs of Iceland and President of the Committee of Ministers, and the Permanent Representative of Ukraine to the Council of Europe, marked one year of the Russian Federation's war of aggression against Ukraine during a special ceremony held in Strasbourg. In his speech, the PACE President expressed the Assembly's full solidarity with the people of Ukraine and reiterated that PACE support for Ukraine, to restore its territorial integrity and national sovereignty and to ensure that justice is done, will never falter. On the same day, the President of the Assembly, the Minister of Foreign Affairs of Iceland and President of the Committee of Ministers, the Council of Europe's Secretary General, Commissioner for Human Rights and President of the Congress of Local and Regional Authorities, made a joint statement calling for unity and the restoration of peace in Ukraine.

How to further support Ukraine against the Russian Federation's aggression was at the heart of a <u>current affairs</u> <u>debate</u> on *Supporting Ukraine one year since the beginning of the Russian Federation's large-scale war of aggression: the role of the Council of Europe*, held during the Standing Committee meeting in the Hague on 2 March 2023. Members of the Assembly underlined that, by building on the numerous Resolutions and Recommendations adopted since the launch of the war of aggression, the Assembly should intensify its efforts to ensure an effective system of accountability.

In addressing the <u>International Bucha Summit</u> on 31 March 2023, the President of the Parliamentary Assembly, Mr Tiny Kox, expressed his profound horror and shock at the grave violations of human rights and breaches of international humanitarian law that happened in Bucha and other towns around Kyiv. In underlying the responsibility of the international community to ensure accountability for these crimes and to guarantee that justice is delivered, the President called on as many States and international organisations as possible, and in particular the United Nations General Assembly, to endorse the establishment of an hoc international criminal tribunal to prosecute the crime of aggression and to support its functioning.

As regards the April part-session's agenda, an urgent debate on *The situation of Ukrainian civilians, including children, forcibly displaced or transferred to the Russian Federation or Ukrainian territories under the de facto control of the Russian Federation, with the online intervention of Ukraine's First Lady Olena Zelenska, is due to take place on Thursday 27 April 2023.* 

# B. Assembly's contribution to the Reykjavík Summit

Under the aegis of the Rapporteur of the Committee on Political Affairs and Democracy, Ms Fiona O'Loughlin (Ireland, ALDE), the Assembly continued to follow the preparations for the Reykjavík Summit of the Council of Europe, and to work on ensuring a strong parliamentary dimension to the Summit.

On 3 March 2023, members of the Standing Committee meeting in the Hague, held an <u>exchange of views</u> on #RoadToReykjavik: towards the Council of Europe of the future. Keynote speakers of this event were Mr Martin Eyjólfsson, Permanent Secretary of State, Ministry of Foreign Affairs, Iceland; Mr Leendert Verbeek, President of the Congress of Local and Regional Authorities; Mr Bjørn Berge, Deputy Secretary General of the Council of Europe; and Ms Jacobine Geel, President of the Netherlands Institute for Human Rights. During the debate, members of the Assembly outlined their expectations from the Summit in line with the Assembly's <u>Recommendation 2245 (2023)</u>. They all recognised that the consequences of the Russian Federation's aggression against Ukraine should be at the centre of the Summit's agenda, with a strong focus on accountability and the practical means to ensuring it. Members also believed that Heads of State and Government should not miss the opportunity offered by the Summit to renew, strengthen and give the Council of Europe new means to have an impact and stay ahead of developments, notably in the field of environmental protection and artificial intelligence.

On 20 March 2023, the President of the Assembly <u>addressed</u> the Committee on Political Affairs and Democracy to discuss preparations for the Reykjavik Summit and the meeting of the Standing Committee he convened in Reykjavik on 15 May 2023. The President referred, in particular, to the Special Event on the Summit taking place during the Standing Committee meeting, which will cover two main themes at the heart of the Summit's deliberations: *the role of the Council of Europe as a key player of the multilateral architecture*, and *the Council of* 

*Europe as a pioneer of human rights protection: the new generation of rights.* Members of the Assembly will have the chance to exchange views on these two topics with the Prime Minister of Iceland and other high-level officials, as well as with youth and civil society representatives.

A current affairs debate on the #RoadtoReykjavik is due to be held on Tuesday 25 April 2023, with the participation of the President of the European Court of Human Rights, Ms Síofra O'Leary. Close dialogue between the Parliamentary Assembly and the Committee of Ministers on the Summit will also continue during the forthcoming part-session on the occasion of a Joint Committee meeting to be held on Wednesday 26 April.

# II. Assembly's second part-session of 2023 (24-28 April 2023)

The draft agenda of the part-session, as well as the list of hearings and exchanges of views open to the public, are enclosed to the present Communication.

As regards the practical organisation of the part-session, due to major modernisation and technical renovation works in the Assembly's hemicycle, plenary sittings will be held in in the hemicycle of the European Parliament. All other official meetings (Committees, political groups, Bureau and Joint Committee) will be held at the Palais de l'Europe (meeting rooms on the second floor). This arrangement will apply to all future part-sessions up until January 2024 included.

Members of the Assembly, secretaries of delegations and political groups, Ambassadors, as well other participants who normally have access to the Assembly's hemicycle, who hold a specific PACE photo badge or a Council of Europe photo badge with the hemicycle in yellow, will have access to the European Parliament building and its hemicycle. Access will be possible via the bridge between the Palais de l'Europe and the European Parliament located on the 1st floor of the Palais, on presentation of their badge.

During the sittings in the hemicycle of the European Parliament, all votes will take place in accordance with the usual procedure (electronic voting). Specific voting cards will be fabricated for each member of the Assembly, compatible with the European Parliament's electronic voting system.

Votes for judges to the European Court of Human Rights and Council of Europe personalities by secret ballot will also be done through the electronic voting system available in the European Parliament's hemicycle.

# III. Decisions taken by the Bureau on 2 March 2023

- Standing Committee in Reykjavik (15 May 2023): took note of the draft agenda;

- **References and transmissions to committees**: approved the references and transmissions as appear in Appendix II, subject to ratification by the Standing Committee;

## - Elections observation

• o Montenegro: Presidential election (19 March 2023): confirmed the appointment of Mr Joe O'Reilly (Ireland, EPP/CD) as Chairperson, approved the final list of members of the ad hoc committee (Appendix III) and took note of the <u>statement</u> by the pre-electoral mission;

• O Bulgaria: parliamentary elections (2 April 2023): approved the list of members of the ad hoc committee to observe these elections and appointed Mr Andrej Hunko (Germany, UEL) as Chairperson (Appendix IV);

• Türkiye: Presidential and parliamentary elections (14 May 2023, tbc): approved the list of members of the ad hoc committee to observe these elections, appointed Mr Frank Schwabe (Germany, SOC) as Chairperson (Appendix V) and decided that the same delegation would observe the second round of these elections;

• O Conference "Elections in times of crisis: challenges and opportunities" (Bern, 9-10 May 2023): decided to include the institutional representatives of the Assembly to the Council for Democratic Elections as *ex officio* members, as well as to allocate a seat to a member not belonging to a political group to the ad hoc committee to participate in the conference, approved the list of members of this ad hoc committee and appointed Mr Damien Cottier (Switzerland, ALDE) as Chairperson (Appendix VI).

- Václav Havel Human Rights Prize: took note of the memorandum prepared by the Secretary General of the Assembly and re-appointed as members of the Selection Panel Ms Anne Brasseur and Mr Nils Muižnieks for a third term of two years starting from 1 June 2023;

- Institutional representation of the Parliamentary Assembly in 2023: following a consultation by written procedure, approved on 15 February 2023 the nominations as set up in Appendix VII;

- Participation of members in Parliamentary Assembly plenary sessions and committee meetings: took note of the information memorandum on the participation of members in Parliamentary Assembly plenary sessions and committee meetings in 2022 in accordance with Resolution 1583 (2007) and decided:
