# I. Second part of the Ordinary Session of 2023 (24 - 28 April 2023)

# A. Assembly's response to the Russian Federation's aggression against Ukraine

The major highlight of the Assembly's April part-session was the debate under urgent procedure on Deportations and forcible transfers of Ukrainian children and other civilians to Russian Federation or to Ukrainian territories temporarily occupied: create conditions for their safe return, stop these crimes and punish the perpetrators. The debate was preceded by the most appreciated online intervention of Ms Olena Volodymyrivna Zelenska, First Lady of Ukraine. In a resolution based on a report prepared by Mr Paulo Pisco (Portugal, SOC), PACE demanded the safe return of Ukrainian children forcibly transferred to the Russian Federation or territory it temporarily occupies, as well as punishment of those who carried it out at all levels - pointing out that the documented evidence of this practice matches with the international definition of genocide. The Assembly added there was evidence that deported children had faced a process of "russification" through re-education in Russian language, culture and history, citing examples of children being banned from speaking Ukrainian, exposure to propaganda, and visits to "patriotic" sites or military training. These transfers of Ukrainian children were "clearly being planned and organised in a systematic way" as state policy, the Assembly said, and had the abhorrent aim of "annihilating every link to and feature of their Ukrainian identity". The Assembly also called for access to Russia for the UN and International Red Cross and Red Crescent to gather information on deported children and urged states to gather evidence of crimes - including genocide - that may have been committed. In a separate recommendation based on the same report, the Assembly welcomed the preparation by the Committee of Ministers of a declaration on the situation of children of Ukraine affected by the Russian Federation's continued aggression against Ukraine initiated by the Steering Committee for the Rights of the Child (CDENF) with a view to its adoption by the Heads of State and Government of the Council of Europe at the forthcoming 4th Summit (16-17 May 2023, Reykjavik, Iceland). Underscoring the need to guarantee the effective protection of the rights of children of Ukraine, the Assembly expressed its readiness to cooperate with the Committee of Ministers on this issue.

This debate was followed by a current affairs debate on *Russia's role in escalating tensions in the Republic of Moldova*. This discussion was opened by Mr Aleksander Pociej (Poland, EPP/CD), who underlined that one lesson to be drawn from the current sanguinary page of European history written by the Russian Federation, is that appeasement is not an option. "The aggression of the Russian Federation against Ukraine is not only a brutal, illegal, unjustified and unjustifiable war of aggression against a member state of the Council of Europe, but a threat against all of us", he added. The Bureau of the Assembly decided to refer the matter to the Political Affairs and Democracy to be taken into account in the preparation of the report on *The political consequences of the Russian Federation's aggression against Ukraine*.

# B. Assembly's contribution to the Reykjavík Summit

On Tuesday 25 April, the Assembly held a current affairs debate on the *#RoadtoReykjavik*. In opening the debate, Ms Fiona O'Loughlin (Ireland, ALDE) highlighted that the Russian Federation is writing a bloody page in European history, waging a barbaric war of aggression to achieve its imperialistic objectives. "It is exactly because our deepest values are being trampled upon that we must reaffirm our identity", she said. The Reykjavik Summit is the response of the member States to the Russian Federation's aggression against Ukraine. She added that the Reykjavik Summit "should be the starting point for a renewed Council of Europe, with a greater capacity to contribute to our shared democratic security, to respond to our citizens' real concerns and to tackle the momentous challenges that confront us. We should make the most of this chance". The President of the European Court of Human Rights, Judge Síofra O'Leary, also participated in the debate. In her intervention, she underlined that at the Summit, the Court is seeking a renewed commitment from the contracting States to the Convention system and to the binding nature of Court judgements and decisions. She then called on parliamentarians and on the Heads of State and Government, to translate the discourse of values into material and political support.

On Wednesday 26 April, the Joint Committee held an exchange of views on the Reykjavik Summit.

The Assembly will continue to follow preparations of the Summit, thanks to the work of the rapporteur of the Committee on Political Affairs and Democracy, Ms Fiona O'Loughlin. It will also pursue discussions on the parliamentary dimension to the Summit during the Standing Committee meeting to be held in Reykjavik on 15 May 2023.

# C. Election of judges to the European Court of Human Rights

On 26 April 2023, the Assembly elected Mr Sebastian Răduleţu as judge to the European Court of Human Rights in respect of Romania.

## E. Current affairs debates and debates under urgent procedure

The Assembly held a debate under urgent procedure on Deportations and forcible transfers of Ukrainian children and other civilians to Russian Federation or to Ukrainian territories temporarily occupied: create conditions for their safe return, stop these crimes and punish the perpetrators.

The Assembly held a current affairs debate on the *#RoadtoReykjavik*, and a second one on *Russia's* role in escalating tensions in the Republic of Moldova.

### F. Media coverage

The 2023 Summer session generated considerable media coverage, with 56 accredited journalists present in Strasbourg to report on it. Most of the coverage was generated in Ukraine, followed by Armenia, Italy, France and international news outlets.

The debate on deportations and forcible transfers of Ukrainian children and the online intervention of Olena Volodymyrivna Zelenska, First Lady of Ukraine, triggered an important media echo on Ukrainian TV, as well as in print and on social media internationally, with more than 70 articles published.

Largely reflected by the press was also the hearing on "Excluding the athletes and officials of the Russian Federation and Belarus from participating in the international Olympic movement", specially in the United Kingdom (Reuters, BBC, The Guardian, The Independent, The Times, Sky Sports...) as well as major international news outlets.

In the margins of the part-session, the special event in support of imprisoned Russian opposition leader Vladimir Kara-Murza, laureate of the Václav Havel Human Rights Prize 2022, benefited from strong coverage on social media platforms, especially on Twitter.

On social media, the debate on the deportations and forcible transfers of Ukrainian children accounted for more than half of the total 255,000 impressions across the week, and produced the top tweet, re-tweeted more than 430 times so far.

President Zelensky tagged the PACE account in a tweet seen by approaching half a million people. The hearing on excluding Russian and Belarusian athletes from the Paris Olympics also had significant impact, being streamed live in tweets by Reuters and Sky. These two issues also dominated coverage of YouTube – with a total of over 5,000 views and some 266 hours of "watch time". Facebook generated a total reach of around 3,000.

The MediaBox, a web-TV studio available to all those making news at the Assembly in Strasbourg or virtually, once again proved its usefulness for both Assembly members and journalists, with 43 statements and interviews with parliamentarians published on the PACE website and social media supports.

# III. Decisions taken by the Bureau (24 April and 28 April 2023)

### Appendix IV – Mandate: General Rapporteur on Political Prisoners in Europe

### 1. Term of office: one year, renewable once

### 2. Mandate

The general rapporteur on Political Prisoners in Europe is mandated to intervene in matters relating to alleged cases of politically motivated arrests and criminal prosecutions in Europe and in other countries having an observer or cooperative status with the Council of Europe or the Parliamentary Assembly.

### 3. Definition

A "political prisoner" is a person who is deprived of his or her liberty in circumstances fulfilling one or more of the criteria reaffirmed in Assembly Resolution 1900 (2012), namely:

- a. if the detention has been imposed in violation of one of the fundamental guarantees set out in the European Convention on Human Rights and its Protocols (ECHR), in particular freedom of thought, conscience and religion, freedom of expression and information, freedom of assembly and association;
- b. if the detention has been imposed for purely political reasons without connection to any offence;
- c. if, for political motives, the length of the detention or its conditions are clearly out of proportion to the offence the person has been found guilty of or is suspected of;
- d. if, for political motives, he or she is detained in a discriminatory manner as compared to other persons; or,
- e. if the detention is the result of proceedings which were clearly unfair and this appears to be connected with political motives of the authorities." (SG/Inf(2001)34, paragraph 10).

The finding by the European Court of Human Rights, in favour of a person deprived of his or her liberty, of a violation of Articles 5 in conjunction with Article 18 of the European Convention of Human Rights is a strong indication that such a person is a "political prisoner".

### 4. Responsibilities

The role of the general rapporteur is to:

- follow activities and maintain working relations, when need arises, with different Council of Europe institutions and bodies which deal with issues relating to politcial prisoners, including the Committee of Ministers, the Commissioner for Human Rights, the Secretary General and the Conference of INGOs;

- follow activities and maintain, when appropriate, working relations with bodies and agencies of the United Nations (including its Working Group on Arbitrary Detentions), the European Union, with the Organisation for Security and Cooperation in Europe (OSCE), in particular the OSCE Parliamentary Assembly's Special Representative on Political Prisoners, and with other international governmental and non-governmental organisations;

- represent the committee on behalf of the Assembly *vis-à-vis* any of the above mentioned bodies and groups, when relevant and appropriate;

- in appropriate cases, make statements and launch appeals on his/her own behalf or propose to do so to the Committee;

- in appropriate cases, engage in communication with alleged political prisoners or their families and their lawyers;

- follow up previous resolutions and recommendations of the Assembly on issues related to alleged cases of political prisoners.

The general rapporteur shall report periodically, at least annually, to the committee on information collected and any action taken.

### Appendix XI – The Vigdís Prize for Women's Empowerment

### The Vigdís Prize for Women's Empowerment

To be launched in Reykjavík on the eve of the 4<sup>th</sup> Summit of Heads of State and Government of Council of Europe Member States (16-17 May 2023)

The Vigdís Prize for Women's Empowerment takes its name from the first woman in the world to be elected President, Vigdís Finnbogadóttir, elected President of Iceland in June 1980. Also a UNESCO Goodwill Ambassador, she is a shining example for women's empowerment, and an inspiration for women today who are still striving for equality in all walks of life. Its aim is to reward outstanding initiatives promoting the empowerment of women in all their diversity, with a broad remit ranging from achievements in gender equality, in equal access to participation and decision making, to championing women's opportunities and helping them to take their place in society, as well as action to encourage inclusive policies and practice.

Eligible candidates for the Vigdís Prize for Women's Empowerment are individuals or civil society groups, including national or international non-governmental organisations, associations and private companies. Current members of the Parliamentary Assembly and deceased individuals are not eligible. Prize-winners will be awarded a sum of 60.000 euros to finance action in the field that is conducted or supported by the Prize-winner, and a diploma, to be presented during each June part-session of the Parliamentary Assembly.

A call for candidates for the Vigdís Prize for Women's Empowerment will be launched each year in November, by submission of a letter to the Secretary General of the Parliamentary Assembly and a form signed by at least 5 sponsors. Once eligibility of the applications has been verified, a meeting of the Selection Panel will be held in spring in Reykjavík or in Strasbourg, on a rotation basis, to examine the candidacies and decide on a shortlist of three nominees to be submitted, for information, to the Bureau of the Assembly. The names of these nominees will be made public by the President of the Assembly. On the Sunday preceding the Assembly's June part-session, the Selection Panel will meet in Strasbourg to decide on the winner of the Prize. The name of the Prize-winner will be announced by the President of the Assembly during a special ceremony to be held at the opening of the Assembly's June part-session.

The Selection Panel of the Prize, chaired by the President of the Assembly or by a person designated by her or him, will be composed of six independent members with recognised standing in the field of women's empowerment, three nominated by the Bureau of the Assembly upon the proposal of the Assembly's Committee on Equality and Non-Discrimination and three nominated by the Government of Iceland. Current members of the Assembly cannot be members of the Selection Panel. They are appointed for a two-year period, renewable twice.

The Vigdis Prize for Women's Empowerment will replace the Parliamentary Assembly's Gender Equality Prize, established pursuant to its Resolution 1593 (2007).

#### Regulations for the Vigdís Prize for Women's Empowerment

#### Article 1 – The Prize

The Vigdís Prize for Women's Empowerment will be awarded by the Parliamentary Assembly of the Council of Europe every year in order to reward outstanding initiatives promoting the empowerment of women in all their diversity, with a broad remit ranging from achievements in gender equality, in equal access to participation and decision making, to championing women's opportunities and helping them to take their place in society, as well as action to encourage inclusive policies and practice.

#### Article 2 – Award

The Prize will consist of a sum of 60 000 euros to finance action in the field that is conducted or supported by the Prize-winner and a diploma.

#### Article 3 - Eligibility

Individuals or civil society groups, including national or international non-governmental organisations, associations and private companies may be nominated for the Prize. Current members of the Parliamentary Assembly and deceased individuals will not be eligible.

#### Article 4 – Nominations

4.1. Nominations for the Prize must reach the Secretary General of the Parliamentary Assembly before 15 February each year. They will be signed by at least five sponsors, other than the nominee, on the special form appended to these Regulations.

4.2. Nominations will provide details of the nominee's action to promote women's empowerment and specify the reasons why the nominee's action(s) can be considered to be outstanding. All relevant supporting documents will be provided.

4.3. Nominations may be submitted in one of the two official languages of the Council of Europe.

Article 5 – Selection Panel

5.1. The Selection Panel, chaired by the President of the Assembly or a person designated by her or him, will be composed of six independent members with recognised standing in the field of women empowerment.

5.2. Three members of the Selection Panel will be nominated by the Bureau of the Assembly upon the proposal of the Assembly's Committee on Equality and Non-Discrimination and three nominated by the Government of Iceland.

5.3. Current members of the Assembly cannot be members of the Selection Panel. They are appointed for a two-year period, renewable twice.

### Article 6 - Decision on the Prize-winner

6.1. The Selection Panel will decide on any conflict of interest concerning its members.

6.2. Once eligibility of the applications has been verified, a meeting of the Selection Panel will be held in spring in Reykjavík or in Strasbourg, on a rotation basis, to examine the candidacies and decide on a shortlist of three nominees to be submitted, for information, to the Bureau of the Assembly. The names of these nominees will subsequently be made public by the President of the Assembly.

6.3. In a second sitting on the Sunday preceding the Assembly's June part-session, the Selection Panel will meet in Strasbourg to decide on the winner of the prize. This decision will be taken by an absolute majority of the votes cast.

#### Article 7 - Award ceremony

7.1. The name of the Prize-winner will be announced by the President of the Assembly during a special ceremony to be held at the opening of the Assembly's June part-session.
