Communication by the Secretary General of the Parliamentary Assembly at the 1470th meeting of the Ministers' Deputies¹ (28 June 2023)

¹ This document covers the activities of the Assembly since the meeting of the Bureau on 19 June 2023 and future activities up to the meeting of the Bureau on 14 September 2023 (Paris).

I. Third part of the Ordinary Session of 2023 (19 - 23 June 2023)

A. Assembly's response to the Russian Federation's war of aggression against Ukraine

During the June part-session (Appendix I), two major Resolutions dealing with the consequences of the Russian Federation's war of aggression against Ukraine were adopted. With the adoption of Resolution 2506 (2023) on "Political consequences of the Russian Federation's war of aggression against Ukraine", the Parliamentary Assembly recognised that one of the main political consequences of the aggression is that it has forged a renewed bond amongst democracies in support of Ukraine. The Reykjavik Summit, parliamentarians highlighted, is the expression of this unity around common values, and of the resolve to support Ukraine as long as it takes. The Resolution also underlined that supporting Ukraine should be a political imperative for the Council of Europe and its member States, not only as an issue of rule of law and international justice, but also to protect democratic security in Europe. In this context, the Assembly also set a number of priorities and recommended in particular to: step up assistance to Ukraine, including by contributing to the Action Plan for Ukraine "Resilience, Recovery and Reconstruction" 2023-2026; complete and implement a comprehensive system of accountability of the Russian Federation and its allies; step up diplomatic efforts to isolate the Russian Federation and Belarus as its accomplice in the war of aggression against Ukraine; counter the false narratives about the war of aggression and the sanction system; tackle legal gaps and loopholes in the sanction system; as well as to strengthen Europe's democratic security and resilience against external threats.

By adopting Resolution 2507 (2023) on "War of aggression against Ukraine - Participation of Russian and Belarusian athletes in the Paris 2024 Olympics and Paralympics", the Assembly called on the International Olympic Committee (IOC) and its constituent sports bodies to maintain the position expressed in 2022, and to prohibit the participation of Russian and Belarusian athletes in the Paris Olympic and Paralympic Games and all other major sporting events as long as the Russian Federation's war of aggression continues. The Assembly stated that any participation in the current context is unthinkable, underlying it would certainly be used as a tool of propaganda and would de facto prevent other athletes - not least Ukrainian ones - from participating. The Assembly also stressed that IOC's efforts to establish a set of criteria allowing these athletes to take part as neutral, individual competitors cannot provide the necessary guarantees, and will not constitute a response worthy of the values of human dignity and peace enshrined in the Olympic Charter. The arguments for permitting their participation on the grounds of neutrality, the independence of sport and non-discrimination do not carry sufficient weight faced with the imperative of condemning and repudiating the atrocities being committed, and of demonstrating the international community's complete and unwavering support for Ukraine as the onslaught continues. The parliamentarians also pointed out that Russian and Belarusian elite athletes received state salaries and were often part of military sports teams and underlined that it seems impossible that they could demonstrate their neutrality and distance from these regimes, let alone make any declaration against the war.

B. Follow-up to the Reykjavík Summit

The Assembly was one of the strongest voices calling for a fourth Council of Europe Summit of Heads of State and Government, a call amplified in the wake of the large-scale war of aggression launched by the Russian Federation against Ukraine in February 2022. During the months of the run-up to the Reykjavik Summit of 16-17 May 2023, the Assembly played an active role in the discussions and preparation of the directions and outcomes, in particular through its Recommendation 2245 (2023). It also had a first exchange on the outcome of the Reykjavik Summit during its Standing Committee in Riga, at the end of which it adopted a Declaration. In order to ensure that its work is firmly oriented towards the successful implementation of the Summit decisions, thus bringing forward the

parliamentary dimension at multilateral and national level, the Assembly has now taken the Reykjavik Declaration as a roadmap for setting its priorities for the coming months and years. As a first step, during the June part-session, each Assembly Committee discussed how to concretely adapt its work plan to implement the priorities set in Reykjavik. The outcome of these discussions was presented during the Bureau meeting on 23 June 2023 in the form of a memorandum and an informal action plan document (Appendix III and IV). The Bureau of the Assembly will in fact have a special responsibility to promote the coordination and synergy of the work of the Assembly's committees' and other structures; to streamline the Assembly's work programme and to regularly take stock of the implementation of the Summit outcomes by the Assembly. At this end, a regular item on the follow-up to the Summit will figure on each future meeting of the Bureau. The President of the Assembly, Mr Tiny Kox, will ensure close coordination with Committees Chairs by convening an informal meeting with all Chairpersons of Committees during every part-session. The follow-up to the Reykjavik Summit was also at the heart of the discussions in the Joint Committee held on Thursday 22 June 2023.

The sections on the Parliamentary Assembly in the draft Programme and Budget 2024-27 will reflect its objectives in contributing actively to the Reykjavik priorities and follow-up in line with the Assembly's Opinion on the budget and priorities of the Council of Europe for the period 2024-2027 (Rapporteur: Ms Ingjerd SCHOU, Norway, EPP/CD), adopted by the Assembly on 21 June 2023. In adopting the Opinion, the Assembly also underlined that given the depth of the priorities set by the leaders of the member States at the 4th Summit, the Council of Europe should be granted resources that are commensurate with the level of member States' political ambition for the Organisation. During the session, the Assembly's expenditure needs for 2024-2025 have also been reviewed and tailored in order to request resources which will allow it to respond to these readjusted political priorities. In particular, the Assembly will continue to provide support to Ukraine, including through interparliamentary co-operation, and to address the political, legal and human rights consequences, as well as to secure accountability. Moreover, the Assembly will focus on parliamentary co-operation and provision of support to member States and their parliaments in delivering a number of key priorities identified in the Reykjavik Declaration. Notably, its priorities will include the support to the implementation of judgements of the European Court of Human Rights, securing accountability and preventing impunity for the crime of aggression and war crimes, crimes against humanity and grave human rights violations committed during the Russian Federation's war of aggression against Ukraine, counteracting democratic backsliding and providing early warning and rapid reaction, as well as addressing the new generation of rights, including regarding the environment and the use of artificial intelligence and emerging digital technologies.

D. Current affairs debate and debates under urgent procedure

The Assembly held a current affairs debate on "Recent political developments in Poland" on Tuesday 20 June 2023.

The Assembly also held three debates under urgent procedure on "Political consequences of the Russian Federation's war of aggression against Ukraine", on "War of aggression against Ukraine – Participation of Russian and Belarusian athletes in the Paris 2024 Olympics and Paralympics?", and on "Ensuring free and safe access through the Lachin Corridor" on Thursday 22 June 2023.

E. Media coverage

The 2023 summer session generated a moderate amount of media coverage, in line with previous summer sessions, with around 28 journalists accredited in Strasbourg to report on it. Most coverage was in Ukraine.

The Assembly's positions on the political consequences of the war in Ukraine – and call for a ban on Russians and Belarusians taking part in the forthcoming Olympics and Paralympics – generated the most coverage, including in international media. Other topics to be widely covered were the Assembly's debates and resolutions on the challenges faced by Belarusians in exile, including the address by Ms Tsikhanouskaya, and ensuring free access through the Lachin corridor.

On social media, the impact was similar. There were just under 340,000 Twitter impressions over session week. There were around 7,500 views on YouTube, amounting to around 382 hours of "watch time", and a little over 2,200 impressions on Facebook.

PARLIAMENTARY ASSEMBLY FOLLOW-UP TO THE REYKJAVIK SUMMIT OF THE COUNCIL OF EUROPE (16-17 MAY 2023)

1. Introduction

1. The Parliamentary Assembly was one of the strongest voices calling for a fourth Council of Europe Summit of Heads of State and Government, a call amplified in the wake of the large-scale aggression of the Russian Federation against Ukraine in February 2022.

During the months of the run-up to the Reykjavik Summit of 16-17 May 2023, the Assembly played an active role in the discussions and preparation of the directions and outcomes, in particular through its Recommendation 2245 (2023) "The Reykjavik Summit of the Council of Europe – United around values in the face of extraordinary challenges", prepared by Ms Fiona O'Loughlin (Ireland, ALDE) for the Committee on Political Affairs and Democracy with the input of the Ad Hoc Committee of the Bureau on the 4th Summit of Heads of State and Government of the Council of Europe, which included all the Chairpersons of the Assembly's Committees.

2. The Rapporteur and the Ad Hoc Committee worked with great intensity, in a constant dialogue with the Secretary General, the rapporteur of the High-Level Reflection Group, Mr Venizelos, and the Committee of Ministers, through meetings of the Joint Committee and an exchange in GT-SOM04. In various formats, the Assembly held several debates to feed into its final contributions, in plenary part-sessions and meetings of its Standing Committee.

The key imperative of ensuring the accountability of the Russian Federation was raised by the Assembly as from its Opinion to the Committee of Ministers of 16 March 2022 which led to the exclusion of Russia from the Council of Europe the following day, and was developed in a comprehensive way in a number of reports prepared by the Committee on Legal Affairs and Human Rights Committee. In fact, the Assembly was the first international institution to take a clear position in favour of the creation of a Special Tribunal on the Crime of Aggression.

3. The Standing Committee of the Assembly met in Reykjavik on 15 May to provide a parliamentary dimension to the Summit. An Assembly delegation composed of its President, the Presidential Committee and the Rapporteur, Ms O'Loughlin, attended the Summit.

At its meeting in Riga on 26 May, the Standing Committee welcomed the outcomes of the Summit, and adopted a Declaration setting out the broad lines of its own follow-up to the priorities of the Reykjavik Declaration.

4. In order to ensure that its work is oriented firmly towards the successful implementation of the Summit decisions, thus bringing forward the parliamentary dimension at multilateral and national level, the Assembly will now take the Reykjavik Declaration as a roadmap for setting its priorities for the coming months and years.

2. Priorities

5. While many areas of work relevant to the Summit actions are already underway, others may be strengthened or added.

Accordingly, the Assembly will give high priority to:

- its firm commitment and concrete actions to support Ukraine and ensure accountability of the Russian Federation;
- supporting the European Court of Human Rights and the Execution of Judgments as the cornerstone of all the Council of Europe's work and promoting European Union accession to the European Court of Human Rights;
- disseminating and implementing the Reykjavik Principles for Democracy as a blueprint for safeguarding and strengthening democratic security and resilience on our continent;
- counteracting democratic backsliding and anchoring democratic culture in societies; protecting media freedom;
- fighting all forms of discrimination, fostering gender equality and protecting the human and social rights of all groups in society;
- participating in the Council of Europe's review and further work on emerging human rights challenges, such as the environmental crisis and the exponential growth in the use of artificial intelligence throughout our societies;
- engaging with youth, civil society and human rights defenders;
- contributing to rules-based multilateralism and strengthening inter-parliamentary dialogue, with national parliaments and international assemblies;
- strengthening dialogue with Belarusian democratic forces and civil society; identifying channels for establishing dialogue with Russian democratic forces and civil society who share Council of Europe values.

3. Structures and working methods

- 6. The contribution of the Parliamentary Assembly to the Reykjavik follow-up will be channelled through its different structures and working methods, including:
 - The work of its thematic Committees, leading to reports, resolutions and recommendations on the main priority topics identified at the Summit (thematic approach); further strengthening of cross-committee collaboration in order to pool efforts and expertise on multi-faceted Reykjavik priorities;
 - The work of General Rapporteurs and thematic sub-committees, focusing on specific issues of particular importance;
 - Its country-by-country monitoring reports;
 - Co-operation with the Committee of Ministers, notably through the Joint Committee, and with the Secretary General of the Council of Europe (trialogue mechanism, regular exchanges with the Bureau and the Assembly):
 - Active participation in, and co-ordination with, work underway in the intergovernmental sector, particularly in the field of setting of new standards and monitoring;

- Strengthened participation in the Organisation's co-operation activities, adding an interparliamentary input into Action Plans, and interparliamentary co-operation activities including through its thematic networks, and through peer exchanges;
- Links with the Court and Execution of Judgments process, focusing on the parliamentary dimension of the implementation of judgments (regular thematic reports) and by fulfilling its statutory role in the Election of Judges;
- Co-operation and co-ordination with the activities of the Commissioner for Human Rights (both thematic and country by country reports);
- Work of PACE members at the national level to ensure adherence to and implementation of Council of Europe standards and increased visibility
- Regular exchanges with civil society, youth, Human Rights defenders and other outside partners.
- 7. The sections on the Parliamentary Assembly in the draft Programme and Budget 2024-27 will reflect its objectives in contributing actively to the Reykjavik priorities and follow-up in line with the Assembly's Opinion on the budget and priorities of the Council of Europe for the period 2024-2027 (Rapporteur: Ms Ingjerd SCHOU, Norway, EPP/CD), adopted on 21 June 2023. Its expenditure needs for 2024-2025 have been reviewed and tailored in order to request resources which will allow it to respond to these readjusted political priorities.

The present document contains further details and examples of the re-prioritisation of its activities in the light of the main directions indicated in the Reykjavik Declaration; it may be further developed following the current discussions on this matter in each committee.

8. As part of its work to ensure the good implementation of the Reykjavik Declaration, the Assembly will continue to review its own functioning and working methods. It will further develop cross-committee working and a task-oriented approach to resource allocation in order to maximise efficiency and optimise impact. It will continue to support and participate in the reform processes underway in the Council of Europe as a whole, especially as regards good governance and staff and budgetary management.

The Bureau of the Assembly will have a special responsibility to promote the coordination and synergy of the work of the Assembly's committees' and other structures; to streamline the Assembly's work programme and to regularly take stock of the implementation of the Summit outcomes by the Assembly


