Council of Europe's Director of Information Society and Action against Crime, Directorate General Human Rights and Rule of Law, Jan Kleijssen, firmly believes in building a Europe without dividing lines, based on the shared values of Human Rights, Rule of Law and Democracy. He brings with him 37 years of accumulated institutional knowledge in all main sectors of the Council of Europe: Judicial, Parliamentary and Intergovernmental. Moreover, as Director of the Private Office, from 1999 until 2004, he was responsible for major reforms, political initiatives and crisis management.

Appointed in 2018 by the Secretary General, he led the work on proposals for the future of the Council of Europe following the Elsinore Ministerial Session. These served as a basis for decisions taken at the Ministerial Session in Helsinki in May 2019, celebrating the 70th Anniversary of the Council of Europe.

His Directorate, with some 200 highly qualified and motivated staff, carries out standard-setting, monitoring and co-operation activities on a wide variety of issues, which include: *Freedom of Expression, Data Protection, Artificial Intelligence, Internet Governance, Cybercrime, Terrorism, Criminal Law, Prison Management, Fighting Corruption and Money Laundering.*

From 2015 to 2020 he was Chair of the Council of Europe's Disciplinary Board and Council of Europe Internet Governance coordinator since 2018. On his initiative, the Council of Europe gave a partnership status to a still growing number of major global and regional private companies and associations. The marketing software platform, Onalytica, included Jan among the 2019 Top 100 influencers on the regulation of new technologies.

Throughout his career, Jan has been acknowledged for his ability to deal impartially with highly sensitive issues, and for clarity on procedural matters. He deviates from the trodden path to find creative and acceptable solutions and obtain concrete results. Equally, his colleagues recognise his capacity for change management and leadership based on motivational guidance, vision and dynamism.

Having obtained Master's Degrees in International Law (Utrecht) and in International Affairs (Ottawa) and performed military service as an officer in the Royal Netherlands Navy, Jan joined the Council of Europe in 1983 as a Lawyer with the European Commission of Human Rights. Subsequently he served for some 9 years as Secretary to the Political Affairs Committee of the Parliamentary Assembly, playing a major role in the accession procedure for new member states.

Fluency in English, French, German and Italian alongside his native Dutch, including the Low Saxon dialect of his birthplace, Almelo, near the German border, and marriage to Stefania from Rome reinforce Jan's multicultural outlook. Marcelo AEBI



Marcelo F. Aebi, Ph.D., is Full Professor of Criminology at the University of Lausanne, Switzerland. He is also responsible for the *Council of Europe Annual Penal Statistics* (SPACE), Head of the *European Sourcebook Group* and of the Scientific Advisory Board of the *Netherlands Institute for the Study of Crime and Law Enforcement* (NSCR), member of the Scientific Advisory Board of the *European Institute for Crime Prevention and Control* (HEUNI), and Executive Secretary of the *European Society of Criminology.* Author or co-author of more than two hundred scientific publications written in (or translated to) English, French, Spanish, Catalan, Italian, Macedonian, Turkish, and German, his main research topics include comparative

criminology, prisons, probation, crime indicators (criminal statistics, victimization surveys and self-reported delinquency studies), as well as drugs and crime. He is also member of the editorial board of several scientific journals including the *European Journal of Criminology*, the *European Journal on Criminal Policy and Research*, the *Journal of Criminal Justice and Security*, the *Revue Internationale de criminologie et de police technique et scientifique*, and *Crime, Law and Social Change*.

After his studies at the universities of Buenos Aires, Argentina (Law) and Lausanne (Post-graduate degree and Ph.D. in Criminology), Marcelo F. Aebi has been a visiting fellow at the Rutgers School of Criminal Justice (New Jersey, United States of America) and at the Max Planck Institute for Foreign and International Criminal Law (Freiburg, Germany), vice-director of the Sevilla Section of the Andalusian Institute of Criminology (Spain), member of the Scientific Advisory Board of the International Center for the Prevention of Crime (ICPC), as well as visiting/associate professor of criminology at the University of Sevilla and at the Autonomous University of Barcelona, Spain.

Dr Lucy Baldwin is a Senior Lecturer/Researcher in Criminology at De Montfort University, she is also a qualified and experienced social worker and probation officer. Lucy has over 35 years of experience in criminal and social justice settings.

Lucys Doctoral and subsequent research is centred around mothers and motherhood in and after prison. Her work explores the impact of criminalisation on maternal identity, emotion and experience and highlights the importance of recognizing maternal trauma and its relevance to women's' experiences of criminal justice. Lucy' provided oral and written evidence to the female focussed farmer Review and to the Joint Human Rights Inquiry into maternal sentencing and the Rights of the Child. Lucy is passionate about positive change for criminalised mothers and mothers in the criminal justice system. Her research and work have informed policy and practice change across the public, private and voluntary sectors and she continues to work closely with all. Lucy has presented nationally and internationally on the importance of working positively with mothers in



She also works closely with public, private and third sector practitioners and is active in her hopes and pursuit of positive change and penal and sentencing reform.

Sébastien CAUWEL, recently appointed as the new Director of the French National Correctional Administration Academy (Énap), holds of a master's degree in private law and was trained at the Enap. He formerly was Deputy Director of the Office of the Prefect of Essonne, Director General of the services of Vendée, Secretary General of the prefecture of Aveyron and Secretary General of the Prefecture of Guadeloupe. Previously, he was Deputy Governor of different prisons (the Osny remand Centre, the Bordeaux-Gradignan remand Centre, the Borgo Penitentiary Centre) and in 2010, Head of the Integration and Probation Department at the Interregional Directorate of Penitentiary Services of Bordeaux.

Mary CORCORAN



Mary Corcoran is Professor of Criminology at Keele University, England. She is internationally recognised for her research on political imprisonment in Ireland, women in custody, and privatisation/marketisation in criminal justice domains. Her work makes a pioneering contribution to the study of the voluntary sector in criminal justice, with a focus on supporting voluntary sector resilience and addressing barriers to citizens' participation in justice. Mary's research also focuses on prison to community custody - designing responsive services for vulnerable groups (women, youth, elders, and bereaved prisoners). More recent research and consultancy works to create sustainable partnership working in criminal justice, enabling statutory, social enterprise and charities to support those caught up in the criminal justice system more effectively.

Professor Corcoran works extensively with governmental, academic, research and civil society organisations to find applied, humanitarian responses to harms arising from crime and punishment. She has worked with several NGOs, including the National Council for Voluntary Organisations, Clinks, and Amnesty. Mary has advised the Department for International Development (DfID) and the Ministry for Justice (both UK). She has previously chaired workshops on inter-agency collaboration for the Confederation of European Probation and

Europris (2019). Mary had held research fellowships at the Centre for Crime, Law and Justice, University of New South Wales (Australia), and the Center for Third Sector Studies, Ben-Gurion University (Israel). She serves on academic advisory boards for charities and the Probation Institute (UK), and is member of the editorial boards for leading academic journals including The *British Journal of Criminology* and *Criminology & Criminal Justice*.

Annie Devos has acquired a large experience throughout her career in the field of prison and probation.

She has consecutively been prison governor (1988-1991), technical expert on prison policy for the Minister of Justice (1991-1995), seconded head of the department for policy and general affairs (1995-1997) and head of the department in charge of the individual inmates' file (1997-1999) at the Ministry of Justice. Afterwards, Annie has run the Belgian probation department - called "Houses of Justice" - since its creation in 1999. At the time, the services depended on the judicial organisation and were then transferred to the services of the Ministry of Justice until late 2014. In 2015, the services were divided between the 3 linguistic communities due to the 6th State reform.

Annie has been appointed as Director-General for the Wallonia-Brussels Federation, which comprises the head office, the 13 local houses of Justice, the Centre for Electronic Monitoring and the Centre for Assistance to People concerned by any Radicalism or Extremism leading to Violence (CAPREV) and subsidises partner services in charge of offenders' and victims' support.

Elle a successivement été directrice de prison (1988-1991), attachée auprès du Ministre de la Justice pour la politique pénitentiaire (1991-1995), directrice détachée au service des études et affaires générales (1995-1997), directrice détachée au service de la gestion des situations individuelles des détenus (1997-1999). Elle a ensuite dirigé les services de probation belges, dénommés « Maisons de justice » depuis leur création en 1999. Les services dépendaient alors du Ministère de la Justice jusque fin 2014. En raison de la 6^e réforme de l'Etat, les services ont ensuite été divisés entre les trois communautés linguistiques.

Annie a été nommée Administratrice générale pour les services de la Fédération Wallonie-Bruxelles qui comptent une administration centrale, treize maisons de Justice, un centre de surveillance électronique et un centre d'aide et de prise en charge des personnes concernées par les radicalismes et extrémismes violents (CAPREV) et subventionne l'aide aux justiciables, exécutée par les services partenaires.

Carlos Fernandez is a prison psychologist from the General Secretariat of Penitentiary Institutions, currently working as Prison Governor in an Open-Regime prison in Murcia after serving as Head of Treatment in other Spanish prisons. He has attended several international working groups in Europe and in the MENA region focused on the management of radicalization and risk assessment, as well as on the best practices for prison intervention with specific groups. He has developed instruments on prison intervention in Spain (Spanish risk assessment instrument) as well as in other countries (Component Leader for security and treatment in the Twinning Project with Turkey 2018-2020). Member of RAN Pool of Experts and the Advisory Committee of the Canadian Practitioners Network for the Prevention of Radicalization. Trainer of the Council of Europe through the HELP Project, Trainer of EU Action Against Drugs and Organized Crime in Georgia (EU-ACT) and Trainer to enhance Penitentiary Capacities in Addressing

Radicalization in prisons in Western Balkans.

He has published papers on the prevention of radicalization and risk assessment in prison (RAN, 2021) and currently involved in the review of the Spanish instrument for risk assessment and the Spanish programme on disengagement from extremist violence. After being successively Deputy Governor of the Paris la Santé prison (1995-2001), Editor at the detention management office (2001-2003), Deputy Governor of the French Polynesia establishments (2003-2007), Deputy Head and then Head of the detention management office at the Prison Administration Directorate (2007-2011), Deputy to the Inter-Regional Director, Head of the overseas prison services mission (2011-2015), Cabinet Director at the Prison Administration Directorate (2015-2017), Governor of the Poissy central prison (2017-2021), Valérie HAZET is, since 1 September 2021, the Head of the Department of Trades, which includes the Sub-Directorate of prison security, the Sub-Directorate of insertion and Probation, and the Mission to Fight Violent Radicalisation.

Robert Josten works as Senior Policy Advisor HRM for the Custodial Institutions Agency, part of the Ministry of Justice and Security of the Netherlands. In his 35 years at the Ministry, he has had jobs as consultant, project manager and strategic management advisor for the Director of Juvenile Institutions. He also contributed largely to the development of Dutch Government Competency Language. In the recent years he was occupied with development of quality standards for staff in the Prison Service which resulted in the establishment of diploma-demands in May 2021, based on the European Qualifications Framework (EQF) and fitting with the requirements of prison staff, contributing to the re-integration of prisoners back into society.

In 2018 he was asked to hold a presentation on diploma-based qualities of prison staff at a meeting of the PC-CP of the Council of Europe in Strasbourg. Parts of his advice are now adopted in Council of Europe's legislation on prison staff. In 2019

he held a presentation of his work on quality standards at the EuroPris meeting in Berlin which was received with lots of positive reactions and international contacts.

In 2020, as part of an assignment of the Centre for International Legal Co-operation (CILC) under the auspices of the European Union, he worked 4 separate weeks at the Ministry of Justice of the Republic of North Macedonia, developing result-based job descriptions for prison staff from the perspective of humane treatment of prisoners and consolidating this expertise by transferring this to local HR Advisors.

Robert is now developing career paths for prison staff, based on these quality standards, both for the benefit of prison staff and to fill the vacancies of higher prison staff in a difficult Dutch labour market.
