- Safe construction
- Avoidance or mitigation of impacts on the environment
- Signed Bern Convention
  - Conserve biodiversity
  - Establish an Emerald network of protected areas

- block the upstream and downstream movement of fish
- prevent sediment transport
- cause a decline in groundwater
- reduced water quality

## **Project EIAs**

No EIA available for Kalivaç

- No assessment of river flow impacts
- Out-of-date analysis of environmental flows
- No assessment of sediment transport impacts
- No mention of aquatic or wetland species, such as mammals, fish or water birds
- International best practice not followed

## Consultation with local people

Local people met with mission team

"strong objection to dams"

"will ruin farming and eco-tourism"

"never told or consulted"

"statutory meeting not advertised and held a long way from river valley"

"have records of rare species"



### Recommendations

- 1. Suspend dam projects until full assessments completed
- 2. Prepare strategic river basin plans
- 3. Study sediment transport impacts
- 4. Consider Vjosa for Emerald network
- 5. Engage with local people
- 6. Repeat EIA using local knowledge
- 7. Improve Albanian EIA training
- 8. Prepare strategic energy plan
- 9. Hold workshop to exchange/discuss biodiversity data
- 10. Improve links between government, academics and NGOs
