# DRAFT COUNCIL OF EUROPE STRATEGY ON ROMA AND TRAVELLER INCLUSION (2026-2030)

#### **DRAFT CONCEPT NOTE**

#### **BACKGROUND**

The regular dialogue events with Roma and Traveller civil society organisations aim to:

- 1. reinforce the regular dialogue between the Council of Europe and Roma communities on all policy issues relevant for Roma inclusion
- 2. stimulate the regular dialogue between member states and Roma organisations at national level
- 3. provide input to the various organs and entities of the Council of Europe on the effectiveness and appropriateness of their operational programmes, monitoring mechanisms and political initiatives, with due respect for their independent character and mandates.
- 4. increase the capacity of Roma and Traveller civil society organisations and to build expertise and knowledge of the Council of Europe standards and monitoring mechanisms, relevant for Roma and Traveller inclusion.

The 19<sup>th</sup> meeting of the Council of Europe dialogue with Roma and Traveller civil society focuses on the draft Council of Europe Strategy on Roma and Traveller Inclusion (2026-2030).

The present is an explanatory footnote, not a definition of Roma and/or Travellers.

The policy framework in the area of Roma and Travellers inclusion is translated into the <u>Strategic Action Plan for Roma and Traveller Inclusion</u>, adopted in 2020. Its implementation will be finalised by the end of 2025.

The <u>mid-term review of the Strategic Action Plan</u> highlights progress made in the three priority areas and in better mainstreaming Roma and Traveller issues across the work of the entire Organisation. It was highlighted that the Council of Europe was able to make a difference for Roma and Travellers by advocating for changes in the member States and supporting them in their endeavours. Key achievements before the mid-term review include strengthening local authorities' capacities to address the needs of Roma and Traveller communities, empowering Roma women, enhancing their participation in decision-making processes, monitoring their situation during the COVID-19 pandemic, and bolstering community resilience. Additionally, member states improved their response to the pandemic by supporting local initiatives and promoting inclusive education.

Challenges are still being reported in areas such as antigypsyism, school segregation, housing, employment, by Council of Europe monitoring bodies<sup>2</sup>, the European Court of Human Rights<sup>3</sup> and Roma and Traveller civil society alike<sup>4</sup>. The Committee of Ministers continues to supervise the execution of several judgments on complex topics such as school segregation, housing, ill-treatment by law enforcement agents and investigation of racial motivation of crimes<sup>5</sup>.

Moving forward, a renewed commitment through 2030 is deemed necessary to continue combatting antigypsyism and ensure equality and inclusion for Roma and Travellers in the Council of Europe member States. The Committee of Experts on Roma and Travellers Issues (ADI-ROM) has been tasked to draft the Council of Europe Strategy on Roma and Travellers Inclusion (2020-2025) before the end of 2025. A Working Group has been constituted in May 2024, with the participation of several representatives of the Council of Europe member States and civil society organisations, observers to ADI-ROM.

The Working Group is supported by its Secretariat (Roma and Travellers Team) and the drafting has been based on reports on the implementation of the Strategic Action Plan for Roma and Traveller Inclusion (2020-2025) inside and outside the Organisation, findings and recommendations of Council of Europe monitoring bodies and inputs from member States and civil society organisations. The Strategy and its content will be aligned with the essential inhouse strategic and policy documents, as well as the ones of external partners and organisations in the field of Roma and Traveller inclusion.

The participants to the 19<sup>th</sup> Dialogue meeting will have the opportunity to exchange with the members of ADI-ROM, by partly joining the 11<sup>th</sup> meeting of the ADI-ROM Committee session in April 2025.

### OBJECTIVES OF THE 19TH DIALOGUE MEETING

The 19<sup>th</sup> meeting of the Council of Europe Dialogue with Roma and Traveller civil society will provide an opportunity for a broad exchange on relevant challenges faced by Roma and

Travellers in Europe and on possible actions from the Council of Europe, in line with its mandate. The discussion will contribute to setting the ground for the work on developing the next policy framework of the Council of Europe in the area of Roma and Travellers inclusion.

#### The meeting will:

- Present the Council of Europe Strategic Action Plan for Roma and Traveller Inclusion (2020-2025) and provide an overview of its implementation
- Collect proposals on how to further develop co-operation between the Council of Europe and Roma and Traveller civil society and the future agenda of the Council of Europe bi-annual dialogue meetings with Roma and Traveller civil society
- Serve as a co-operative and networking platform for Roma and Traveller civil society organisations and other stakeholders
- Serve as a platform for extending the knowledge of Council of Europe work in this area, exchanging experiences and sharing best practices on Roma inclusion, including with members of the Committe of Experts on Roma and Traveller Inclusion (ADI-ROM)
- Highlight and exchange examples of good practice in addressing obstacles to Roma and Traveller inclusion
- Bring forward solutions to advance Roma and Travellers inclusion which can be incorporated in the future actions of the Council of Europe;
- Identify possible topics that should be included in the future Council of Europe Strategy on Roma and Travellers Inclusion.

#### **PARTICIPATION**

25 civil society participants will be chosen through an open call disseminated via the
public website of the Council of Europe's Roma and Travellers Division. Participants will
be representatives of Roma and Traveller organisations, including representatives of
youth and women organisations, and experts from international, national and local civil
society organisations. Priority is given to representatives who hold specific expertise
regarding the different priorities of the Council of Europe Strategic Action Plan for Roma
and Traveller Inclusion (2020-2025), and that have been co-operating with the Council
of Europe.

Participants must be competent to work in <u>English or French or Romani</u>, the working languages of the meeting.

- Members of the Committe of Experts on Roma and Traveller Inclusion (ADI-ROM) (for a part of the meeting)
- Members of the Roma and Travellers Division who implement the current Strategic Action Plan
- Members of other departments of the Council of Europe and of the Inter-Secretariat
  Task Force who are mainstreaming Roma and Traveller issues into their respective
  areas of work, whose activities support the implementation of the current Council of
  Europe Strategic Action Plan for Roma and Traveller Inclusion (2020-2025) and can
  inform the development of the next policy framework in the area of Roma and Traveller
  inclusion.

#### **DATES AND VENUE**

The meeting will take place on 2 April 2025, from 09:00-17:00 and on 3 April 2024 from 09:30 to 15:15 – in Strasbourg, France.

Travel and subsistence expenses, as well as visa fees, if necessary, related to the participation in this 19<sup>th</sup> Dialogue meeting will be reimbursed according to Council of Europe rules and regulations.
