### Annex / Committee involvement

3. In which committees and other activities of the Council of Europe is this committee mainly involved?

The Committee on the Rights of Migrants has regular contact with the Standing Committee of the Conference of INGOs, its President and its representative for the Committee.

3.1 As from its creation, its validation by the General Assembly of April 2021, the Committee "Rights of Migrants" has contacted the Special Representation of the Secretary General of the Council of Europe in charge of Migration, Refugees and Asylum Seekers.

In practical terms, this means:

- ✓ An initial contact with presentation of the objectives,
- ✓ A comparative presentation of the "Action Plan of the Council of Europe" and the Action Plan
  of the Committee on the Rights of Migrants; identification of common points with a
  perspective of joint work,
- ✓ Participation in coordination meetings between the different departments, services of the Council of Europe (quarterly meetings) in order to inform each other and enrich the approaches and specific actions.
- 3.2 The issues addressed by the Committee on the Rights of Migrants are naturally linked to other Committees created in April 2021 or at the subsequent General Assemblies of the Conference of INGOs of the Council of Europe. Indeed, the Committee is particularly keen to deal with the holistic dimension of migration and not just one aspect. Thus, at least one representative of the following committees is present as a "structural link":
  - ✓ The Committee of the "Civil Society for the Rights of Children"
  - ✓ The "Action for Social Rights" Committee
  - √ The Interreligious and Interfaith Committee
  - ✓ The Committee: "Education to democracy".

In concrete terms, this means that the drafting of the basic texts on the right to health, security and education has been carried out taking into account the reflections of the other Committees.

In the same way, the field visit planned to test the activities and reflections of the Committee is designed so that the members of the "Migrants' Rights" Committee representing another Committee can indicate a correspondent on the spot to participate in the meetings and debates.

More particularly, we can note a close collaboration between the Committee on the Rights of Migrants and the Civil Society Committee on the Rights of the Child during the "shadow games" side event on the situation of unaccompanied minors.
