The Education and Culture Committee (CEC) is carrying out **three consultations on the European cultural identity** (axis 4 of the action plan 2018 – 2021) with a view to the elaboration of a white paper by June 2020. The first was held on 27 June with European personalities; the second will be held on 9 April 2019 with experts from UNESCO and the Council of Europe; the third will take place between 28 and 31 October 2019 with local and regional elected representatives.

The document aims to give food for thought for everyone (individuals, educational staff, cities, states, institutions), and promote different attitudes that are unique, open and civil towards the diversity of the contemporary intellectual world.

The future work and the second consultation should allow us to answer the following three general questions:

- How to determine the idea of European cultural identity (ECI and is it legitimate to speak about this notion?)
- In the context of solvency of national and regional identities in the ECI, why claim that federating is not destroying?
- What policies and actions do institutions carry out to educate people about European citizenship?

After the first consultation in June 2018, which focused on the importance of culture, the CEC is continuing the process by organizing this second consultation with ambassadors and experts from UNESCO and the Council of Europe.

The aim of this consultation is to present the work of UNESCO and the Council of Europe on education and on the appropriation and mobilisation of culture as dynamic elements of European cultural identity.
