PANEL 2. PERSONAL DATA, CYBERCRIME TARGETS

Cybercrime is an international scourge which, beyond digital development, affects the very functioning of our societies. It mainly affects personal data, which is a favourite target of cybercriminals at both national and international level and, knowing no borders, it challenges the sovereignty of states as much as it affects individuals. The universal standard in this area is the Council of Europe's Budapest Convention. 66 countries have signed up to it, demonstrating that this crime cannot be fought alone. States must cooperate to investigate, identify and punish criminals and thus protect citizens.

PANEL 3. PROTECTION OF PERSONAL DATA AND DIGITAL IDENTITY

Digital identity is an important element in a digital society. It includes sensitive personal data that must be protected in order to secure exchanges on the networks but also in physical life. Personal identification procedures vary greatly, but techniques and tools are widely spreading through an international movement of mimicry where no time is taken to assess advantages and risks. While it enables to respond to legitimate concerns, resorting to biometric identification, but also to unique identifiers entail high risks for the empowerment of individuals and respect for their human dignity

PANEL 4. REGULATING TRANSBORDER FLOW OF PERSONAL DATA

This is of course the case for individual movements and communications. It is especially the case in the context of economic activities. The question is not preventing these flows - if that is even possible - but facilitating them within the framework of maximum protection of personal data and, therefore, of the rights and freedoms of individuals.
