The Office will launch the 9<sup>th</sup> edition of the “My Privacy! Don’t Look, Don’t Poke About!” competition for children and youth.

This year the competition topic is as follows:

Value of information compares gold. Everything is OK if held in proper hands and used for intended purposes. Imagine however that your personal information, possibly even sensitive data would leak from, for instance, the database of your bank, insurance company, public administrative body, from police registers or medical records. What could happen then?

Young competitors may write a story, essay, or screenplay, they even may perform the invented story before a camera and produce a film or depict the narration in form of cartoon. Well-read children and youth will have the opportunity to write a text explaining in which book or movie they encountered the issue of privacy and personal data protection or what historic event reflects, in their view, privacy protection as a key element, regardless of how the event came off, well or badly.

For those who prefer drawing or painting we prepared an alternative. They may - within the boundaries of the prescribed subject matter – create freely a poster reminding on the first sight of the topicality of personal data protection. There are no limits to creativity.

Children and youth up to 18 years of age are invited to send in their contributions by 17 April 2015, either electronically or by ordinary post to the Office for Personal Data Protection.

We will welcome any supporting activity taken by schools, for example by announcing the competition simultaneously in more classes, holding a discussion on personal data protection or by way of organizing other accompanying program related to the subject matter. These schools will receive the opportunity to post their views concerning the competition on the Office's website. The most interesting contributions will be awarded.

Winning authors will be invited to Prague to an award-giving ceremony followed by an interesting programme.

Andrea Voßhoff: Now, the European Commission has to speak out plainly!

On 28<sup>th</sup> January 2015, in Berlin, the European Data Protection Day will take place for the 9<sup>th</sup> time. This year's motto "Europe: Safe Harbor of data protection?" will focus on the relations between the US and the EU, which are compromised in regard to data protection law since the Snowden revelations.

Since autumn 2013 the European Commission has been negotiating with the US-Government on the Safe Harbor rules which form the essential bases for the movement of data between the EU and the US. The finalisation of negotiations, which was originally envisaged for summer 2014, has not yet been achieved.

According to the Federal Commissioner for Data Protection and Freedom of Information, Mrs. Andrea Voßhoff, the transatlantic discussion on data protection is at a crossroads: "Obviously, the negotiations between the European Commission and the US-Government on Safe Harbor are not making any progress on the key issues. I call on the negotiating partners, who are the European Commission and the US-Government, to grasp existing chances for solutions which are in compliance with data protection requirements. Failure of negotiations may entail the suspension of data transfers to the United States by data protection supervisory authorities and hence significant economic consequences.

However, if no solution is found in a timely manner taking adequately into account the European citizens' fundamental rights, the European Commission should not exclude suspending or reversing the Safe Harbour Decision and it should enter into negotiations for a new agreement." By this statement, the Federal Commissioner for Data Protection emphasises a demand of the European Commissioner for the Digital Single Market, Mr. Andrus Ansip. He has declared Safe Harbor not to be safe. The agreement still has to deserve its name.

The European Data Protection Day recalls the signature of the European Data Protection Convention in 1981 and aims at raising the citizens' awareness about data protection issues.

2. The Ministry of Local Government and Modernisation is launching two sets of guidelines: one on the use of access logs; and one on the duty of information and the right of access. The launch is timed to coincide with the Data Protection Day and the guidelines will be presented at the seminar hosted by the Data Protection Authority.

For this purpose it has developed a new Databases Registration System that will allow the controller to register the Databases entirely online throughout the website, thus avoiding the need of filing the application for registration at the Unit's office.

This system will be made available with the goal of easing the compliance with the Principle of Legality included in article 6 of Law 18.331 of August 11<sup>th</sup>, 2008, ensuring the legality of databases, as well as compliance with other fundamental principles such as informed previous consent, purpose and data security.

Other initiatives concerning Data Protection Day is the summer contest in the framework of the « Data Is Worth It » (« Tus Datos Valen ») campaign, aimed at children in school age. The contest basis require the development of a poster, comic or animation referring to situations in which data is in jeopardy and the means to ensure its protection. The annual contest reflects the premise that awareness-raising of children in data protection issues is critical to spread this right, also reaching out by these means to their educators and families.

Finally, and in the spite of the efforts being held by other Data Protection authorities throughout the world to celebrate this date, Mag. Federico Monteverde, member of the Executive Council of the Unit will be participating as a guest speaker at the Seminar organized by the Public Information Acces and Personal Data Protection Institute of Mexico, D.F., taking place in Mexico City, on January 27-29. This Seminar tries to raise awareness in various actors (international organizations, Authorities and corporations) and mainly individuals, regarding the promotion and dissemination of the right on personal data protection and its importance as a fundamental right.

On the one side it aims at controllers of databases containing personal data, in order to emphasize the need of compliance with the regulatory requirements that include the registration obligation of the previously mentioned databases before the authority, as a way to guarantee that data included in such bases is properly protected. Moreover, it seeks to raise awareness on the importance of protecting personal data, especially to children, taking into account the potential risks to which they are exposed, for example through the use of the Internet or social networks.

## Data Privacy Day: new infringements on the horizon

Brussels, 27 January 2015

On 28 January 1981, the first binding international legal instrument on personal data was signed: the Council of Europe's Convention 108 "for the Protection of Individuals with regard to Automatic Processing of Personal Data". Since 2006, 28 January has become an international day to recognise personal data protection, known as "Data Privacy Day".

In honour of the occasion, AEDH would like to reaffirm its high regard for the privacy and personal data protection guarantees as set out in the Charter of Fundamental Rights of the European Union and the European Convention on Human Rights as well as those stated in the EU Data Protection Directive 95/46/EC and the Council of Europe's Convention 108.

In view of these texts which guarantee fundamental rights, AEDH condemns the abuses stemming from data collection by businesses and the creation of records by law enforcement in the name of security and fighting terrorism, which has been denounced by whistle-blowers. Not only are such records proliferating, but they are increasingly being used for reasons other than originally intended without any need being proven. As such, AEDH renews its disapproval of the development of "an explicitly repressive system applied to all citizens rather than only to those suspected of being involved in illegal activities".<sup>i</sup>

The recent terrorist attacks in France on 7, 8 and 9 January 2015 are being used by the European Union and its Member States to justify their reinforced security practices regarding the use of personal data records in renewed projects that have been contested by the European Parliament, such as the European PNR<sup>ii</sup> and the implementation of new measures. Despite severe criticisms by the European Data Protection Supervisor (EDPS) about existing projects, the following proposals will be made at the Informal EU Council Meeting of Ministers for Justice and Home Affairs on 29 January at Riga (Latvia)<sup>iii</sup>: reinforced internet control; disclosure of the encryption keys used by web and telecommunication companies; amendments to the Schengen code; improved processing of biometric data in the Schengen Information System (SIS), especially with regards to foreigners; the integration of national financial records into a single European system; and a more systematic and proactive use of criminal records (ECRIS) shared between Member States.

All of these measures, which fall under the responsibility of and are coordinated by Europol – which already has access to numerous records such as international financial transactions, asylum seekers (Eurodac) and visas (Visa Information System, or VIS) – will give Europol considerable additional power. However, no reference has been made to oversight by an independent authority, a user's right (or not) to reject the interoperability of records and the use of sensitive data, or the respect of proportionality and necessity criteria of the use of records, especially in the fight against terrorism, which should be considered separately.

This proposed “mega system” will complete existing border control systems, including the recent implementation of the EUROSURiv system, or the future ‘Smart Borders’ package, directives that have been unanimously opposed by EDPS, the European Parliament, AEDH and numerous NGOs. These measures, which have no established system of guarantees and controls, come at a time when the “personal data protection” package meant to replace Directive 95, approved by the European Parliament in the spring of 2014, remains blocked by the Council.

The law and respect of fundamental rights must always triumph over draconian measures, including in the fight against terrorism. Focusing on security objectives does not automatically translate to effectiveness, and such objectives are unacceptable infringements on privacy and personal data protection. The crucial fight against terrorism must be carried out within a strict framework of rules with regards to the use of records. The institutions and organisations using such records should be subject to oversight by independent and even legal authorities. Implementing these regressive measures would in fact be a new victory for terrorists.

AEDH refuses to fall into the defeatism expressed by Harvard professors on 23 January 2015 at the Davos World Economic Forum. According to Margo Seltzer, “Privacy as we knew it in the past is no longer feasible... How we conventionally think of privacy is dead.” Current practices of capturing biometric data (particularly DNA) and their use by law enforcement and private companies led Sophia Roosth to claim that “we are at the dawn of the age of genetic McCarthyism”. This type of discourse is disconnected from rights, rights which were not founded on our technological capabilities, especially when it is a question of regressive governmental or institutional practices such as those in the EU. The loss of rights should not be viewed as inevitable; instead, any democratic nation should consider maintaining rights to be a battle worth fighting.

Today on 28 January 2015, AEDH calls on all citizens and their representative organisations to reject the measures that challenge their privacy and data protection and for MPs to defend against these breaches of our rights. AEDH also calls on the EU’s decision-making bodies and Member States’ governments to re-evaluate their decisions and to understand that such ineffective measures are not only an infringement on fundamental rights but an attack on the principles of democracy and rule of law they are meant to defend.

**« Journée internationale de la protection des données personnelles : de nouvelles atteintes en préparation, restons vigilants. »**

Bruxelles, le 27 janvier 2015

Le 28 janvier 1981 était ouvert à signature le premier instrument international juridiquement contraignant en matière de données personnelles, la Convention 108 du Conseil de l'Europe « pour la protection des personnes à l'égard du traitement automatisé des données à caractère personnel ». Cette date du 28 janvier est devenue, depuis 2006, la journée internationale de la protection des données personnelles, « Privacy day ».

En cette occasion, l'AEDH ne peut qu'affirmer à nouveau son attachement aux garanties protégeant la vie privée et les données personnelles telles qu'affirmées dans la Charte des droits fondamentaux de l'Union européenne et la Convention européenne des droits de l'Homme et précisées dans la Directive 95/46/CE de l'Union européenne et la Convention 108 du Conseil de l'Europe.

En référence à ces textes garants de droits fondamentaux, l'AEDH se doit, en cette journée, de dénoncer les dérives des fichiers commerciaux mais aussi celles des fichiers de police et de renseignement au prétexte de la sécurité et de la lutte contre le terrorisme, qui ont été dénoncées par des lanceurs d'alerte. Non seulement les fichiers se multiplient, mais ils sont de plus en plus détournés de leur finalité, utilisés pour des usages aux objectifs disproportionnés par rapport à leur finalité, sans pour autant qu'une stricte nécessité soit prouvée. Aussi, l'AEDH dénonce à nouveau le fait que se mette en place « *un système de caractère explicitement répressif qui s'applique à la totalité des citoyens et non pas seulement à ceux contre lesquels il y a des présomptions ou des indices d'être impliqués dans des actes illicites* »<sup>i</sup>.

Les attaques terroristes récentes, en France les 7, 8 et 9 janvier 2015, sont l'occasion pour l'Union européenne et ses Etats membres de justifier un renforcement de leurs pratiques sécuritaires dans l'usage de fichiers de données personnelles, dans la réactivation de projets contestés par le Parlement européen, comme le PNR européen<sup>ii</sup> et dans la mise en place de nouvelles mesures. Ainsi, malgré de sévères appréciations du Contrôleur européen de la protection des données (CEPD) sur les projets déjà connus, seront proposés au Conseil des ministres Justice et Affaires intérieures (JAI) du 29 janvier à Riga<sup>iii</sup> : un contrôle renforcé d'Internet ; une déclaration des codes de cryptage par les entreprises de l'Internet et de télécommunications ; des amendements au code Schengen ; une meilleure prise en compte des données biométriques dans le Système d'Information Schengen (SIS), en particulier concernant les étrangers ; l'intégration dans un même système européen de l'ensemble des fichiers financiers nationaux ; l'utilisation plus systématique et plus proactive des fichiers de casiers judiciaires (ECRIS) partagés entre les Etats membres.

Toutes ces mesures placées sous la direction et la coordination d'Europol, qui bénéficie déjà de l'accès à de nombreux fichiers tels que les fichiers relatifs aux transactions financières internationales, aux demandeurs d'asile (Eurodac), aux visas (Visa Information System - VIS), donneront ainsi à Europol un pouvoir considérable sans la moindre référence à un contrôle par une autorité indépendante, aux possibilités ou non d'user d'un droit à l'interopérabilité des fichiers et à l'utilisation de données sensibles, au respect des critères de proportionnalité et de nécessité dans leur utilisation notamment dans la lutte contre le terrorisme ce qui devrait être exclusif. Ce « méga système » proposé vient s'ajouter et compléter les systèmes déjà existants de contrôle des frontières, dont la récente mise en œuvre du système EUROSUR<sup>iv</sup>, ou à venir avec le projet de frontières intelligentes, directives unanimement contestées par le CEPD, le Parlement européen, l'AEDH et de nombreuses ONG. Un ensemble de mesures sans mise en place d'un système de garantie et de contrôle, alors même que le paquet « protection des données personnelles » destiné à remplacer la Directive 95, voté par le Parlement européen au printemps 2014 est actuellement bloqué par le Conseil.

Le droit, le respect des droits fondamentaux doivent toujours l'emporter sur toutes mesures liberticides, y compris quand il s'agit de lutter contre le terrorisme. Mettre en avant des objectifs sécuritaires n'est pas synonyme d'efficacité ; ils sont autant d'atteintes inacceptables à la vie privée et à la protection des données personnelles. La nécessaire lutte contre le terrorisme, doit impérativement se faire dans un cadre strictement nécessaire quant à l'utilisation des fichiers, les institutions et organismes concernés par leur usage devant être soumis au contrôle d'autorités indépendantes, voire judiciaires. La mise en place de ces mesures régressives en matière de droits constituerait de fait une nouvelle victoire des terroristes.

L'AEDH ne tombera pas dans le défaitisme qu'ont pu exprimer des membres de l'Université de Harvard le 23 janvier 2015 à l'occasion du Forum économique de Davos déclarant : « *la sphère privée telle que nous la connaissons ne peut plus exister, la façon dont nous envisagions avant la sphère privée, c'est fini* ». Affirmant d'autre part que nous serions maintenant à l'heure « *d'un Maccartisme génétique* »<sup>v</sup>, par la captation des données biométriques, en particulier l'ADN, et par leur usage par les services policiers et privés. Parler ainsi, c'est être déconnecté des droits, lesquels ne sont pas fondés sur une référence et une reconnaissance de ce que permettraient les technologies, y compris quand il s'agit de régressions dans les pratiques des gouvernements ou d'institutions comme l'Union européenne. Il n'y a pas de fatalité, mais un combat pour le respect des droits comme référence à tout Etat démocratique.

En cette journée du 28 janvier 2015, l'AEDH appelle tous les citoyens, leurs organisations représentatives à s'élever contre les mesures qui mettent en cause leur vie privée et la protection des données, les parlementaires à être des remparts à ces atteintes aux droits. Elle appelle les instances de décisions de l'Union européenne, les gouvernements qui en sont membres, à se ressaisir et à ce qu'ils prennent conscience que loin d'être efficaces de telles mesures sont non seulement une atteinte aux droits mais à terme une atteinte à la démocratie et à l'Etat de droit qu'ils sont censés défendre.
