Introduction

Founded in 2010, BAFÖ (Bund Autonome Frauenberatungsstellen bei sexueller Gewalt Österreich - Federation of Autonomous Women's Counselling Centres Against Sexual Violence Austria) now represents nine member institutions, each of which offers specialised support for female victims of sexualised violence (aged 14, respectively 16 and older) in each of Austria's federal provinces. Together with the BAFÖ, these nine specialised NGOs also carry out prevention work and awareness raising and take a socio-political stand against sexism and sexualised violence.

In the following contribution, we refer to the GREVIO Questionnaire and the State report of the Austrian Authorities.

II Implementation in the areas of prevention, protection and prosecution

Article 12: General obligations

We note that the nine member institutions of BAFÖ as NGOs make an essential contribution to public relations and prevention work around the issue of sexualised violence with their actions and campaigns. There is no Austria-wide campaign against sexualised violence initiated and financed by the Austrian authorities. The following actions and campaigns are selected examples of the activism of BAFÖ as specialist counselling centres for victims of sexual violence¹ (SCSV) in Austria. They are (co-)financed by different funding agencies on local and national levels.

Article 16: Preventive intervention and treatment programs

We note that the anti-violence counselling mentioned in the State report is not intended for sex offenders. There are no comprehensive treatment programmes for sex offenders in Austria.

Article 25: Support for victims of sexual violence

Specialist support service offering crisis intervention to victims of sexual violence:

All nine SCSVs offer this service.

Specialist support service offering immediate medical care and forensic examination for victims of sexual violence:

Theoretically, female victims of sexual violence can be examined in gynaecology departments of hospitals. Court-adjacent forensic medicine departments carry out forensic evidence collection. To our knowledge, the establishment of outpatient clinics specialising in violent victimisation is currently under development. Independent medical examination centres uniquely specialising in sexual offences do not exist in Austria.

b. & c.

We nine SCSVs offer long-term counselling, crisis intervention, and legal and psychosocial court assistance for female victims of sexualised violence starting at age 16 (sometimes at age 14). Two of our member institutions (Lower Austria and Styria) also offer psychotherapy. These services can be used at any time, i.e., for current incidents as well as for incidents that occurred in a more distant past. Since the end of 2019, there has been an SCSV in each of the nine provinces.

Number of women and girls (aged 14, respectively 16 and older) supported annually in the nine SCSVs, BAFÖ statistics:

*Note: Since the four new SCSVs Burgenland, Carinthia, Lower Austria, and Vorarlberg were still under development in 2020, the number of women and girls supported in 2020 only includes the five already established SCSVs Upper Austria, Salzburg, Styria, Tyrol, and Vienna for this year.

In the following, we refer to the information and statistics of the 24/7 women's emergency helpline of the City of Vienna mentioned in the State report: It is unclear whether the published figures represent only female victims of sexualised violence. As stated in the State report, this helpline offers support for girls and women affected by various forms of violence and - in contrast to the nine SCSVs - is therefore not specialised in sexualised violence. Furthermore, we take the liberty of noting that the Vienna-based helpline can hardly support victims from the provinces in a face-to-face setting (i.e., in a facility).

For comparison, we present here the counselling statistics of the BAFÖ with its nine member SCSVs:

*Note: The 2020 statistics also include only the figures for the five established SCSVs at that time - Upper Austria, Salzburg, Styria, Tyrol, and Vienna.

With the exception of the age of the target group (women and girls aged 14 and 16), there are no limiting access criteria for the nine SCSVs. The services are low-threshold, free of charge and anonymous if desired. No legal charges need to be filed for any psychosocial support, except - by definition - for legal and psychosocial court assistance. Almost all facilities are barrier-free. It is possible to use the services in any language, and an interpreter is consulted if necessary. Following the feminist principles of gender-homogeneous counselling and the notion of safe spaces, only women work in the nine SCSVs.

Articles 49 and 50: General obligations and immediate response, prevention, and protection

Here we would like to make a statement of principle: In our counselling work, we notice that our clients, as female victims of sexualised violence, have little trust in the police and law enforcement per se. The way the authorities deal with the victims is still characterised by mistrust and sometimes victim blaming. In addition, the rate of convictions for crimes against sexual integrity and self-determination is extremely low².
