



COUNCIL OF EUROPE COMMITTEES General Overview



With a mandate based on a Council of Europe Convention or a Resolution of the Committee of Ministers, including partial and enlarged agreements.



State of play on 1 January 2022



ork in committees lies at the heart of the Council of Europe and allows the direct participation of governmental and independent experts in its work. It significantly contributes to the Organisation's core mission, which is "to achieve a **greater unity between its members** for the purpose of safeguarding and realising the ideals and principles which are their common heritage and facilitating their economic and social progress", as stated in Article 1 of its Statute.

Committees whose mandates are based on a Convention or Resolution carry the acquis of the Council of Europe in protecting Human Rights and promoting the Rule of Law and Democracy.

Based on a consolidated set of international treaties and of Resolutions adopted by the Committee of Ministers of the Council of Europe, including to establish partial or enlarged agreements, these committees are of three kinds:

A first category includes **committees representing the parties** to a given treaty, or representing all the Council of Europe member States for Resolution-based committees. They can be characterised as 'intergovernmental'.

A second category includes **committees composed of independent experts** elected by the Committee of Ministers of the Council of Europe. These experts sit in their individual capacity and these committees can be characterised as independent monitoring or advisory committees.

A third category includes **committees established to manage partial and enlarged agreements** based on Statutory Resolution (96)36 on partial and enlarged agreements as amended by Resolution CM/Res(2010)2.

The aim of the Council of Europe is to achieve a greater unity between its members for the purpose of safeguarding and realising the ideals and principles which are their common heritage and facilitating their common heritage and facilitating their economic and social progress.

This aim shall be pursued through the organs of the Council by discussion of questions of common concern and by agreements and common action in economic, social, cultural, scientific, legal and administrative matters and in the maintenance and further realisation of human rights and fundamental freedoms.

ANTI-DISCRIMINATION, DIVERSITY AND INCLUSION

It promotes policies that contribute to more inclusive societies that value diversity, free from discrimination and hate, with an emphasis on persons belonging to national minorities, Roma and Travellers, migrants and other exposed groups.


SOCIAL RIGHTS
