Living with Controversy – Teaching Controversial Issues through Education for Democratic Citizenship and Human Rights (EDC/HRE) (2015 in English; translated in various languages). The training pack for teachers consists both of 1) a scoping paper explaining what controversial issues are and why they should be taught in school, and 2) a set of training activities on how to teach controversial issues in school. It examines major challenges of teaching such issues and provide practical tools on how to deal with them. The main approach is encouraging teachers to create safe spaces in which children and youth are given the opportunity to explore and discuss controversial issues within the framework of education for democratic citizenship, human rights and inclusive education.

This manual was produced within the Roma Youth Action Plan of the Council of Europe to provide teachers, trainers and facilitators of non- formal education processes with essential information and methodological tools (18 activities) to address antigypsyism with young people of all ages and in any social-cultural setting.

Reference Framework of Competences for Democratic Culture (CDC), Volume 1-3. (2018). The Framework comprises three volumes.

- The first contains the Model of Competences, as determined by a multidisciplinary team of international experts following extensive research and consultation. The 20 competences are divided into four areas Values, Attitudes, Skills and Knowledge and critical understanding and accompanied by information about the background to the model, how it was developed and how it is intended to be used.
- Volume 2 contains a series of statements setting out learning targets and outcomes for each competence. These descriptors are intended to help educators design learning situations that enable them to observe learners' behaviour in relation to a given competence.
- Volume 3 offers guidance on how the Model of Competences might be used in six education contexts. Further chapters will be added in due course.
