3rd meeting of the Working Group on the 24/7 MEDICRIME Network / 3^{ème} réunion du groupe de travail sur le réseau MEDICRIME 24/7

Lisbon, 4 - 5 July 2024 / Lisbonne, 4-5 julliet 2024



- 1. The meeting of the 3rd Working Group of the 24/7 Network was convened on 4-5 July 2024 to:
 - exchange views on international cooperation in criminal matters to combat the counterfeiting of medical products and similar crimes;
 - review practical experiences in a criminal law Network:
 - draft a recommendation addressed to the MEDICRIME Committee on whether a 24/7 Network is to be set up.
- 2. The meeting was held in person at the New Headquarters of the Polícia Judiciária, Lisbon, (Portugal). Participants included:
 - 13 representatives from Parties to the MEDICRIME Convention¹; a.
 - 3 representatives from signatory countries to the MEDICRIME Convention² (from b. which two Council of Europe member States);
 - C. 2 representatives from Council of Europe member States (Non-signatory countries of the MEDICRIME Convention)3;
 - d. International experts⁴;
 - Council of Europe Secretariat⁵. e.
- 3. The recommendation addressed to the MEDICRIME Committee was decided by technical participants following considerations at five workshops and supporting presentations conducted during the meeting. The options on recommendations available to participants were the following:
 - A 24/7 Network on cooperation and information exchange be established to a. specifically include falsified medical product crimes and related crimes.
 - b. A 24/7 Network on cooperation and information exchange is not established to specifically include falsified medical product crimes and related crimes.
 - C. Medical product crimes and related crimes are not considered as a specific category of crimes to be recorded by countries.

4. Outcome and conclusions:

The outcomes and conclusions from the workshops highlighted the importance of the implementation at the internal level of the State of the criminal law offences of the MEDICRIME Convention (Article 5-14; Chapter II Substantive criminal law) as this is the basis for obtaining an important level of homogeneity necessary for a 24/7 Network to effectively operate.

Related to the constitution of a 24/7 Network on cooperation and information exchange, the majority of the experts reached a level of consensus on the basis of the following points:

- a. Majority of the participants were favourable to a 24/7 Network which is integrated into an existing cooperation and information exchange network operating with the same staff and recognising medical product-related crimes as a specific crime type. This means that such conducts have to be prosecuted on the basis of specific criminal offences (e.g., manufacturing and trafficking of counterfeit medical products and similar crimes, etc.) and not on the basis of other concurring criminal offences (such as theft, deception and other fraudulent acts).
- b. This would result in excluding the creation of a standalone 24/7 Network for this purpose.
- c. The Network should be open to any country that wishes to participate in it and should not be confined to Parties to the MEDICRIME Convention or Council of Europe member States only.
- 5. Participants to this 3rd Working Group made the following technical recommendation to the MEDICRIME Committee:

"A 24/7 Network on cooperation and information exchange be established to specifically include falsified medical product crimes and related crimes".
