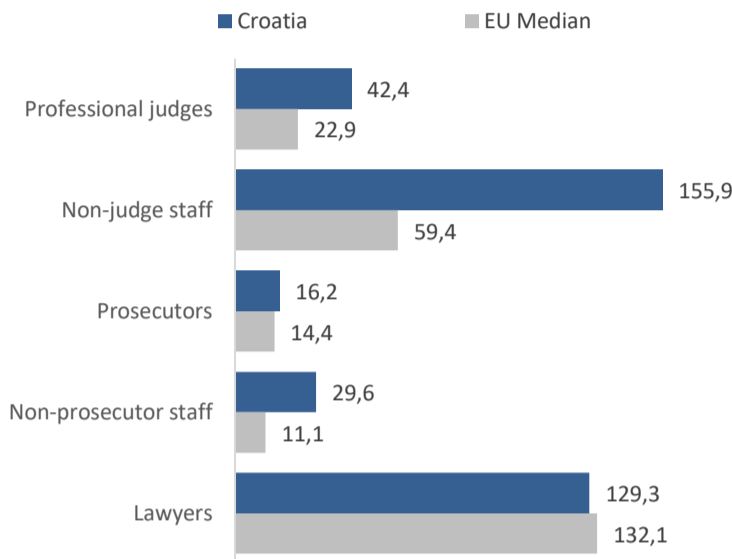

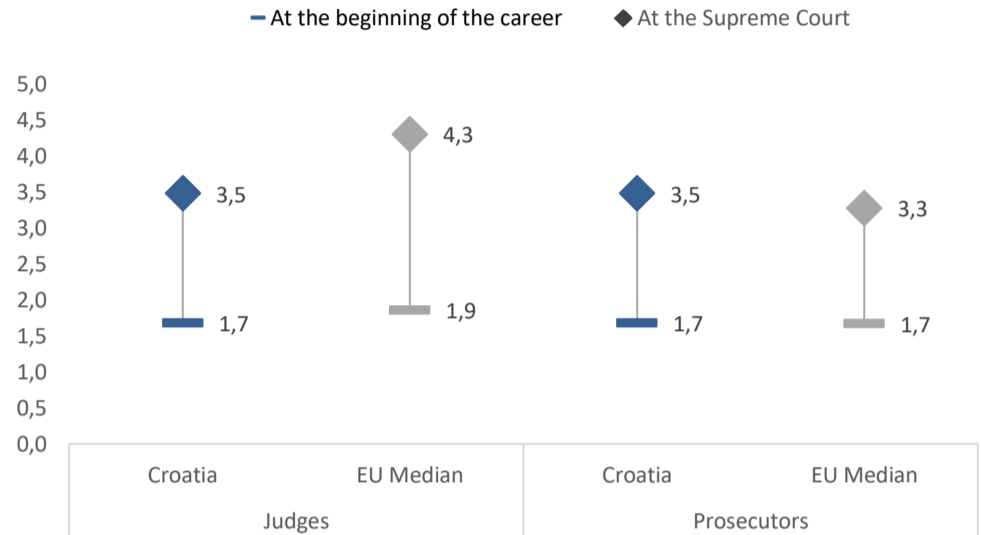

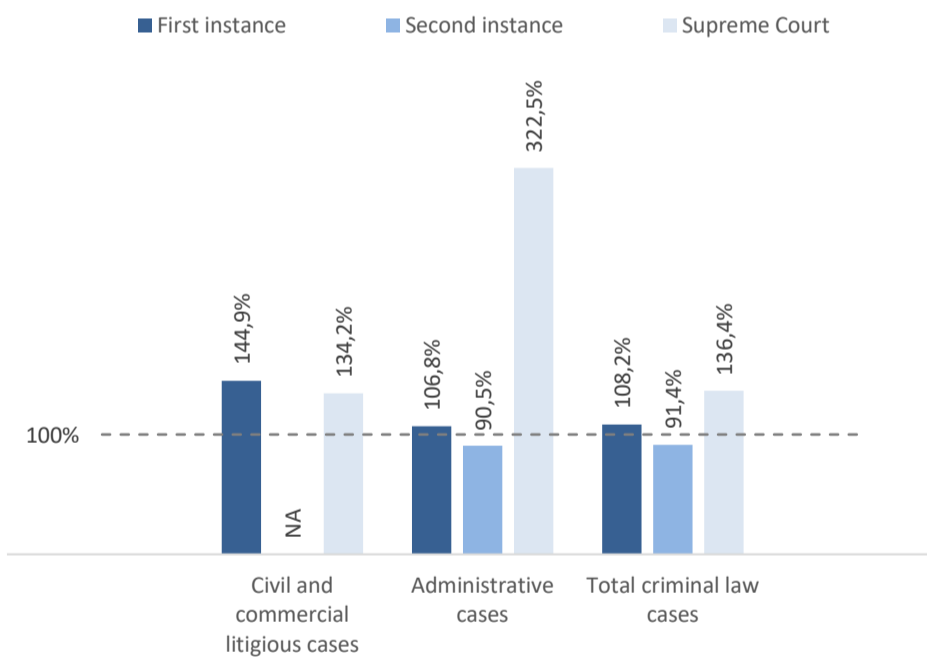


Gross salaries of judges and prosecutors vs average annual salary in 2022

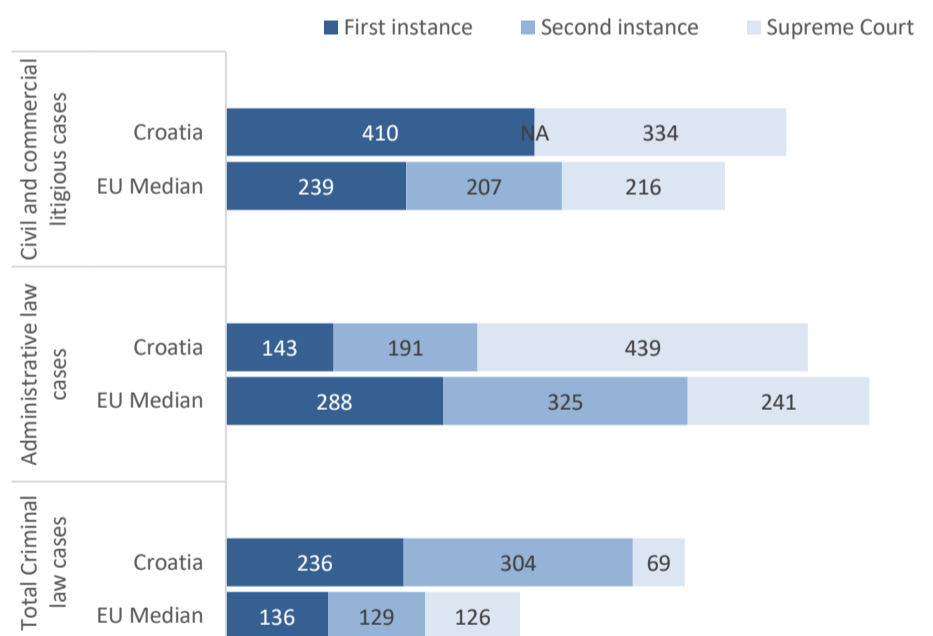

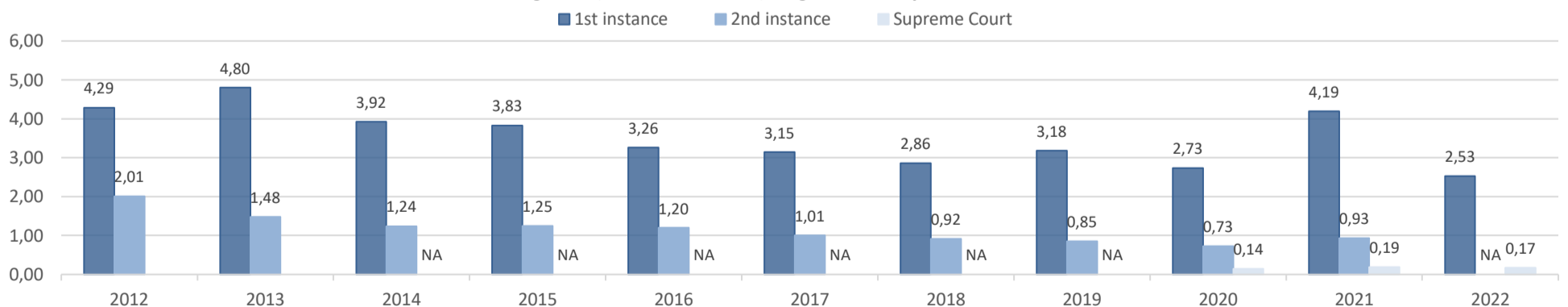


Disposition Time by instance and by matter in 2022 (days)

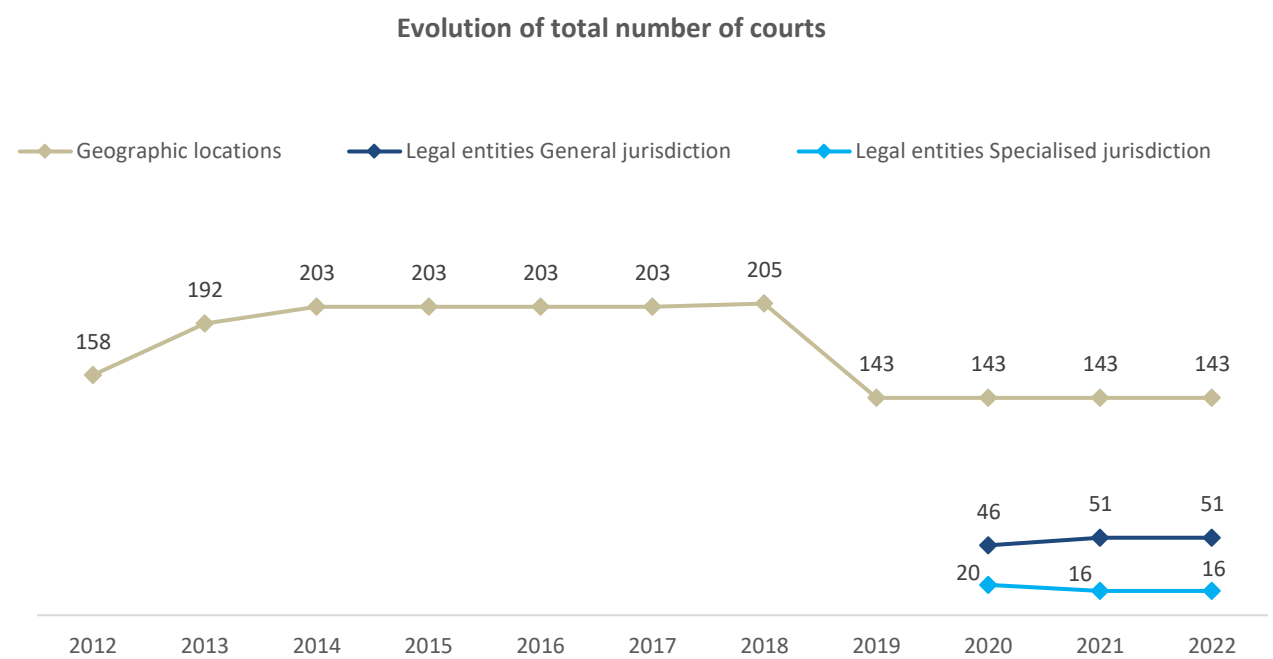

1. Judicial organisation in Croatia (2022 data)

According to 2022 data, the Republic of Croatia has 51 courts of general jurisdiction (33 in the first instance, 17 in the second instance, and the Supreme Court as the last instance). It has also 16 specialised courts. Moreover, the total number of courts - geographic locations is 143.

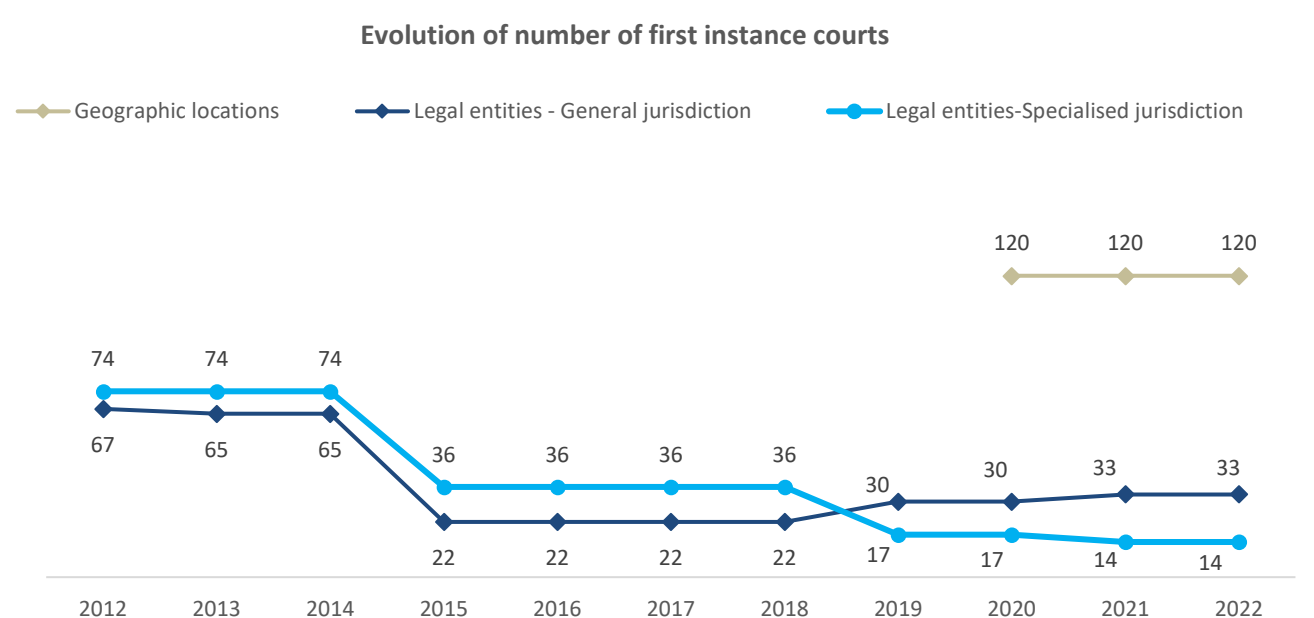

Between 2020 and 2021, there was a small variation in the number of courts of general jurisdiction and specialised jurisdiction. This was due to the establishment of the High Criminal Court in 2021, as well as to a change of methodology following which four courts which used to be classified as specialised are now classified as general (Misdemeanour Courts of Zagreb and Split; Municipal Court of Zagreb; High Misdemeanour Court).

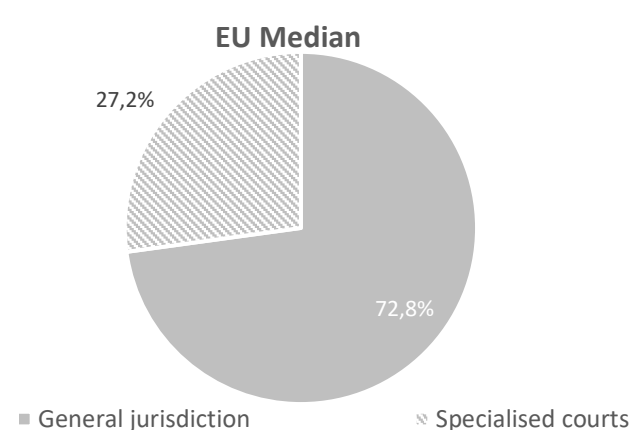
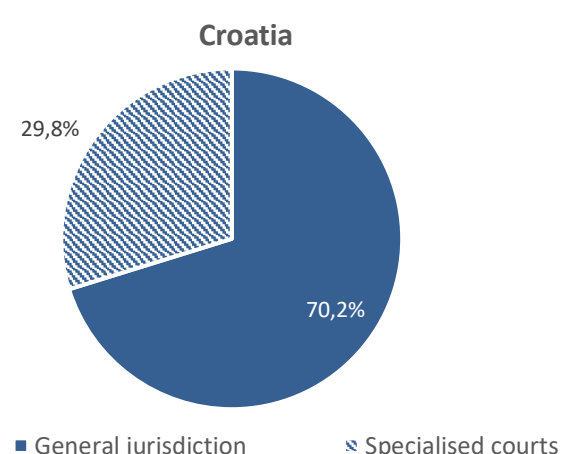

The reform of judicial map implemented in 2015 decreased the number of Misdemeanour Courts from 63 to 22. Therefore, in accordance with the Act on Territorial Jurisdiction and Seats of Courts (Official Gazette, No. 128/14) in force, there are currently 22 Misdemeanour Courts in function. On the 1st of January 2019, new Courts Areas and Seats Act came into force. From the organizational aspect, the most important organizational measure was the merging of misdemeanor courts into municipal courts, and few municipal courts were reopened after 2015. That is why there were less first instance specialized courts in 2019 than in 2018 and more courts of general jurisdiction (22 courts which were in 2018 plus 8 courts which were reopened after the new law came into force).

The distribution between first instance general jurisdiction courts and first instance specialised courts in Croatia is 70,2% - 29,8% (distribution tendency in EU: 72,8% - 27,2%).

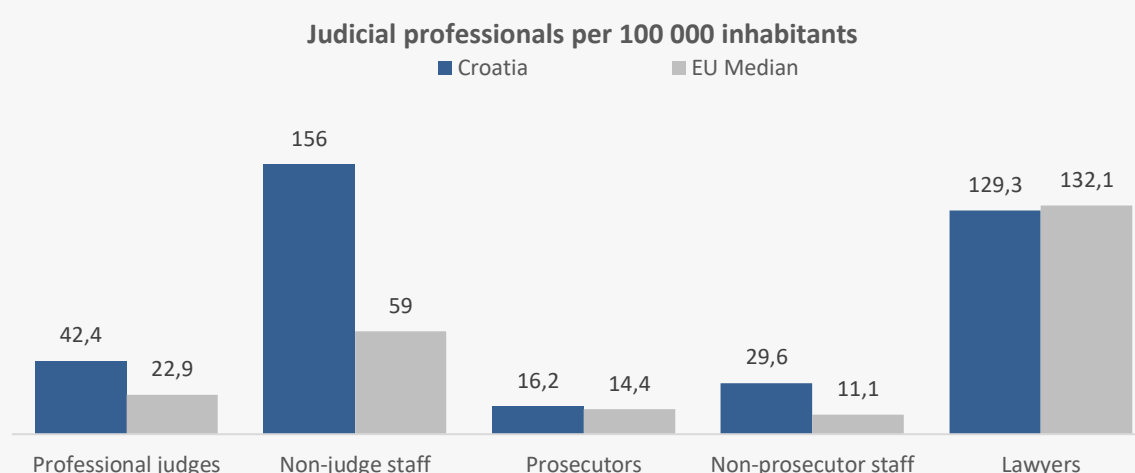

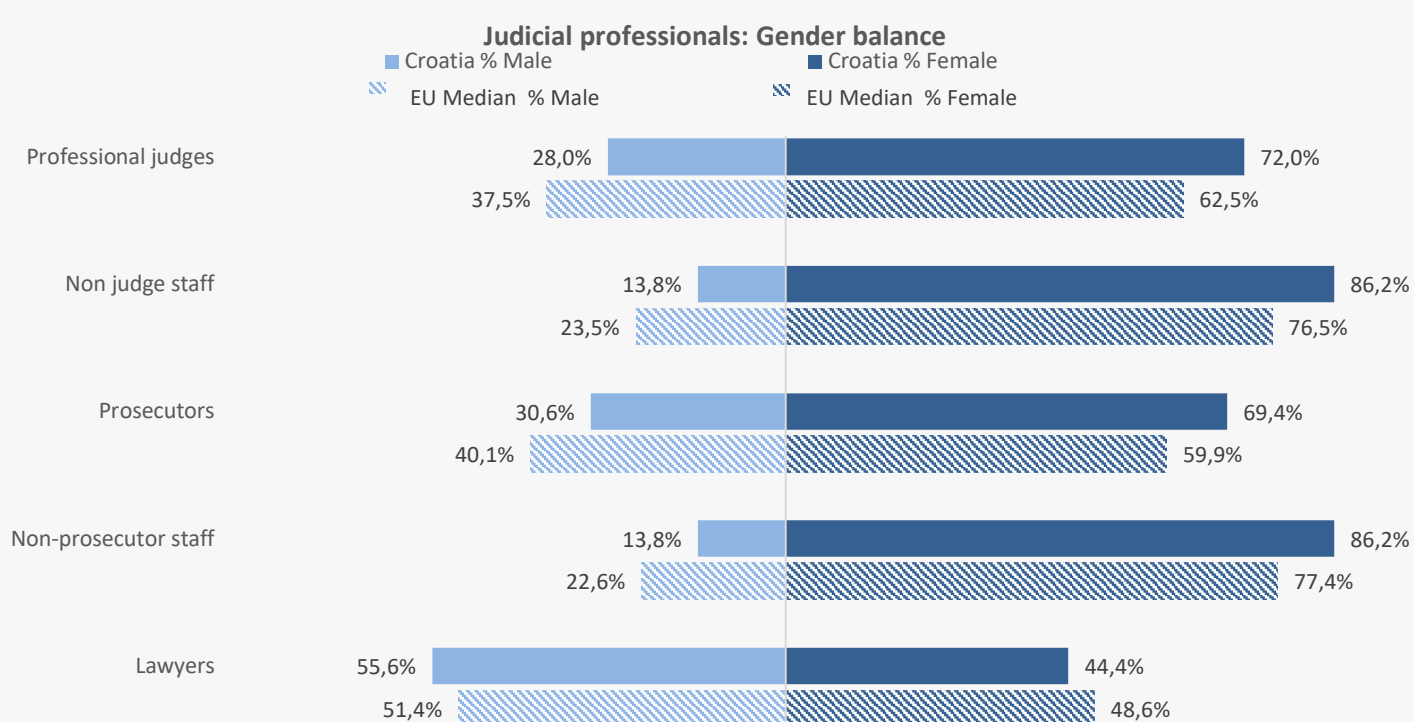

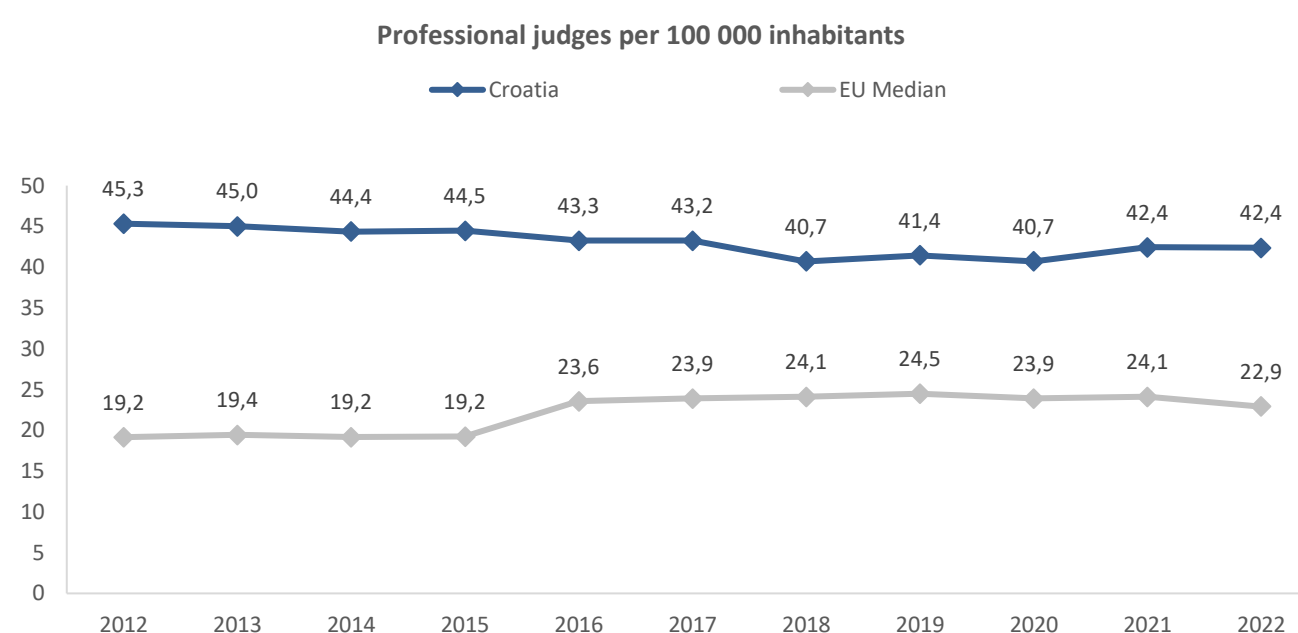

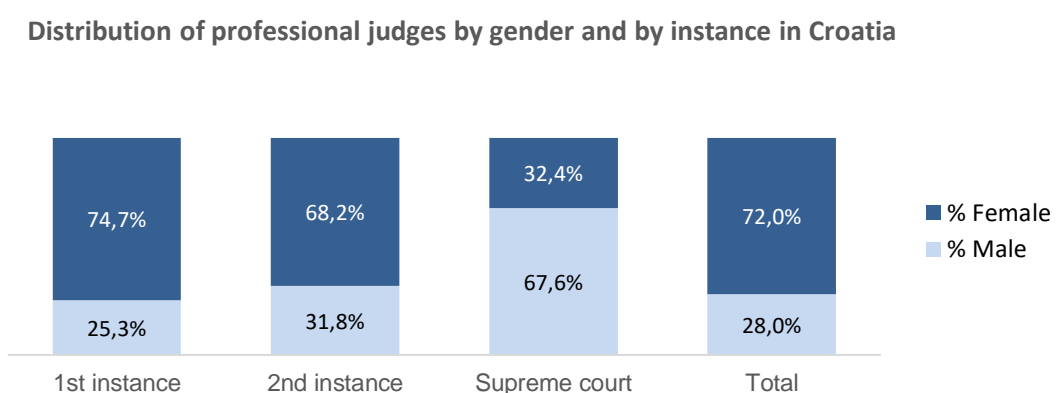
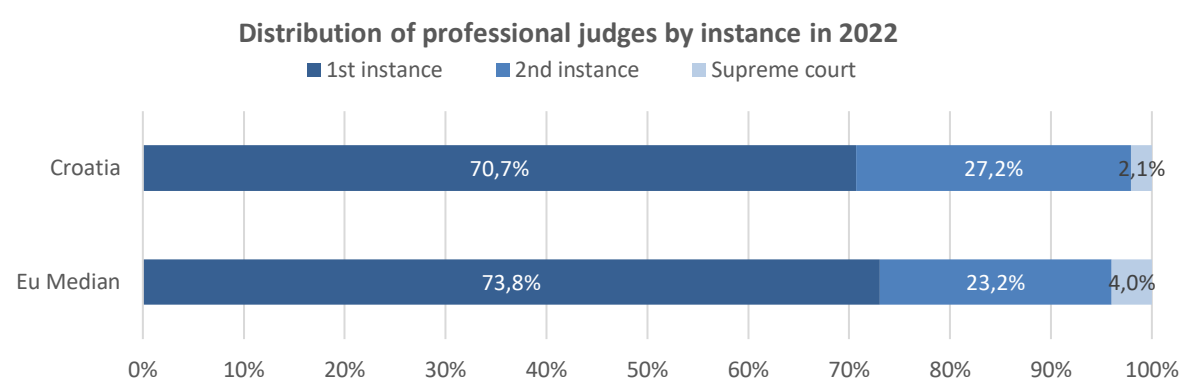
According to 2022 data, the total number of professional judges sitting in courts (all instances) in Croatia is 1 631, which is -0,7% less than in previous cycle.

More precisely, in Croatia, there are 42,4 professional judges per 100 000 inhabitants (this figure is well above the EU median of 22,9 judges per 100 000 inhabitants)

The data refer to all judges: court presidents, judges authorized to perform court administration and judges.

In this cycle, the total number of female professional judges (all instances) is 1 175, which represents 72,0% of the total number of judges.

The total number of judges is distributed among the different judicial instances in the following way: 1 153 are sitting in the first instance courts (of which 861 are female); 444 are sitting in the second instance courts (of which 303 are female) and 34 are sitting at the Supreme Court (of which 11 are female).

Compared with the EU distribution of professional judges per instance, Croatia professional judges are distributed in a similar way. The predomination of first instance judges is less pronounced, while second instance judges are more numerous.

As regards the distribution male/female, it has to be specified that the total professional judges are mainly female in Croatia (72%). At the first and second instances, female professional judges represent the majority (74,7% and 68,2%, respectively), while they are only 32,4% at the Supreme court.

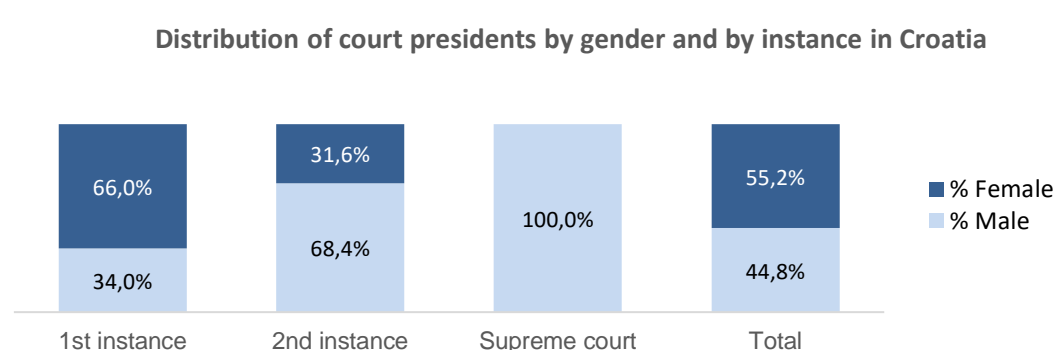

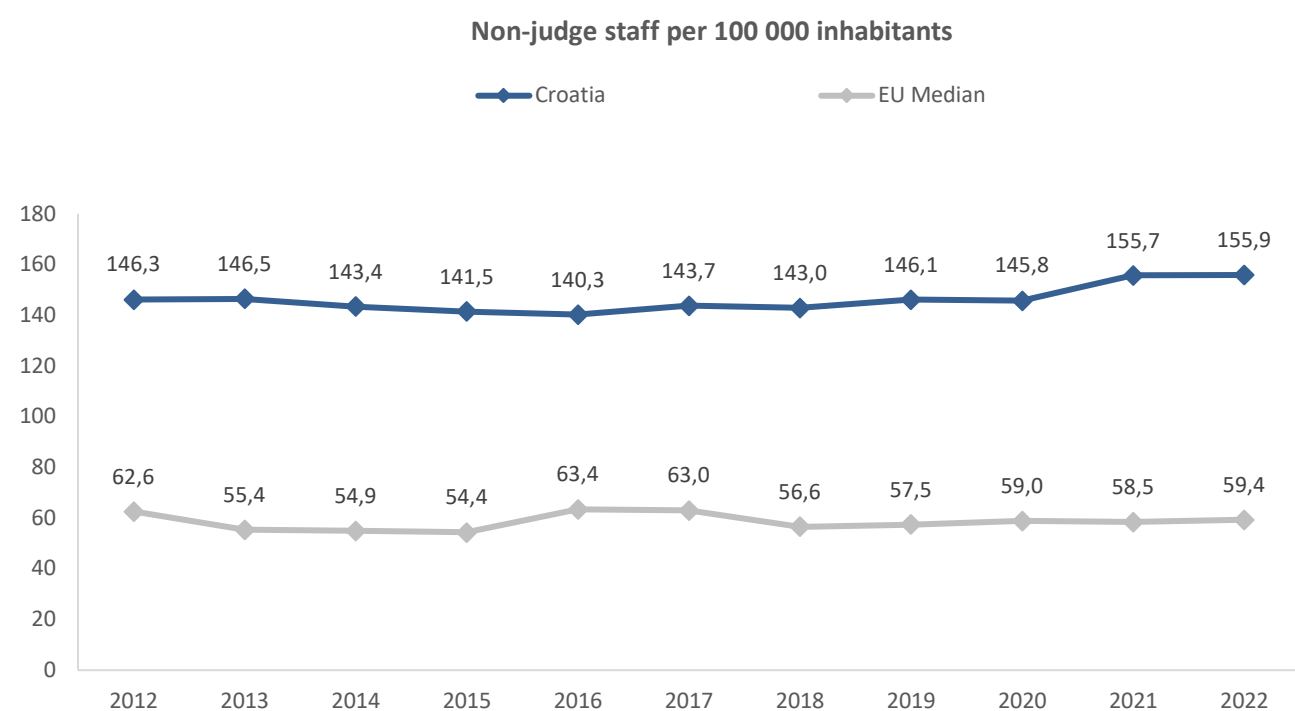


The total number of court presidents is distributed among the different judicial instances in the following way: 47 are sitting in first instance courts (of which 31 are female); 19 are sitting in second instance courts (of which 6 are female) and 1 is sitting in the Supreme Court (and he is a man).

In this cycle, the total number of female court presidents (all instances) is 37, which represents 55,2% of the total number of court presidents.

In 2022, Croatia has 6 002 non-judge staff (of which 5 173 are Female). The total number of non-judge staff in comparison with the previous cycle reveals a decrease of -0,4%. In 2022, the number of non-judge staff per 100 000 inhabitants has increased (from 155,7 in 2021 to 155,9 in 2022).

The number of judges per 100 000 inhabitants remains the same in 2022 compared to 2021, which is 42,4 judges per 100 000 inhabitants.

In this cycle, the non-judge staff is broken down as follows:

- 594 Rechtspfleger (or similar bodies) with judicial or quasi-judicial tasks having autonomous competence and whose decisions could be subject to appeal (among which 501 are Female);
- 4 176 non-judge staff whose task is to assist the judges such as registrars (of which 3 823 are Female);
- 567 staff in charge of different administrative tasks and of the court management (of which 439 are Female);
- 665 technical staff (of which 410 are Female);

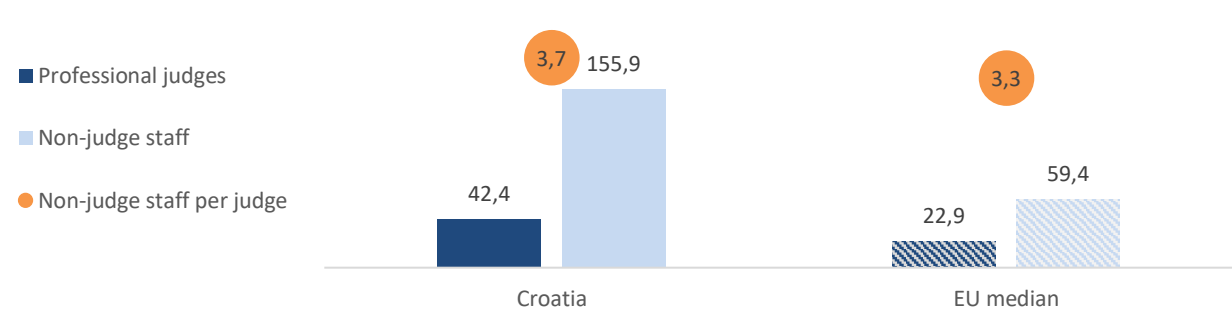
The total number of non-judicial staff is a result of a deduction and subsumes only actually working staff. Moreover, two non-judicial officials working half-time (for the reason of care for a child with special needs) are counted as 1 non-judicial official. The reason for fluctuation and differences in the number of Rechtspflegers in Republic of Croatia is that they work for 2 years, then prolonged 5 years and then they get a permanent post or not.

The data refer to civil servants and employees employed for an indefinite period.

Professional judges and non-judge staff per 100 000 inhabitants, and their ratio



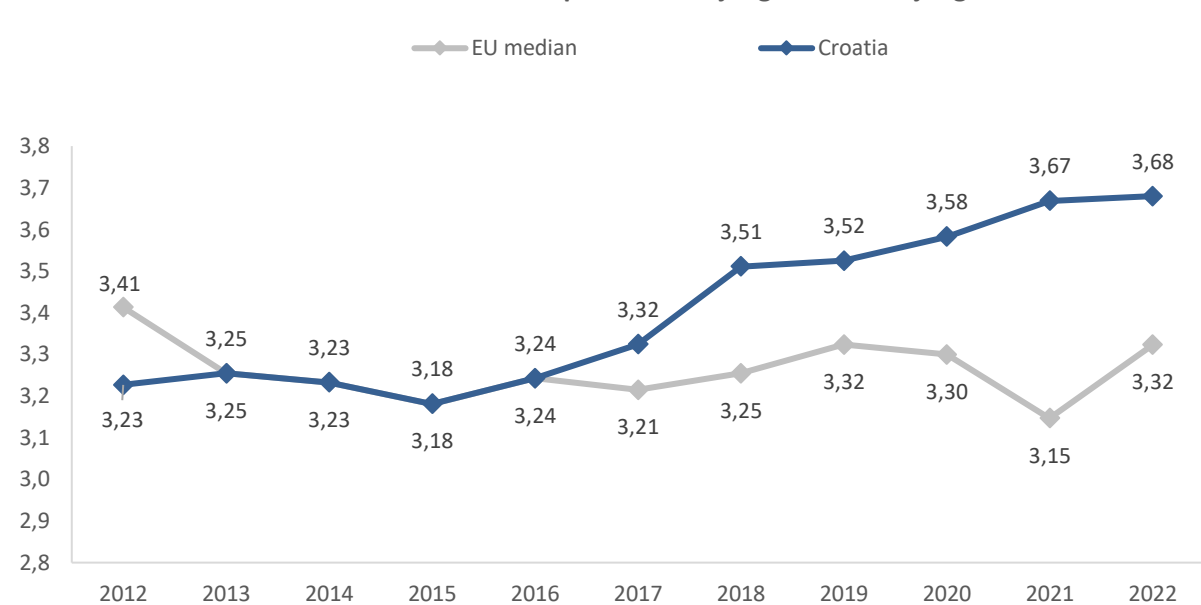
In Croatia, there are 42,4 professional judges per 100 000 inhabitants (this figure is above the EU median of 22,9) and about 3,7 non-judge staff per judge.

Regarding the ratio between non-judges staff per judge, there is no significant difference compared with previous cycle.

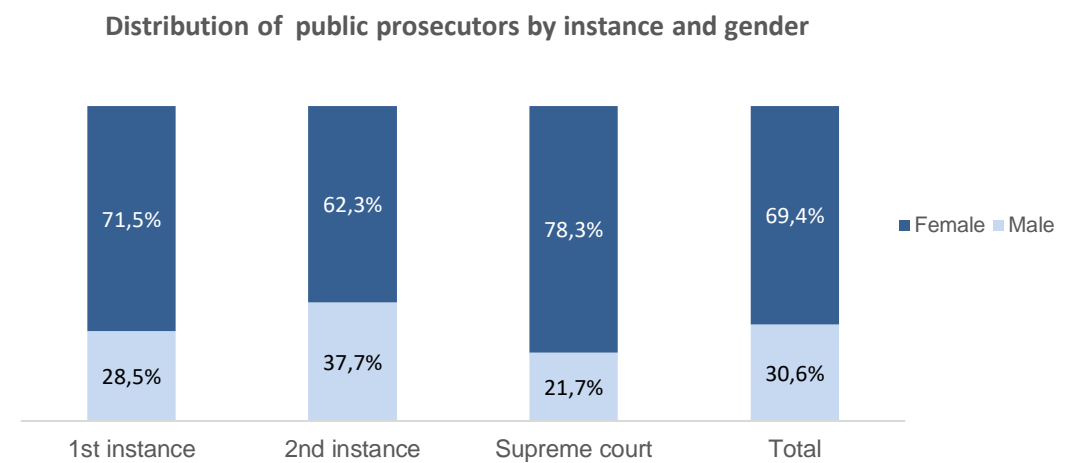
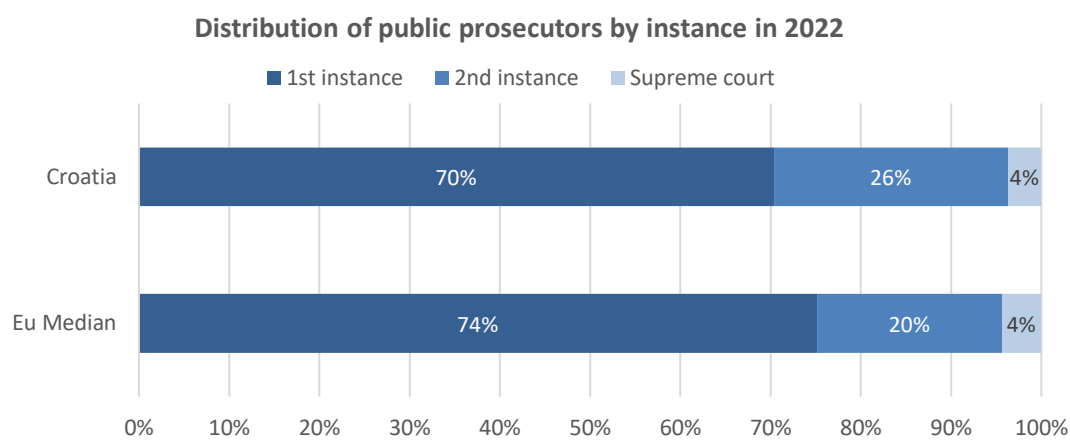
Evolution of the ratio between professional judges and non-judge staff

The total number of prosecutors is distributed among the different judicial instances in the following way: 439 in first instance (of which 314 are female); 162 are in second instance (of which 101 are female) and 23 in final instance (of which 18 are female).

In this cycle, the total number of female prosecutors (all instances) is 433, which represents 69,4% of the total number of prosecutors.

As regards the distribution of the number of prosecutors, the provided data encompasses all officials in the public prosecutors' offices, including heads of the public prosecutors' offices (the Public Prosecutor of the Republic of Croatia, county and municipal public prosecutors, the head of the Bureau for Combating Corruption and Organised Crime) and all public prosecutors deputies. The number of prosecutors at the first instance level includes all municipal public prosecutors, their deputies, as well as the head of the Bureau for Combating Corruption and Organised Crime and his deputies. The number of prosecutors at the second instance (court of appeal) level includes all county public prosecutors and their deputies. The number of prosecutors at the Supreme Court level includes the Public Prosecutor and his deputies.

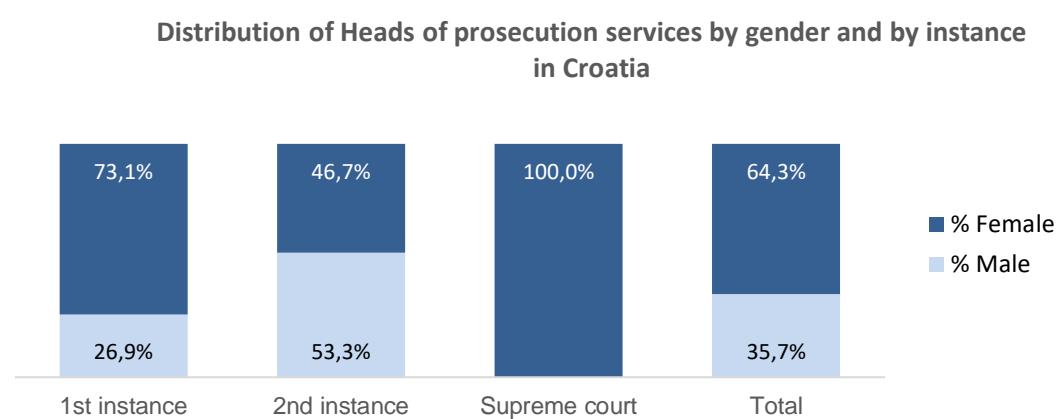
The data refer to all state attorneys: State Attorney General, municipal/county state attorneys, deputy municipal/county state attorneys authorized to perform duties of municipal/county state attorneys, deputy state attorneys and deputies of municipal/county state attorneys.

As regards the distribution male/female, the majority of public prosecutors are female for all instances. It should be underlined that the highest percentage of female public prosecutors is at the Supreme court level (78,3%).

The total number of Heads of prosecution is distributed among the different judicial instances in the following way: 26 at first instance level (of which 19 are female); 15 at second instance level (of which 7 are female) and 1 at the highest instance level (who is a female).

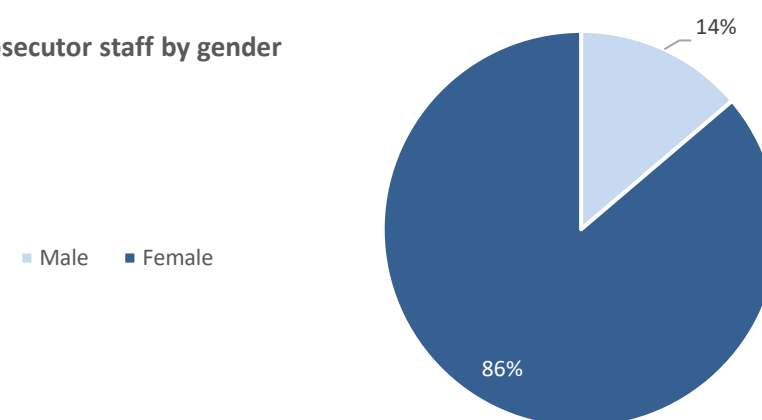
In this cycle, the total number of female Heads of prosecution (all instances) is 27, which represents 64,3% of the total number of Heads of prosecution.

The organisational structure of the public prosecution services comprises: the State Attorney of the Republic of Croatia, the Office for Combating Corruption and Organised Crime (USKOK), county State attorneys' offices and municipal State attorneys' offices. The number of public prosecutors' offices has been significantly rationalised. The number of Heads of the State attorneys' offices does not correspond to the number of municipal State attorneys' offices, because in some of these offices the Heads of offices were not appointed and, until such appointment is made, their duties are exercised by their deputies. The number of the first instance State attorneys' offices includes the number of the municipal State attorneys and Head of Office for Combating Corruption and Organised Crime (USKOK).

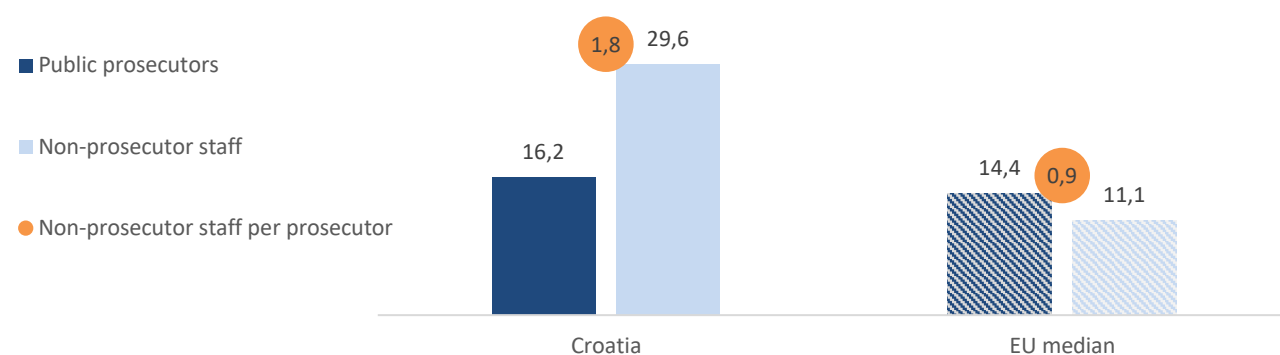
Non-prosecutor staff by gender

Public prosecutors and non-prosecutor staff per 100 000 inhabitants, and their ratio

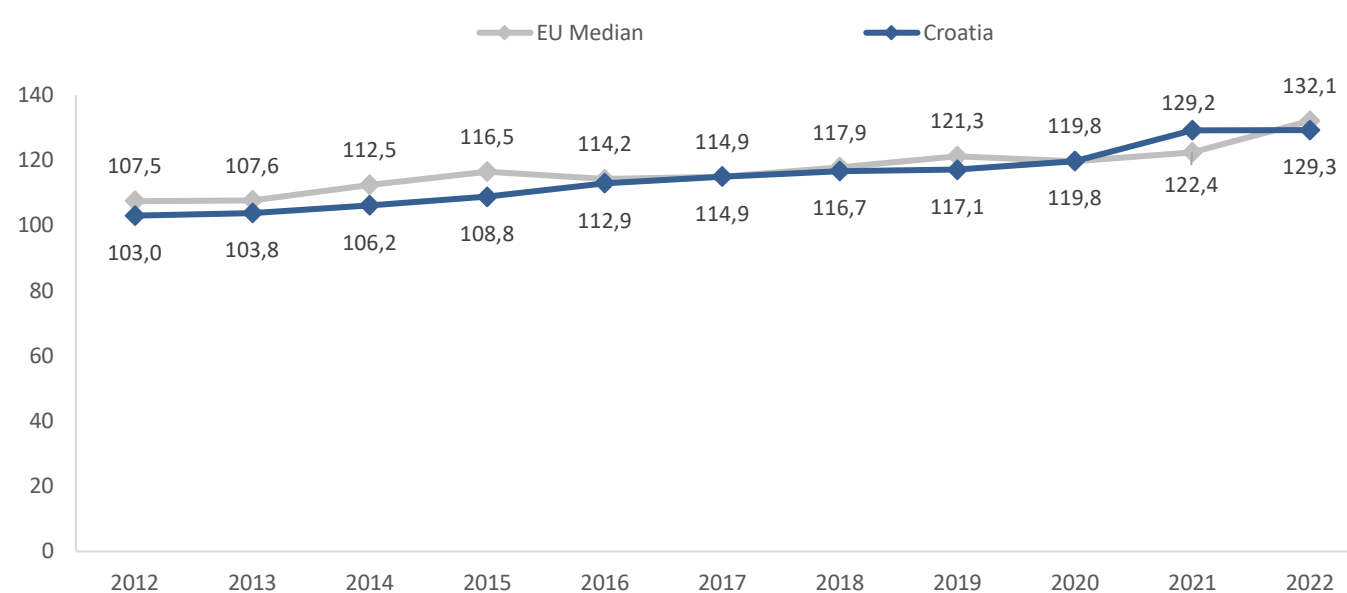


In 2022, in Croatia the ratio between non-prosecutor staff and prosecutors of 1,8 was 50% above than the EU median of 0,9.

Lawyers per 100 000 inhabitants



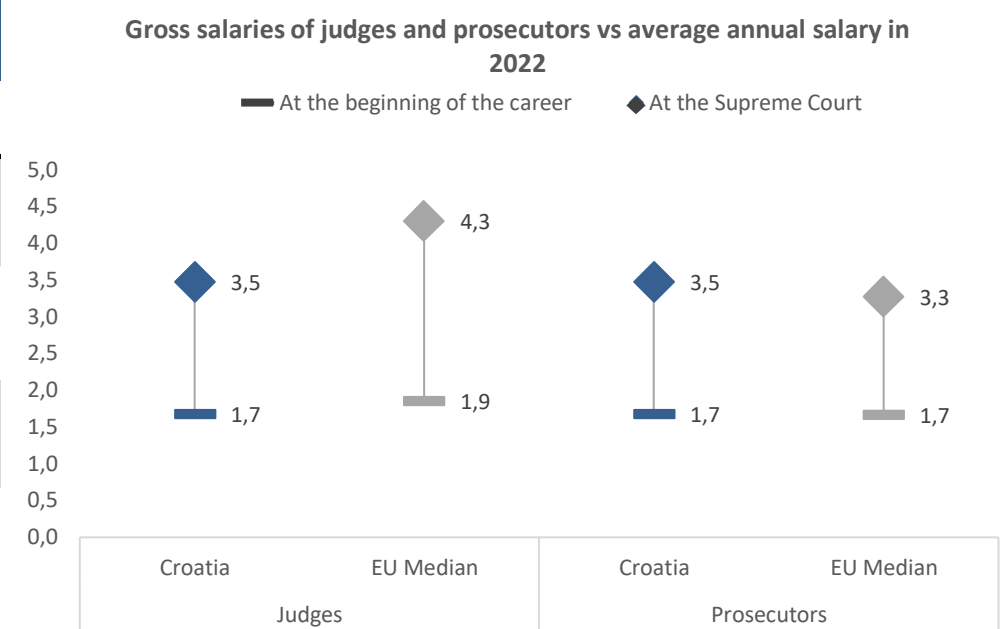
In 2022, there are 4 979 lawyers, which is -0,5% less than in 2021.

There are 2 213 female lawyers which is 44% of the total.

Croatia has 129,3 lawyers per 100 000 inhabitants, which is around the EU median of 132,1 lawyers per 100 000 inhabitants.

In the European Union, the absolute gross salary for a judge at the beginning of career ranges from a minimum of 26 931€ to a maximum of 140 244€.

According to 2022 data, the absolute gross salary of a judge at the beginning of his/her career in Croatia is 27 754€, which is rather below the EU median of 54 224€ (-49% below).

Compared with the annual average salary in the country, the salary for a judge at the beginning of his/her career is 1,7 times higher (the EU median is 1,9).

At the highest level, the range of the EU absolute gross salary for a judge is from 53 144€ to 261 648€. Croatia's absolute gross salaries for judges at the highest level is -46% below the EU median of 106 533€.

For the public prosecutors, the range for the absolute gross salary at the beginning of career is from a minimum of 24 609€ to a maximum of 96 084€.

In 2022, the absolute gross salary of a public prosecutor at the beginning of his/her career in Croatia of 27 754€ is rather below the EU median of 48 728€ (-43% below).

Compared with the annual average salary in the country, the salary for a public prosecutors at the beginning of his/her career is 1,7 times higher (the EU median is 1,7).

At the highest level, the minimum absolute gross salary for prosecutors in the European Union is 44 880€ and the maximum is 194 005€. Croatia's absolute gross salaries for prosecutors at the highest level is -34% below the EU median of 87 247€.

For the 2022 data, the information in the table also refers to Wrongful arrest/detention and wrongful conviction.

The request for compensation for wrongful arrest and wrongful conviction is submitted to the Ministry of Justice and Administration, which is also responsible for peaceful proceedings. In case the applicant does not accept the offer of the Ministry of Justice and Administration, he has the right to file a complaint with the competent court.

The amount of compensation that the Ministry offers to the injured parties as a fair monetary compensation on this basis is unique in all cases and amounts to HRK 280.00 per day of deprivation of liberty. The amount paid for 2022 refers to payments based on decisions made in a peaceful procedure. The amount is expressed in kuna.

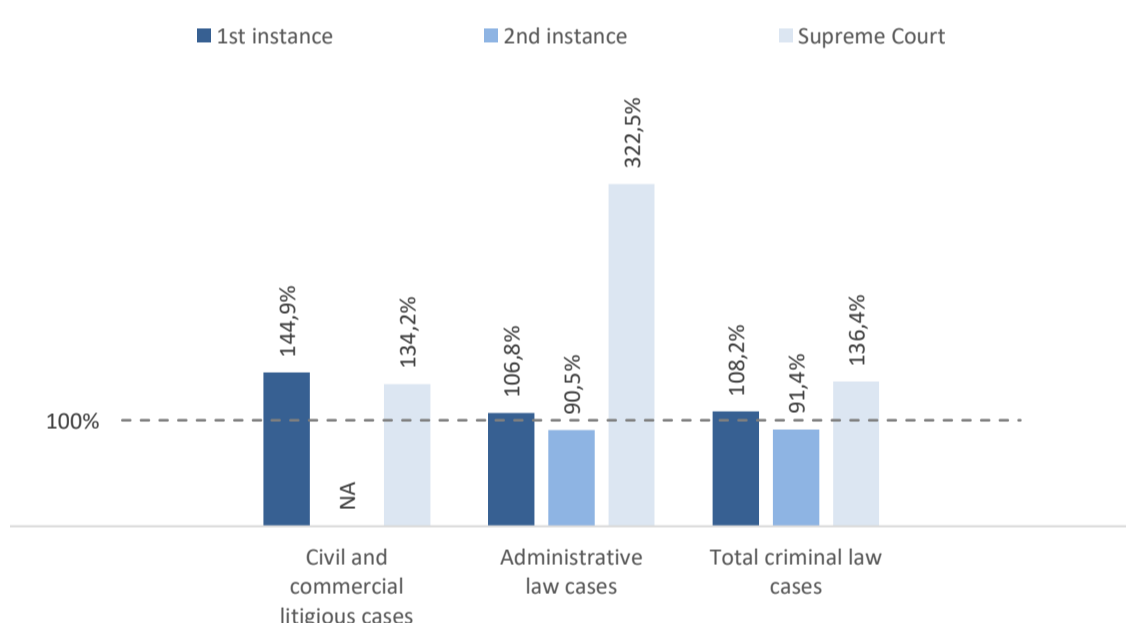
The Clearance Rate shows the capacity of a judicial system to deal with the incoming cases. A Clearance Rate of 100% and higher does not generate backlog.

The Disposition Time determines the estimated number of days necessary for a pending case to be solved in a court.

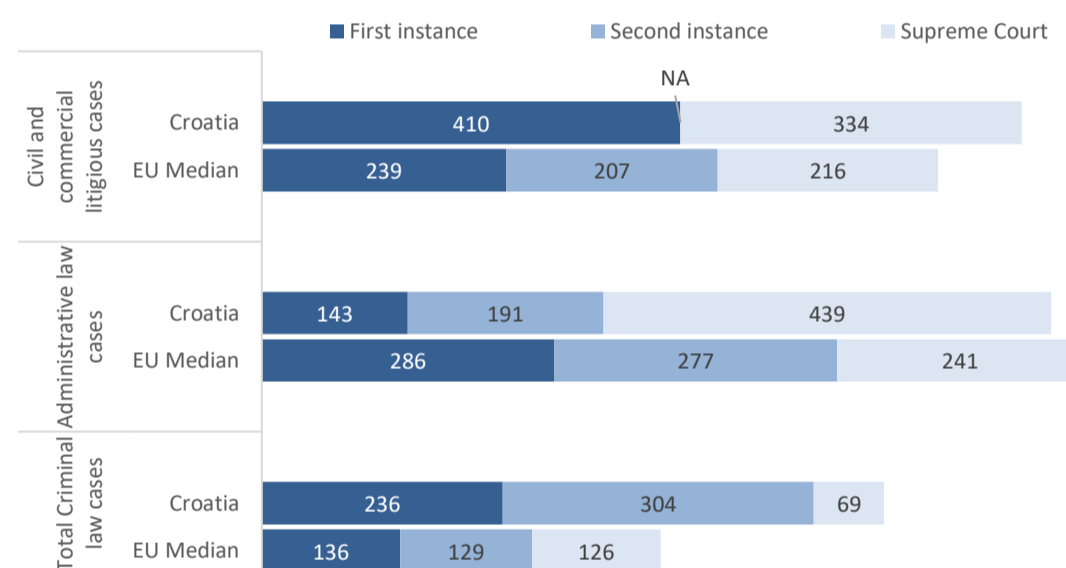
Overall efficiency by instance and by case matter

In 2022, the third instance total criminal law cases are resolved faster than any other type of cases. Also, their Disposition Time (69 days) is well below the EU median of 126 days and their Clearance Rate is 136,4%.

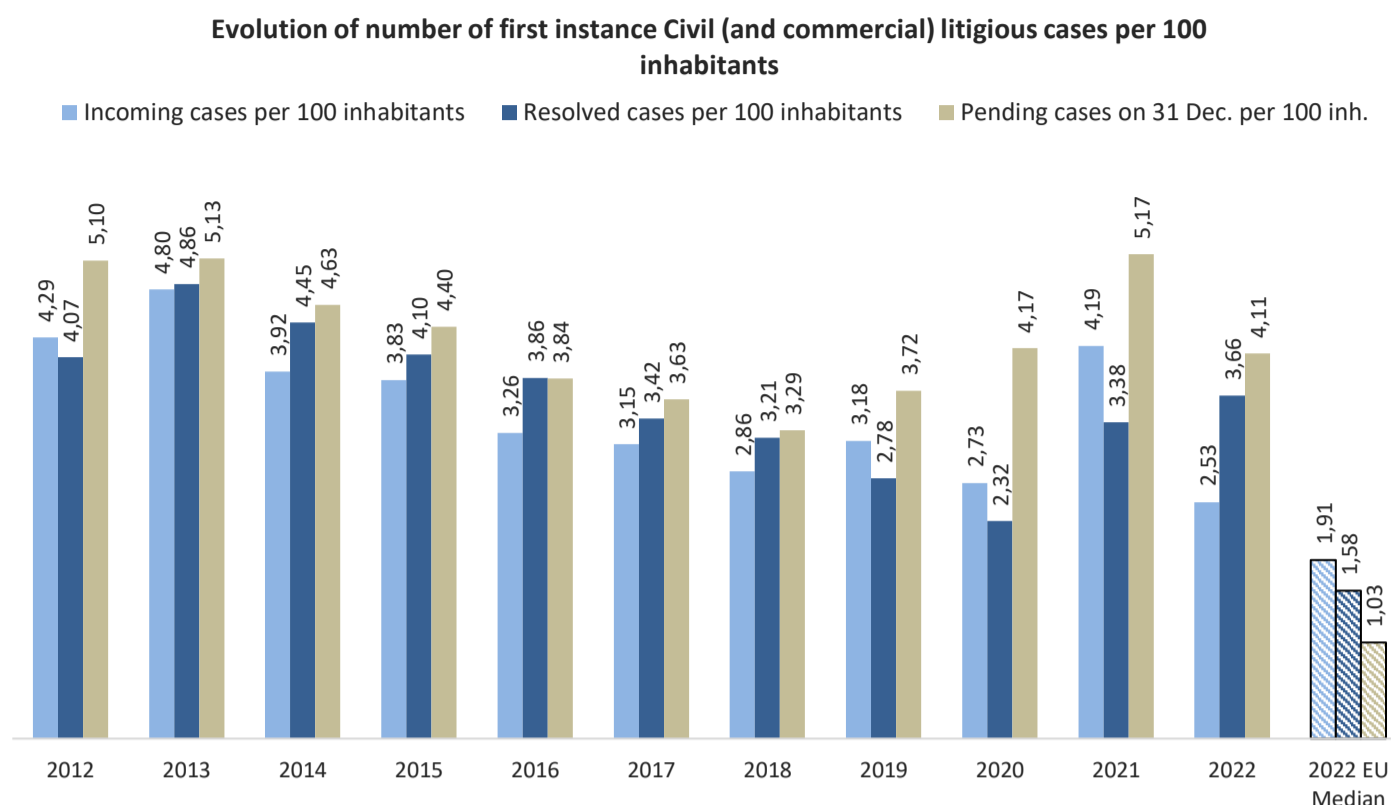
As regards the first instance civil and commercial litigious cases, their Clearance Rate is 144,9%. In 2022, while the number of incoming cases has dropped, the courts have resolved the significant number of collective labour cases from the public sector workers that were registered in the previous year (more than 60 000 cases). As a consequence, this has led to a significant increase in the number of resolved cases. Yet, the Disposition Time for this type of cases is still well above the EU median (410 vs 239 days).

Finally, the highest Clearance Rate is calculated for the third instance administrative law cases (322,5%). Their Disposition time is also the highest compared to the other type of cases and instances (439 days). Yet, it should be noticed that these indicators are calculated by using very small numbers (40 incoming cases, 129 resolved cases and 155 pending cases at the end of the year).

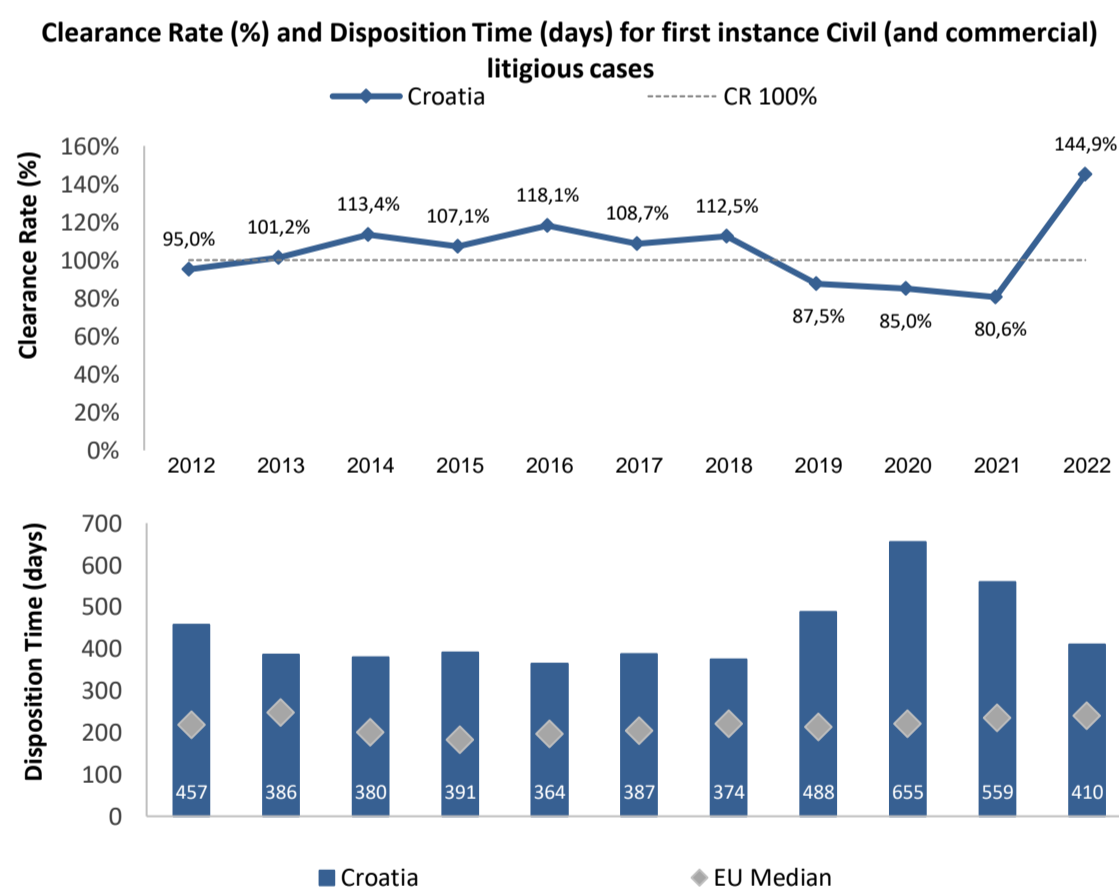


In 2022, the number of incoming cases in Croatia (2,53 per 100 inhabitants) is somewhat above EU median (1,91 per 100 inhabitants). 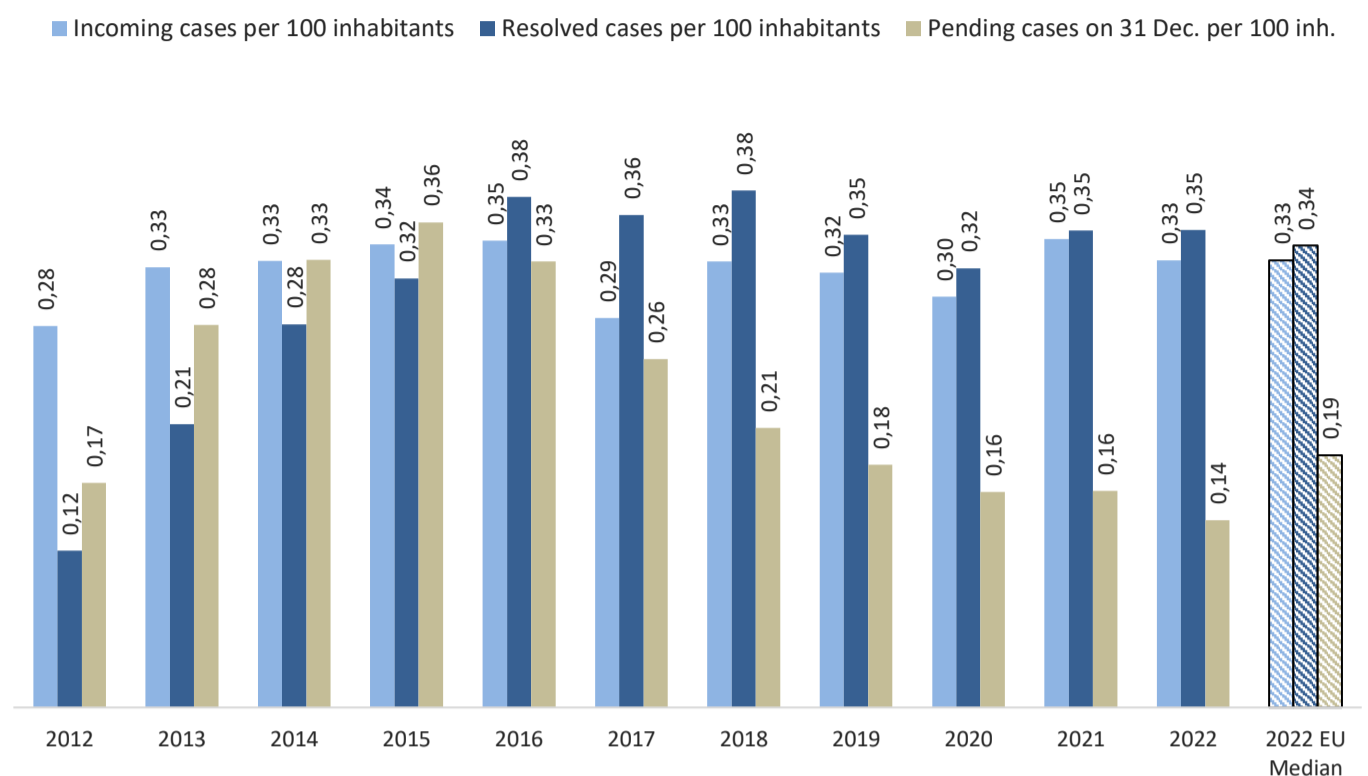

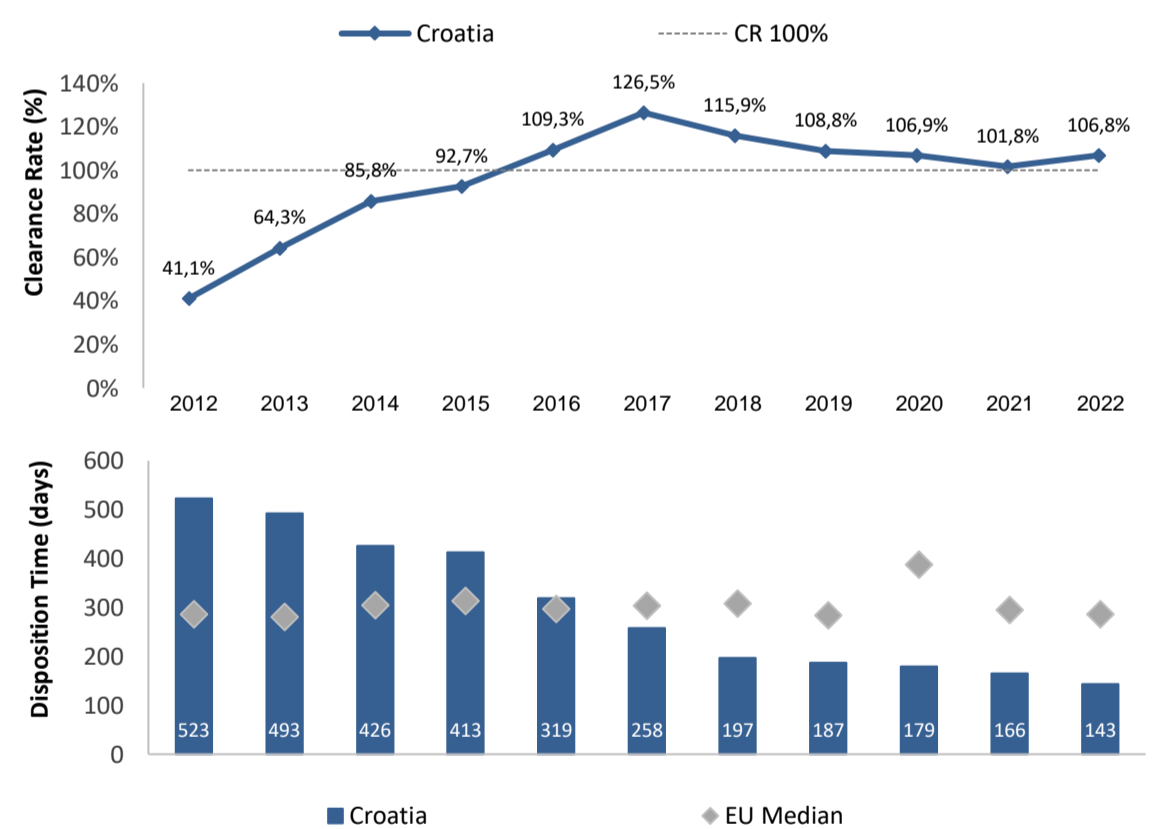

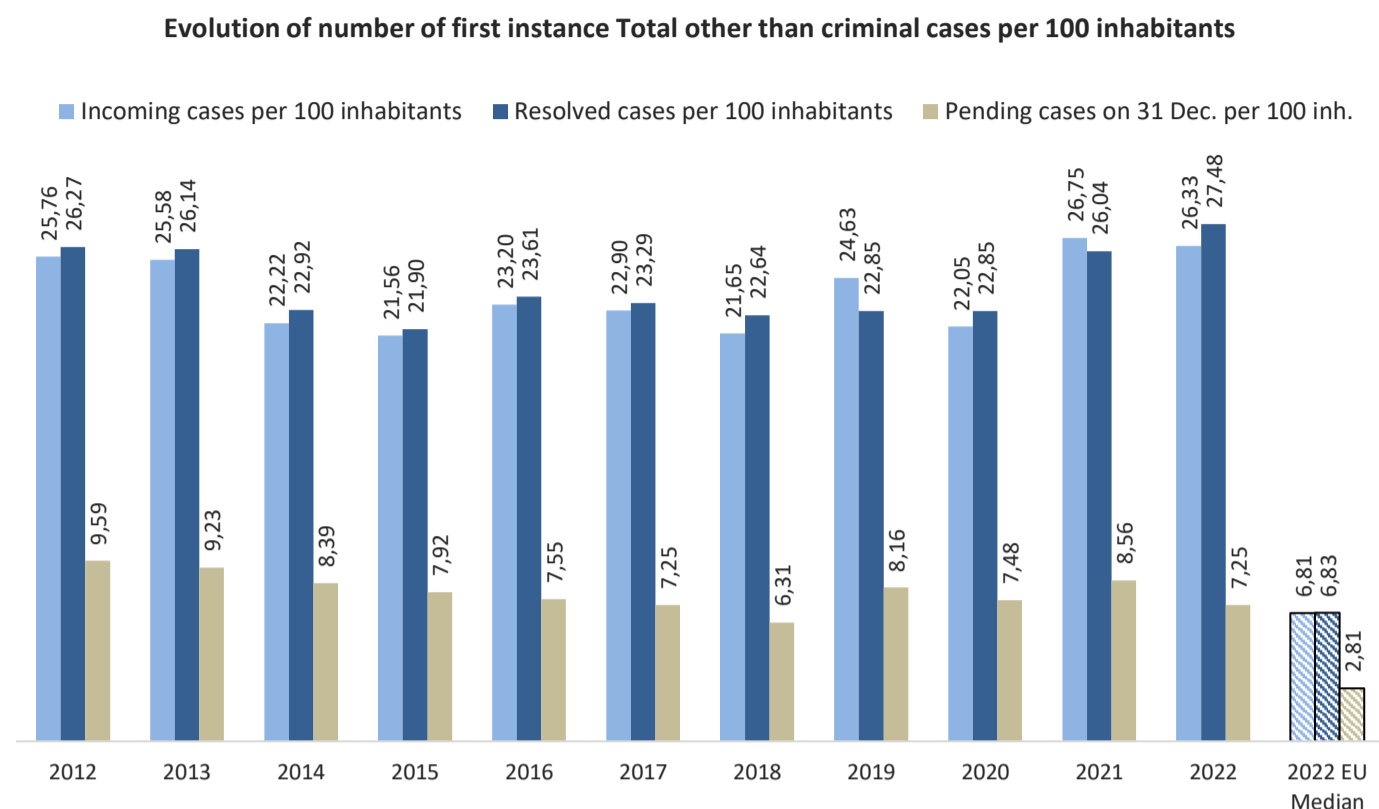

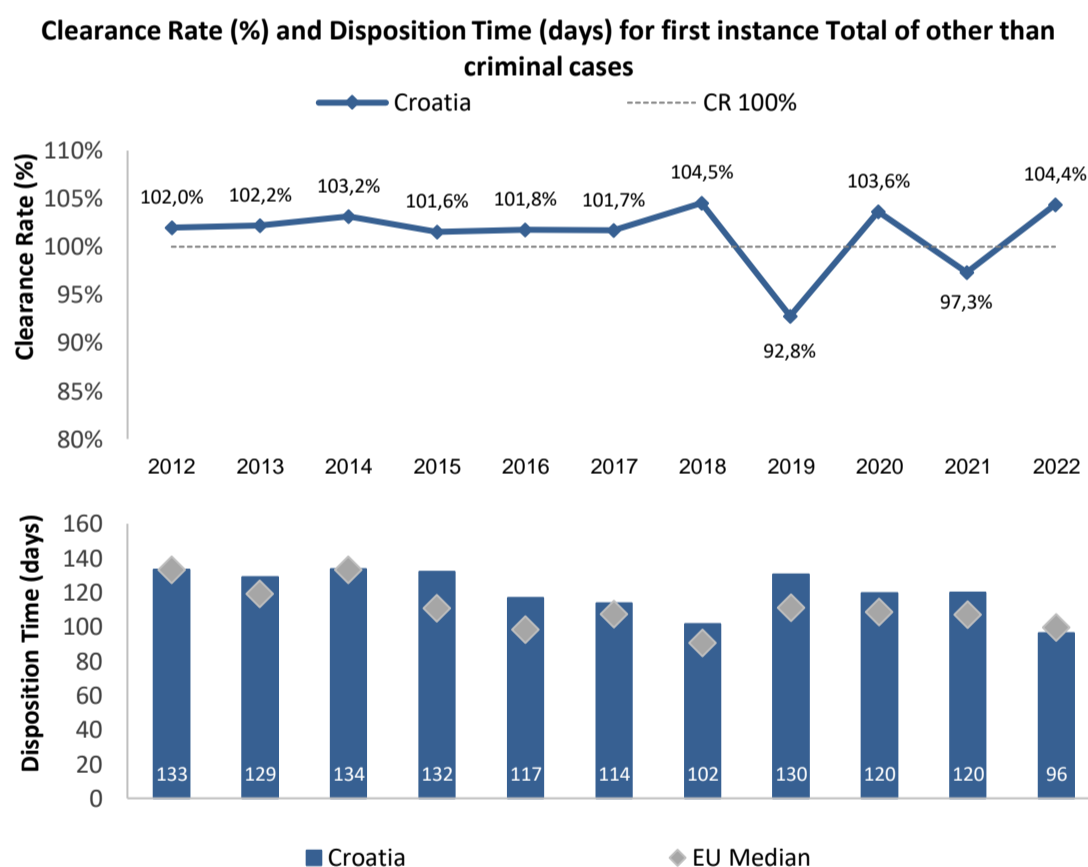

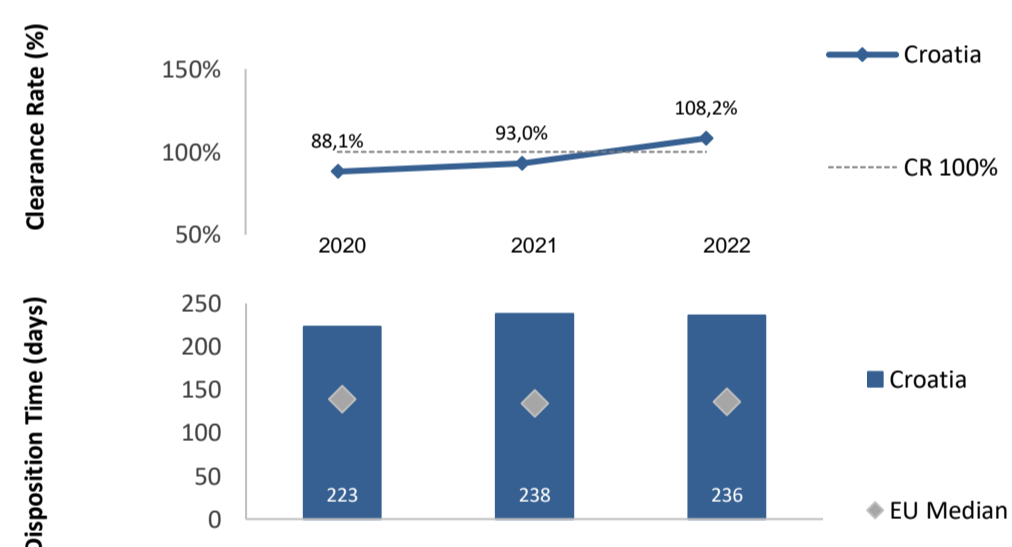

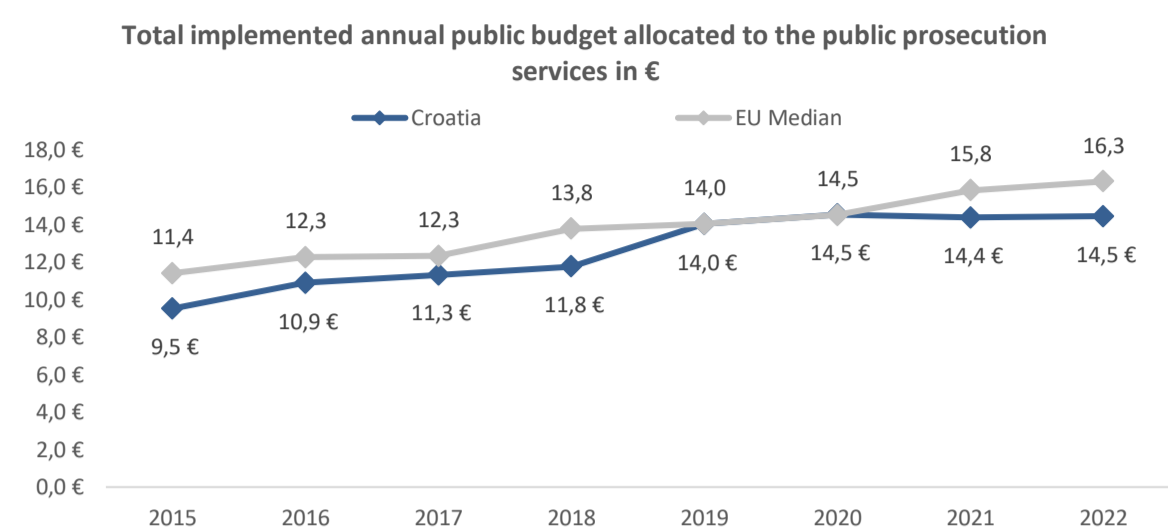

Besides, due to the overloading of certain state attorney's offices, specifically the Municipal Criminal State Attorney's Office in Zagreb, 1.060 cases were delegated to other state attorney's offices, which statistically for the Zagreb Municipal Criminal State Attorney's Office is shown as a transfer of cases and also included in the number of cases resolved by the state attorney's office to another method (that is, for 2022 in section 3.1.4, which is included in the total in section 3.1). Therefore, the increase in the number of cases discontinued during the reference year is an increase that occurred due to the statistical method of presentation, and not a real increase.

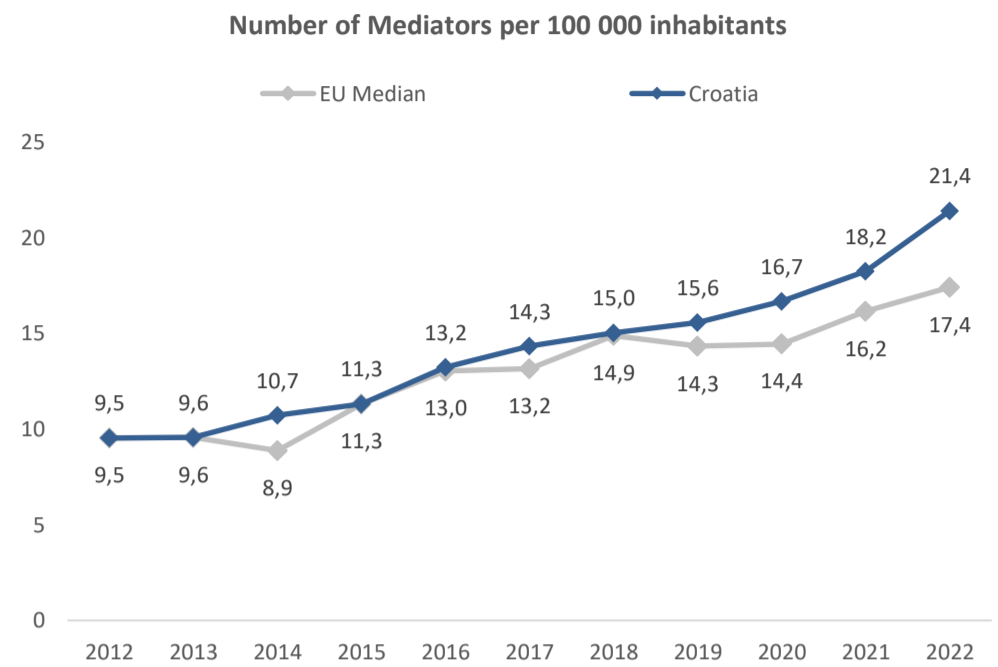

According to the Courts Act, the Minister of Justice, upon the proposal of the General Session of the Supreme Court of the Republic of Croatia, adopts the Framework criteria for the workload of judges.

According to the Courts Act (Official Gazette No. 28/13, 33/15, 82/15, 67/18, 126/19, 130/20, 21/22, 60/22), the president of the court in which the judge performs the judicial duty determines by decision for the previous calendar year whether the judge has fulfilled his duties as a judge according to the prescribed criteria. If the president of the court determines that the judge, without justifiable reason, did not make the number of decisions determined by the Framework Criteria for the work of judges in a one-year period or that he performed his judicial duties improperly, he is obliged to initiate disciplinary proceedings against such a judge, in accordance with the State Judicial Council Act. Disciplinary proceedings against the president of the court are initiated by the president of the immediately higher court.

According to the State Judicial Council Act (Official Gazette No. 116/10, 57/11, 130/11, 13/13, 28/13, 82/15, 67/18, 126/19, 80/22), disciplinary penalties may be imposed for committed disciplinary offences: rebuke, a fine of up to one third of the salary earned in the previous month in a period of one to three months, a fine of up to one third of the salary earned in the previous month in a period of four to six months, a fine of up to one third of the salary earned in the previous month in a period of seven to twelve months or dismissal from duty. If the president of the court determines that, due to justified reasons, the judge did not make the number of decisions determined by the Framework Criteria for the work of judges in a one-year period, he is obliged to state in the explanation of the decision what justified reasons are in question and submit the decision immediately to the president of the higher court.

Against the decision of the president of the court, which determines whether the judge has fulfilled his duties as a judge, the judge can submit an objection to the president of the court within three days of receiving the decision. The president of the court is obliged to decide on the objection within eight days. The president of the court can reject the complaint or accept it and make a new decision. If the objection is rejected, the judge has the right to appeal to the president of the immediately higher court within eight days from the delivery of the decision on the objection. The president of the immediately higher court can make a decision confirming the decision of the president of the court or accept the appeal and take a new decision. Against this decision, the judge has no right to declare legal remedies.

According to the State Attorney Council Act (Official Gazette No. 67/18, 126/19, 80/22) if the number of resolved cases and actions taken in a one-year period is, without justifiable reason, less than 80% of the average of the state attorney's office in which he holds office, the Deputy state attorney is disciplinary liable for disciplinary offence of irregular performance of duty.
