Meeting of the Current Affairs Committee

Hybrid, Thursday 18 November 2021

Abridged report – List of items discussed and decisions taken

1. The chair of the Committee, Thomas ANDERSSON, opened the meeting. The list of participants appears in Appendix 1.

2. The Committee adopted the agenda as set out in Appendix 2.

3. The Committee adopted the synopsis of the previous remote meeting (7 May 2021).

4. The Committee took note of the communication by the Chair of the Committee and by the Secretary General of the Congress

5. The Committee elected Joanne LABAN, United Kingdom (L, ECR) as 1st Vice Chair of the Committee.

6. The Committee heard from co-rapporteurs James MOLONEY, Ireland (L, ILDG) and Aida JALILZADE, Azerbaijan (R, ECR) about the draft report on the future of youth in rural areas; heard from expert Dr. Jayne GLASS, Scotland's Rural College; held an exchange of views; adopted the draft explanatory memorandum, and approved the preliminary draft Resolution and Recommendation, on the proviso that the suggestions and comments made by members will be included into the text before the text be submitted for adoption at the Congress plenary session in March 2022.

7. The Committee heard from Rapporteur Brigitte VAN DEN BERG, Netherlands (L, ILDG) about the Resolution introducing a draft booklet for children on sustainable development in their cities as well as its accompanying draft guidelines for local authorities; heard from experts Stina HEIKKILA, URBACT and Michelle TEMPLETON, Queen's University Belfast; held an exchange of views on the draft booklet and draft guidelines and; adopted the preliminary draft Resolution, which will be submitted for adoption with the final draft booklet and guidelines at a Congress plenary session in 2022, and took note of the call for interested members to pilot the project.

8. The Committee heard from Nino KAVTARADZE, Georgia (L, EPP), Prof. Angel Manuel MORENO MOLINA, Group of Independent Experts and Rosmarie WYDLER-WALTI, Vereins Klima Seniorinnen (Switzerland) about the impact of climate change on human rights; held an exchange of views on the issue; took note of the foreseen report on human rights and the environment and of the interest of several members to be co-rapporteur.

9. The Committee was informed by Thomas ANDERSSON of the ongoing cooperation with the Conference of International NGOs and the Council of Europe's Directorate General of Democracy for the creation of an on-line compendium with good practice examples of civil participation.

10. The Committee heard from Congress Youth Delegate Kristina MINCHEVA (Bulgaria) about the Congress conference on youth work to be held on 29 October 2021.
