Relevant qualifications summary

As a Public prosecutor, I continuously carried out in the last thirty years investigations

on the most serious and alarming forms of organised crime, both Italian and

transnational. I conducted investigations on Camorra, 'Ndrangheta and Nigerian mafia

crimes and I dealt with many cases of cross-border trafficking in human beings, arms

and drugs. In the last six years (July 2012- March 2018) I worked at the National Anti-

mafia and Anti-terrorism Directorate (DNA), the most important judicial Prosecution

Office in Italy, in charge of coordinating at national level investigations aimed at

dismantling mafia and terrorist networks. In that context, I was Coordinator of the

Department dealing with transnational crime, including human trafficking and smuggling

of illegal migrants. Therefore, I had the possibility to acquire extensive knowledge of

these phenomena also as relevant sources of financing of terrorism. I have wide experience of the most advanced investigative techniques to be applied in the fight against human trafficking, in full respect of human rights, and a deep knowledge of national and international legal frameworks in this area. I largely took part in judicial cooperation activities, including with Eastern Europe, Balkan and African judicial Authorities, and I coordinated investigations between Italian and foreign Prosecution Offices in several cases. Thanks to this activity, I gained deep knowledge of procedural and substantive legal systems of the other Council of Europe Member States and Third Countries. I believe that my professional background allow me to provide a specialized and professional support to the evaluation and monitoring activities carried out by GRETA, as previously demonstrated by my contribution to the activities of GRETA in the first 4 four years of mandate from 2018 to 2022

# Current professional activity

As Chief District Prosecutor, I am in charge, on the one hand, of coordinating investigations related to all criminal offences that fall within the territorial competence of the Court of Potenza. On the other hand, I lead the Antimafia and Antiterrorim District Directorate (DDA), that coordinates at District level (the entire Basilicata Region) investigations related to terrorism and organised crime, including trafficking in human beings and smuggling of illegal migrants. In particular, we mostly deal with 'ndrangheta, camorra and local mafia organisations that work in synergy with each other in our Region. This activity requires continuous investigative cooperation with the DNA at



national level and effective interaction and exchange of information with Eurojust and other foreign judicial Authorities for transnational cases.

During my current position as Chief Prosecutor of Potenza I have conducted many investigations on the subject of "labor exploitation" ("Caporalato" in agriculture) and human trafficking. I concluded the investigations - carried out jointly with the Moldovan authorities - on a vast trafficking of women, aimed at the exploitation of domestic work, from Moldova to Basilicata. Over eighty victims have been identified. In addition this activity carried out by my office has allowed support and assistance to dozens of victims of trafficking who have been able to obtain, thanks to our request and intervention, provisional residence permits to carry out their work activities regularly in Italy. The proceeding is in the trial phase.

Furthermore, the writer has been a member of the Greta Group since December 2018 until today and in this capacity: I attended, in Strasbourg, the periodic plenary meetings of Greta (one every three months, approximately) contributing to the drafting of dozens of reports containing the assessments of compliance with the provisions of the Treaty of the member countries: I participated to the working group that has drawn up an important document containing the guidelines on identifying and combating trafficking for the purpose of labor exploitation; I has carried out numerous visits to member countries (Croatia, Spain, Ireland, Portugal) aimed at acquiring elements of evaluation on the same, meeting both competent authorities and experts and qualified components of civil society

## Relevant previous professional activities

From July 2012 – to March 2018: Prosecutor, Member of the National Anti-mafia and Anti-terrorism Directorate (DNA). The DNA was established in Italy in 1991 and coordinates at national level investigations related to terrorism and organised crime,



including human trafficking. It coordinates the activities of 26 District Anti-mafia and Anti-terrorism Directorates (DDA) in Italy, including the DDA of Potenza, which I currently lead. As already said, in this period I coordinated the Department of the National Anti-mafia and Anti-terrorism Directorate dealing with transnational crime, in particular trafficking in drugs, human beings and arms. In addition, I was responsible of coordinating investigations against Camorra and 'Ndrangheta. Since in 2015 the tasks of the DNA were expanded to counter-terrorism, this allowed us to use the investigative tools already developed and experimented in the fight against mafia to respond to international terrorism, while granting full respect of fundamental rights and protection to victims. Moreover, in the DNA I started to deeply look into the interconnections between organised crime and terrorism and in that perspective developed a thorough analysis of human trafficking and smuggling of illegal migrants as relevant sources of terrorism financing.

From July 2009 to July 2012: Prosecutor, Member of the District Anti-mafia Directorate of Naples, specialised in investigations against organised crime. In particular, I extensively dealt with investigations against the Camorra network called "Casalesi" and with crimes performed by Nigerian mafia organisations particularly active in the province of Caserta and involved in human trafficking.

From January 2006 to July 2009: Prosecutor, Associate member of the District Antimafia Directorate of Rome. I mostly dealt with complex investigations related to the criminal activities performed by Camorra in Rome and in the Lazio region, by expanding its criminal network from Naples to other areas of our Country.

From January 1997 to December 2005: Prosecutor, Member of the District Antimafia Directorate of Naples, specialised in investigations against organised crime. In particular, I extensively dealt with investigations against the Camorra network called "Casalesi" and with crimes performed by Nigerian mafia organisations particularly active in the province of Caserta and involved in human trafficking.



From September 1994 to December 1996: Prosecutor, Member of the Financial Crime Unit of the Prosecutor's Office of Naples.

From April 1989 to August 1994: Prosecutor, Member of Prosecutor's Office of Santa Maria Capua Vetere, in the Province of Caserta.

From June 1987 to April 1989: Judicial training at the Prosecutor's Office and Court of Rome, after having passed the national competition to become a Magistrate in November 1986.
