1971: admitted to the competitive entrance examination for the French National Judicial Training College (*l'Ecole nationale de la magistrature – ENM*)

1973-1975: studied at ENM

1975-1984: deputy public prosecutor then senior deputy public prosecutor at Orléans *Tribunal de Grande Instance*

1984-1988: auxiliary judge at the Court of Cassation (Second Civil Division)

1988-1999: Vice-President at the Paris *Tribunal de Grande Instance* (Press Division then First Civil Division)

1999-2004: Divisional President at the Paris Court of Appeal (Provisional Orders Appeals Division + Division ruling on appeals against decisions of independent administrative authorities)

September 2004 - December 2008: judge at the Court of Cassation (Second Civil Division, Procedural Section), and Director of the Court of Cassation's documentation and research department

Since January 2009: Divisional President at the Court of Cassation (Third Civil Division up to September 2011 and since then, President of the Social Affairs Division of the Court of Cassation).

From September 2014 to May 2017: Divisional President retained in service beyond retirement age at the Court of Cassation.

Honorary Divisional President at the Court of Cassation since 2017.
