The organization has been involved in the advocacy and development of effective legislation on gender equality and domestic violence and supporting women exposed to domestic violence by providing legal counseling and representation.

During the mandate, built the organization from scratch, was responsible for the overall management of the organization, strategic administrative, human resources and financial planning. During this period the organization has witnessed tremendous growth, having an yearly budget amounting to 500,000 USD and a team of more than 10 persons. The impact of the organization deals with systemic change at legislative and policy level as well as transformative thinking of the professionals responsible for responding for cases of DV. To note, WLC has pioneered the first police and judiciary trainings as well as other groups of professionals involved, having trained more than 10.000 specialists so far and managed to develop curriculums both at the National Institute for Justice as well as Police Training Institute. WLC has lead the process of legislation reform in accordance with the Istanbul Convention and as а result. emergency protection order and risk assessment was introduced, as well legislation criminalizing sexual harassment and stalking, as well as introduced free legal assistance for women victims.
