Briefly:

Jana Zezulová is a public prosecutor at the Prosecutor General's Office, where she works in the Analytical and Legislative Department. In the past, she worked as an assistant professor at the Department of Criminal Law, Faculty of Law, Masaryk University in Brno, and as an assistant to judges of the Constitutional Court. She is the national correspondent of the Public Prosecutor's Office for the fight against trafficking in human beings, the abuse of women and children, illegal migration and employment, gender, domestic and sexually motivated violence and for the protection of the rights of victims of crime.

She publishes in professional journals, is a co-author of comments on the Act on Victims of Crime (2014, 2020), the Criminal Code (2015), the Code of Criminal Procedure (2017) and the Public Prosecutor's Office Act (2020), monographies Detention and Custody in the Czech Criminal Procedure (2004), Injured party and Adhesion Proceedings in the Czech Republic (2007), Fundamentals of Criminology and Criminal Policy (2012) and she also participated on some legislative proposals.

Jana Zezulová also took part in study and work stays abroad, she is a member of the Consultative Council of European Prosecutors (CCPE) at the Council of Europe and a member of the Focus Group on Migrant Smuggling (EUROJUST).
