As a team leader, I was involved in both operational leadership and professional and substantive contributions.

The Trend Bureau Overijssel contributes to policy debates and decision-making by exploring trends, engaging with social partners in Overijssel. I gave presentations and workshops to officials, politicians, civil servants, and community organizations about addressing developments in their regions. I also contributed to trend explorations on current social issues (e.g., energy transition, rising polarization, future landscapes).

Advised the mayor, the executive board, and senior management on strategic social issues and politically sensitive topics. I also coached colleagues on the job by challenging their logic on content and processes and ensuring accountability for results to management and the board.

In addition to my roles in oversight and public representation, I served as the local political leader of


