Cybercrime is Dangerous, but a New UN Treaty Could Be Worse for Rights

"[...] A global comprehensive treaty to counter cybercrime first proposed by Russia has gained enough support at the United Nations for negotiations to begin early next year. In addition to the irony of a government that faces criticism for turning a blind eye to cybercriminals operating within its borders pushing a global cybercrime treaty, the proposal is dangerous. [...] Until now, there has been very little scrutiny of this process from a human right – as opposed to a geopolitical – perspective. A closer look at who is proposing the treaty, the way many states have defined "crime" in the cyber context, how efforts to fight cybercrime have undermined rights, and the shortcomings of multilateral negotiating processes reveals the dangers that this treaty process poses." Putin Is Crushing Biden's Room to Negotiate on Ransomware

"At the end of June, just before the White House scrambled to respond to another ransomware attack from Russia, Moscow presented a new international cyber treaty in the United Nations. Moscow has tightened its grip on the internet domestically for years and has recently pushed for a sovereign internet. [...] The crux of the 69-page document is hardly shocking: The Putin regime is continuing its battle for a more closed, state-controlled internet. [...] It purports to advance common ground between countries on cybersecurity, while the meaning of "cybersecurity" itself isn't even agreed upon. It promotes a broad range of requirements for technology companies under the guise of increasing stability in the cyber realm, when in reality it would encourage greater state censorship, surveillance, and control of the internet where countries are seeking more top cover to do so. Unmasked: 23 charged over covid-19 business email compromise fraud

"On 10 August, 23 suspects were charged as a result of a series of raids carried out simultaneously in the Netherlands, Romania and Ireland. In total, 34 places were searched. These criminals are believed to have defrauded companies in at least 20 countries of approximately €1 million. The fraud was run by an organised crime group which prior to the COVID-19 pandemic already illegally offered other fictitious products for sale online, such as wooden pellets. Last year the criminals changed their modus operandi and started offering protective materials after the outbreak of the COVID-19 pandemic." [READ MORE](#)

“O Brasil até aqui não tinha aderido porque, apesar das loas de quem atua na perseguição criminal, há situações complicadas. A primeira delas é (ou era antes de 2019) a tradição diplomática brasileira de não aderir a acordos dos quais o país não participou da elaboração. Além disso, apesar da maior integração no combate à criminalidade online, o tratado abre margem para vigilância governamental; permite que provedores de internet sejam obrigados a cooperar em buscas e apreensões eletrônicas, autoriza monitoramento remoto em tempo real, mesmo em nome de governos estrangeiros. E o que é muito pouco mencionado, mas atíça parte do apoio, é sobre o enforcement dos direitos autorais.” [READ MORE](#)

Guatemala: Global collaborative investigation nets suspected child sexual abuser

“A suspected prolific child sexual abuser has been arrested by Guatemalan law enforcement in a police operation supported by INTERPOL. In an investigation that began in February 2017, specialized law enforcement officers from around the world worked together through INTERPOL’s International Child Sexual Exploitation (ICSE) database to identify eight child victims – aged approximately between seven and 17 years old – of a 45-year-old offender operating on the dark web. [...] National investigators from Australia, Brazil, France and Switzerland cooperated with INTERPOL over years to comb through the substantial amount of child sexual abuse materials produced by this single offender over a 10-year period and piece together his identity as well as those of his victims.” [READ MORE](#)

Accenture hit by massive ransomware attack

“Accenture, counted amongst the world’s largest IT consultancy firms, has confirmed that its network has been breached by the LockBit ransomware. [...] Accenture is the latest of the high-profile victims of ransomware operators who are now actively targeting billion-dollar corporations. In fact, the number of ransomware attacks in 2021 has already surpassed last years’ total since businesses aren’t averse to paying the threat actors to prevent data leaks.” [READ MORE](#)

Zoom to pay \$85M for lying about encryption and sending data to Facebook and Google

“Zoom has agreed to pay \$85 million to settle claims that it lied about offering end-to-end encryption and gave user data to Facebook and Google without the consent of users. The settlement between Zoom and the filers of a class-action lawsuit also covers security problems that led to rampant "Zoombombings." [...] In addition to payments, Zoom "agreed to over a dozen major changes to its practices, designed to improve meeting security, bolster privacy disclosures, and safeguard consumer data," the settlement said. With the pandemic boosting its videoconferencing business, Zoom more than quadrupled its annual revenue from \$622.7 million to \$2.7 billion in the 12 months ending January 31, 2021.” [READ MORE](#)

Researchers turn the spotlight on the hidden workers of the cybercrime world

"A collaborative research project by Czech Technical University in Prague, plus cybersecurity companies GoSecure and SecureWorks, analyzed the activities of people on the fringes of cybercrime, those behind projects like building the websites that end up being used for phishing attacks, affiliate schemes to drive traffic towards compromised or fake websites or writing the code that ends up in malware. [...] "They are trying to earn a living and maybe crime is paying better so they go there, they drift into crime and come and go," said Sebastian Garcia, assistant professor at Czech Technical University, who argues that more attention needs to be paid to the people who dance the line between cybercrime and legal activity." Apple to scan iPhones for child sex abuse images

"Apple has announced details of a system to find child sexual abuse material (CSAM) on US customers' devices. Before an image is stored onto iCloud Photos, the technology will search for matches of already known CSAM. Apple said that if a match is found a human reviewer will then assess and report the user to law enforcement. However there are privacy concerns that the technology could be expanded to scan phones for prohibited content or even political speech." [READ MORE](#)

1M Stolen Credit Cards Hit Dark Web for Free

"A dump of hundreds of thousands of active accounts is aimed at promoting AllWorld.Cards, a recently launched cybercriminal site for selling payment credentials online. Threat actors have leaked 1 million stolen credit cards for free online as a way to promote a fairly new and increasingly popular cybercriminal site dedicated to...selling payment-card credentials. [...] The cards were published on an underground card-selling market, AllWorld.Cards, and stolen between 2018 and 2019, according to info posted on the forum." [READ MORE](#)

Ransomware attack hits Italy's Lazio region, affects COVID-19 site

“The Lazio region in Italy has suffered a reported ransomware attack that has disabled the region's IT systems, including the COVID-19 vaccination registration portal. Early Sunday morning, the Lazio region suffered a ransomware attack that encrypted every file in its data center and disrupted its IT network. [...] While ransomware gangs are known to steal data during an attack as leverage in extortion attempts, the region states that health, financial, and budget data are safe. [...] Italian security researcher JAMESWT stated that there is evidence in Italy that the attack was conducted by LockBit 2.0 but could not share further information.” [READ MORE](#)

Angriffsziel deutsche Wirtschaft: mehr als 220 Milliarden Euro Schaden pro Jahr

“Durch Diebstahl, Spionage und Sabotage entsteht der deutschen Wirtschaft jährlich ein Gesamtschaden von 223 Milliarden Euro. [...]Die Schadenssumme ist mehr als doppelt so hoch wie in den Jahren 2018/2019, als sie noch 103 Milliarden Euro p.a. betrug. Neun von zehn Unternehmen (88 Prozent) waren 2020/2021 von Angriffen betroffen.[...] Sie sind meist unmittelbare Folge von Ransomware-Angriffen. Durch sie werden Computer und andere Systeme blockiert, anschließend werden die Betreiber erpresst. Die so verursachten Schäden haben sich im Vergleich zu den Vorjahren 2018/2019 mehr als vervierfacht (+358 Prozent).” [READ MORE](#)
