Debate: Return of the death penalty in Europe: genuine threat or populist fiction?

10 October 2017

Context

For decades, the abolition of the death penalty has been one of the main priorities for the Council of Europe. The efforts deployed by the Council of Europe and its Member States to outlaw the death penalty across Europe have made abolition a universally accepted value. As a result, this year we can celebrate 20 years without executions. It is an immeasurable progress for humanity.

However, the threat of a return of the death penalty is never afar, especially today, when Europe is facing a significant number of crises. The fears caused by these crises, amplified by the media, increase xenophobia and hate speech. This reaction and the resulting consequences are instrumentalised by demagogues using a populist, pseudo-security discourse that endangers human rights. On the pretext of fighting against terrorism, notably of religious nature, some people call for the use of the death penalty. However, this discourse, which in the past would have given rise to strong reactions, no longer seems to encounter strong opposition, even within European countries.

The Conference of INGOs remains convinced that the death penalty is not the solution and that the European Convention on Human Rights and Fundamental Freedoms (ECHR) as well as its additional Protocols 6 and 13 should be defended in all circumstances. To do so, the Conference of INGOs, in collaboration with the International Federation of Action by Christians for the Abolition of Torture (FIACAT), one of its members, is organising a debate on 10 October 2017 aimed at strengthening and better coordinating the fight against the threat of a return of the death penalty in Europe.

In the European area freed from state-sponsored executions for the past 20 years, this fight requires new modes of action along with our unconditional commitment to the right of everyone to life and to full recognition of human dignity as a fundamental value in a democratic society (ECHR, Protocol 13).

The Conference of INGOs, as usual, organizes this debate by associating several categories of stakeholders: Council of Europe personalities, emblematic figures who contributed to the abolition of the death penalty in the Member States and those who continue to fight in the Observer States, experts, representatives of diplomatic delegations to the Council of Europe, NGOs, the European Network of National Human Rights Institutions (ENNHRI), representatives of International and Regional Human Rights Organisations, and above all, families of victims of terrorist attacks.
