## **Declaration for a Network of Corruption Prevention Authorities** 15-16 October 2018

The Anti-Corruption bodies, organisations and institutions,

Supported by members of Parliament, governments, and relevant international institutions;

*Considering* that the aim of the Council of Europe is to achieve a greater unity among its members;

*Conscious* of the importance of strengthening international co-operation and exchange of information in the fight against corruption through prevention;

*Emphasising* that corruption represents a major threat to the rule of law, democracy and human rights, fairness and social justice, hinders economic development and endangers the proper and fair functioning of market economies;

*Recognising* the adverse financial consequences of corruption to individuals, companies and States, as well as international institutions;

*Convinced* of the importance for civil law and administrative cooperation to contribute to the fight against corruption;

*Recalling* the statements made by the Ministers of Justice or their representatives at the High-Level Conference which took place in Croatia, on 15-16 October 2018;

*Taking into account* the role and activities of the Group of States against Corruption (GRECO) of the Council of Europe;

Having regard to Article  $5.4^1$  and  $61.2^2$  of the United Nations Convention Against Corruption (UNCAC), as well as the resolution 3/2 of the Conference the States Parties (Preventive measures)<sup>3</sup> to the UNCAC;

*Having regard* to Principle 20 of Resolution (97)24<sup>4</sup> on the Twenty Guiding Principles for the Fight Against Corruption of the Council of Europe;

*Commit* to work towards the establishment of an international network of relevant public authorities for the detection and prevention of corruption, with a view to promoting the systematic collection, management and exchange of information, intelligence and good practices among these authorities<sup>5</sup>, in partnership with interested international institutions (such as the Council of Europe's Group of States against Corruption).

This declaration is signed in Croatia, on 16 of October 2018.

The declaration is open for signature and implementation to all interested national public authorities active in fighting corruption, as well as other relevant supporting parties and institutions.
