SPECIAL STATUS WITH THE CONGRESS OF LOCAL AND REGIONAL AUTHORITIES

There are two types of partnership status available in the Congress rules and procedures for the co-operation with non-member States: **Partner for Local Democracy status** which must be requested jointly by the national association(s) and the national government and **Guest Observer status** for the national association(s) of local and/or regional authorities.

Following an official request by the **Federation of Local Authorities of Israel (FLAI)** received in September 2020, the Bureau meeting decided to grant the status of Guest Observer to the FLAI during its meeting on 28 September 2020. This is a follow-up to previous co-operation developed with Israel in the past, since under its previous name - the Union of Local Authorities in Israel (ULAI) - the association used to have observer status with the Congress since 1994 and was engaged in cooperation activities.

China (China International Friendship Cities Association (CIFCA)) and **Japan** (Council of Local Authorities for International Relations (CLAIR)) also enjoy the status of Guest Observer with the Congress.

Contacts were also re-established in 2020 with **Palestine*** following the election of Musa Hadid, Mayor of Ramallah and President of the Association of Palestinian Local Authorities (APLA), as Co-Chair of the Euro-Mediterranean Regional and Local Assembly (ARLEM) where the Congress holds Observer status. The association used to benefit from the Observer status which had been granted in 2005 and would need to be re-activated.

At the end of 2020, **Kazakhstan** expressed its interest to be associated with the work of the Congress.
