#### **ELOGE ACCREDITATION PLATFORM**

# REPORT OF THE 8th MEETING 24 March 2023, Strasbourg

#### 1. Opening of the meeting

The meeting was opened with Mr Paul Rowsell (United Kingdom, Chair of the CDDG) in the Chair. He welcomed the participants, whose list appears in Appendix 1.

#### 2. Adoption of the agenda

The agenda was adopted, as it appears in Appendix 2.

#### 3. Report of the 7th meeting (25 March 2022)

The Chair recalled the main decisions that had been taken by the European Stakeholder' Platform at its last meeting, as outlined in the meeting report [DG-AP(2022)3]

#### 4. Information on **ELOGE** progress and implementation in 2023

The Secretariat presented the ELoGE progress and implementation in 2023, referring to document *DG-AP(2023)1*. It informed the Platform members about the most recent and ongoing ELoGE projects and provided an update on the intended process and calendar of work for the revision of the ELoGE Benchmark which dates back to 2009. Those involved in the process (experts, Secretariat etc) would make the broadest use of the E-DEN platform and feedback from a dozen of countries. The resulting document would then be presented to the CDDG at its 18<sup>th</sup> plenary at the end of the year. The Platform members were further encouraged to support those efforts to introduce ELoGE in more member states. In response to a question from the Congress representative, it was explained that the new Benchmark would involve an updating process rather than a full revision. The Bureau concurred that it should be no problem for the accredited entities to run ELoGE on the basis of the current Benchmark and then later use the updated one.

The Bureau also considered that there was a need to adapt paragraph 7 of the ELoGE Regulations and the following text was considered, and subsequently approved: "7. ELoGE is awarded for a term of up to three years, subject to a decision by the accredited entity".

As further adjustments to the Platfom's rules appeared to be desirable and timely, including on the quorum and voting, the Secretariat would prepare some draft amendments to be discussed at the next Platform meeting.

### 5. Renewal and new requests of accreditations

The Platform examined accreditation requests presented by the Secretariat, as set out in document [DG-AP(2023)2]:

#### A. Requests for renewal

- North Macedonia: after examining the request, the Platform agreed to grant the accreditation for 3 years (April 2023-April 2026) to ALDA-Skopje, the local branch of the European Association for Local Democracy.
- Kosovo\*: after examining the request, the Platform agreed to renew the
  accreditation for 3 years (April 2023-April 2026) to ALDA, the European
  Association for Local Democracy.
- Malta: as the renewal request was delayed, the Platform agreed that it would consider the request through the written procedure when all the necessary information becomes available.
- Poland: after examining the request, the Platform agreed to renew the
  accreditation to the Foundation in Support of Local Democracy (FRDL) to run
  ELoGE in Poland for 3 years, from 2024 (when the period of validity of the current
  accreditation lapses) until 2027.
- **Portugal:** the European Federation of Local Chief Executives (UDiTE) had submitted a request to slightly prolong the accreditation expired on 31 December 2022 so as to enable it to complete the second ELoGE round and to award the label to two municipalities; after examining the request, the Platform agreed to **extend the accreditation until the end of 2023.**
- Türkiye: after examining the request, the Platform agreed to renew the accreditation for 3 years (April 2023-April 2026) of the Argüden Governance Academy to run ELoGE in Türkiye.

\* All references to Kosovo, whether to the territory, institutions or population, in this text shall be understood in full compliance with United Nations' Security Council Resolution 1244 and without prejudice to the status of Kosovo.

#### B. New requests for accreditation

- **Finland:** after examining the request, the Platform agreed to grant the accreditation **for 3 years (April 2023-April 2026)** to the Finish Institute of Public Management to run ELoGE in Finland, subject to the approval of the adaptation of the Benchmark, as announced by the applicant.
- **Lithuania:** after examining the request for accreditation of the Ministry of Interior to run a second ELoGE programme in the country, the Platform agreed **to grant it the accreditation for 3 years (April 2023-April 2026)**, with the proviso that the composition of the new platform is agreed, as announced in the application.

### 6. Any other business

### 7. Next meeting

The Platform agreed to hold its next meeting tentatively, depending on requests for accreditation, after the CDDG Bureau meeting in the Autumn, i.e on 17 October 2023 afternoon.
