## Introduction

The Steering Committee for Human Rights (CDDH) was mandated by the Council of Europe's Committee of Ministers, under whose authority it operates, to submit to it a "report evaluating the effectiveness of the system for the selection and election of the Court's judges and the means to ensure due recognition for judges' status and service on the Court and providing additional safeguards to preserve their independence and impartiality" by the end of 2024. To prepare this report the CDDH created the Drafting Group on issues relating to judges of the European Court of Human Rights (DH-SYSC-JC).

This questionnaire was adopted by the DH-SYSC-JC at its 2<sup>nd</sup> meeting which took place from 25 to 27 January 2023. It intends to seek information for use in that report.
