MEETING REPORT

2nd meeting

29-30 November 2021 in Strasbourg and via KUDO

ITEMS 1 AND 2: OPENING OF THE MEETING, ADOPTION OF THE AGENDA AND THE ORDER OF BUSINESS

- 1. The Drafting Committee on Trafficking for the purpose of Labour exploitation (DH-TET) held its 2nd meeting in Strasbourg and via video-conference, due to the measures related to the COVID-19 pandemic, from 29 to 30 November 2021. The meeting was chaired by Mr Morten RUUD (Norway). The list of participants appears in Appendix I.
- 2. The Drafting Committee adopted the agenda (see <u>Appendix II</u>) and the order of business (see <u>Appendix III</u>).
- 3. Mr Morten RUUD welcomed the participants and thanked them for the many written comments submitted in the follow-up to the first meeting of the Drafting Committee. The Chair also thanked the Secretariat for the revised draft recommendation, which reflects the proposals made at the first meeting for restructuring the appendix and takes into account the comments received.

ITEM 3: DISCUSSION OF ANY GENERAL MATTERS RELATING TO THE WORK OF THE DH-TET

4. Mr Morten RUUD emphasised the importance of the topic of trafficking in human beings for the purposes of labour exploitation to the work of the Council of Europe in general. He expressed hope that this recommendation could, once adopted, make an important contribution to preventing its occurrence in Council of Europe member States and beyond.

ITEM 4: DISCUSSION AND AMENDMENT OF THE REVISED DRAFT RECOMMENDATION PARAGRAPH BY PARAGRAPH

- 5. The structure and content of the preliminary draft recommendation and its appendix (DH-TET(2021)01) has been revised on the basis of the discussion held at the first meeting of the Drafting Committee and the many written comments submitted by participants following the meeting.
- 6. The second meeting of the Drafting Committee was mainly dedicated to a first reading, paragraph by paragraph, of the Appendix of the revised draft recommendation. The participants exchanged views on each paragraph so as to approve it or suggest amendments. The Secretariat took note of the comments made and invited the participants, whenever necessary, to submit concrete drafting proposals and/or suggestions for amendment in the follow-up to the meeting.
- 7. Suggestions for amendment formulated during the meeting were added in track changes to the revised draft recommendation¹.
- 8. The participants agreed on the necessity to revisit and reflect on several paragraphs of the revised draft recommendation, the content of which did not necessarily meet full consensus during the second meeting.
