In the ambit of the Data Protection Day, the Commissioner's Office will launch the initiative of developing and distributing the first comprehensive questionnaire on the level of awareness of the right to personal data protection in the public sector of the Republic of Albania. This questionnaire will be addressed to all public institutions that perform significant personal data processing activities, and circulated internally to all the employees directly or otherwise involved in such processing activities. The feedback received will be useful for the Commissioner's Office to evaluate the level of awareness of the employees regarding the obligations stemming from the legislation on personal data protection, and the practices followed by the institutions in handling personal data, the adequacy of training received both internally and by the Albanian School of Public Administration, etc. Subsequently, the Commissioner's Office will prepare a study based on the findings, and evaluate the relevant recommendations to be rendered.
2. A discussion forum, in the form of an open lecture entitled "How do we protect your personal data" will be organised by the Commissioner's Office in co-operation with the European University of Tirana, gathering students and the academic staff of this university.
3. A hybrid event to introduce the newly drafted legal package on personal data protection aligned with the EU acquis will also be organised by the Commissioner's Office. This event is intended for representatives of public institutions, various private sector entities, including banking, insurance, telecommunications, marketing sectors, etc. as well as representatives of the civil society.

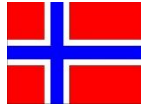

As part of the campaign, the Information Commissioner highlights that, whilst a growing digital economy can in many instances be considered a positive evolution to business practices, such evolution must be accompanied by appropriate mechanisms that safeguard personal data and uphold individuals’ rights in relation to the same. The Information Commissioner sends a reminder that personal data uses that are detrimental to individuals may also become detrimental to the digital economy, and therefore, if data-driven business models are to thrive in a growing ‘digital economy’, data protection should be considered a pre-requisite for their success.

The campaign includes -

- a series of infographics, highlighting the main developments and trends in the digital economy whilst also laying emphasis on the possible risks presented in the digital environment and the appropriate safeguards provided by data protection and privacy law;
- an explanatory video drawing attention to the exponential growth in the volumes and types of data processed and the impact of data protection on the developing digital economy.
