CONCEPT

The Supreme Court of Albania is celebrating its 110th anniversary on 10 May 2023. On this occasion, a high-level international conference is organised by the Supreme Court with the support of the European Union and Council of Europe joint programme, "Horizontal Facility for the Western Balkans and Türkiye III", in the framework of the action "Improving the protection of the right to property and facilitating executions of ECthr judgements in Albania".

The conference "Supreme Courts judicial practices, from national identity to universal values" will be attended by prominent judges from the higher courts of Germany, Italy, France, Greece, England and Wales, Azerbaijan, Türkiye, North Macedonia, Kosovo*, and Montenegro as well as European Court of Human Rights and Supreme Court of the United States of America. It will commemorate and reflect on a particular journey of the High Court of Albania from a national set of values defining its case-law at its birth, to a more universal ones that are more in line with standards enshrined in the European Convention of Human Rights and its path towards the membership in the European Union. Notwithstanding the distinctive path of the High Court of Albania, the conference is focused on connecting the present and future challenges with the context of the post-World War II legal and political developments shaping its history, legal culture, identity, and jurisprudence. This legacy influenced a patchwork transformation of the judicial architecture as well as the success of legal reforms following two decades of lengthy path of democratic transition in Albania. This concerned not only of the role of the High Court but of guiding standards and values it adheres to the entire judiciary and rule of law system in general.

After decades of peace, with the Russian Federation's military aggression against Ukraine, nowadays we are witnessing a worldwide challenge over universal and especially core human rights values and principles, under threat from authoritarian ideas and regimes. Against this backdrop, it is important to remember as well as to emphasise the role of independent judiciaries as adversaries to totalitarian regimes and especially of the role of high courts practices in upholding values and standards enshrined in both convention and domestic legislation as well as to promoting human rights, rule of law and democracy.

The Supreme Court of Albania is a very good example on endorsing a judicial reform aiming to adhere to the Council of Europe human rights standards as well as values on judicial independence, professionalism and integrity. As a member of the Council of Europe (1995) and candidate to the European Union (2020), Albania has been aligning its legal framework with the standards set forth by the European institutions. Implementation of justice and human rights standards in particular are crucial for the success European integration process. In addition, as part of comprehensive justice reform, since 2016 the High Court of Albania plays a crucial role in the integration of European standards, being a leading actor in the harmonisation of national judicial practices to align with these standards.

The Conference will address the delicate issue of finding a balance among values, principles as standards arising from past legacies, present rule of law, as well as challenges and future aspirations and commitments. It will also explore the role that the Albanian Supreme Court plays in preserving a national identity that is original and determined of its history while navigating the integration process into the European Union. The discussions will provide valuable insights on how judiciaries respond to these challenges and why more than ever values of democracy, human rights are rule of law are important to safeguard the national identity.
