<u>LIVING COMPASS</u> aims at supporting the provision and quality of human rights education with young people by developing the competences of multipliers the context of local, national, or international activities and projects and foster the implementation of the Council of Europe Charter on Education for Democratic Citizenship and Human Rights Education and the UN World Programme on Human Rights Education.

Objectives

- 1. To strengthen participants' understanding of key concepts of human rights and human rights education and their ability to put them in practice with young people.
- 2. To develop essential competences, skills and attitudes for multipliers and advocates working with human rights education in non-formal learning settings.
- 3. To familiarise participants with the approaches of Compass and with how to best use it and adapt it to local contexts and realities for both advocacy and practice of human rights education with young people.

- 5. To analyse current global and local developments and trends in human rights education and favouring global solidarity for human rights education.
