Communication by the Secretary General of the Parliamentary Assembly at the 1503rd meeting of the Ministers' Deputies¹ (1st July 2024)

¹ This document covers the activities of the Assembly since the meeting of the Bureau on 24 June 2024 and future activities up to the meeting of the Bureau on 6 September 2024 (Paris).

I. Third part of the Ordinary Session of 2024 (24 – 28 June 2024)

A. Assembly's response to the Russian Federation's war of aggression against Ukraine

The Parliamentary Assembly, adopting a trio of resolutions on the occasion of a joint debate devoted to the consequences of the Russian Federation's aggression against Ukraine, put forward its proposals regarding the judicial process for the trials of Vladimir Putin and his generals for aggression against Ukraine, for strengthening sanctions against the Russian Federation and for countering the attempts of the aggressor State to erase Ukrainian cultural identity. Approving a resolution and recommendation on Legal and Human Rights aspects of the Russian Federation's aggression against Ukraine, the Assembly concluded that a special tribunal, created by agreement between the Council of Europe and Ukraine and supported by an enlarged partial agreement open to non-member States and other international organisations, was now the best feasible option, in terms of the legal basis and political legitimacy. Stressing that there cannot be peace without accountability, the parliamentarians invited the Core Group to maintain the momentum towards a tribunal, thanked the Netherlands for its offer to host it in The Hague, and urged states and other international organisations to participate. The Assembly called again for the seizure and repurposing of Russian State assets, with a view to transferring them to an international compensation fund for Ukraine. In a separate resolution on The role of sanctions in countering the Russian Federation's war of aggression against Ukraine, the Assembly proposed ways to plug gaps and loopholes in existing sanctions against the Russian Federation, such as listing and banning shadow fleet vessels, enhancing export controls, and holding parent companies accountable for subsidiaries' actions. Finally, In a third Resolution on Countering the erasure of cultural identity in war and peace, the Assembly condemned Russia's systematic efforts to erase Ukrainian cultural identity such as the "Russification" of children, rewriting history textbooks, removing archives, and destroying cultural heritage, recognising that these were war crimes and crimes against humanity and underlining the need for full reparations in due course. Council of Europe Human Rights Commissioner Michael O'Flaherty, making his first address to PACE in the framework of this debate, set out five priorities for standing up for the human rights of Ukrainians.

On 27 June 2024, the Parliamentary Assembly adopted Resolution 2562 (2024) on "An urgent call to Europe and its partners: envisioning immediate and long-term policy solutions in support of the displaced people of Ukraine". Emphasising the need for a people-centred approach in policy making in times of crisis, the Assembly called on EU member States to prolong the duration of the initially-agreed temporary protection or to open new avenues for allowing a regular and legally secure presence of peoples of Ukraine on their territory with access to rights available for asylum seekers. According to the Resolution, EU member States should also consider granting the Ukrainians under temporary protection the right to permanent residency in the host country after a three-year period of residence. In addition, PACE proposed a series of measures to support internally-displaced people in Ukraine, such as the rapid provision of sufficient humanitarian assistance, with a specific emphasis on the needs of internally displaced children and their families. Finally, the Assembly reiterated its call to take urgent measures to liberate Ukrainians who are now on the territory of the Russian Federation and Belarus, as a result of forcible displacement or deportation. In particular, it underlined the need to enhance cooperation between various parties and mechanisms to help return forcibly-displaced children, stating that "third-party interventions could offer guarantees of impartiality and effectiveness."

Finally, on 27 June 2024, the Assembly also launched its new Parliamentary Network on the situation of the children of Ukraine. The Network is part of the follow-up to PACE's Resolution 2529 (2024) on this issue adopted in January 2024. Its task will be to enable the Assembly to continue its role as a facilitator to support the Ukrainian authorities and various international organisations in determining the most rapid means to identify and facilitate an effective search for deported children. The Network will also serve as a platform of exchange to promote the protection of the rights of all Ukrainian children including those internally displaced and having sought protection in other countries.

B. Follow-up to the Reykjavik Summit

Adopting a Resolution on Strengthening a youth perspective in the work of the Parliamentary Assembly, PACE members stressed that taking on board the views, expectations and concerns of young people is an essential pre-condition to ensure the good functioning of democracy. It regretted that young people are under-represented in parliaments and do not engage sufficiently with traditional politics. PACE therefore called for the establishment of a mechanism aimed at ensuring that a youth perspective is systematically taken into account in its deliberations. Such a PACE-Youth Participation Mechanism, detailed in the resolution adopted,

would include members of the Assembly and young Europeans, represented by the Advisory Council of Youth and other structures of the Council of Europe youth sector. Each of the Assembly's general committees (except for the Committee on the Election of Judges to the European Court of Human Rights) should moreover appoint from amongst its members or alternates a Youth Rapporteur, responsible for ensuring that the youth perspective is systematically taken into account in each committee's work. The Resolution also calls on the Assembly's national delegations to increase the presence of young parliamentarians amongst their members, such as considering reserving a certain number of seats for young parliamentarians. Marharyta Vorykhava, Vice-chair of the Advisory Council on Youth, addressed the Assembly during the debate and emphasised the need to mainstream young people's viewpoints in all aspects of the Parliamentary Assembly's work.

The Assembly adopted a Resolution on Protecting women human rights defenders in Europe, strongly condemning the frequent attacks perpetrated against women human rights defenders and calling for an end to impunity for perpetrators of violence. The Resolution emphasises that women human rights defenders – which include activists, NGO members, health workers, private sector actors, researchers, lawyers, students, teachers, artists, trade unionists, bloggers and journalists – are working in a peaceful and legal way to promote and protect human rights. The Assembly deplores the attacks and threats that they face, both on and offline, and the intersecting forms of discrimination affecting them. PACE called on member States to repeal laws, policies and practices that adversely affect women human rights defenders, in all their diversity, and which unduly restrict their activities. Their protection should be guaranteed by a secure and enabling environment and the perpetrators of attacks and threats, including members of police forces must be prosecuted. Finally, PACE called on national parliaments to support women human rights defenders.

C. Election of the Secretary General of the Council of Europe

On 25 June 2024, the Parliamentary Assembly of the Council of Europe (PACE) <u>elected</u> Alain Berset (Switzerland) as Secretary General of the Council of Europe for a five-year term beginning on 18 September 2024.

D. Election of judges to the European Court of Human Rights

On 26 June 2024, the Assembly elected Mr András Jakab, Mr Juha Lavapuro and Mr Mateja Durović, as judges to the European Court of Human Rights in respect of respectively Austria, Finland and Serboa.

F. Current affairs debates and debates under urgent procedure

The Assembly held one debate under urgent procedure on "Challenges to democracy in Georgia".

The Assembly held two current affairs debates on "War in Gaza: ensuring the release of the hostages, the implementation of an immediate ceasefire and the provision of humanitarian aid" and on "Can the Council of Europe step up its efforts to counter threats to the freedom of expression?".

G. Media coverage

The media coverage of the 2024 third part-session was outstanding. With more than 75 journalists accredited, there were more than 330 articles (provisional figures) in the international and key national print and electronic media, the second highest figure for a summer session in recent years. Their geographic distribution reflected the PACE agenda, with strong coverage notably found in Switzerland and Ukraine, as well as in many relevant international media.

The election of Alain Berset as the new Secretary General of the Council of Europe was widely reflected in Swiss and international media (fifteen Swiss journalists were physically present in Strasbourg to cover the event). The highly emotional event of the Olympic Torch, which was welcomed at the Council of Europe on its way to Paris, was an exceptional occasion in terms of the Assembly's visibility, as was the conducting of 'Ode to Joy' by the Speaker of the Austrian National Council, Mr Wolfgang Sobotka. Indeed, the event was broadcast live on France TV and was prominent on TV and social media. For the two items mentioned, a specific Eurovision feed was proposed for international TV stations. Other items widely covered were the first Vigdís Prize for Women's Empowerment, awarded to the Irida Women's Center in Greece; the debate on the plans set up by PACE to try Russian leaders, strengthen sanctions and stop the 'erasure' of Ukrainian identity; as well as the urgent debate on the challenges to democracy in Georgia.

Social media engagement across the session week was sustained across all platforms. The top posts all concerned the Vigdís Prize, the Olympic Torch in the chamber and the election of Alain Berset as Secretary General. Total Facebook reach over the week was 4200. There were 56,300 views on YouTube over the week.

The MediaBox, a web-TV studio available to all those making news at the Assembly, once again proved its usefulness for Assembly members, as a way of raising the institution's profile: 28 interviews with parliamentarians and other participants were recorded.

They will focus on "Strengthening political finance oversight: challenges and steps forward" with the Anti-corruption Bureau (ACB) and its Political Finance Monitoring Department to support effective monitoring of legality and transparency of political party and campaign finance (29 June); a two-day seminar for the common court judges of trial and appellate courts to improve the quality of court decisions on electoral complaints in line with international standards and case law of the ECtHR (20-21 July); a one-day workshop for representatives of regional media outlets to enhance the role of the regional media in covering electoral processes in accordance with international standards and good practices (27 July); a of cascade trainings for district election commissions (DECs) (6-9 August); training of trainers for the pool of trainers of the Election Administration to support improving the management of the elections and to increase knowledge of the trainers on the new voting technology to be used for the 2024 elections (29 August);
- 2 3 July, Strasbourg: the PACE Parliamentary and Electoral Cooperation Division, in the framework of the project on "Supporting democratic post-war elections in Ukraine" will co-organise, together with the Congress of Local and Regional Authorities of the Council of Europe, an High-Level Dialogue III "Good Democratic Governance in Ukraine: Achievements, Challenges and the Way Forward in Post-War Period") upon the request of Mr Oleksandr Korniyenko, First Deputy Chairperson of the Ukrainian Parliament. The High-Level Dialogue, launched in November 2022 as a format of respective thematic exchanges between key Ukrainian stakeholders (leadership, members and representatives of the Ukrainian Parliament, Central Election Commission, profile ministries and agencies, local authorities, civil society), continues to serve a multilateral platform supported by the Council of Europe to discuss perspectives for good democratic governance reforms in Ukraine and reach broad agreement among the key national stakeholders as regards further actions to improve legal framework on multilevel governance and elections in light of European standards, good practice and Ukraine's status of the EU candidate country. The Dialogue is conducted in the format of in-camera moderated discussions under Chatham House rules with moderation and facilitation by the Secretariats of the Parliamentary Assembly of the Council of Europe, Venice Commission and the Congress of Local and Regional Authorities of the Council of Europe. Previous two rounds of the High-Level Dialogue took place in Strasbourg, France, on 8 – 9 November 2022 and in Kyiv, Ukraine, on 4 December 2023. The Secretary General of the Parliamentary Assembly will speak in the opening session of this event.
- 2-3 July Chisinau: the PACE Parliamentary and Electoral Cooperation Division through the project "Improving electoral practice in the Republic of Moldova, Phase 3" will participate and contribute to the Regional Conference 2024 Money in Politics in the Era of Globalization and Digitalization which will bring together over 120 representatives of political finance oversight agencies, civil society monitors, political parties, international organisations, representatives of online platform, and electoral, media, and political finance practitioners from across the Eastern European region (Albania, Armenia, Croatia, Georgia, Estonia, Latvia, Lithuania, Republic of Moldova, Poland, Romania and Ukraine) to discuss the impact of money on politics, including online financing, globalization, and digitalization. The project is one of the co-organisers of the Conference together with Central Electoral Commission of the Republic of Moldova, International Institute for Democracy and Electoral Assistance (International IDEA), the OSCE Office for Democratic Institutions and Human Rights (OSCE/ODIHR), the International Republican Institute (IRI) and Westminster Foundation for Democracy.
- Division in the framework of the project on "Supporting democratic post-war elections in Ukraine" will organise another four episodes of series of radio programmes on war-related challenges for organisation and conduct of first post-war elections in Ukraine are planned to be aired on "Ukrainian Radio" a publicly-funded radio broadcaster in Ukraine and one of the biggest and most popular nationwide news and talk FM radio networks in Ukraine. The activity is conducted in the framework of cooperation with the Central Election Commission of Ukraine with the aim to prevent and mitigate the risks of public opinion manipulations channelled through disinformation and misinformation campaign about elections in Ukraine, and for that purpose to raise public awareness on necessary democratic pre-conditions for the conduct of free, fair, and transparent elections.

- **2-4 August, Chisinau**: the PACE Parliamentary and Electoral Cooperation Division through the project "Improving electoral practice in the Republic of Moldova, Phase 3", in cooperation with the Centre for Continuous Electoral Training and the National Youth Council from the Republic of Moldova, will organise a school for young people particularly first-time voters, ahead of the 2024 Presidential election and EU-related constitutional referendum. Participants will familiarise with electoral practices and procedure and increase their level of knowledge and practical skills to improve use social media platforms, gather information about electoral candidates, ensure promote youth priorities in the campaign, debunk misinformation in elections and combat misuse of administrative resources.

Appendix 2 – Organisation of elections by the Parliamentary Assembly during the June 2024 partsession

Introduction

1. On 14 September 2023, and again on 27 November 2023, the Bureau decided that the Assembly would proceed to the election of judges to the European Court of Human Rights and other high-level personalities of the Council of Europe in accordance with the procedure laid down in Rule 40.11 of the Rules of Procedure, using ballot papers and ballot boxes, and to maintain the practice established since 2020 of having tellers appointed by political groups.

Since the January 2024 part-session, these elections have been held in accordance with the standard voting procedure laid down in the Rules of Procedure, by secret ballot with paper ballots, polling booths and ballot boxes; however, the paper attendance sheets have been replaced by a system of verification and electronic signature through the badge of the voting member of the Assembly.

On 19 April 2024, the Bureau instructed the Secretariat to organise the elections to be held during the June 2024 part-session in such a way that a possible second round can be held on the same day. On 23 May 2024, the Bureau held an exchange of views on the organisation of elections by the Parliamentary Assembly during the June 2024 part-session. The arrangements described below were agreed.

Terms and conditions

At the June 2024 part-session, the Parliamentary Assembly will elect the next Secretary General of the Council of Europe and three judges to the European Court of Human Rights.

In order to meet the Bureau's request, the following arrangements have been identified to ensure the possibility of organising a possible second round on the same day:

the election of the Secretary General will be held on Tuesday 25 June:

the elections of judges to the European Court of Human Rights will be held on Wednesday 26 June;

in both cases, votes for the 1st round will be open from 10.05 a.m. to 12.05 noon, and the results will be announced before the sitting adjourns at 1 p.m.

votes for a possible second round will be open in the afternoon from 4 p.m. to 6 p.m. on Tuesday 25 June for the election of the Secretary General, and from 4.30 p.m. to 6.30 p.m. on Wednesday 26 June for the election of judges to the Court; the results will be announced before the sitting is adjourned.

In order to ensure that all members, entitled to take part in the vote, vote in these elections during a limited timeframe, polling stations will be set up in the Lobby of the Committee of Ministers which provides the necessary space for the installation of sufficient number of polling booths to ensure that the elections can be held within the allotted time.

Concerning the election of the Secretary General, the vote will be carried out according to the same terms as for previous elections, namely: the members entitled to vote will be given a single ballot paper presenting the list of the three candidates for the position of General Secretary, in alphabetical order. They will be asked to tick the name of the candidate for whom they are voting. The vote counting will be carried out manually by five tellers duly appointed by the political groups.

With regards to the elections of judges to the European Court of Human Rights, the Assembly will have to elect three judges on the same day. Due to the number of elections, another procedure must be put in place. The vote count will be carried out automatically, under the supervision of tellers duly appointed by the political groups. This step will substantially speed up the counting of the three elections which will be held at the same time and will allow a possible second round of one or more of these elections to be held on the same day. As the ballot papers must be compatible with the device that will carry out the automatic counting, these will be individual ballot papers accompanied with a unique barcode. The ballot papers will be arranged in alphabetical order on dedicated tables. Members entitled to vote will be asked to bring three ballot papers

for each election. They will then be able to slip their ballot paper into the dedicated envelope. Opaque bins will be available in the polling station to allow members entitled to vote to throw away unused ballot papers.

Conclusion

Following discussions at its meetings on 19 April and 23 May, within the framework of its competence for the organisation of the Assembly's part-sessions and plenary sittings, the Bureau of the Assembly is invited to approve the arrangements for the organisation of the elections by the Assembly during the June 2024 part-session.

Appendix 4 - Terms of Reference General Rapporteur on Russian democratic forces

Denomination: General Rapporteur on Russian democratic forces

Term of office: One year, renewable once

Mandate: The General Rapporteur on Russian democratic forces promotes the coherence of the Assembly's action aimed at building dialogue with Russian democratic forces who share the Council of Europe's values and recognise the territorial integrity of Ukraine in its internationally recognised border, supporting their efforts to bring about a democratic change in Russia.

Responsibilities: Taking into account Assembly Resolutions <u>2433 (2022)</u>, <u>2473 (2022)</u> and <u>2540 (2024)</u>, the role of the General Rapporteur is to:

act as a focal point in pursuing a two-way dialogue between the Assembly and Russian democratic forces;

contributes to the activities of the Contact Platform for dialogue with representatives of Russian democratic forces, under the leadership of the President of the Assembly, and deputises for the President when requested;

maintain relations with the Council of Europe organs and bodies conducting work related to Russia; follow their relevant activities, representing the Assembly as appropriate;

work and co-ordinate actions with the other Assembly's General Rapporteurs and rapporteurs;

promote relevant parliamentary initiatives at national level;

follow activities and maintains relations with officials/bodies in Council of Europe member and observer States pursuing dialogue with Russian democratic forces;

follow activities and maintain relations with relevant bodies and agencies of the United Nations, the European Union, the Organisation for Security and Co-operation in Europe, and with other international governmental and inter-parliamentary organisations;

enhance the external visibility and outreach of the work and role of the Assembly relating to Russia and/or Russian democratic forces, including the follow-up and promotion of adopted resolutions and recommendations of the Assembly; in appropriate cases, make public statements, launch appeals, or propose to do so to the Committee.

The General Rapporteur on Russian democratic forces periodically reports to the Committee on Political Affairs and Democracy.

Appendix 5 – Terms of reference of The Parliamentary Network on the situation of the children of Ukraine

Duration: June 2024 – 31 December 2025

In accordance with the Bureau decision of 7 March 2024 to invite the Committee on Social Affairs, Health and Sustainable Development to consider the setting-up of a Network on the Situation of the Children of Ukraine in the framework of the follow-up and implementation of paragraph 26 of Resolution 2529 (2024) on "the situation of the children of Ukraine", the Parliamentary Network on the situation of the children of Ukraine of the Parliamentary Assembly of the Council of Europe shall be constituted in the June 2024 part-session of the Assembly under the auspices of the Committee on Social Affairs, Health and Sustainable Development.

The terms of reference of the Network were adopted by the Committee on Social Affairs, Health and Sustainable Development of the Parliamentary Assembly of the Council of Europe at its meeting on 3 June 2024 for transmission to the Bureau of the Assembly.

Aim of the Network

1. In accordance with Resolution 2529 (2024), it is the task of the Network to provide support to the Assembly "to continue its role as a facilitator (...) to support the Ukrainian authorities and various international organisations, such as UNICEF, the UNHCR, the High Commissioner for Human Rights and other competent United Nations agencies, and the ICRC, in determining the most rapid means to identify and facilitate an effective search for children, with access to as much information as possible about their identity and the conditions of their deportation or forcible transfer by the Russian Federation."

In particular, as a platform of exchange, the Network should:

facilitate the coordination between Ukrainian authorities, international organisations, civil society and other relevant stakeholders

facilitate the rapid and effective implementation of existing mechanisms and contribute to finding new mechanisms, as appropriate, for the identification, tracing and repatriation of deported Ukrainian children

ensure that returned Ukrainian children are smoothly reintegrated

promote the protection of the rights of displaced and refugee Ukrainian children

ensure promotion and dissemination of Council of Europe standards and of Consultation Group on the Children of Ukraine (CGU) tools and deliverables

support the access of Ukrainian children to education and healthcare, including treatment and psychological support for those affected by war.

Composition of the Network

The Network shall be composed of:

- 1.1. In respect of the 46 member States of the Council of Europe: one member of each national delegation, appointed by the national delegation.
- 1.2. In respect of the parliaments with Observer or Partner for Democracy status with the Parliamentary Assembly of the Council of Europe: one member of each national delegation, appointed by the national delegation.
- 1.3. One member each appointed by the following Committees of the Parliamentary Assembly:

Committee on Political Affairs and Democracy

Committee on Legal Affairs and Human Rights

Committee on Migration, Refugees and Displaced Persons

Committee on Social Affairs, Health and Sustainable Development

Committee on Culture, Science, Education and Media Committee on Equality and Non-discrimination.

1.4. One associate member appointed by the Congress of Local and Regional Authorities of the Council of Europe.

The members of the Bureau of the Committee on Social Affairs, Health and Sustainable Development, the chairpersons of political groups and the President of the Assembly, shall be *ex officio* members of the Network.

Working methods of the Network

In terms of the application of the Rules of Procedure of the Assembly, the Network shall be assimilated to a Sub-Committee of the Committee on Social Affairs, Health and Sustainable Development. All members of the Committee on Social Affairs, Health and Sustainable Development shall be entitled to attend the Network's meetings.

The working languages of the Network shall be English and French.

The Network shall hold its first meeting during the 2024 fourth part-session of the Assembly (30 September – 4 October), with the President of the Assembly in the Chair and shall elect its Bureau amongst its members on this occasion.

In fulfilling its task set out in paragraph 1 of these terms of reference, the Network shall be inspired by international and European treaties, United Nations declarations and reports, and texts adopted by the Parliamentary Assembly, in particular those related to the war of aggression of the Russian Federation against Ukraine.

The Network may co-operate with parliamentarians and national parliaments outside of Europe, as well as parliamentary networks and regional and international parliamentary assemblies.

The Network may rely on the "Bring Kids Back UA" initiative and on information sharing with Ukrainian civil society.

The Network shall endeavour to limit its environmental impact.

Appendix 10 - Terms of reference of the Parliamentary Assembly Network of Election Observers

The Parliamentary Assembly has been committed to election observation since 1991, providing essential recommendations that have helped shape the electoral legislation of member States and informed the endeavours of both the Monitoring and the Political Affairs Committees.

Confronting emerging challenges that threaten electoral integrity and undermine public trust in democratic processes, the Assembly has decided to take a more proactive stance in advocating for activities aimed at enhancing the legal frameworks and improved electoral practices in member States. In 2022, its Elections Division co-initiated the Council of Europe's Electoral Cycle, in 2023 it organised the Bern Conference on "Elections in times of crisis", which drew on the synergies of various stakeholders, including members of International Election Observation Missions (IEOM), electoral management bodies, civil society organisations, and academic institutions.

In response to the "Reykjavik Principles for Democracy" adopted at the Council of Europe Summit of Heads of State and Government (16-17 May 2023) and the subsequent Riga Declaration which committed the Assembly to "strengthening its initiatives to uphold the integrity of elections", the Assembly has realigned its activities, including by incorporating intergovernmental election cooperation in its structures as of January 2024 to enhance support for member States throughout the electoral process. It is now also managing the Council of Europe Electoral Cycle and focusing more on the preparation and follow-up to the Assembly's thematic reports on topics such as foreign interference, crisis situations, migrant portrayal in campaigns, reconstruction of Ukraine, etc.

In this context, the creation of a Parliamentary Network of election observers will facilitate cross-cutting dialogue on electoral issues and will formally represent the Assembly in external forums, without altering the operational mechanisms of existing election observation missions (EOMs) or new cooperation activities. The terms of reference for this newly established network are delineated below.

Aim of the Network

In accordance with <u>Resolution 2538 (2024)</u> "Promoting the revised Code of Good Practice on Referendums", the Parliamentary Assembly decides to create the Parliamentary Assembly Network of Election Observers to enable a more effective exchange among PACE observers, reinforce electoral activities and enhance the visibility of the Assembly's electoral endeavours in light of post-Reykjavik Summit and the addition of a cooperation component.

In particular, as platform of exchange, the Network should:

- 1.1. foster exchange of information on electoral activities and election observation missions (EOMs) between PACE observers;
- 1.2. promote the Council of Europe <u>reference standards</u> in electoral matters, in particular:
 - Venice Commission's Code of good conduct in electoral matters, Revised Code of Good Practice on Referendums and its legal opinions on (draft) legislation on elections, referendums and political parties,
 - The Committee of Ministers' Recommendations in electoral matters,
 - The European Court of Human rights' case-law on the right to free and fair elections as set out in Protocol 1, Article 3,
 - PACE Resolutions related to electoral matters,

as well as

 PACE <u>Guidelines for the observation of elections by the Parliamentary Assembly</u>, the <u>Declaration of principles for international election observation</u> and the Code of Conduct for International Election Observers,

- PACE reports on election observation.
- 1.3. organise dedicated seminars;
- 1.4. ensure the representation of the Assembly in external electoral activities;
- 1.5. promote visibility of the Assembly's electoral activities its contribution to the Council of Europe Electoral Cycle.

The Bureau of the Assembly remains responsible for the appointment of PACE ad hoc committees to observe elections and referenda in line with the Assembly's Rules of Procedure (Appendix XIII).

Composition of the Network

The Network shall be composed of members approved by the Bureau of the Assembly, as follows:

- 1.6. in respect of the member States of the Council of Europe: members of the Parliamentary Assembly on the basis of candidatures presented by the political groups and taking into account active participation in PACE election observation missions, gender balance and regional balance. The Bureau of the Assembly shall approve additional members to the Network from among the representatives and substitutes of the Assembly who do not belong to any political group upon proposal of the Bureau of the Network:
- 1.7. in respect of the parliaments with Observer or Partner for Democracy status with the Parliamentary Assembly of the Council of Europe: one member of parliament for each unicameral parliament, and one member of each Chamber for bicameral parliaments, appointed by the national delegation;
- 1.8. a representative appointed by the Congress of Local and Regional Authorities of the Council of Europe;
- 1.9. a representative appointed by the Venice Commission.

The President of the Assembly, the Chairpersons of the Committee on Political Affairs and Democracy, of the Monitoring Committee and of the Committee of Legal Affairs and Human Rights, the chairpersons of political groups, the General Rapporteur on Democracy, as well as the representatives of the Assembly in the Council for Democratic Elections of the Venice Commission (members and substitutes), shall be ex officio members of the Network.

Working methods of the Network

In terms of application of the Rules of Procedure of the Assembly, the Network shall follow the rules applicable to sub-committees of the Assembly (article 49 of the Rules), except as otherwise provided.

The working languages of the Network shall be English and French.

The Bureau of the Network shall be composed of one member designated by each political group and approved by the Bureau of the Assembly. The Chairperson of the Network shall be designated among the members of the Bureau of the Network on the basis of an agreement reached among the political groups ensuring the rotation amongst political groups. The chairperson and the vice-chairpersons of the Network shall remain in office until the opening of the next ordinary session of the Assembly. They may serve for one further term, consecutive or not. A chairperson or vice-chairperson of the Network designated in the course of a session for an incomplete term may be designated for maximum two further terms.

The costs of participation of members of the Network in its meetings and events shall be borne by the respective national parliaments.

The Network shall develop co-operation with all Council of Europe parties active in electoral matters within the framework of the Council of Europe Electoral Cycle, in particular the Steering Committee on Democracy (CDDEM) and the Rapporteur Group on Democracy (GR-DEM).

The Network shall actively co-operate with national parliaments and parliamentarians in and beyond Europe, as well as parliamentary networks and regional and international parliamentary assemblies, including but not limited to the Assembly's partners in the framework of the International Election Observation Missions, in particular the Office for Democratic Institutions and Human Rights of the Organization for Security and Cooperation in Europe (OSCE/ODIHR), OSCE PA, EP and NATO PA.

The Network shall also co-operate with other international organisations, election management bodies, NGOs as well as representatives of the media and the academia dealing with electoral matters.

The Network shall periodically, and at least once a year, report to the Bureau of the Assembly of its activities, which shall approve its decisions.
