Communication by the Secretary General of the Parliamentary Assembly at the 1533rd meeting of the Ministers' Deputies^{*} (3 July 2025)

^{*} This document covers the activities of the Assembly since the meeting of the Bureau on 23 June 2025 and future activities up to the meeting of the Bureau on 5 September 2025.

I. Third part of the Ordinary Session of 2025 (23 – 27 June 2025)

A. Assembly's response to the Russian Federation's war of aggression against Ukraine

On Wednesday 25 June 2025, Ukrainian President Volodymyr Zelenskyy hailed Europe's commitment to justice in an address to the Parliamentary Assembly as aggression tribunal is signed. In his speech, President Zelenskyy thanked the Assembly for "real leadership" in its stand against Russian aggression and hailed Europe's commitment to justice in an address to the Assembly just after the signature of an agreement to create a Special Tribunal for the Crime of Aggression against Ukraine. "It was here in this Assembly, that the first call for such a tribunal was made," Mr Zelenskyy said. "The idea was born here - and now it's gaining real support from partner countries in Europe and beyond." "It will take strong political and legal co-operation to make sure every Russian war criminal faces justice - including Putin. This is the path we must walk - all the way to real charges and real verdicts," he added. "The aggressor must lose. We're working on that. But justice matters too. It must work - so that war criminals have nowhere to hide, not in Europe, not anywhere. And in a way that sets a legal principle - NO rewards for aggression," the Ukrainian President declared. Welcoming Mr Zelenskyy to the Assembly chamber, the President of the Parliamentary Assembly Theodoros Rousopoulos cited Aeschylus, who wrote: We must suffer, suffer into truth. "This is the daily reality of Ukraine. For over 1,200 days and nights, the people of Ukraine have lived what I once called a thousand nightmares." "And among those nightmares, one stands out as the most dangerous: that the world might become accustomed to this war. That a full-scale invasion of a sovereign state becomes normalised. That war crimes become invisible. But this Assembly - this Council - was created to stand precisely against such moral erosion." President Zelenskyy also answered questions from members of the Assembly.

On Tuesday 24 June 2025, the Assembly adopted Resolution 2605 (2025) on Legal and human rights aspects of the Russian Federation's aggression against Ukraine which states that "Certain fundamental principles of international law must not and cannot be set aside or undermined in any ongoing or future negotiations". The Assembly condemned the "illegal, unprovoked and unjustified war of aggression of the Russian Federation against Ukraine" and warned against proposals to legitimise the annexation of Ukrainian territory through war. The Assembly reaffirmed Ukraine's sovereignty and territorial integrity within its internationally recognised borders, including Crimea, and expresses concern about the evolving foreign policy of the new US administration, which it believes risks weakening global accountability efforts. It is concerned about the disengagement of the US from these efforts, including withdrawal from the Core Group on the Establishment of a Special Tribunal for the Crime of Aggression against Ukraine, and calls out the suspension of justice initiatives due to reduced aid. The Assembly urged all member states to swiftly adopt the necessary decisions for the establishment of the Special Tribunal for the Crime of Aggression, and called on observer and partnerfor-democracy States to join the future enlarged partial agreement in support of the tribunal. It also calls on States to support the Register of Damage for Ukraine and work towards the creation of a claims commission and compensation fund, ensuring reparations remain central to any future peace settlement. It further invites the International Criminal Court to consider adding new charges related to crimes against humanity and genocide, in connection with the deportation and forcible transfer of Ukrainian children and the enforced disappearance and torture of civilians. It encourages states to use "universal jurisdiction" to prosecute atrocity crimes, and urges increased assistance to Ukrainian prosecutorial authorities and international accountability mechanisms. The Assembly also condemned the militarisation and political indoctrination of Ukrainian children in territories temporarily occupied by Russia, as well as the policy of ethnic cleansing in those territories, carried out through forced displacement, deportation and violent assimilation. It called for the immediate establishment of an independent international monitoring mission, preferably under the auspices of the United Nations, to observe and report on the human rights situation in the occupied territories.

The Assembly also pressed the Russian Federation to immediately release all unlawfully detained Ukrainian civilians and ensure safe access for the ICRC to all places of detention, while calling for stronger international pressure, including sanctions, to secure the return of Ukrainian prisoners of war and Ukrainian children.

On the same day, the Assembly adopted <u>Resolution 2606 (2025)</u> Support for political negotiations to enforce exchange and release of prisoners of war and expressed concern about the dire situation of Ukrainian prisoners of war, "subjected to summary executions, widespread and systematic torture, and inhuman and degrading treatment, amounting to war crimes and crimes against humanity". The Assembly called for urgent intervention by the international community and urged all states to support political negotiations to accelerate the release and repatriation of all prisoners of war. The Assembly also called on Russia to comply with international human rights and humanitarian law, and to respect all the conditions of detention of prisoners of war as set out in the Third Geneva Convention, by establishing dedicated places of internment – including prisoner of war camps and temporary and permanent transit camps – providing adequate food, water and medical care, and allowing them to communicate with their families. Furthermore, the adopted resolution recommends the establishment of "a structured, permanent mechanism" to enable the prompt, secure and

regular identification, tracing, release and repatriation of all prisoners of war. Finally, the Parliamentary Assembly called on all states whose legislation provides for universal jurisdiction to prosecute officials of Russia involved in war crimes and other crimes.

B. Follow-up to the Reykjavik Summit

Ensuring clean, safe and affordable energy is not only central to addressing climate change and pollution but is also a matter of human rights of present and future generations, the Parliamentary Assembly stated in its Resolution 2611 (2025) on Analysis and guidelines for a sustainable and socially fair energy transition. Transition to more sustainable energy systems is "essential to securing Europe's continued prosperity," the Assembly stressed. The Assembly called for a human rights-based approach to the energy transition, warning that energy poverty continues to affect millions of Europeans. It emphasised the need for "stable long-term policies" to enable a fair shift to renewable sources and to secure access to energy as a condition for the enjoyment of fundamental social rights such as housing, health, work, protection from poverty, and education, notably for the vulnerable population. The resolution urges states to eliminate fossil fuel subsidies, scale up investment in solar, wind and smart grids, and support local initiatives for clean energy production, as well as sustainable mobility and more energy efficient buildings. It highlights the importance of empowering citizens, especially at municipal level, and fostering cooperation across borders to strengthen energy resilience and supply stability. In a series of recommendations, PACE also calls on governments to protect vulnerable people from energy poverty through price caps, income support and renovation grants, and to ensure that workers can transition to green jobs. National energy transition strategies, the Assembly concluded, must be "socially fair", economically viable and environmentally sound.

The President of the European Court of Human Rights Mattias Guyomar took part in a current affairs debate on the topic *The European Court of Human Rights: rising to the challenges of our times*. He focused on the three priorities of his three-year mandate: efficiency, visibility, and responsibility — all framed under the principle of shared responsibility, with the Court working with national authorities and the courts of the 46 Council of Europe member states. He underlined that the Court's role embodies the principle of the separation of powers—grounded in balance and complementarity among the three branches of power.

C. Election of judges to the European Court of Human Rights

On 24 June 2025, the Assembly elected Mr Hugh Mercer as judge to the European Court of Human Rights in respect of the United Kingdom.

E. Current affairs debates and debates under urgent procedure

On 25 June 2025, the Parliamentary Assembly adopted <u>Resolution 2609 (2025)</u> on *Global peace under threat: halting the humanitarian catastrophe in Gaza and addressing the wider conflict in the Middle East* calling on all parties in the broader war taking place in the Middle East to de-escalate and to respect international law, and recalled the need to spare civilians and minimise their suffering and casualties: "The solution to the multiple, deep-seated, long-standing conflicts and challenges affecting the Middle East cannot be achieved through military confrontation but through diplomacy and an inclusive political process." The parliamentarians urged all parties to refrain from jeopardising the recent fragile ceasefire between Israel and Iran, while expressing their grave concern at the "destabilising activities" of Iran, which they said has "emerged as a direct threat to European security". As regards Gaza, the Assembly repeated its urgent appeal for the release of all hostages and an immediate and permanent ceasefire to stop "the relentless loss of civilian life" and to allow

humanitarian relief to reach those in need. It condemned "any use of starvation of a civilian population as a method of warfare, the weaponisation of humanitarian aid and the unlawful denial of humanitarian access" as crimes under international law. The parliamentarians said there must be "no unlawful transfer or forcible displacement of Palestinians from Gaza, nor any attempt to alter the territory of the Gaza strip", while affirming that sustainable peace in Gaza cannot be achieved as long as "Hamas and other groups designated as terrorist organisations maintain any governing or operational role". The Assembly reaffirmed its commitment to peace based on a two-state solution, and urged Council of Europe member and observer states to work with the UN and international courts to ensure international law is upheld.

On 26 June 2025, while noting progress in gender equality, with "growing female participation in economic, public, cultural and political life" and legal standards that have changed to reflect this progress, the Parliamentary Assembly expressed concern in its Resolution 2614 (2025) on Women's rights in Europe -Progress and challenges, that women's rights were increasingly being challenged and eroded worldwide. The Parliamentary Assembly is particularly concerned about "the political instrumentalisation of family values so as to undermine women's rights, "the spread of gendered disinformation, the increasing popularity of "masculinists" advocating for the submission of women to men, hate speech and threats of violence against women politicians, and harassment by anti-choice activists of women's rights defenders, healthcare professionals and people seeking abortion care. In this regard, emphasising that most Council of Europe member states recognise the right to abortion, the Assembly said that once this right has been established, "it is also necessary to guarantee access to free, legal, and safe abortion for all who seek it." It also deplores the important levels of gendered discrimination in the fields of housing, employment, and healthcare, as well as the persistent gender pay gap and pension gap. Faced with this risk of democratic backsliding, the Assembly proposed to states a set of measures to prevent and combat violence against women and domestic violence, in particular "with the aim of tackling the current low reporting rates and high levels of impunity." It also made recommendations on access to sexual and reproductive health and rights, stressing that obstructing a person's access to legal abortion care - when provided for by national law - should be prohibited and criminally sanctioned. The adopted resolution also contains measures to promote greater political participation of women and to combat sexism, gender-based discrimination, and gender stereotypes, Finally, the Parliamentary Assembly called on national parliaments to focus on "securing and mainstreaming women's rights both in national legislation and in policies throughout all fields of life."

The Assembly held two current affairs debates on *The European Court of Human Rights: rising to the challenges* of our times and on *A call for the immediate release of persons facing politically motivated persecution in Georgia.*

F. Media coverage

The 2025 Summer Session of the Parliamentary Assembly generated exceptional media coverage, with 62 journalists present in Strasbourg, and around 277 articles (provisional figures) identified so far in the international press. The highest number of articles was published in Ukrainian media, followed by French and Italian media.

By far the largest coverage - almost half - was for the address to PACE by Ukrainian President Volodymyr Zelenskyy, the highlight of the session, and the signature of the agreement on a Special Tribunal for the Crime of Aggression against Ukraine, which were live-streamed in three languages, and rebroadcast live by a number of television channels around Europe.

Also widely reported, particularly in Ukraine, were the main points of the Assembly's resolution on the legal and human rights aspects of Russia's aggression against Ukraine, and the exchange and release of prisoners of war. Other items drawing media attention were Maltese Prime Minister Robert Abela's address, the Assembly's debates on the humanitarian catastrophe in Gaza and the wider conflict in the Middle East, and on politically motivated persecution in Georgia.

There was a similar pattern as regards the Assembly's social media output, with around 38,000 impressions on the main channels, and the main focus again on the Ukrainian President's visit – including a post from Mr Zelenskyy highlighting his address to PACE. The award of the 2025 Vigdis Prize for Women's Empowerment to Palestinian group "Women of the Sun" featured next in terms of impressions. Meanwhile viewing figures continue to rise for the livestreams on the Assembly's YouTube channel, with around 31k views in total over the week.

The MediaBox, the Assembly's web-TV studio available to all those making news at the Assembly, recorded a total of 43 interviews across session week, with those by rapporteurs published in a dedicated playlist on the PACE YouTube channel.

> **September 2025:** The project supported a nationwide electoral education program targeting first-time voters in public schools across Albania, preparing them for the parliamentary elections (May 2025) and fostering youth civic engagement. The local civil society organisation engaged in the implementation of the program is conducting an analysis on the impact of the program and will disseminate the findings and recommendations in a workshop with stakeholders during September 2025. The event will be an opportunity to discuss with institutional partners on the sustainability of the electoral education programme.

The PACE Parliamentary and Electoral Cooperation Division, through the Project "Supporting Transparency, Inclusiveness, and Integrity of Electoral Practice and Processes in Bosnia and Herzegovina – Phase II":

> July 2025, Sarajevo: Expert mission on the needs assessment for the establishment of the Center for Education in the Central Election Commission of Bosnia and Herzegovina.

September 2025: Inaugural seminar and the official launch of the Academy for women candidates.

The PACE Parliamentary and Electoral Cooperation Division through the Project "Supporting Transparency, Inclusiveness and Integrity of Electoral Practice and Process in Georgia - Phase 2":

> 27 June 2025, Georgia: will organise a one-day workshop on *Mainstreaming gender equality and intersectionality perspectives in electoral processes*. This gains its utmost importance in the context when in 2024 mandatory gender quotas were abolished in Georgia. The workshop will be targeting civil society representatives, as well as women and young leaders. Participants will explore challenges, legal frameworks, and strategies to enhance women's participation in public decision-making. This workshop will foster collaboration among key stakeholders and generate practical solutions for creating a more inclusive and gender-equal decision-making process in Georgia.

28-30 July 2025, Georgia: will conduct a three-day workshop for youth and young leaders, *My vote in democracy.* This aims to empower young people in Georgia with knowledge, skills, and critical awareness around electoral processes and democratic participation. Through expert-led sessions, interactive discussions, and practical exercises, participants will explore the foundations of democratic elections, the role of youth in shaping political systems, and the importance of safeguarding electoral integrity. Participants will be empowered with a better understanding of how electoral systems function and impact citizens, and increased motivation to take part in and advocate for fair, inclusive, and transparent elections.

The PACE Parliamentary and Electoral Cooperation Division, through the Project "Improving Electoral Practice in the Republic of Moldova, 2025-2028":

> 24-26 June 2025 Bern, Switzerland: organised a study visit of 16 representatives of the Moldovan Electoral Administration in Bern. The purpose of the event was to learn and exchange with the Swiss federal and cantonal authorities good practices in key areas such as the alternative voting methods, in particular for voters from abroad; oversight of political and electoral financing; combatting mis/disinformation in elections; ensuring the (cyber-)security and the integrity of the electoral process, as well as with the Moldovan diaspora to raise awareness about electoral procedures and processes ahead of 28 September 2025 Parliamentary election in the Republic of Moldova.

8-9 July 2025 Chisinau: Regional conference Money in Politics (edition III) will provide a platform for peer exchange and strategic dialogue, aimed at confronting digital-era challenges and advancing a shared agenda for transparency, integrity, and electoral resilience. By bringing together key actors from across Eastern Europe, the conference will support the identification of stronger safeguards, smarter oversight, and more coordinated responses to the growing threats facing democracies in the region and beyond. Coorganised in cooperation with other 6 (six) national and international partners.

> **15-16 August 2025, Chisinau**: Training on capacities of around 35 district electoral councils' representatives regarding the management of financial sources designed for 28 September 2025 Parliamentary election.

> August 2025 Republic of Moldova: adjust the Manual for members of the electoral management bodies created abroad ahead of 28 September Parliamentary election.

5-7 September 2025, outside Chisinau: Summer School for Young People - an electoral awareness raising activity for about 25 young people, with a focus on first voters, organised in cooperation with the National Youth Council of Moldova and the Centre for Continuous Electoral Training to share electoral knowledge among young people encouraging them to actively take part into electoral and public processes.

> July-August 2025, Chisinau: adjustment of the Communication plan in crisis of the Central Electoral Commission. The activity is design to better prepare the CEC towards communication with electoral stakeholders, media, tackle with disinformation and image crises during electoral period towards 28 September 2025 Parliamentary election.

The PACE Parliamentary and Electoral Cooperation Division, through the Project "Supporting democratic postwar elections in Ukraine – Phase II, 2025-2026":

3-4 July 2025, Lviv, Ukraine: High-Level Dialogue-IV "Good Democratic Governance in Ukraine: Achievements, Challenges and the Way Forward in Post-War Period" is convened at the request of Mr Oleksandr Korniyenko, First Deputy Speaker of the Ukrainian Parliament, and facilitated jointly by the Secretariats of the Parliamentary Assembly of the Council of Europe, Congress of Regional and Local Authorities and the Venice Commission. The High-Level Dialogue aims to build consensus among national stakeholders on reform priorities for multilevel governance and post-war elections in line with European standards and Ukraine's EU candidacy. Around 50 participants are expected, including members of parliament, national and local authorities, the Central Election Commission and civil society representatives.

➤ 18 – 24 August 2025, United Kingdom: An on-site visit of the Ukrainian delegation, comprising representatives of the Central Election Commission of Ukraine and the Ministry of Foreign Affairs of Ukraine, is planned for the purpose of bilateral exchanges and enhanced cooperation with the UK authorities on election related issues with particular focus on possible arrangements for Ukrainian voters' out-of-country voting in the UK during the post-war elections (following the invitation from the UK Electoral Commission).

Appendix 3 – Terms of Reference for the Parliamentary Network on the situation of the children of Ukraine

Duration: June 2024 - 31 December 2025

In accordance with the Bureau decision of 7 March 2024 to invite the Committee on Social Affairs, Health and Sustainable Development to consider the setting-up of a Network on the Situation of the Children of Ukraine in the framework of the follow-up and implementation of paragraph 26 of <u>Resolution 2529 (2024) on "the situation of the children of Ukraine"</u>, the Parliamentary Network on the situation of the children of Ukraine of the Parliamentary Assembly of the Council of Europe shall be constituted in the June 2024 part-session of the Assembly under the auspices of the Committee on Social Affairs, Health and Sustainable Development.

The terms of reference of the Network were adopted by the Committee on Social Affairs, Health and Sustainable Development of the Parliamentary Assembly of the Council of Europe at its meeting on 3 June 2024 for transmission to the Bureau of the Assembly.

Aim of the Network

1. In accordance with Resolution 2529 (2024), it is the task of the Network to provide support to the Assembly "to continue its role as a facilitator (...) to support the Ukrainian authorities and various international organisations, such as UNICEF, the UNHCR, the High Commissioner for Human Rights and other competent United Nations agencies, and the ICRC, in determining the most rapid means to identify and facilitate an effective search for children, with access to as much information as possible about their identity and the conditions of their deportation or forcible transfer by the Russian Federation."

In particular, as a platform of exchange, the Network should:

- facilitate the coordination between Ukrainian authorities, international organisations, civil society and other relevant stakeholders

- facilitate the rapid and effective implementation of existing mechanisms and contribute to finding new mechanisms, as appropriate, for the identification, tracing and repatriation of deported Ukrainian children

- ensure that returned Ukrainian children are smoothly reintegrated

- promote the protection of the rights of displaced and refugee Ukrainian children

- ensure promotion and dissemination of Council of Europe standards and of Consultation Group on the Children of Ukraine (CGU) tools and deliverables

- support the access of Ukrainian children to education and healthcare, including treatment and psychological support for those affected by war.

Composition of the Network

2. The Network shall be composed of:

2.1. In respect of the 46 member States of the Council of Europe: for each unicameral parliament, one titular and one substitute member of parliament, appointed by their national delegation; for each for bicameral parliament, one titular and one substitute member of each chamber of the parliament, appointed by their national delegation.

2.2. In respect of the parliaments with Observer or Partner for Democracy status with the Parliamentary Assembly of the Council of Europe: one member of each national delegation, appointed by the national delegation.

2.3. **Three members** appointed by **each of** the following Committees of the Parliamentary Assembly:

- •Committee on Political Affairs and Democracy
- •Committee on Legal Affairs and Human Rights
- •Committee on Migration, Refugees and Displaced Persons
- •Committee on Social Affairs, Health and Sustainable Development
- •Committee on Culture, Science, Education and Media
- •Committee on Equality and Non-discrimination.

2.4. One associate member appointed by the Congress of Local and Regional Authorities of the Council of Europe.

3. The members of the Bureau of the Committee on Social Affairs, Health and Sustainable Development, the chairpersons of political groups and the President of the Assembly, shall be *ex officio* members of the Network.

Working methods of the Network

4. In terms of the application of the Rules of Procedure of the Assembly, the Network shall be assimilated to a Sub-Committee of the Committee on Social Affairs, Health and Sustainable Development. All members of the Committee on Social Affairs, Health and Sustainable Development shall be entitled to attend the Network's meetings.

5. The working languages of the Network shall be English and French.

6. The Network shall hold its first meeting during the 2024 fourth part-session of the Assembly (30 September – 4 October), with the President of the Assembly in the Chair and shall elect its Bureau amongst its members on this occasion.

7. In fulfilling its task set out in paragraph 1 of these terms of reference, the Network shall be inspired by international and European treaties, United Nations declarations and reports, and texts adopted by the Parliamentary Assembly, in particular those related to the war of aggression of the Russian Federation against Ukraine.

8. The Network may co-operate with parliamentarians and national parliaments outside of Europe, as well as parliamentary networks and regional and international parliamentary assemblies.

9. The Network may rely on the "Bring Kids Back UA" initiative and on information sharing with Ukrainian civil society.

10. The Network shall endeavour to limit its environmental impact.

Appendix 7 - Terms of reference of the General Rapporteur on European migration and asylum policies

Denomination: General Rapporteur on European migration and asylum policies

Term of office: two years renewable, subject to a maximum of four years.

Subject: The General Rapporteur on European migration and asylum policies ensures the visibility and coherence of the Assembly's action to promote the Council of Europe standards on international protection, detention, data protection, procedural safeguards, and the prohibition of inhumane and degrading treatments in the way migration, border management and asylum policies are designed by member States. The General Rapporteur will have a particular role at valuing and promoting consistency between the Council of Europe standards and other instruments applicable in member States, in particular EU law. He or she shall report periodically to the Committee on Migration, Refugees and Displaced Persons on the information collected and the activities undertaken.

Responsibilities: the role of the General Rapporteur is to:

- follow activities and maintain working relations with the Registry of the European Court of Human Rights, the Division on Migration and Refugees, the liaison office of the Council of Europe in Brussels, as well as with relevant Council of Europe intergovernmental and monitoring bodies as regards their activities related to migration, asylum and border management such as the European NPM platform, the CPT, the CDDH, and the GRETA;
- represent the Committee on behalf of the Assembly at the meetings of these bodies where appropriate;
- follow activities and maintain working relations with EU institutions and competent EU agencies (FRA, EUAA and Frontex) and represent the Committee on behalf of the Assembly at the meetings of these entities, where appropriate;
- make public statements and declarations on matters relevant to his/her mandate;
- ensure that the relevant resolutions and recommendations of the Parliamentary Assembly are promoted and given due consideration in the above-mentioned responsibilities, in particular Resolution 2555 (2024) "Ensuring human rights-compliant asylum procedures", Resolution 2461 (2022) and Recommendation 2238 (2022) "Safe third countries for asylum seekers", Resolution 2416 (2022) "European Union Pact on Migration and Asylum: a human rights perspective".
