Communication by the Secretary General of the Parliamentary Assembly at the 1509th meeting of the Ministers' Deputies¹ (9 October 2024)

¹ This document covers the activities of the Assembly since the meeting of the Bureau on 30 September 2024 and future activities up to the meeting of the Bureau on 28 November 2024.

I. Fourth part of the Ordinary Session of 2024 (30 September – 4 October 2024)

A. Assembly's response to the Russian Federation's war of aggression against Ukraine

The Parliamentary Assembly held a debate under urgent procedure and adopted Resolution 2573 (2024) and Recommendation 2285 (2024) on Missing persons, prisoners of war and civilians in captivity as a result of the war of aggression of the Russian Federation against Ukraine. In doing so, the Assembly expressed its wish to help keep the suffering of prisoners of war and civilian captives, held in the Russian Federation or the temporarily occupied areas of Ukraine, and their families, high on the international political agenda. The Assembly said that too often, relatives have no way of obtaining information about the fate of their loved ones and demanded "immediate and unimpeded" access for International Committee of the Red Cross (ICRC) to all places of detention. Among other things, it also welcomed prisoner exchanges and supported the idea of an "all for all" exchange. A group of Ukrainian women whose loved ones are being held in the Russian Federation observed the debate from the public gallery, and met the PACE President, who expressed his full solidarity with and support for them. These women also participated in a side event with the title "Tortures and deaths of Ukrainian POWs and illegally detained civilians in Russian captivity: what the Council of Europe member States can do to stop it and hold Russia accountable".

The Assembly further adopted Resolution 2575 (2024) on Commemorating the 90th anniversary of the Holodomor – Ukraine once again faces the threat of genocide, drawing a parallel between the Holodomor and the methods used and statements made at the highest level today in the context of Russia's ongoing war of aggression. The parliamentarians pointed to the massacres of Bucha and Irpin, the use of powerful weapons in heavily populated areas, the targeting of civilian infrastructure by the Russian Federation, the "filtering out" and torture of Ukrainian political and cultural elites, the systematic destruction of the spiritual legacy and cultural heritage of the Ukrainian people, the use of food as a weapon, and the forcible deportation of tens of thousands of Ukrainian children as evidence of this new genocidal threat. The Assembly called on all Council of Europe member, observer and partner states to "make use of all instruments at their disposal, including under the Genocide Convention, to prevent any further acts of genocide against the Ukrainian people as a national group". It also invited the ICC Prosecutor to "consider examining the reported allegations of genocide against the Ukrainian people", both generally and regarding the transfer of Ukrainian people.

The Parliamentary Network on the situation of the children of Ukraine, launched on 27 June 2024, held its first meeting on Monday 30 September 2024. On Wednesday 2 October, the documentary Intercepted was screened, in presence of the President of the Assembly, the Secretary General of the Council of Europe, the Chair of the Minister's deputies and the director of the movie. The documentary contrasts scenes of everyday life of Ukrainians since the full-scale invasion with intercepted phone conversations between Russian soldiers and their families.

Last but not least, Mr Vladimir Kara-Murza, 2022 Václav Havel Prize winner imprisoned in 2022 for criticizing the war in Ukraine and released with other political prisoners in a prisoner exchange on 1 August 2024, delivered a speech in occasion of the 2024Václav Havel Prize ceremony. He called for the release of all prisoners of war and for a collective strive for a democratic Russian Federation.

B. Follow-up to the Reykjavik Summit

Adopting Resolution 2566 "The Council of Europe Development Bank: implementing the Reykjavik Declaration" the Assembly called on the Council of Europe Development Bank (CEB) to "gradually enhance support for the Ukrainian Government in the recovery, reconstruction and rehabilitation efforts in social sectors", paying particular attention to housing and public health. In addition, it encouraged the CEB to "focus on the social dimensions of climate change and environmental degradation", as highlighted in the Reykjavik Declaration. According to the parliamentarians, the CEB should also step up its focus on target group countries through the provision of more grants and technical assistance to support the preparation and implementation of social projects with the highest potential impact.

Adopting <u>Resolution 2567</u> on "Propaganda and freedom of information in Europe ", the parliamentarians stressed the need to address harmful propaganda effectively and in a more co-ordinated way to safeguard the proper functioning of our democratic systems. They called on States not to confine their response to restrictions, which could become a tool to silence critical voices and opposition, but rather to develop holistic

strategies which safeguard freedom of expression and freedom of information. According to the adopted text, it is crucial to build trust in institutions and that the public is provided with reliable information on matters of public interest. Transparency of media ownership and financial sources must be enhanced, and equal access to information and media, as well as information literacy, must be fostered.

The parliamentarians called for an explicit "right to food" in national constitutions, including the right of access to drinking water, which would "oblige all branches of government to place people's rights at the heart of food policies". Adopting Resolution 2577, the Assembly also urged laws to make food distribution, processing and marketing fairer and more stable by "reducing economic imbalances between public and private players, aligning agricultural issues with the objectives of ecological transition and supporting farmers in this transition in an inclusive way, while ensuring fair remuneration and greater protection of their rights". In the framework of the debate, the PACE hosted the Nomad Kitchen, a workshop where smoothies were prepared and shared using surplus food collected locally.

Finally, the Assembly adopted Resolution 2578 (2024) on Risks and opportunities of the metaverse. With this, the Assembly urges the decision makers to have a balanced approach to immersive technologies, acknowledging the many opportunities for breakthrough advances which the metaverse triggers, while being aware of the possible threats to democracy, human rights and the rule of law and the potential misuses which would undermine our societies. The Assembly calls on Council of Europe member States to ensure that the legislative and regulatory frameworks applicable to metaverse environments uphold democracy, human rights and the rule of law, responds to law infringements with adequate measures concerning policing, jurisdiction, evidence gathering and deterrent sanctions. International co-operation among governments, as well as their collaboration with the private sector and researchers are essential to address the complexities of metaverse technology, promote sound competition and incentivise the development of safe creative immersive ecosystems and ethical metaverse standards.

C. Election of judges to the European Court of Human Rights

On 1st October 2024, the Assembly elected Ms Anna Adamska-Gallant as judge to the European Court of Human Rights in respect of Poland.

E. Debates under urgent procedure and current affairs debates

The Assembly held a debate under urgent procedure on "Missing persons, prisoners of war and civilians in captivity as a result of the war of aggression of the Russian Federation against Ukraine".

The Assembly held two current affairs debates on "Deteriorating situation of human rights, rule of law and democracy in Azerbaijan" and on "Situation in the Middle-East: escalation of violence and mounting humanitarian crisis, particularly in Gaza".

F. Media coverage

The media coverage of the 4th part-session was outstanding, with the number of articles identified so far jumping by around a third compared to the equivalent part-session last year. Some 135 journalists and TV crews were accredited in Strasbourg, with teams present from several international news agencies and mainstream media from around the world, as well as a number of documentary-makers.

From the Assembly's agenda, the <u>award of the 2024 Havel Prize</u> to María Corina Machado made the biggest headlines, particularly in Spanish-speaking countries, with the highest number of identified press articles coming from Spain as a result. Russian opposition leader Vladimir Kara-Murza, winner of the 2022 edition of the Prize, also addressed the Assembly in the context of the ceremony.

Dominating the coverage , was the <u>testimony</u> given by Julian Assange to the Assembly's Legal Affairs Committee, together with the <u>plenary debate</u> on his case the following day, which saw global coverage from mainstream media, powered by news agency reports and the livestreams. Other topics to generate significant national coverage were the <u>waiving</u> of the immunity of Polish PACE member Marcin Romanowski and the <u>debate</u> on Ukrainian missing persons, prisoners of war and civilians in captivity.

Online, the Assembly's <u>YouTube channel</u> saw 132,000 views across the week, an increase of around 60 per cent compared to the last session. The <u>livestream</u> of the hearing with Mr Assange generated the bulk of that, 82,000 views so far, and a record number of public comments. Many other media posted our broadcast-quality footage of the hearing, often in full, generating well in excess of 1m total views worldwide on this platform alone. A <u>podcast</u> in which PACE President Theodoros Rousopoulos spoke with Ms Corina Machado – the second in a new <u>series</u> of conversations with leading figures reflecting on Council of Europe values – has seen a significant number of views so far. The pattern was similar on the Assembly's other social media platforms, X, LinkedIn and Facebook, with total social media engagement estimated at around 1.4 million.

Finally, the <u>MediaBox</u> continued to be a much-used resource for members and VIP guests, contributing to the social media impact, with a total of 38 recordings in total. The <u>top interview</u>, with Stella Assange and Sunna Ævarsdóttir, has so far garnered just under 5,000 views.

Václav Havel Human Rights Prize

The twelfth Václav Havel Human Rights Prize, which honours outstanding civil society action in defence of human rights – has been awarded to Venezuelan political figure and rights defender María Corina Machado. The prize was presented at a special ceremony on the opening day of the autumn plenary session of the Parliamentary Assembly of the Council of Europe.

Appendix 5 - Parliamentary Network on the situation of the children of Ukraine

Revised terms of reference

Duration: June 2024 - 31 December 2025

In accordance with the Bureau decision of 7 March 2024 to invite the Committee on Social Affairs, Health and Sustainable Development to consider the setting-up of a Network on the Situation of the Children of Ukraine in the framework of the follow-up and implementation of paragraph 26 of Resolution 2529 (2024) on "the situation of the children of Ukraine", the Parliamentary Network on the situation of the children of Ukraine of the Parliamentary Assembly of the Council of Europe shall be constituted in the June 2024 part-session of the Assembly under the auspices of the Committee on Social Affairs, Health and Sustainable Development.

The terms of reference of the Network were adopted by the Committee on Social Affairs, Health and Sustainable Development of the Parliamentary Assembly of the Council of Europe at its meeting on 3 June 2024 for transmission to the Bureau of the Assembly.

Aim of the Network

1. In accordance with Resolution 2529 (2024), it is the task of the Network to provide support to the Assembly "to continue its role as a facilitator (...) to support the Ukrainian authorities and various international organisations, such as UNICEF, the UNHCR, the High Commissioner for Human Rights and other competent United Nations agencies, and the ICRC, in determining the most rapid means to identify and facilitate an effective search for children, with access to as much information as possible about their identity and the conditions of their deportation or forcible transfer by the Russian Federation."

In particular, as a platform of exchange, the Network should:

- facilitate the coordination between Ukrainian authorities, international organisations, civil society and other relevant stakeholders
- facilitate the rapid and effective implementation of existing mechanisms and contribute to finding new mechanisms, as appropriate, for the identification, tracing and repatriation of deported Ukrainian children
- ensure that returned Ukrainian children are smoothly reintegrated
- promote the protection of the rights of displaced and refugee Ukrainian children
- ensure promotion and dissemination of Council of Europe standards and of Consultation Group on the Children of Ukraine (CGU) tools and deliverables
- support the access of Ukrainian children to education and healthcare, including treatment and psychological support for those affected by war.

Composition of the Network

- 2. The Network shall be composed of:
- 2.1. In respect of the 46 member States of the Council of Europe: for each unicameral parliament, one titular and one substitute member of parliament, appointed by their national delegation; for each for bicameral parliament, one titular and one substitute member of each chamber of the parliament, appointed by their national delegation.
- 2.2. In respect of the parliaments with Observer or Partner for Democracy status with the Parliamentary Assembly of the Council of Europe: one member of each national delegation, appointed by the national delegation.
- 2.3. One member each appointed by the following Committees of the Parliamentary Assembly:
 - Committee on Political Affairs and Democracy
 - Committee on Legal Affairs and Human Rights
 - Committee on Migration, Refugees and Displaced Persons
 - Committee on Social Affairs, Health and Sustainable Development
 - Committee on Culture, Science, Education and Media
 - Committee on Equality and Non-discrimination.
- 2.4. One associate member appointed by the Congress of Local and Regional Authorities of the Council of Europe.

3. The members of the Bureau of the Committee on Social Affairs, Health and Sustainable Development, the chairpersons of political groups and the President of the Assembly, shall be *ex officio* members of the Network.

Working methods of the Network

- 4. In terms of the application of the Rules of Procedure of the Assembly, the Network shall be assimilated to a Sub-Committee of the Committee on Social Affairs, Health and Sustainable Development. All members of the Committee on Social Affairs, Health and Sustainable Development shall be entitled to attend the Network's meetings.
- 5. The working languages of the Network shall be English and French.
- 6. The Network shall hold its first meeting during the 2024 fourth part-session of the Assembly (30 September 4 October), with the President of the Assembly in the Chair and shall elect its Bureau amongst its members on this occasion.
- 7. In fulfilling its task set out in paragraph 1 of these terms of reference, the Network shall be inspired by international and European treaties, United Nations declarations and reports, and texts adopted by the Parliamentary Assembly, in particular those related to the war of aggression of the Russian Federation against Ukraine.
- 8. The Network may co-operate with parliamentarians and national parliaments outside of Europe, as well as parliamentary networks and regional and international parliamentary assemblies.
- 9. The Network may rely on the "Bring Kids Back UA" initiative and on information sharing with Ukrainian civil society.
- 10. The Network shall endeavour to limit its environmental impact.

Appendix 6 - Parliamentary Network for a healthy environment²

Revised terms of reference

Duration: 2022-2027

In accordance with Resolution 2399 (2021) on "the climate crisis and the rule of law", the Parliamentary Network for a healthy environment of the Parliamentary Assembly of the Council of Europe (hereafter, "the Network") was constituted during the January 2022 part-session of the Assembly under the auspices of the Committee on Social Affairs, Health and Sustainable Development.

The terms of reference of the network were adopted by the Committee on Social Affairs, Health and Sustainable Development of the Parliamentary Assembly of the Council of Europe at its meeting on 1st December 2021 for transmission to the Bureau of the Assembly. The Committee adopted a revised version at its meeting on 13 September 2024 for transmission to the Bureau.

Aims of the network

- 1. In accordance with Resolution 2399 (2021) on "the climate crisis and the rule of law", the general aim of the Network is "to inspire and follow the action taken by the national authorities to honour the strong commitments they have made vis-à-vis the climate crisis while fostering the mutual enrichment of ideas and setting up regular opportunities for parliamentarians in Europe and on other continents to pool their experience." To this end, the Network shall be inspired by international and European instruments and the United Nations Sustainable Development Goals and shall promote the texts adopted by the Parliamentary Assembly relating to the environment.
- 2. As a platform for exchanges, the Network shall pursue the following specific goals: work to improve climate governance and to embed and promote the right to a safe, clean, healthy and sustainable environment in treaties, national legislation, public policies, business and public practice and consciousness in Europe and elsewhere.
- 3. To achieve these goals, the Network shall:
- Raise parliamentarians' awareness of their role in their respective assemblies in connection with the direction, content and funding of environmental policies and the adoption of legislation affecting the environment.
- Inform parliamentarians about developments in the strategies, standards and supervisory mechanisms which exist within the Council of Europe and other relevant bodies regarding human and environmental rights and of their role in helping them to evolve towards better protection of the right to a healthy environment.
- Improve interaction between parliamentarians, representatives of civil society in the broadest sense and climate justice mechanisms.

Composition of the Network

- 4. The Network shall be composed of:
 - 4.1. In respect of the 46 member States of the Council of Europe: one member of parliament for each unicameral parliament, and one member of each Chamber for bicameral parliaments, appointed by the national parliament or chamber respectively.
 - 4.2. In respect of the parliaments with Observer or Partner for Democracy status with the Parliamentary Assembly of the Council of Europe: one member of parliament for each unicameral parliament, and one member of each Chamber for bicameral parliaments, appointed by the national parliament or chamber respectively.
 - 4.3. One member each appointed by the following Committees of the Parliamentary Assembly:
 - Committee on Political Affairs and Democracy
 - Committee on Legal Affairs and Human Rights
 - Committee on Migration, Refugees and Displaced Persons
 - Committee on Social Affairs, Health and Sustainable Development
 - Committee on Culture, Science, Education and Media
 - Committee on Equality and Non-Discrimination

- 4.4. One associate member appointed by the Congress of Local and Regional Authorities of the Council of Europe.
- 5. The members of the Bureau of the Committee on Social Affairs, Health and Sustainable Development, the chairpersons of political groups and the immediate past President of the Assembly shall be ex officio members of the Network.

Working methods

- 6. In terms of the application of the Rules of Procedure of the Assembly, the Network shall be assimilated to a Sub-Committee of the Committee on Social Affairs, Health and Sustainable Development. All members of the Committee on Social Affairs, Health and Sustainable Development shall be entitled to attend the Network's meetings.
- 7. The working languages of the Network shall be English and French.
- 8. The Network shall elect its Chairperson and its Vice-Chairperson, who shall make up the Bureau. It shall renew its Bureau every two years during the Assembly's first part-session.
- 9. The Network shall adopt its work programme on an annual basis.
- 10. The Network shall facilitate synergy and consistency between the Assembly and other Council of Europe sectors involved in environmental work.
- 11. The Network may co-operate with parliamentarians and national parliaments outside of Europe, as well as parliamentary networks and regional and international parliamentary assemblies.
- 12. The Network shall endeavour to limit its environmental impact so as to enhance its sustainability.

Funding

13. The Network's projects shall be funded with voluntary contributions from the member States.
